

# PREFACE



When we wrote the first edition of *Renal Physiology* in 1992, our goal was to provide a clear and concise overview of the function of the kidneys for health professions students who were studying the topic for the first time. The feedback we have received over the years has affirmed that we met our goal, and that achievement has been a key element to the book's success. Thus, in this fifth edition we have adhered to our original goal, maintaining all the proven elements of the last four editions.

Since 1992, much has been learned about kidney function at the cellular, molecular, and clinical level. Although this new information is exciting and provides new and greater insights into the function of the kidneys in health and disease, it can prove daunting to first-time students and in some cases may cause them to lose the forest for the trees. In an attempt to balance the needs of the first-time student with our desire to present some of the latest advances in the field of renal physiology, we have updated the highlighted text boxes, titled “At the Cellular Level” and “In the Clinic,” to supplement the main text for students who wish additional detail. The other features of the book, which include clinical material that illustrates important physiologic principles, multiple-choice questions, self-study problems, and integrated case studies, have been retained and updated. To achieve our goal of keeping the book concise, we have removed some old material as new material was added. We hope that all who use this book find that the changes have made it an improved learning tool and a valuable source of information.

**To the instructor:** This book is intended to provide students in the biomedical and health sciences with a basic understanding of the workings of the kidneys. We believe that it is better for the student at this stage to master a few central concepts and ideas rather than to assimilate a large array of facts. Consequently, this book is designed to teach the important aspects and fundamental concepts of normal renal function. We have emphasized clarity and conciseness in presenting the material. To accomplish this goal, we have been selective in the material included. The broader field of nephrology, with its current and future frontiers, is better learned at a later time and only after the “big picture” has been well established. For clarity and simplicity, we have made statements as assertions of fact even though we recognize that not all aspects of a particular problem have been resolved.

**To the student:** As an aid to learning this material, each chapter includes a list of objectives that reflect the fundamental concepts to be mastered. At the end of each chapter, we have provided a summary and a list of key words and concepts that should serve as a checklist while working through the chapter. We have also provided a series of self-study problems that review the central principles of each chapter. Because these questions are learning tools, answers and explanations are provided in Appendix D. Multiple-choice questions are presented at the end of each chapter. Comprehensive clinical cases are included in other appendixes. We recommend working through the clinical cases in Appendix A only after completing the book. In this way, they can indicate where additional work or review is required.

We have provided a highly selective bibliography that is intended to provide the next step in the study of the kidney; it is a place to begin to add details to the subjects presented here and a resource for exploring other aspects of the kidney not treated in this book.

We encourage all who use this book to send us your comments and suggestions. Please let us know what we have done right as well as what needs improvement.

# 1

## PHYSIOLOGY OF BODY FLUIDS

---

### OBJECTIVES

Upon completion of this chapter, the student should be able to answer the following questions:

1. How do body fluid compartments differ with respect to their volumes and their ionic compositions?
2. What are the driving forces responsible for movement of water across cell membranes and the capillary wall?
3. How do the volumes of the intracellular and extracellular fluid compartments change under various pathophysiologic conditions?

In addition, the student should be able to define and understand the following properties of physiologically important solutions and fluids:

1. Molarity and equivalence
2. Osmotic pressure
3. Osmolarity and osmolality
4. Oncotic pressure
5. Tonicity

**O**

ne of the major functions of the kidneys is to maintain the volume and composition of the body's fluids constant despite wide variation in the daily intake of water and solutes. In this chapter, the volume and composition of the body's fluids are discussed to provide a background for the study of the kidneys as regulatory organs. Some of the basic principles, terminology, and concepts related to the properties of solutes in solution also are reviewed.

### PHYSICOCHEMICAL PROPERTIES OF ELECTROLYTE SOLUTIONS

---

#### Molarity and Equivalence

The amount of a substance dissolved in a solution (i.e., its concentration) is expressed in terms of either **molarity** or **equivalence**. Molarity is the amount of a substance relative to its molecular weight. For example, glucose has a molecular weight of 180 g/mol. If 1 L

of water contains 1 g of glucose, the molarity of this glucose solution would be determined as:

$$\frac{1\text{g/L}}{180\text{ g/mol}} = 0.0056\text{ mol/L or }5.6\text{ mmol/L} \quad (1-1)$$

For uncharged molecules, such as glucose and urea, concentrations in the body fluids are usually expressed in terms of molarity.\* Because many of the substances of biologic interest are present at very low concentrations, units are more frequently expressed in the millimolar range (mmol/L).

The concentration of solutes, which normally dissociate into more than one particle when dissolved in solution (e.g., sodium chloride [NaCl]), is usually expressed in terms of equivalence. Equivalence refers to the stoichiometry of the interaction between cation and anion and is determined by the valence of these ions. For example, consider a 1 L solution containing 9 g of NaCl (molecular weight = 58.4 g/mol). The molarity of this solution is 154 mmol/L. Because NaCl dissociates into Na<sup>+</sup> and Cl<sup>-</sup> ions, and assuming complete dissociation, this solution contains 154 mmol/L of Na<sup>+</sup> and 154 mmol/L of Cl<sup>-</sup>. Because the valence of these ions is 1, these concentrations also can be expressed as milliequivalents (mEq) of the ion per liter (i.e., 154 mEq/L for Na<sup>+</sup> and Cl<sup>-</sup>, respectively).

For univalent ions such as Na<sup>+</sup> and Cl<sup>-</sup>, concentrations expressed in terms of molarity and equivalence are identical. However, this is not true for ions having valences greater than 1. Accordingly, the concentration of Ca<sup>++</sup> (molecular weight = 40.1 g/mol and valence = 2) in a 1 L solution containing 0.1 g of this ion could be expressed as:

$$\frac{0.1\text{ g/L}}{40.1\text{ g/mol}} = 2.5\text{ mmol/L} \quad (1-2)$$

$$2.5\text{ mmol/L} \times 2\text{ Eq/mol} = 5\text{ mEq}$$

\*The units used to express the concentrations of substances in various body fluids differ among laboratories. The International System of Units (SI) is used in most countries and in most scientific and medical journals in the United States. Despite this convention, traditional units are still widely used. For urea and glucose, the traditional unit of concentration is mg/dL (milligrams per deciliter, or 100 mL), whereas the SI unit is mmol/L (millimoles per liter). Similarly, electrolyte concentrations are traditionally expressed as mEq/L (milliequivalents per liter), whereas the SI unit is mmol/L (see Appendix B).

Although some exceptions exist, it is customary to express concentrations of ions in milliequivalents per liter (mEq/L).

## Osmosis and Osmotic Pressure

The movement of water across cell membranes occurs by the process of **osmosis**. The driving force for this movement is the osmotic pressure difference across the cell membrane. Figure 1-1 illustrates the concept of osmosis and the measurement of the osmotic pressure of a solution.

**Osmotic pressure** is determined solely by the number of solute particles in the solution. It is not dependent on factors such as the size of the solute particles, their mass, or their chemical nature (e.g., valence). Osmotic pressure ( $\pi$ ), measured in atmospheres (atm), is calculated by **van't Hoff's law** as:

$$\pi = nCRT \quad (1-3)$$


where  $n$  is the number of dissociable particles per molecule,  $C$  is total solute concentration,  $R$  is gas constant, and  $T$  is temperature in degrees Kelvin (°K).

For a molecule that does not dissociate in water, such as glucose or urea, a solution containing 1 mmol/L of these solutes at 37° C can exert an osmotic pressure of  $2.54 \times 10^{-2}$  atm as calculated by equation 1-3 using the following values:  $n$  is 1,  $C$  is 0.001 mol/L,  $R$  is 0.082 atm L/mol, and  $T$  is 310° K.

Because 1 atm equals 760 mm Hg at sea level,  $\pi$  for this solution also can be expressed as 19.3 mm Hg. Alternatively, osmotic pressure is expressed in terms of osmolarity (see the following discussion). Thus a solution containing 1 mmol/L of solute particles exerts an osmotic pressure of 1 milliosmole/L (1 mOsm/L).

For substances that dissociate in a solution,  $n$  of equation 1-3 has a value other than 1. For example, a 150 mmol/L solution of NaCl has an osmolarity of 300 mOsm/L because each molecule of NaCl dissociates into a Na<sup>+</sup> and a Cl<sup>-</sup> ion (i.e.,  $n = 2$ ). If dissociation of a substance into its component ions is not complete,  $n$  is not an integer. Accordingly, osmolarity for any solution can be calculated as:

$$\begin{aligned} \text{Osmolarity} &= \text{Concentration} \times \text{Number of} \\ &\quad \text{dissociable particles} \\ \text{mOsm/L} &= \text{mmol/L} \times \text{number of} \\ &\quad \text{particles/mol} \end{aligned} \quad (1-4)$$



**FIGURE 1-1** ■ Schematic representation of osmotic water movement and the generation of an osmotic pressure. Compartment A and compartment B are separated by a semipermeable membrane (i.e., the membrane is highly permeable to water but impermeable to solute). Compartment A contains a solute, and compartment B contains only distilled water. Over time, water moves by osmosis from compartment B to compartment A. (Note: This water movement is driven by the concentration gradient for water. Because of the presence of solute particles in compartment A, the concentration of water in compartment A is less than that in compartment B. Consequently, water moves across the semipermeable membrane from compartment B to compartment A down its gradient). This movement raises the level of fluid in compartment A and decreases the level in compartment B. At equilibrium, the hydrostatic pressure exerted by the column of water ( $h$ ) stops the movement of water from compartment B to A. This pressure is equal and opposite to the osmotic pressure exerted by the solute particles in compartment A.

## Osmolarity and Osmolality

**Osmolarity** and **osmolality** are frequently confused and incorrectly interchanged. Osmolarity refers to the number of solute particles per 1 L of solvent, whereas osmolality is the number of solute particles in 1 kg of solvent. For dilute solutions, the difference between osmolarity and osmolality is insignificant. Measurements of osmolarity are temperature dependent because the volume of solvent varies with temperature (i.e., the volume is larger at higher temperatures). In contrast, osmolality, which is based on the mass of the solvent, is temperature independent. For this reason, osmolality is the preferred term for biologic systems and is used throughout this and subsequent chapters. Osmolality has the units of Osm/kg H<sub>2</sub>O. Because of the dilute nature of physiologic solutions and because water is the solvent, osmolalities are expressed as milliosmoles per kilogram of water (mOsm/kg H<sub>2</sub>O).

Table 1-1 shows the relationships among molecular weight, equivalence, and osmoles for a number of physiologically significant solutes.

## Tonicity

The **tonicity** of a solution is related to its effect on the volume of a cell. Solutions that do not change the volume of a cell are said to be **isotonic**. A **hypotonic**

solution causes a cell to swell, whereas a **hypertonic** solution causes a cell to shrink. Although it is related to osmolality, tonicity also takes into consideration the ability of the solute to cross the cell membrane.

Consider two solutions: a 300 mmol/L solution of sucrose and a 300 mmol/L solution of urea. Both solutions have an osmolality of 300 mOsm/kg H<sub>2</sub>O and therefore are said to be **isosmotic** (i.e., they have the same osmolality). When red blood cells (which, for the purpose of this illustration, also have an intracellular fluid osmolality of 300 mOsm/kg H<sub>2</sub>O) are placed in the two solutions, those in the sucrose solution maintain their normal volume, but those placed in urea swell and eventually burst. Thus the sucrose solution is isotonic and the urea solution is hypotonic. The differential effect of these solutions on red cell volume is related to the permeability of the plasma membrane to sucrose and urea. The red blood cell membrane contains uniporters for urea (see Chapter 4). Thus urea easily crosses the cell membrane (i.e., the membrane is **permeable** to urea), driven by the concentration gradient (i.e., extracellular [urea] > intracellular [urea]). In contrast, the red blood cell membrane does not contain sucrose transporters, and sucrose cannot enter the cell (i.e., the membrane is **impermeable** to sucrose).

To exert an osmotic pressure across a membrane, a solute must not permeate that membrane. Because the red blood cell membrane is impermeable to sucrose, it exerts an osmotic pressure equal and opposite to the osmotic pressure generated by the contents of the red blood cell (in this case, 300 mOsm/kg H<sub>2</sub>O). In contrast, urea is readily able to cross the red blood cell membrane, and it cannot exert an osmotic pressure to balance that generated by the intracellular solutes of the red blood cell. Consequently, sucrose is termed an **effective osmole** and urea is termed an **ineffective osmole**.

To take into account the effect of a solute's membrane permeability on osmotic pressure, it is necessary to rewrite equation 1-3 as:

$$\pi = \sigma(nCRT) \quad (1-5)$$

where  $\sigma$  is the **reflection coefficient** or **osmotic coefficient** and is a measure of the relative ability of the solute to cross a cell membrane.

For a solute that can freely cross the cell membrane (such as urea in this example),  $\sigma = 0$ , and no effective osmotic pressure is exerted. Thus urea is an ineffective

osmole for red blood cells. In contrast,  $\sigma = 1$  for a solute that cannot cross the cell membrane (i.e., sucrose). Such a substance is said to be an effective osmole. Many solutes are neither completely able nor completely unable to cross cell membranes (i.e.,  $0 < \sigma < 1$ ) and generate an osmotic pressure that is only a fraction of what is expected from the total solute concentration.

## Oncotic Pressure

**Oncotic pressure** is the osmotic pressure generated by large molecules (especially proteins) in solution. As illustrated in Figure 1-2, the magnitude of the osmotic pressure generated by a solution of protein does not conform to van't Hoff's law. The cause of this anomalous relationship between protein concentration and osmotic pressure is not completely understood but appears to be related to the size and shape of the protein molecule. For example, the correlation to van't Hoff's law is more precise with small, globular proteins than with larger protein molecules.


The oncotic pressure exerted by proteins in human plasma has a normal value of approximately 26 to 28 mm Hg. Although this pressure appears to be small when considered in terms of osmotic pressure (28 mm Hg  $\approx$  1.4 mOsm/kg H<sub>2</sub>O), it is an important force involved in fluid movement across capillaries (details of this topic are presented in the following section on fluid exchange between body fluid compartments).

## Specific Gravity

The total solute concentration in a solution also can be measured as **specific gravity**. Specific gravity is defined as the weight of a volume of solution divided by the weight of an equal volume of distilled water. Thus the specific gravity of distilled water is 1. Because biologic fluids contain a number of different substances, their specific gravities are greater than 1. For example, normal human plasma has a specific gravity in the range of 1.008 to 1.010.

## VOLUMES OF BODY FLUID COMPARTMENTS

Water makes up approximately 60% of the body's weight, with variability among individuals being a

function of the amount of adipose tissue that is present. Because the water content of adipose tissue is lower than that of other tissue, increased amounts of adipose tissue reduce the fraction of total body weight

attributed to water. The percentage of body weight attributed to water also varies with age. In newborns, it is approximately 75%. This percentage decreases to the adult value of 60% by 1 year of age.

As illustrated in **Figure 1-3**, **total body water** is distributed between two major compartments, which are divided by the cell membrane.\* The **intracellular fluid** (ICF) compartment is the larger compartment and contains approximately two thirds of the total body water. The remaining one third of the body water is contained in the **extracellular fluid** (ECF) compartment. Expressed as percentages of body weight, the volumes of total body water, ICF, and ECF are:


$$\begin{aligned} \text{Total body water} &= 0.6 \times (\text{body weight}) \\ \text{ICF} &= 0.4 \times (\text{body weight}) \\ \text{ECF} &= 0.2 \times (\text{body weight}) \end{aligned} \quad (1-6)$$

\*In these and all subsequent calculations, it is assumed that 1 L of fluid (e.g., ICF and ECF) has a mass of 1 kg. This assumption allows conversion from measurements of body weight to volume of body fluids.

### IN THE CLINIC

The specific gravity of urine is sometimes measured in clinical settings and used to assess the concentrating ability of the kidney. The specific gravity of urine varies in proportion to its osmolality. However, because specific gravity depends on both the number of solute particles and their weight, the relationship between specific gravity and osmolality is not always predictable. For example, patients who have been injected with radiopaque dye (molecular weight >500 g/mol) for radiographic studies can have high values of urine-specific gravity (1.040 to 1.050) even though the urine osmolality is similar to that of plasma (e.g., 300 mOsm/kg H<sub>2</sub>O).

The ECF compartment is further subdivided into **interstitial fluid** and **plasma**, which are separated by the capillary wall. The interstitial fluid surrounds the cells in the various tissues of the body and constitutes three fourths of the ECF volume. The ECF includes water contained within the bone and dense connective tissue, as well as the cerebrospinal fluid. Plasma represents the remaining one fourth of the ECF. Under some pathologic conditions, additional fluid may accumulate in what is referred to as a “**third space.**” Third space collections of fluid are part of the ECF and include, for example, the accumulation of fluid in the peritoneal cavity (**ascites**) of persons with liver disease.

### COMPOSITION OF BODY FLUID COMPARTMENTS

Sodium is the major cation of the ECF, and  $\text{Cl}^-$  and bicarbonate ( $\text{HCO}_3^-$ ) are the major anions. The ionic

composition of the plasma and interstitial fluid compartments of the ECF is similar because they are separated only by the capillary endothelium, a barrier that is freely permeable to small ions. The major difference between the interstitial fluid and plasma is that the latter contains significantly more protein. This differential concentration of protein can affect the distribution of cations and anions between these two compartments (i.e., the Donnan effect) because plasma proteins have a net negative charge that tends to increase the cation concentrations and reduce the anion concentrations in the plasma compartment. However, this effect is small, and the ionic compositions of the interstitial fluid and plasma can be considered identical. Because of its abundance,  $\text{Na}^+$  (and its attendant anions, primarily  $\text{Cl}^-$  and  $\text{HCO}_3^-$ ) is the major determinant of ECF osmolality. Accordingly, a rough estimate of the ECF osmolality can be obtained by simply doubling the sodium concentration  $[\text{Na}^+]$ . For example, if the plasma  $[\text{Na}^+]$  is 145

mEq/L, the osmolality of plasma and ECF can be estimated as:

$$\begin{aligned} \text{Plasma osmolality} &= 2(\text{plasma } [\text{Na}^+]) & (1-7) \\ &= 290 \text{ mOsm/kg H}_2\text{O} \end{aligned}$$

Because water is in osmotic equilibrium across the capillary endothelium and the plasma membrane of cells, measurement of the plasma osmolality also provides a measure of the osmolality of the ECF and ICF.

### IN THE CLINIC

In clinical situations, a more accurate estimate of the plasma osmolality is obtained by also considering the contribution of glucose and urea to the plasma osmolality. Accordingly, plasma osmolality can be estimated as:

$$\text{Plasma osmolality} = 2(\text{plasma}[\text{Na}^+]) + \frac{[\text{glucose}]}{18} + \frac{[\text{urea}]}{2.8} \quad (1-8)$$

The glucose and urea concentrations are expressed in units of mg/dL (dividing by 18 for glucose and 2.8 for urea\* allows conversion from the units of mg/dL to mmol/L and thus to mOsm/kg H<sub>2</sub>O). This estimation of plasma osmolality is especially useful when dealing with patients who have an elevated plasma [glucose] level as a result of diabetes mellitus and patients with chronic renal failure whose plasma [urea] level is elevated.

\*The [urea] in plasma is measured as the nitrogen in the urea molecule, or blood urea nitrogen.

In contrast to the ECF, where the [Na<sup>+</sup>] is approximately 145 mEq/L, the [Na<sup>+</sup>] of the ICF is only 10 to 15 mEq/L. K<sup>+</sup> is the predominant cation of the ICF, and its concentration is approximately 150 mEq/L. This asymmetric distribution of Na<sup>+</sup> and K<sup>+</sup> across the plasma membrane is maintained by the activity of the ubiquitous sodium–potassium–adenosine triphosphatase (Na<sup>+</sup>-K<sup>+</sup>-ATPase) mechanism. By its action, Na<sup>+</sup> is extruded from the cell in exchange for K<sup>+</sup>. The anion composition of the ICF differs from that of the ECF. For example, Cl<sup>-</sup> and HCO<sub>3</sub><sup>-</sup> are the predominant anions of the ECF, and organic molecules and

the negatively charged groups on proteins are the major anions of the ICF.

## FLUID EXCHANGE BETWEEN BODY FLUID COMPARTMENTS

Water moves freely and rapidly between the various body fluid compartments. Two forces determine this movement: hydrostatic pressure and osmotic pressure. Hydrostatic pressure from the pumping of the heart (and the effect of gravity on the column of blood in the vessel) and osmotic pressure exerted by plasma proteins (oncotic pressure) are important determinants of fluid movement across the capillary wall. By contrast, because hydrostatic pressure gradients are not present across the cell membrane, only osmotic pressure differences between ICF and ECF cause fluid movement into and out of cells.

### Capillary Fluid Exchange


The movement of fluid across a capillary wall is determined by the algebraic sum of the hydrostatic and oncotic pressures (the so-called **Starling forces**) as expressed by the following equation:

$$\text{Filtration rate} = K_f[(P_c - P_i) - \sigma(\pi_c - \pi_i)] \quad (1-9)$$

where the filtration rate is the volume of fluid moving across the capillary wall (expressed in units of either volume/capillary surface area or volume/time) and where  $K_f$  is the filtration coefficient of the capillary wall,  $P_c$  is hydrostatic pressure within the capillary lumen,  $\pi_c$  is oncotic pressure of the plasma,  $P_i$  is hydrostatic pressure of the interstitial fluid,  $\pi_i$  is oncotic pressure of the interstitial fluid, and  $\sigma$  is the reflection coefficient for proteins across the capillary wall.

The Starling forces for capillary fluid exchange vary between tissues and organs. They also can change in a given capillary bed under physiologic conditions (e.g., exercising muscle) and pathophysiologic conditions (e.g., congestive heart failure). [Figure 1-4](#) illustrates these forces for a capillary bed located in skeletal muscle at rest.

The capillary filtration coefficient ( $K_f$ ) reflects the intrinsic permeability of the capillary wall to the movement of fluid, as well as the surface area available for

filtration. The  $K_f$  varies among different capillary beds. For example, the  $K_f$  of glomerular capillaries in the kidneys is approximately 100 times greater in magnitude than that of skeletal muscle capillaries. This difference in  $K_f$  accounts for the large volume of fluid filtered across glomerular capillaries compared with the amount filtered across skeletal muscle capillaries (see Chapter 3).

The hydrostatic pressure within the lumen of a capillary ( $P_c$ ) is a force promoting the movement of fluid from the lumen into the interstitium. Its magnitude depends on arterial pressure, venous pressure, and precapillary (arteriolar) and postcapillary

(venular and small vein) resistances. An increase in the arterial or venous pressures results in an increase in  $P_c$ , whereas a decrease in these pressures has the opposite effect.  $P_c$  increases with either a decrease in precapillary resistance or an increase in postcapillary resistance. Likewise, an increase in precapillary resistance or a decrease in postcapillary resistance decreases  $P_c$ . For virtually all capillary beds, precapillary resistance is greater than postcapillary resistance, and thus the precapillary resistance plays a greater role in determining  $P_c$ . An important exception is the glomerular capillaries, where both precapillary and postcapillary resistances modulate  $P_c$  (see Chapter 3). The magnitude of  $P_c$  varies not only among tissues, but also among capillary beds within a given tissue; it also is dependent on the physiologic state of the tissue.

Precapillary sphincters control not only the hydrostatic pressure within an individual capillary, but also the number of perfused capillaries in the tissue. For example, in skeletal muscle at rest, not all capillaries are perfused. During exercise, relaxation of precapillary sphincters allows perfusion of more capillaries. The increased number of perfused capillaries reduces the diffusion distance between the cells and capillaries and thereby facilitates the exchange of  $O_2$  and cellular metabolites (e.g., carbon dioxide [ $CO_2$ ] and lactic acid).

The hydrostatic pressure within the interstitium ( $P_i$ ) is difficult to measure, but in the absence of edema (i.e., abnormal accumulation of fluid in the interstitium), its value is near zero or slightly negative. Thus under normal conditions it causes fluid to move out of the capillary. However, when edema is present,  $P_i$  is positive and it opposes the movement of fluid out of the capillary (see Chapter 6).

The oncotic pressure of plasma proteins ( $\pi_c$ ) retards the movement of fluid out of the capillary lumen. At a normal plasma protein concentration,  $\pi_c$  has a value of approximately 26 to 28 mm Hg. The degree to which oncotic pressure influences capillary fluid movement depends on the permeability of the capillary wall to the protein molecules. If the capillary wall is highly permeable to protein,  $\sigma$  is near zero and the oncotic pressure generated by plasma proteins plays little or no role in capillary fluid exchange. This situation is seen in the capillaries of the liver (i.e., hepatic sinusoids),

which are highly permeable to proteins. As a result, the protein concentration of the interstitial fluid is essentially the same as that of plasma. In the capillaries of skeletal muscle,  $\sigma$  is approximately 0.9, whereas in the glomeruli of the kidneys the value is essentially 1. Therefore plasma protein oncotic pressure plays an important role in fluid movement across these capillary beds.

The protein that leaks across the capillary wall into the interstitium exerts an oncotic pressure ( $\pi_i$ ) and promotes the movement of fluid out of the capillary lumen. In skeletal muscle capillaries under normal conditions,  $\pi_i$  is small and has a value of only 8 mm Hg.

As depicted in [Figure 1-4](#), the balance of Starling forces across muscle capillaries causes fluid to leave the lumen (filtration) along its entire length. Some of this filtered fluid reenters the vasculature across the post-capillary venule where the Starling forces are reversed (i.e., the net driving force for fluid movement is into the vessel). The remainder of the filtered fluid is returned to the circulation through the lymphatics. The sinusoids of the liver also filter along their entire length. In contrast, during digestion of a meal, the balance of forces across capillaries of the gastrointestinal tract results in the net uptake of fluid into the capillary.

Normally, 8 to 12 L/day of fluid moves across capillary beds throughout the body and are collected by lymphatic vessels. This lymphatic fluid flows first to lymph nodes, where most of the fluid is returned to the circulation. Fluid not returned to the circulation at the lymph nodes (1 to 4 L/day) reenters the circulation through the thoracic and right lymphatic ducts. However, under conditions of increased capillary filtration, such as that which occurs in persons with congestive heart failure, thoracic and right lymphatic duct flow can increase 10-fold to 20-fold.

### Cellular Fluid Exchange

Osmotic pressure differences between ECF and ICF are responsible for fluid movement between these compartments. Because the plasma membrane of cells contains water channels (aquaporins [AQPs]), water can easily cross the membrane. Thus a change in the osmolality of either ICF or ECF results in rapid movement (i.e., in minutes) of water between these

compartments. Thus, except for transient changes, the ICF and ECF compartments are in osmotic equilibrium.

#### AT THE CELLULAR LEVEL

Water movement across the plasma membrane of cells occurs through a class of integral membrane proteins called **aquaporins** (AQPs). Although water can cross the membrane through other transporters (e.g., an  $\text{Na}^+$ -glucose symporter), AQPs are the main route of water movement into and out of the cell. To date, 13 AQPs have been identified. These AQPs can be divided into two subgroups. One group, which includes the AQP involved in the regulation of water movement across the apical membrane of renal collecting duct cells by arginine vasopressin (AQP-2) (see Chapter 5), is permeable only to water. The second group is permeable not only to water but also to low-molecular-weight substances, including gases and metalloids. Because glycerol can cross the membrane via this group of aquaporins, they are termed aquaglyceroporins. AQPs exist in the plasma membrane as a homotetramer, with each monomer functioning as a water channel (see Chapter 4).

In contrast to the movement of water, the movement of ions across cell membranes is more variable from cell to cell and depends on the presence of specific membrane transport proteins. Consequently, as a first approximation, fluid exchange between the ICF and ECF under pathophysiologic conditions can be analyzed by assuming that appreciable shifts of ions between the compartments do not occur.

A useful approach for understanding the movement of fluids between the ICF and the ECF is outlined in [Box 1-1](#). To illustrate this approach, consider what happens when solutions containing various amounts of NaCl are added to the ECF.\*

\*Fluids usually are administered intravenously. When electrolyte solutions are infused by this route, rapid equilibration occurs (i.e., within minutes) between plasma and interstitial fluid because of the high permeability of the capillary wall to water and electrolytes. Thus these fluids essentially are added to the entire ECF.

**BOX 1-1****PRINCIPLES FOR ANALYSIS OF FLUID SHIFTS BETWEEN ICF AND ECF**

The volumes of the various body fluid compartments can be estimated in a healthy adult as shown in [Figure 1-3](#).

- All exchanges of water and solutes with the external environment occur through the extracellular fluid (ECF) (e.g., intravenous infusion and intake or loss via the gastrointestinal tract). Changes in the intracellular fluid (ICF) are secondary to fluid shifts between the ECF and the ICF. Fluid shifts occur only if the perturbation of the ECF alters its osmolality.
- Except for brief periods of seconds to minutes, the ICF and the ECF are in osmotic equilibrium. A measurement of plasma osmolality provides a measure of both the ECF and the ICF osmolality.
- For the sake of simplification, it can be assumed that equilibration between the ICF and the ECF occurs only by movement of water and not by movement of osmotically active solutes.
- Conservation of mass must be maintained, especially when considering either addition or removal of water and/or solutes from the body.

**Example 1: Addition of Isotonic NaCl to ECF**

The addition of an isotonic NaCl solution (e.g., intravenous infusion of 0.9% NaCl: osmolality  $\approx$ 290 mOsm/kg H<sub>2</sub>O to a patient)\* to the ECF increases the volume of this compartment by the volume of fluid administered. Because this fluid has the same osmolality as ECF and therefore also has the same osmolality as ICF, no driving force for fluid movement between these compartments exists, and the volume of ICF is unchanged. Although Na<sup>+</sup> can cross cell membranes, it is effectively restricted to the ECF by the activity of Na<sup>+</sup>-K<sup>+</sup>-ATPase, which is present in the plasma

\*A 0.9% NaCl solution (0.9 g NaCl/100 mL) contains 154 mmol/L of NaCl. Because NaCl does not dissociate completely in solution (i.e., 1.88 Osm/mol), the osmolality of this solution is 290 mOsm/kg H<sub>2</sub>O, which is very similar to that of normal ECF.

membrane of all cells. Therefore no net movement of the infused NaCl into the cells occurs.

**IN THE CLINIC**

Neurosurgical procedures and cerebrovascular accidents (strokes) often result in the accumulation of interstitial fluid in the brain (i.e., edema) and swelling of the neurons. Because the brain is enclosed within the skull, edema can raise intracranial pressure and thereby disrupt neuronal function, leading to coma and death. The blood-brain barrier, which separates the cerebrospinal fluid and brain interstitial fluid from blood, is freely permeable to water but not to most other substances. As a result, excess fluid in brain tissue can be removed by imposing an osmotic gradient across the blood-brain barrier. Mannitol can be used for this purpose. Mannitol is a sugar (molecular weight = 182 g/mol) that does not readily cross the blood-brain barrier and membranes of cells (neurons as well as other cells in the body). Therefore mannitol is an effective osmole, and intravenous infusion results in the movement of fluid from the brain tissue by osmosis.

**Example 2: Addition of Hypotonic NaCl to ECF**

The addition of a hypotonic NaCl solution to the ECF (e.g., intravenous infusion of 0.45% NaCl: osmolality <145 mOsm/kg H<sub>2</sub>O to a patient) decreases the osmolality of this fluid compartment, resulting in the movement of water into the ICF. After osmotic equilibration, the osmolalities of ICF and ECF are equal but lower than before the infusion, and the volume of each compartment is increased. The increase in ECF volume is greater than the increase in ICF volume.

**Example 3: Addition of Hypertonic NaCl to ECF**

The addition of a hypertonic NaCl solution to the ECF (e.g., intravenous infusion of 3% NaCl: osmolality  $\approx$ 1000 mOsm/kg H<sub>2</sub>O to a patient) increases the osmolality of this compartment, resulting in the movement of water out of cells. After osmotic equilibration, the osmolalities of ECF and ICF are equal but higher than before the infusion. The volume of the ECF is increased, whereas that of the ICF is decreased.

### IN THE CLINIC

Fluid and electrolyte disorders often are seen in clinical practice (e.g., in patients with vomiting and/or diarrhea). In most instances these disorders are self-limited, and correction of the disorder occurs without need for intervention. However, more severe or prolonged disorders may require fluid replacement therapy. Such therapy may be administered orally with special electrolyte solutions, or intravenous fluids may be administered.

Intravenous solutions are available in many formulations (see Table 1-2). The type of fluid administered to a particular patient is dictated by the patient's need. For example, if an increase in the patient's vascular volume is necessary, a solution containing substances that do not readily cross the capillary wall is infused (e.g., 5% albumin solution). The oncotic pressure generated by the albumin molecules retains fluid in the vascular compartment, expanding its volume. Expansion of extracellular fluid (ECF) is accomplished most often by using isotonic saline solutions (e.g., 0.9% sodium chloride [NaCl]).

As already noted, administration of an isotonic NaCl solution does not result in the development of an osmotic pressure gradient across the plasma membrane of cells. Therefore the entire volume of the infused solution remains in the ECF. Patients whose body fluids are hyperosmotic need hypotonic solutions. These solutions may be hypotonic NaCl (e.g., 0.45% NaCl or 5% dextrose in water [D5W]). Administration of D5W is equivalent to infusion of distilled water because the dextrose is metabolized to CO<sub>2</sub> and water. Administration of these fluids increases the volumes of both the intracellular fluid (ICF) and ECF. Finally, patients whose body fluids are hypotonic need hypertonic solutions, which typically are solutions that contain NaCl (e.g., 3% and 5% NaCl). These solutions expand the volume of the ECF but decrease the volume of the ICF. Other constituents, such as electrolytes (e.g., K<sup>+</sup>) or drugs, can be added to intravenous solutions to tailor the therapy to the patient's fluid, electrolyte, and metabolic needs.

## S U M M A R Y

1. Water, which is a major constituent of the human body, accounts for 60% of the body's weight. Body water is divided between two major compartments: ICF and ECF. Two thirds of the water is in the ICF, and one third is in the ECF. Osmotic pressure gradients between ICF and ECF drive water movement between these compartments. Because the plasma membrane of most cells is highly permeable to water, ICF and ECF are in osmotic equilibrium.
2. The ECF is divided into a vascular compartment (plasma) and an interstitial fluid compartment. Starling forces across capillaries determine the exchange of fluid between these compartments.
3. Sodium is the major cation of ECF, and potassium is the major cation of the ICF. This asymmetric distribution of  $\text{Na}^+$  and  $\text{K}^+$  is maintained by the activity of  $\text{Na}^+/\text{K}^+$ -ATPase.



## STRUCTURE AND FUNCTION OF THE KIDNEYS

---

### OBJECTIVES

Upon completion of this chapter, the student should be able to answer the following questions:

# S

tructure and function are closely linked in the kidneys. Consequently, an appreciation of the gross anatomic and histologic features of the kidneys is a prerequisite for an understanding of their function.

### STRUCTURE OF THE KIDNEYS


---

#### Gross Anatomy

The kidneys are paired organs that lie on the posterior wall of the abdomen behind the peritoneum on either side of the vertebral column. In the adult human, each kidney weighs between 115 and 170 g and is approximately 11 cm long, 6 cm wide, and 3 cm thick.

The gross anatomic features of the human kidney are illustrated in [Figure 2-1, A](#). The medial side of

each kidney contains an indentation, through which pass the renal artery and vein, nerves, and pelvis. If a kidney were cut in half, two regions would be evident: an outer region called the **cortex** and an inner region called the **medulla**. The cortex and medulla are composed of **nephrons** (the functional units of the kidney), blood vessels, lymphatics, and nerves. The medulla in the human kidney is divided into conical masses called **renal pyramids**. The base of each pyramid originates at the corticomedullary border, and the apex terminates in a papilla, which lies within a **minor calyx**. Minor calyces collect urine from each papilla. The numerous minor calyces expand into two or three open-ended pouches, which are the major calyces. The **major calyces** in turn feed into the **pelvis**. The pelvis represents the

upper, expanded region of the **ureter**, which carries urine from the pelvis to the urinary bladder. The walls of the calyces, pelvis, and ureters contain smooth muscle that contracts to propel the urine toward the **urinary bladder**.

The blood flow to the two kidneys is equal to about 25% (1.25 L/min) of the cardiac output in resting individuals. However, the kidneys constitute less than 0.5% of total body weight. As illustrated in **Figure 2-1**, the **renal artery** branches progressively

to form the **interlobar artery**, the **arcuate artery**, the **interlobular artery**, and the **afferent arteriole**, which leads into the **glomerular capillaries**. The glomerular capillaries come together to form the **efferent arteriole**, which leads into a second capillary network, the **peritubular capillaries**, which supply blood to the nephron. The vessels of the venous system run parallel to the arterial vessels and progressively form the **interlobular vein**, **arcuate vein**, **interlobar vein**, and **renal vein**, which courses beside the ureter.

### Ultrastructure of the Nephron

The functional unit of the kidneys is the nephron. Each human kidney contains approximately 1.2 million nephrons, which are hollow tubes composed of a single cell layer. The nephron consists of a **renal corpuscle**, **proximal tubule**, **loop of Henle**, **distal tubule**, and **collecting duct system** (Figure 2-2).<sup>\*</sup> The **renal corpuscle** consists of glomerular capillaries and **Bowman's capsule**.<sup>†</sup> The proximal tubule initially forms several coils, followed by a straight piece that descends toward the medulla. The next segment is the loop of Henle, which is composed of the straight part of the proximal tubule, the descending thin limb (which ends in a hairpin turn), the ascending thin limb (only in nephrons with long loops of Henle), and the thick ascending limb. Near the end of the thick ascending limb, the nephron passes between the afferent and efferent arterioles of the same nephron. This short segment of the thick ascending limb that touches the glomerulus is called the **macula densa** (see Figure 2-2). The distal tubule begins a short distance beyond the macula densa and extends to the

point in the cortex where two or more nephrons join to form a cortical collecting duct. The **cortical collecting duct** enters the medulla and becomes the outer **medullary collecting duct** and then the **inner medullary collecting duct**.


Each nephron segment is made up of cells that are uniquely suited to perform specific transport functions. Proximal tubule cells have an extensively amplified apical membrane (the urine side of the cell) called the **brush border**, which is present only in the proximal tubule of the nephron. The basolateral membrane (the blood side of the cell) is highly invaginated. These invaginations contain many mitochondria. In contrast, the descending and ascending thin limbs of Henle's loop have poorly developed apical and basolateral surfaces and few mitochondria. The cells of the thick ascending limb and the distal tubule have abundant mitochondria and extensive infoldings of the basolateral membrane.

The collecting duct is composed of two cell types: principal cells and intercalated cells. **Principal cells** have a moderately invaginated basolateral membrane and contain few mitochondria. Principal cells play an important role in sodium chloride (NaCl) reabsorption (see Chapters 4 and 6) and K<sup>+</sup> secretion (see Chapter 7). **Intercalated cells**, which play an important role in regulating acid-base balance, have a high density of mitochondria. One population of intercalated cells secretes H<sup>+</sup> (i.e., reabsorbs bicarbonate [HCO<sub>3</sub><sup>-</sup>]) and a second population of intercalated cells secretes HCO<sub>3</sub><sup>-</sup> (see Chapter 8). The final segment of the nephron, the inner medullary collecting duct, is composed of inner medullary collecting duct cells. Cells of the inner medullary collecting duct have poorly developed apical and basolateral surfaces and few mitochondria.


Except for intercalated cells, all cells in the nephron have in the apical plasma membrane a single nonmotile primary cilium that protrudes into tubule fluid (Figure 2-3). Primary cilia are mechanosensors (i.e., they sense changes in the flow rate of tubule fluid) and chemosensors (i.e., they sense or respond to compounds in the surrounding fluid), and they initiate Ca<sup>++</sup>-dependent signaling pathways, including those that control kidney cell function, proliferation, differentiation, and apoptosis (i.e., programmed cell death).

<sup>\*</sup>The organization of the nephron is actually more complicated than presented here. However, for simplicity and clarity of presentation in subsequent chapters, the nephron is divided into five segments. For details on the subdivisions of the five nephron segments, consult Seldin and Giebisch's *The Kidney: Physiology and Pathophysiology*, edition 4 (see Additional Reading). The collecting duct system is not actually part of the nephron. However, for simplicity, we consider the collecting duct system part of the nephron.

<sup>†</sup>Although the renal corpuscle is composed of glomerular capillaries and Bowman's capsule, the term *glomerulus* commonly is used to describe the renal corpuscle.

### AT THE CELLULAR LEVEL

Polycystin 1 (encoded by the *PKD1* gene) and polycystin 2 (encoded by the *PKD2* gene) are expressed in the membrane of primary cilia, and the *PKD1*/*PKD2* complex mediates the entry of  $\text{Ca}^{++}$  into cells. *PKD1* and *PKD2* are thought to play an important role in flow-dependent  $\text{K}^+$  secretion by principal cells of the collecting duct (see Chapter 7). As described in more detail in Chapter 7, increased flow of tubule fluid in the collecting duct is a strong stimulus for  $\text{K}^+$  secretion. Increased flow bends the primary cilium in principal cells, which activates the *PKD1*/*PKD2*  $\text{Ca}^{++}$  conducting channel complex, allowing  $\text{Ca}^{++}$  to enter the cell and increase intracellular  $[\text{Ca}^{++}]$ . The increase in  $[\text{Ca}^{++}]$  activates  $\text{K}^+$  channels in the apical plasma membrane, which enhances  $\text{K}^+$  secretion from the cell into the tubule fluid.

Nephrons may be subdivided into superficial and juxtamedullary types (see Figure 2-2). The glomerulus of each superficial nephron is located in the outer region of the cortex. Its loop of Henle is short, and its efferent arteriole branches into peritubular capillaries that surround the nephron segments of its own and adjacent nephrons. This capillary network conveys

### IN THE CLINIC

**Autosomal dominant polycystic kidney disease** (ADPKD), which is the most common inherited kidney disease, occurs in 1 in 1000 people. Approximately 12.5 million people worldwide have ADPKD, which is caused primarily by mutations in the genes *PKD1* (85% of cases) and *PKD2* (~15% of cases). The major phenotype of ADPKD is enlargement of the kidneys related to the presence of hundreds to thousands of renal cysts that can be as large as 20 cm in diameter. Cysts also are seen in the liver and other organs. About 50% of patients with ADPKD progress to renal failure by the age of 60 years. Although it is not clear how mutations in *PKD1* and *PKD2* cause ADPKD, renal cyst formation results from defects in  $\text{Ca}^{++}$  uptake that lead to alterations in  $\text{Ca}^{++}$ -dependent signaling pathways, including those that control kidney cell proliferation, differentiation, and apoptosis.

oxygen and important nutrients to the nephron segments in the cortex, delivers substances to the nephron for secretion (i.e., the movement of a substance from the blood into the tubular fluid), and serves as a pathway for the return of reabsorbed water and solutes to the circulatory system. A few species, including humans, also possess very short superficial nephrons whose Henle's loops never enter the medulla.


The glomerulus of each **juxtamedullary nephron** is located in the region of the cortex adjacent to the medulla (see Figure 2-2). In comparison with the superficial nephrons, the juxtamedullary nephrons differ anatomically in two important ways: the loop of Henle is longer and extends deeper into the medulla, and the efferent arteriole forms not only a network of peritubular capillaries but also a series of vascular loops called the **vasa recta**.

As shown in Figure 2-1, B, the vasa recta descend into the medulla, where they form capillary networks that surround the collecting ducts and ascending limbs of the loop of Henle. The blood returns to the cortex in the ascending vasa recta. Although less than 0.7% of the blood enters the vasa recta, these vessels subserve important functions in the renal medulla, including (1) conveying oxygen and important nutrients to nephron segments, (2) delivering substances to the

nephron for secretion, (3) serving as a pathway for the return of reabsorbed water and solutes to the circulatory system, and (4) concentrating and diluting the urine (urine concentration and dilution are discussed in more detail in Chapter 5).

### Ultrastructure of the Glomerulus




**FIGURE 2-4** ■ Scanning electron micrograph of interlobular artery, afferent arteriole (*af*), efferent arteriole (*ef*), and glomerulus. The white lines on the afferent and efferent arterioles indicate that they are about 15 to 20  $\mu\text{m}$  wide. (From Kimura K, Hirata Y, Nanba S, et al: *Effects of atrial natriuretic peptide on renal arterioles: morphometric analysis using microvascular casts*, Am J Physiol 259:F936, 1990.)

The first step in urine formation begins with the passive movement of a plasma ultrafiltrate from the glomerular capillaries into **Bowman's space**. The term *ultrafiltration* refers to the passive movement of fluid that is similar in composition to plasma, except that the protein concentration in the ultrafiltrate is lower than that in the plasma, from the glomerular capillaries into Bowman's space. To appreciate the process of ultrafiltration, one must understand the anatomy of the glomerulus. The glomerulus consists of a network of capillaries supplied by the afferent arteriole and drained by the efferent arteriole (Figure 2-4). During embryologic development, the glomerular capillaries press into the closed end of the proximal tubule, forming **Bowman's capsule**. As the epithelial cells thin on the outside circumference of Bowman's

capsule, they form the parietal epithelium (Figure 2-5). The epithelial cells in contact with the capillaries thicken and develop into **podocytes**, which form the **visceral layer** of Bowman's capsule (see Figures 2-5 to 2-7). The space between the visceral layer and the parietal layer is Bowman's space, which at the urinary pole (i.e., where the proximal tubule joins Bowman's capsule) of the glomerulus becomes the lumen of the proximal tubule.


The endothelial cells of glomerular capillaries are covered by a basement membrane, which is surrounded by **podocytes** (see Figures 2-5 to 2-7). The capillary endothelium, basement membrane, and foot processes of podocytes form the so-called **filtration**


**FIGURE 2-7** ■ **A**, Scanning electron micrograph showing the outer surface of glomerular capillaries. This view would be seen from Bowman's space. Processes (P) of podocytes run from the cell body (CB) toward the capillaries, where they ultimately split into foot processes. Interdigitation of the foot processes creates the filtration slits. **B**, Scanning electron micrograph of the inner surface (blood side) of a glomerular capillary. This view would be seen from the lumen of the capillary. The fenestrations of the endothelial cells are seen as small 700-Å holes. The glycocalyx on the endothelial cells cannot be seen because it is removed during the process of tissue preparation. (From Kriz W, Kaissling B: *Structural organization of the mammalian kidney*. In Seldin DW, Giebisch G, editors: *The kidney: physiology and pathophysiology*, ed 2, New York, 1992, Raven.)

**barrier** (see Figures 2-5 to 2-7). The endothelium is fenestrated (i.e., it contains 700-Å holes where 1 Å =  $10^{-10}$  m) and is freely permeable to water, small solutes (such as  $\text{Na}^+$ , urea, and glucose), and small proteins but is not permeable to large proteins, red blood cells, white blood cells, or platelets. Because endothelial cells express glycoproteins on their surface, they minimize the filtration into Bowman's space of albumin, the most abundant plasma protein, and small plasma proteins (see Chapter 3). In addition to their role as a barrier to filtration, the endothelial cells synthesize a number of vasoactive substances (e.g., nitric oxide, a vasodilator, and endothelin-1, a vasoconstrictor) that are important in controlling renal plasma flow (see Chapter 3).

The basement membrane, which is a porous matrix of negatively charged proteins, including type IV collagen, laminin, the proteoglycans agrin and perlecan,

and fibronectin, is also an important filtration barrier to plasma proteins.

The podocytes have long fingerlike processes that completely encircle the outer surface of the capillaries (see Figures 2-6 and 2-7). The processes of the podocytes interdigitate to cover the basement membrane and are separated by apparent gaps called **filtration slits**. Each filtration slit is bridged by a thin diaphragm, the **filtration slit diaphragm**, which appears as a continuous structure when viewed by electron microscopy (see Figure 2-6). The filtration slit diaphragm is composed of several proteins including **nephrin**, **NEPH-1**, and **podocin**, along with intracellular proteins that associate with slit diaphragm proteins, including **CD2-AP** and  **$\alpha$ -actinin 4** (ACTN4) (Figure 2-8). Filtration slits, which function primarily as a size-selective filter, minimize the filtration of proteins and macromolecules that cross the basement membrane from entering Bowman's space.

### AT THE CELLULAR LEVEL


**Nephrotic syndrome** is produced by a variety of disorders and is characterized by an increase in the permeability of the glomerular capillaries to proteins and by a loss of normal podocyte structure, including effacement (i.e., thinning) of foot processes. The augmented permeability to proteins results in an increase in urinary protein excretion (**proteinuria**). Thus the appearance of proteins in the urine can indicate kidney disease. Hypoproteinemia often develops in persons with this syndrome as a result of the proteinuria. In addition, generalized edema commonly is seen in persons with the nephrotic syndrome (see Chapter 6). Mutations in several genes that encode slit diaphragm proteins (see Figure 2-8), including **nephrin**, **NEPH-1**, and **podocin**, along with intracellular proteins that associate with slit diaphragm proteins, including **CD2-AP** and  **$\alpha$ -actinin 4** (ACTN4), or a knockout of these genes in mice, cause proteinuria and kidney disease. For example, mutations in the nephrin gene (*NPHS1*) lead to abnormal or absent slit diaphragms, causing massive proteinuria and renal failure (i.e., congenital nephrotic syndrome). In addition, mutations in the podocin gene (*NPHS2*) cause autosomal recessive, steroid-resistant nephrotic syndrome. These naturally occurring mutations and knockout studies in mice demonstrate that nephrin, NEPH-1, podocin, CD2-AP, and  $\alpha$ -actinin 4 play key roles in podocyte structure and function.

### IN THE CLINIC

**Alport syndrome** is characterized by hematuria (i.e., blood in the urine) and progressive glomerulonephritis (i.e., inflammation of the glomerular capillaries) and accounts for 1% to 2% of all cases of end-stage renal disease. Alport syndrome is caused by mutations in type IV collagen, a major component of the glomerular basement membrane. In about 80% of patients with Alport syndrome, the disease is X-linked with mutations in the *COL4A5* gene. Fifteen percent of patients also have mutations in type IV collagen genes (*COL4A3* and *COL4A4*); six have been identified, but the mode of inheritance is autosomal recessive. The remaining 5% of patients with Alport syndrome have autosomal dominant disease that arises from heterozygous mutations in the *COL4A3* or *COL4A4* genes. In persons with Alport syndrome the glomerular basement membrane

becomes irregular in thickness and fails to serve as an effective filtration barrier to blood cells and protein.

Another important component of the renal corpuscle is the **mesangium**, which consists of **mesangial cells** and the **mesangial matrix** (Figure 2-9).

### AT THE CELLULAR LEVEL

Mesangial cells are involved in the development of **immune complex–mediated glomerular disease**. Because the glomerular basement membrane does not completely surround all glomerular capillaries (see Figure 2-9), some immune complexes can enter the mesangial area without crossing the glomerular basement membrane. Accumulation of immune complexes induces the infiltration of inflammatory cells into the mesangium and promotes the production of proinflammatory cytokines and autacoids by cells in the mesangium. These cytokines and autacoids enhance the inflammatory response. This inflammatory response can lead to cell death, scarring and eventually obliterating the glomerulus.

Mesangial cells, which possess many properties of smooth muscle cells, provide structural support for the glomerular capillaries, secrete the extracellular matrix, exhibit phagocytic activity that removes macromolecules from the mesangium, and secrete prostaglandins and proinflammatory cytokines. Because they also contract and are adjacent to glomerular capillaries, mesangial cells may influence the glomerular filtration rate (GFR) by regulating blood flow through the glomerular capillaries or by altering the capillary surface area (see Chapter 3). Mesangial cells located outside the glomerulus (between the afferent and efferent arterioles) are called **extraglomerular mesangial cells**.

### Ultrastructure of the Juxtaglomerular Apparatus

The **juxtaglomerular apparatus (JGA)** is one component of an important feedback mechanism, the tubuloglomerular feedback mechanism, that is described in Chapter 3. The following structures make up the JGA (see Figure 2-5):

1. The **macula densa** of the thick ascending limb
2. The extraglomerular mesangial cells
3. The renin- and angiotensin II–producing **granular cells** of the afferent arteriole

The cells of the macula densa represent a morphologically distinct region of the thick ascending limb. This region passes through the angle formed by the afferent and efferent arterioles of the same nephron. The cells of the macula densa are in contact with the extraglomerular mesangial cells and the granular cells of the afferent arterioles. Granular cells of the afferent arterioles are derived from metanephric mesenchymal cells. They contain smooth muscle myofilaments and they manufacture, store, and release **renin**. Renin is involved in the formation of **angiotensin II** and ultimately in the secretion of **aldosterone** (see Chapters 4 and 6). The JGA is one component of the tubuloglomerular feedback mechanism that is involved in the autoregulation of renal blood flow and the GFR (see Chapter 3).

### Innervation of the Kidneys

Renal nerves regulate renal blood flow, GFR, and salt and water reabsorption by the nephron. The nerve supply to the kidneys consists of sympathetic nerve fibers that originate in the celiac plexus. No parasympathetic innervation occurs. Adrenergic fibers that innervate the kidneys release norepinephrine. The adrenergic fibers lie adjacent to the smooth muscle cells of the major branches of the renal artery (the interlobar, arcuate, and interlobular arteries) and the afferent and efferent arterioles. Moreover, sympathetic nerves innervate the renin-producing granular cells of the afferent arterioles. Renin secretion is stimulated by increased sympathetic activity. Nerve fibers also innervate the proximal tubule, loop of Henle, distal tubule, and collecting duct; activation of these nerves enhances  $\text{Na}^+$  reabsorption by these nephron segments.

## S U M M A R Y

1. The functional unit of the kidneys is the nephron, which consists of a renal corpuscle (i.e., glomerulus), proximal tubule, Henle's loop, distal tubule, and collecting duct.
2. Cilia play an important role in mechanosensation and chemosensation in nephron cells. Mutations in *PKD1* and *PKD2*, which encode proteins that associate with the central cilium and mediate  $\text{Ca}^{++}$  entry into cells, cause polycystic kidney disease.
3. The first step in urine formation begins with the passive movement of a plasma ultrafiltrate from the glomerular capillaries into Bowman's space. The term *ultrafiltration* refers to the passive movement of a plasmalike fluid that has a very low concentration of proteins from the glomerular capillaries into Bowman's space. The endothelial cells of glomerular capillaries are covered by a glycocalyx and sit on a basement membrane, which is surrounded by podocytes. The capillary endothelium, basement membrane, and foot processes of podocytes form the so-called filtration barrier.
4. The filtration slit diaphragm between foot processes of podocytes is composed of several proteins, including nephrin, NEPH-1, podocin, and intracellular proteins that associate with slit diaphragm proteins, including podocin, CD2-AP, and  $\alpha$ -actinin 4 (ACTN4). Mutations in these genes cause the nephrotic syndrome, which is associated with proteinuria and ultimately renal failure.
5. The JGA is one component of an important feedback mechanism (i.e., tubuloglomerular feedback) that regulates renal blood flow and the glomerular filtration rate. The structures that make up the JGA include the macula densa, extraglomerular mesangial cells, and renin-producing granular cells.
6. The kidneys are innervated by sympathetic nerves that regulate renal blood flow, GFR, and salt and water reabsorption by the nephron.

# 3

## GLOMERULAR FILTRATION AND RENAL BLOOD FLOW

### OBJECTIVES

# T

he first step in the formation of urine by the kidneys is the production of an ultrafiltrate of plasma across the filtration barrier. The process of glomerular filtration and regulation of the glomerular filtration rate (GFR) and renal blood flow (RBF) are discussed in this chapter. The concept of renal clearance, which is the theoretical basis for the measurements of GFR and RBF, also is presented.

### RENAL CLEARANCE


The concept of **renal clearance** is based on the Fick principle (i.e., mass balance or conservation of mass).

Figure 3-1 illustrates the various factors required to describe the mass balance relationships of a kidney. The renal artery is the single input source to the kidney, whereas the renal vein and ureter constitute the two output routes. The following equation defines the mass balance relationship:

$$P_x^a \times RPF^a = (P_x^v \times RPF^v) + (U_x \times \dot{V}) \quad (3-1)$$

where  $P_x^a$  and  $P_x^v$  are concentrations of substance  $x$  in the renal artery and renal vein plasma, respectively,  $RPF^a$  and  $RPF^v$  are **renal plasma flow** (RPF) rates in the artery and vein, respectively,  $U_x$  is the concentration of  $x$  in the urine, and  $\dot{V}$  is the urine flow rate.

This relationship permits the quantification of the amount of  $x$  excreted in the urine versus the amount returned to the systemic circulation in the renal venous

blood. Thus for any substance that is neither synthesized nor metabolized by the kidneys, the amount that enters the kidneys is equal to the amount that leaves the kidneys in the urine plus the amount that leaves the kidneys in the renal venous blood.

The principle of renal clearance emphasizes the excretory function of the kidneys; it considers only the rate at which a substance is excreted into the urine and not its rate of return to the systemic circulation in the renal vein. Therefore in terms of mass balance (equation 3-1), the urinary excretion rate of  $x$  ( $U_x \times \dot{V}$ ) is proportional to the plasma concentration of  $x$  ( $P_x^a$ ):

$$P_x^a \propto U_x \times \dot{V} \tag{3-2}$$

To equate the urinary excretion rate of  $x$  to its renal arterial plasma concentration, it is necessary to determine the rate at which  $x$  is removed from the plasma by the kidneys. This removal rate is the clearance ( $C_x$ ).

$$P_x^a \times C_x = U_x \times \dot{V} \tag{3-3}$$

If equation 3-3 is rearranged and the concentration of  $x$  in the renal artery plasma ( $P_x^a$ ) is assumed to be identical to its concentration in a plasma sample from any peripheral blood vessel, the following relationship is obtained:

$$C_x = \frac{U_x \times \dot{V}}{P_x^a} \tag{3-4}$$

Clearance has the dimensions of volume/time, and it represents a volume of plasma from which all the substance has been removed and excreted into the urine per unit time. The last point is best illustrated by considering the following example. If a substance is present in the urine at a concentration of 100 mg/mL and the urine flow rate is 1 mL/min, the excretion rate for this substance is calculated as follows:


$$\begin{aligned} \text{Excretion rate} &= U_x \times \dot{V} = 100 \text{ mg/mL} \times (1 \text{ mL/min}) \\ &= 100 \text{ mg/min} \end{aligned} \tag{3-5}$$

If this substance is present in the plasma at a concentration of 1 mg/mL, its clearance according to equation 3-4 is as follows:

$$C_x = \frac{U_x \times \dot{V}}{P_x^a} = \frac{100 \text{ mg/min}}{1 \text{ mg/mL}} = 100 \text{ mL/min} \tag{3-6}$$

In other words, 100 mL of plasma are completely cleared of substance  $x$  each minute. The definition of clearance as a volume of plasma from which all the substance has been removed and excreted into the urine per unit time is somewhat misleading because it is not a real volume of plasma; rather, it is an idealized volume.\* The concept of clearance is important because it can be used to measure the GFR and RPF and determine whether a substance is reabsorbed or secreted along the nephron.

\*For most substances cleared from the plasma by the kidneys, only a portion is actually removed and excreted in a single pass through the kidneys.

### Glomerular Filtration Rate

The GFR of the kidney is equal to the sum of the filtration rates of all functioning nephrons. Thus it is an index of kidney function. A decrease in GFR generally means that kidney disease is progressing, whereas movement toward a normal GFR generally suggests recuperation. Thus knowledge of the patient’s GFR is essential in evaluating the severity and course of kidney disease.

Creatinine, which is a byproduct of skeletal muscle creatine phosphate metabolism, can be used to measure the GFR.\* Creatinine is freely filtered across the glomerular filtration barrier into Bowman’s space, and to a first approximation it is not reabsorbed, secreted, or metabolized by the cells of the nephron. Accordingly, the amount of creatinine excreted in the urine per minute equals the amount of creatinine filtered across the filtration barrier each minute (Figure 3-2):

$$\begin{aligned} \text{Amount filtered} &= \text{Amount excreted} \\ GFR \times P_{Cr} &= U_{Cr} \times \dot{V} \end{aligned} \quad (3-7)$$

\*Under experimental conditions GFR is usually measured using inulin, a polyfructose molecule (molecular weight  $\approx 5000$ ). However, because inulin is not produced by the body and must be infused, it is not used in most clinical situations.

where  $P_{Cr}$  is plasma concentration of creatinine,  $U_{Cr}$  is urine concentration of creatinine, and  $\dot{V}$  is the urine flow rate.

If equation 3-7 is solved for the GFR:

$$GFR = \frac{U_{Cr} \times \dot{V}}{P_{Cr}} \quad (3-8)$$

This equation is the same form as that for clearance (equation 3-4). Thus the clearance of creatinine provides a means for determining the GFR. Clearance has the dimensions of volume/time, and it represents a volume of plasma from which all the substance has been removed and excreted into the urine per unit time.

Creatinine is not the only substance that can be used to measure the GFR. Any substance that meets the following criteria can serve as an appropriate marker for the measurement of GFR. The substance must:

1. Be freely filtered across the filtration barrier into Bowman’s space
2. Not be reabsorbed or secreted by the nephron
3. Not be metabolized or produced by the kidney
4. Not alter the GFR

### IN THE CLINIC

**Creatinine** is used to estimate GFR in clinical practice. It is synthesized at a relatively constant rate, and the amount produced is proportional to the muscle mass. However, creatinine is not a perfect substance for measuring GFR because it is secreted to a small extent by the organic cation secretory system in the proximal tubule (see Chapter 4). The error introduced by this secretory component is approximately 10%. Thus the amount of creatinine excreted in the urine exceeds the amount expected from filtration alone by 10%. However, the method used to measure the plasma creatinine concentration ( $P_{Cr}$ ) overestimates the true value by 10%. Consequently, the two errors cancel, and in most clinical situations creatinine clearance provides a reasonably accurate measure of the GFR.


### IN THE CLINIC

A decrease in GFR may be the first and only clinical sign of kidney disease. Thus measuring the GFR is important when kidney disease is suspected. A 50% loss of functioning nephrons reduces the GFR by only about 25%. The decline in GFR is not 50% because the remaining nephrons compensate. Because measurements of GFR are cumbersome, the National Institute of Diabetes and Digestive and Kidney Diseases, the National Kidney Foundation, and American Society of Nephrology all recommend estimating GFR from the plasma creatinine concentration ( $P_{Cr}$ ), which is inversely related to the GFR (Figure 3-3). However, as Figure 3-3 shows, the GFR must decline substantially before an increase in the  $P_{Cr}$  can be detected in a clinical setting. For example, a decrease in GFR from 120 to 100 mL/min is accompanied by an increase in the  $P_{Cr}$  from 1.0 to 1.2 mg/dL. This situation does not appear to represent a significant change in the  $P_{Cr}$ , but the GFR actually has fallen by almost 20%. Figure 3-4 illustrates how a decrease in GFR by 50% causes a doubling of  $P_{Cr}$ . Initially, when GFR is reduced, the excretion of creatinine declines because the amount of creatinine that is filtered (i.e.,  $GFR \times P_{Cr}$ ) and excreted (i.e.,  $U_{Cr} \times \dot{V}$ ) decreases. Because creatinine production is constant and its production transiently exceeds filtration and excretion, creatinine accumulates in the extracellular fluid until the amount filtered equals the amount produced (i.e.,  $GFR \times P_{Cr} = \text{production}$ ). At this point,  $P_{Cr}$  remains stable but elevated.

Not all of the creatinine (or other substances used to measure the GFR) that enters the kidney in the renal arterial plasma is filtered at the glomerulus (see Figure 3-2). Likewise, not all of the plasma coming into the kidneys is filtered. Although nearly all of the plasma that enters the kidneys in the renal artery passes through a glomerulus, approximately 10% does not. The portion of filtered plasma is termed the **filtration fraction** and is determined as:

$$\text{Filtration fraction} = \text{GFR/RPF} \quad (3-9)$$

Under normal conditions, the filtration fraction averages 0.15 to 0.20, which means that only 15% to 20% of

Because the production of creatinine is constant, excretion must be constant to maintain creatinine balance. Therefore if the GFR falls from 120 to 60 mL/min, the  $P_{Cr}$  must increase from 1 to 2 mg/dL to keep the filtration of creatinine and its excretion equal to the production rate.

the plasma that enters the glomerulus is actually filtered. The remaining 80% to 85% continues through the glomerular capillaries and into the efferent arterioles, peritubular capillaries, and the vasa recta. It is finally returned to the systemic circulation in the renal vein.


## GLOMERULAR FILTRATION

The first step in the formation of urine is ultrafiltration of the plasma by the glomerulus. In healthy adults, the GFR ranges from 90 to 140 mL/min for men and from 80 to 125 mL/min for women. Thus in 24 hours as much as 180 L of plasma is filtered by the glomeruli. The plasma ultrafiltrate is devoid of cellular elements (i.e., red and white blood cells and platelets) and has a very low concentration of proteins. The concentrations of salts and of organic molecules, such as glucose and

amino acids, are similar in the plasma and ultrafiltrate. Starling forces drive ultrafiltration across the glomerular capillaries, and changes in these forces alter the GFR. The GFR and RPF normally are held within very narrow ranges by a phenomenon called **autoregulation**. The next sections of this chapter review the composition of the glomerular filtrate, the dynamics of its formation, and the relationship between RPF and GFR. In addition, the factors that contribute to the autoregulation and regulation of GFR and RBF are discussed.

## Determinants of Ultrafiltrate Composition

The glomerular filtration barrier determines the composition of the plasma ultrafiltrate. It restricts the filtration of molecules primarily on the basis of size. In general, molecules with a radius smaller than 20 Å are

### IN THE CLINIC

A reduction in GFR in disease states is most often due to decreases in the ultrafiltration coefficient ( $K_f$ ) because of the loss of filtration surface area. The GFR also changes in pathophysiologic conditions because of changes in the hydrostatic pressure in the glomerular capillary ( $P_{GC}$ ), oncotic pressure in the glomerular capillary ( $\pi_{GC}$ ), and hydrostatic pressure in Bowman's space ( $P_{BS}$ ).

1. Changes in  $K_f$ : An increased  $K_f$  enhances the GFR, whereas a decreased  $K_f$  reduces the GFR. Some kidney diseases reduce the  $K_f$  by decreasing the number of filtering glomeruli (i.e., diminished surface area). Some drugs and hormones that dilate the glomerular arterioles also increase the  $K_f$ . Similarly, drugs and hormones that constrict the glomerular arterioles also decrease the  $K_f$ .
2. Changes in  $P_{GC}$ : With decreased renal perfusion, the GFR declines because the  $P_{GC}$  decreases. As previously discussed, a reduction in the  $P_{GC}$  is caused by a decline in renal arterial pressure, an increase in afferent arteriolar resistance, or a decrease in efferent arteriolar resistance.
3. Changes in  $\pi_{GC}$ : An inverse relationship exists between the  $\pi_{GC}$  and the GFR. Alterations in the  $\pi_{GC}$  result from changes in protein synthesis outside the kidneys. In addition, protein loss in the urine caused by some renal diseases can lead to a decrease in the plasma protein concentration and thus in the  $\pi_{GC}$ .
4. Changes in  $P_{BS}$ : An increased  $P_{BS}$  reduces the GFR, whereas a decreased  $P_{BS}$  enhances the GFR. Acute obstruction of the urinary tract (e.g., a kidney stone occluding the ureter) increases the  $P_{BS}$ .

filtered freely, molecules larger than 42 Å are not filtered, and molecules between 20 and 42 Å are filtered to various degrees. For example, serum albumin, an anionic protein that has an effective molecular radius of 35.5 Å, is filtered poorly. Because the filtered albumin and other small proteins normally are reabsorbed avidly by the proximal tubule, almost no protein appears in the urine of persons with normal renal function.\*

\*Some studies suggest that the filtration of anionic proteins is affected by the presence of negatively charged glycoproteins on the surfaces of the glomerular filtration barrier. These charged glycoproteins repel similarly charged molecules. Because most plasma proteins are negatively charged, the negative charge on the filtration barrier may restrict the filtration of anionic proteins that have a molecular radius of 20 to 42 Å.

### Dynamics of Ultrafiltration

The forces responsible for the glomerular filtration of plasma are the same as those in all capillary beds (see Chapter 1). Ultrafiltration occurs because the Starling forces (i.e., hydrostatic and oncotic pressures) drive fluid from the lumen of glomerular capillaries, across the filtration barrier, and into Bowman's space (Figure 3-5). The hydrostatic pressure in the glomerular capillary ( $P_{GC}$ ) is oriented to promote the movement of fluid from the glomerular capillary into Bowman's space. Because the reflection coefficient ( $\sigma$ ) for proteins across the glomerular capillary is essentially 1, the glomerular ultrafiltrate has a very low concentration of proteins, and the oncotic pressure in Bowman's space ( $\pi_{BS}$ ) is near zero. Therefore  $P_{GC}$  is the only force that favors filtration. The hydrostatic pressure in Bowman's space ( $P_{BS}$ ) and the oncotic pressure in the glomerular capillary ( $\pi_{GC}$ ) oppose filtration.


As shown in Figure 3-5, a net ultrafiltration pressure ( $P_{UF}$ ) of 17 mm Hg exists at the afferent end of the glomerulus, whereas at the efferent end, it is 8 mm Hg (where  $P_{UF} = P_{GC} - P_{BS} - \pi_{GC}$ ). Two additional points concerning Starling forces and this pressure change are important. First,  $P_{GC}$  decreases slightly along the length of the capillary because of the resistance to flow. Second,  $\pi_{GC}$  increases along the length of the glomerular capillary. Because water is filtered and protein is retained in the glomerular capillary, the protein concentration in the capillary rises, and  $\pi_{GC}$  increases.

The GFR is proportional to the sum of the Starling forces that exist across the capillaries [ $(P_{GC} - P_{BS}) - \sigma(\pi_{GC} - \pi_{BS})$ ] multiplied by the ultrafiltration coefficient ( $K_f$ ). That is:

$$GFR = K_f [(P_{GC} - P_{BS}) - \sigma(\pi_{GC} - \pi_{BS})] \quad (3-10)$$

$K_f$  is the product of the intrinsic permeability of the glomerular capillary and the glomerular surface area available for filtration. The rate of glomerular filtration is considerably greater in glomerular capillaries than in systemic capillaries, mainly because  $K_f$  is approximately 100 times greater in glomerular capillaries. Furthermore, the  $P_{GC}$  is approximately twice as great as the hydrostatic pressure in systemic capillaries.

The GFR can be altered by changing  $K_f$  or by changing any of the Starling forces. In healthy

persons, the GFR is regulated by alterations in the  $P_{GC}$  that are mediated mainly by changes in afferent or efferent arteriolar resistance.  $P_{GC}$  is affected in three ways:

1. *Changes in afferent arteriolar resistance:* a decrease in resistance increases the  $P_{GC}$  and GFR, whereas an increase in resistance decreases the  $P_{GC}$  and GFR.
2. *Changes in efferent arteriolar resistance:* a decrease in resistance reduces the  $P_{GC}$  and GFR, whereas an increase in resistance elevates the  $P_{GC}$  and GFR.
3. *Changes in renal artery pressure:* an increase in blood pressure transiently increases the  $P_{GC}$  (which enhances the GFR), whereas a decrease in blood pressure transiently decreases the  $P_{GC}$  (which reduces the GFR).

## RENAL BLOOD FLOW

Blood flow (~1.25 L/min) through the kidneys serves several important functions. This blood flow:

1. Indirectly determines the GFR
2. Modifies the rate of solute and water reabsorption by the proximal tubule
3. Participates in the concentration and dilution of urine
4. Delivers oxygen, nutrients, and hormones to the cells of the nephron and returns carbon dioxide and reabsorbed fluid and solutes to the general circulation
5. Delivers substrates for excretion in the urine

Blood flow through any organ may be represented by the following equation:


$$Q = \frac{\Delta P}{R} \tag{3-11}$$

where  $Q$  is blood flow,  $\Delta P$  is mean arterial pressure minus venous pressure for that organ, and  $R$  is resistance to flow through that organ.

Accordingly, RBF is equal to the pressure difference between the renal artery and the renal vein divided by the renal vascular resistance:

$$RBF = \frac{\text{Aortic pressure} - \text{Renal venous pressure}}{\text{Renal vascular resistance}} \tag{3-12}$$

The interlobular artery, afferent arteriole, and efferent arteriole are the major resistance vessels in the kidneys and determine renal vascular resistance. Like most other organs, the kidneys regulate their blood flow by adjusting the vascular resistance in response to changes in arterial pressure. As shown in Figure 3-6, these adjustments are so precise that blood flow remains relatively constant as arterial blood pressure fluctuates between 90 and 180 mm Hg. The GFR also is regulated over the same range of arterial pressures. The phenomenon whereby RBF and GFR are maintained at a relatively constant level, namely **autoregulation**, is achieved by changes in vascular resistance, mainly through the afferent arterioles of the kidneys. Because both the GFR and RBF are regulated over the same range of pressures and because RBF is an important determinant of GFR, it is not surprising that the same mechanisms regulate both flows.


Two mechanisms are responsible for the autoregulation of *RBF* and *GFR*: one mechanism that responds to changes in arterial pressure and another that responds to changes in the sodium chloride ( $\text{NaCl}$ ) concentration of tubular fluid. Both mechanisms regulate the tone of the afferent arteriole. The pressure-sensitive mechanism, the so-called **myogenic mechanism**, is related to an intrinsic property of vascular smooth muscle: the tendency to contract when it is stretched. Accordingly, when the arterial pressure rises and the renal afferent arteriole is stretched, the smooth muscle contracts. Because the increase in the resistance of the arteriole offsets the increase in pressure, *RBF* and therefore *GFR* remain constant (i.e., *RBF* is constant if  $\Delta P/R$  is kept constant [see equation 3-11]).


**FIGURE 3-7** ■ Tubuloglomerular feedback. An increase in the glomerular filtration rate (GFR) (1) increases sodium chloride (NaCl) concentration in tubule fluid in the loop of Henle (2), which is sensed by the macula densa and converted into a signal (3) that increases the resistance of the afferent arteriole ( $R_A$ ) (4), which decreases the GFR. JGA, Juxtaglomerular apparatus. (Modified from Cogan MG: Fluid and electrolytes: physiology and pathophysiology, Norwalk, CT, 1991, Appleton & Lange.)

The second mechanism responsible for the autoregulation of *GFR* and *RBF* is the  $\text{NaCl}$  concentration-dependent mechanism known as **tubuloglomerular feedback** (Figure 3-7). This mechanism involves a feedback loop in which the  $\text{NaCl}$  concentration of tubular fluid is sensed by the macula densa of the **juxtaglomerular apparatus** (JGA; see Figure 2-5 in

Chapter 2) and converted into a signal or signals that affect afferent arteriolar resistance and thus the *GFR*. When the *GFR* increases and causes the  $\text{NaCl}$  concentration of tubular fluid at the macula densa to rise, more  $\text{NaCl}$  enters macula densa cells. This process leads to an increase in the formation and release of adenosine triphosphate (ATP) and adenosine, a metabolite of ATP, by macula densa cells, which causes vasoconstriction of the afferent arteriole. Vasoconstriction of the afferent arteriole returns the *GFR* to normal levels. In contrast, when the *GFR* and  $\text{NaCl}$  concentration of tubule fluid decrease, less  $\text{NaCl}$  enters macula densa cells, and the production and release of ATP and adenosine decline. The decrease in ATP and adenosine causes vasodilation of the afferent arteriole, which returns the *GFR* to normal. Nitric oxide (NO), a vasodilator produced by the macula densa, attenuates tubuloglomerular feedback, whereas angiotensin II enhances tubuloglomerular feedback. Thus the macula densa may release both vasoconstrictors (e.g., ATP and adenosine) and a vasodilator (e.g., NO), which oppose each other's action at the level of the afferent arteriole. Production and release of

#### AT THE CELLULAR LEVEL

**Tubuloglomerular feedback** is absent in mice that do not express the adenosine receptor A1. This finding underscores the importance of adenosine signaling in tubuloglomerular feedback. Studies have shown that when *GFR* increases and causes  $\text{NaCl}$  concentration of tubular fluid at the macula densa to rise, more  $\text{NaCl}$  enters cells through the  $\text{Na}^+\text{-K}^+\text{-2Cl}^-$  cotransporter (NKCC2) located in the apical plasma membrane (see Chapter 4). Increased intracellular  $[\text{NaCl}]$  in turn stimulates the release of adenosine triphosphate (ATP) through ATP-conducting ion channels located in the basolateral membrane of macula densa cells. In addition, adenosine production is enhanced. Adenosine binds to A1 receptors and ATP binds to P2X receptors located on the plasma membrane of smooth muscle cells in the afferent arteriole. Both hormones increase intracellular  $[\text{Ca}^{++}]$ , which causes vasoconstriction of the afferent artery and therefore a decrease in *GFR*. Although adenosine is a vasodilator in most other vascular beds, it constricts the afferent arteriole in the kidney.

vasoconstrictors and vasodilators ensure exquisite control over tubuloglomerular feedback.

Figure 3-8 illustrates the role of the macula densa in controlling the secretion of renin by the granular cells of the afferent arteriole. This aspect of JGA function is considered in detail in Chapter 6.

Because animals engage in many activities that can change arterial blood pressure (e.g., changes in posture, mild to moderate exercise, and sleep), mechanisms that maintain RBF and GFR at relatively constant

levels despite changes in arterial pressure are highly desirable. If the GFR and RBF were to rise or fall suddenly in proportion to changes in blood pressure, urinary excretion of fluid and solute also would change suddenly. Such changes in water and solute excretion without comparable changes in intake would alter the fluid and electrolyte balance (the reason for which is discussed in Chapter 6). Accordingly, autoregulation of the GFR and RBF provides an effective means for uncoupling renal function from arterial pressure, and

it ensures that fluid and solute excretion remain constant when the extracellular fluid volume is normal (see Chapter 1).

Three points concerning autoregulation should be noted:

1. Autoregulation is absent when arterial pressure is less than 90 mm Hg.
2. Autoregulation is not perfect; RBF and GFR do change slightly as the arterial blood pressure varies.

3. Despite autoregulation, RBF and GFR can be changed by certain hormones and by changes in sympathetic nerve activity (Table 3-1).

## REGULATION OF RENAL BLOOD FLOW AND GLOMERULAR FILTRATION RATE

Several factors and hormones affect GFR and RBF (see Table 3-1). As discussed, the myogenic mechanism and tubuloglomerular feedback play key roles in

**IN THE CLINIC**

Persons with **renal artery stenosis** (narrowing of the artery lumen) caused by atherosclerosis, for example, can have an elevated systemic arterial blood pressure mediated by stimulation of the renin-angiotensin system (see Chapter 6). Pressure in the renal artery proximal to the stenosis is increased, but pressure distal to the stenosis is normal or reduced. Autoregulation is important in maintaining RBF, hydrostatic pressure in the glomerular capillary ( $P_{GC}$ ), and GFR in the presence of this stenosis. The administration of drugs to lower the systemic blood pressure also lowers the pressure distal to the stenosis; accordingly, the RBF,  $P_{GC}$ , and GFR decrease.

maintaining GFR and RBF at a constant level when the extracellular fluid volume is normal. In addition, sympathetic nerves and angiotensin II play major roles in regulating GFR and RBF. Although they are quantitatively less important than sympathetic nerves

and angiotensin II, prostaglandins, NO, endothelin, bradykinin, ATP, and adenosine also affect RBF and GFR. Figure 3-9 shows how changes in afferent and efferent arteriolar resistance, mediated by changes in the hormones listed in Table 3-1, modulate the GFR and RBF.

**Sympathetic Nerves**

The afferent and efferent arterioles are innervated by sympathetic neurons; however, sympathetic tone is minimal when the volume of extracellular fluid is normal (see Chapter 6). Sympathetic nerves release norepinephrine and dopamine, and circulating epinephrine (which is a catecholamine like norepinephrine and dopamine) is secreted by the adrenal medulla. Norepinephrine and epinephrine cause vasoconstriction by binding to  $\alpha_1$ -adrenoceptors, which are located mainly on the afferent arterioles. Activation of  $\alpha_1$ -adrenoceptors decreases GFR and RBF. Dehydration or strong emotional stimuli, such as fear and pain, activate sympathetic nerves and reduce GFR and RBF.

**Renalase**, a catecholamine-metabolizing hormone produced by kidneys, facilitates the degradation of catecholamines.


**Angiotensin II**

Angiotensin II is produced systemically and locally within the kidneys. It constricts the afferent and efferent arterioles\* and decreases the RBF and GFR. Figure 3-10 shows how norepinephrine, epinephrine, and angiotensin II act together to decrease the RBF and GFR and thereby increase blood pressure and extracellular fluid (ECF) volume, as would occur, for example, with hemorrhage.

**Prostaglandins**

Prostaglandins do not play a major role in regulating RBF in healthy, resting people. However, during


\*The efferent arteriole is more sensitive to angiotensin II than the afferent arteriole. Thus with low concentrations of angiotensin II, constriction of the efferent arteriole predominates, GFR increases, and RBF decreases. However, with high concentrations of angiotensin II, constriction of both afferent and efferent arterioles occurs and both GFR and RBF fall (see Figure 3-9).

pathophysiologic conditions such as hemorrhage, prostaglandins ( $PGI_2$ ,  $PGE_1$ , and  $PGE_2$ ) are produced locally within the kidneys, and they increase RBF without changing the GFR. Prostaglandins increase RBF by dampening the vasoconstrictor effects of sympathetic nerves and angiotensin II. This effect is important because it prevents severe and potentially harmful vasoconstriction and renal ischemia. Prostaglandin synthesis is stimulated by dehydration and stress (e.g., surgery and anesthesia), angiotensin II, and sympathetic nerves.

Nonsteroidal antiinflammatory drugs (NSAIDs), such as aspirin and ibuprofen, inhibit the synthesis of prostaglandins. Thus administration of these drugs during renal ischemia and hemorrhagic shock is contraindicated because, by blocking the production of prostaglandins, they decrease RBF and increase renal ischemia. Prostaglandins play an increasingly important role in maintaining RBF and GFR as people age. Accordingly, NSAIDs can significantly reduce RBF and GFR in the elderly.

### IN THE CLINIC

Hemorrhage decreases arterial blood pressure and therefore activates the sympathetic nerves to the kidneys by the baroreceptor reflex (Figure 3-10). Norepinephrine causes intense vasoconstriction of the afferent and efferent arterioles and thereby decreases *GFR* and *RBF*. The rise in sympathetic activity also increases the release of epinephrine and renin (renin in turn generates angiotensin II), which causes further vasoconstriction and a fall in *RBF*. The rise in the vascular resistance of the kidneys and other vascular beds increases the total peripheral resistance. The resulting tendency for blood pressure to increase ( $\text{Blood pressure} = \text{Cardiac output} \times \text{Total peripheral resistance}$ ) offsets the tendency of blood pressure to decrease in response to hemorrhage. Hence this system works to preserve the arterial pressure at the expense of maintaining a normal *GFR* and *RBF*.

### Nitric Oxide

NO, an endothelium-derived relaxing factor, is an important vasodilator under basal conditions, and it counteracts the vasoconstriction produced by angiotensin II and catecholamines. When blood flow increases, a greater shear force acts on the endothelial cells in the arterioles and increases the production of NO. In addition, a number of vasoactive hormones, including acetylcholine, histamine, bradykinin, and ATP, cause the release of NO from endothelial cells. Increased production of NO causes dilation of the afferent and efferent arterioles in the kidneys. Whereas increased levels of NO decrease the total peripheral resistance, inhibition of NO production increases the total peripheral resistance.

### Endothelin

Endothelin is a potent vasoconstrictor secreted by endothelial cells of the renal vessels, mesangial cells,

### IN THE CLINIC

Abnormal production of nitric oxide (NO) is observed in persons with **diabetes mellitus** and **hypertension**. Excess renal NO production in persons with diabetes may be responsible for glomerular hyperfiltration (i.e., increased GFR) and damage of the glomerulus, which are problems characteristic of this disease. Elevated NO levels increase the glomerular capillary hydrostatic pressure as a result of a decrease in the resistance of the afferent arteriole. The ensuing hyperfiltration is thought to cause glomerular damage. The normal response to an increase in dietary salt intake includes the stimulation of renal NO production, which prevents an increase in blood pressure. In some persons, however, NO production may not increase appropriately in response to an elevation in salt intake, and blood pressure rises.

and tubular epithelial cells in response to angiotensin II, bradykinin, epinephrine, and endothelial shear stress. Endothelin causes profound vasoconstriction of the afferent and efferent arterioles and decreases the GFR and RBF. Although this potent vasoconstrictor may not influence the GFR and RBF in resting subjects, endothelin production is elevated in a number of glomerular disease states (e.g., renal disease associated with diabetes mellitus).

### Bradykinin

Kallikrein is a proteolytic enzyme produced in the kidneys. Kallikrein cleaves circulating kininogen to bradykinin, which is a vasodilator that acts by stimulating the release of NO and prostaglandins. Bradykinin increases the GFR and RBF.

### Adenosine

Adenosine is produced within the kidneys and causes vasoconstriction of the afferent arteriole, thereby reducing the GFR and RBF. As previously mentioned, adenosine plays a role in tubuloglomerular feedback.

### Natriuretic Peptides

Secretion of atrial natriuretic peptide (ANP) by the cardiac atria and brain natriuretic peptide (BNP) from

the cardiac ventricle increases when the ECF volume is expanded. Both ANP and BNP dilate the afferent arteriole and constrict the efferent arteriole. Therefore ANP and BNP produce a modest increase in the GFR with little change in RBF.

### Adenosine Triphosphate

Cells release ATP into the renal interstitial fluid. ATP has dual effects on the GFR and RBF. Under some conditions, ATP constricts the afferent arteriole, reduces RBF and GFR, and may play a role in tubuloglomerular feedback. In contrast, ATP may stimulate NO production and increase the GFR and RBF.

### Glucocorticoids

Administration of therapeutic doses of glucocorticoids increases the GFR and RBF.


### Histamine

The local release of histamine modulates RBF in the resting state and during inflammation and injury. Histamine decreases the resistance of the afferent and efferent arterioles and thereby increases RBF without elevating the GFR.

### Dopamine

The vasodilator dopamine is produced by the proximal tubule. Dopamine has several actions within the kidney, such as increasing RBF and inhibiting renin secretion.

Finally, as illustrated in [Figure 3-11](#), vascular endothelial cells play an important role in regulating the resistance of the renal afferent and efferent arterioles by producing a number of paracrine hormones, including NO, prostacyclin (PGI<sub>2</sub>), endothelin, and angiotensin II. These hormones regulate contraction or relaxation of vascular smooth muscle cells in afferent and efferent arterioles and mesangial cells. Shear stress, acetylcholine, histamine, bradykinin, and ATP stimulate the production of NO, which increases the GFR and RBF. **Angiotensin-converting enzyme**, located on the surface of

endothelial cells lining the afferent arteriole and glomerular capillaries, converts angiotensin I to angiotensin II, which decreases the GFR and RBF. Angiotensin II also is produced locally in the granular cells in the afferent arteriole and proximal tubular cells. PGI<sub>2</sub> and PGE<sub>2</sub> secretion by endothelial cells, stimulated by sympathetic nerve activity and angiotensin II, increases the GFR and RBF. Finally, the release of endothelin from endothelial cells decreases the GFR and RBF.

#### IN THE CLINIC

Angiotensin-converting enzyme (ACE) degrades and thereby inactivates bradykinin. It also converts angiotensin I, an inactive hormone, to angiotensin II, an active hormone. Thus ACE increases angiotensin II levels and decreases bradykinin levels. Drugs called **ACE inhibitors** (e.g., enalapril and captopril), which reduce systemic blood pressure in patients with hypertension, decrease angiotensin II levels and elevate bradykinin levels. Both effects lower systemic vascular resistance, reduce blood pressure, and decrease renal vascular resistance, thereby increasing GFR and RBF. **Angiotensin II receptor antagonists** (e.g., losartan) also are used to treat high blood pressure. As their name suggests, they block the binding of angiotensin II to the angiotensin II receptor (AT1). These antagonists block the vasoconstrictor effects of angiotensin II on the afferent arteriole; thus they increase GFR and RBF. In contrast to ACE inhibitors, AT1 antagonists do not inhibit kinin metabolism (e.g., bradykinin).

## S U M M A R Y

1. Creatinine and inulin clearance can be used to measure the GFR.
2. Clinically, the GFR is evaluated by measuring plasma creatinine concentration.
3. Starling forces across the glomerular capillaries provide the driving force for the ultrafiltration of plasma from the glomerular capillaries into Bowman's space.
4. The glomerular ultrafiltrate is devoid of cellular elements, including red and white blood cells and platelets, and contains very little protein but otherwise is identical to plasma.
5. RBF (1.25 L/min) is about 25% of the cardiac output. RBF determines the GFR; modifies solute and water reabsorption by the proximal tubule; participates in the concentration and dilution of the urine; delivers oxygen, nutrients, and hormones to the cells of the nephron; returns carbon dioxide and reabsorbed fluid and solutes to the general circulation; and delivers substrates for excretion in the urine.
6. Autoregulation allows the GFR and RBF to remain constant despite fluctuations in arterial blood pressure between 90 and 180 mm Hg.
7. Hemorrhage activates renal sympathetic nerves and stimulates angiotensin II production and thereby reduces renal perfusion and urinary excretion of NaCl and water.
8. Sympathetic nerves and angiotensin II are the major hormones that regulate GFR and RBF; however, prostaglandins, NO, endothelin, natriuretic peptides, prostaglandins, bradykinin, and adenosine also affect GFR and RBF.

# 4

## RENAL TRANSPORT MECHANISMS: NaCl AND WATER REABSORPTION ALONG THE NEPHRON

### OBJECTIVES

# T

he formation of urine involves three basic processes: (1) **ultrafiltration** of plasma by the glomerulus, (2) **reabsorption** of water and solutes from the ultrafiltrate, and (3) **secretion** of select solutes into the tubular fluid. Although an average of 115 to 180 L of fluid for women and 130 to 200 L of fluid for men is filtered by the human glomeruli each day,\* less than 1% of

the filtered water and sodium chloride (NaCl) and variable amounts of other solutes are excreted in the urine (Table 4-1). By the processes of reabsorption and secretion, the renal tubules regulate the volume and composition of urine (Table 4-2). Consequently, the tubules precisely control the volume, osmolality, composition, and pH of the intracellular and extracellular fluid compartments. Transport proteins in cell membranes of the nephron mediate the reabsorption and secretion of solutes and water in the kidneys. Approximately 5% to 10% of all human genes code for transport proteins, and genetic and acquired defects in transport proteins are

\*The normal glomerular filtration rate averages 115 to 180 L/day in women and 130 to 200 L/day in men. Thus the volume of the ultrafiltrate represents a volume that is approximately 10 times the extracellular fluid volume. For simplicity, this book assumes that glomerular filtration rate is 180 L/day.

the cause of many kidney diseases (Table 4-3). In addition, numerous transport proteins are important drug targets. This chapter discusses NaCl and water reabsorption, organic anion and cation transport, the transport proteins involved in solute and water transport, and some of the factors and hormones that regulate NaCl transport. Details on acid-base transport and on K<sup>+</sup>, Ca<sup>++</sup>, and inorganic phosphate (P<sub>i</sub>) transport and their regulation are provided in Chapters 7 to 9.

## GENERAL PRINCIPLES OF MEMBRANE TRANSPORT

Solutes may be transported across cell membranes by passive mechanisms, active transport mechanisms, or endocytosis. In mammals, solute movement occurs by both passive and active mechanisms, whereas all water movement is passive. The movement of a solute across a membrane is passive if it develops spontaneously and does not require direct expenditure of metabolic energy. **Passive transport** (diffusion) of uncharged solutes occurs from an area of higher concentration to one of lower concentration (i.e., down its chemical concentration gradient). In addition to concentration gradients, the passive diffusion of ions (but not uncharged solutes, such as glucose and urea) is affected by the electrical potential difference (i.e., electrical gradient) across cell membranes and the renal tubules. Cations (e.g., Na<sup>+</sup> and K<sup>+</sup>) move to the negative side of

the membrane, whereas anions (e.g.,  $\text{Cl}^-$  and bicarbonate [ $\text{HCO}_3^-$ ]) move to the positive side of the membrane. Diffusion of water (**osmosis**) occurs through aquaporin (AQP) water channels in the cell membrane and is driven by osmotic pressure gradients. When water is reabsorbed across tubule segments, the solutes dissolved in the water also are carried along with the water. This process is called **solvent drag** and can account for a substantial amount of solute reabsorption across the proximal tubule. Traditionally, it was thought that the biologically important gases  $\text{O}_2$ , carbon dioxide ( $\text{CO}_2$ ), and ammonia ( $\text{NH}_3$ ) diffused across the lipid bilayer of plasma membranes. It is now known that these gases also move across the membrane via specific membrane transport proteins (e.g.,  $\text{CO}_2$  and  $\text{NH}_3$  have been shown to cross the membrane via the AQP1 water channel).

In **facilitated diffusion**, transport depends on the interaction of the solute with a specific protein in the membrane that facilitates its movement across the membrane. If defined broadly, the term “facilitated diffusion” can be used to describe several different types of membrane transporters. For example, one form of facilitated diffusion is the diffusion of ions, such as  $\text{Na}^+$  and  $\text{K}^+$ , through aqueous-filled channels created by proteins that span the plasma membrane. Also, the movement of a single molecule across the membrane by a transport protein (**uniport**), such as occurs with urea and glucose, is a form of facilitated diffusion.\*

Another form of facilitated diffusion is coupled transport, in which the movement of two or more solutes across a membrane depends on their interaction with a specific transport protein. Coupled transport of two or more solutes in the same direction is mediated by a **symport** mechanism. Examples of symport mechanisms in the kidneys include  $\text{Na}^+$ -glucose,  $\text{Na}^+$ -amino acid, and  $\text{Na}^+$ - $\text{P}_i$  symporters in the proximal tubule and the  $\text{Na}^+$ - $\text{K}^+$ - $2\text{Cl}^-$  symporter in the thick ascending limb of Henle's loop. Coupled transport of two or more solutes in opposite directions is mediated by an **antiport** mechanism. An  $\text{Na}^+$ - $\text{H}^+$  antiporter in the proximal tubule mediates  $\text{Na}^+$  reabsorption and  $\text{H}^+$  secretion. With coupled transporters, at least one of the solutes

usually is transported against its electrochemical gradient. The energy for this uphill movement is derived from the passive downhill movement of at least one of the other solutes into the cell. For example, in the proximal tubule, operation of the  $\text{Na}^+$ - $\text{H}^+$  antiporter in the apical membrane of the cell results in the movement of  $\text{H}^+$  against its electrochemical gradient out of the cell into the tubular lumen. The movement of  $\text{Na}^+$  from the tubular lumen into the cell, down its electrochemical gradient, drives the uphill movement of  $\text{H}^+$ . The uphill movement of  $\text{H}^+$  is termed **secondary active transport** to reflect the fact that the movement of  $\text{H}^+$  is not directly coupled to the hydrolysis of adenosine triphosphate (ATP) (see below). Instead, the energy is derived from the gradient of the other coupled ion (in this example,  $\text{Na}^+$ ).

Transport is **active** if it is coupled directly to energy derived from metabolic processes (i.e., it consumes ATP). Active transport of solutes usually takes place from an area of lower concentration to an area of higher concentration. In the kidneys, the most prevalent active transport mechanism is sodium-potassium adenosine triphosphatase ( $\text{Na}^+$ - $\text{K}^+$ -ATPase) (or the sodium pump), which is located in the basolateral membrane. The  $\text{Na}^+$ - $\text{K}^+$ -ATPase mechanism is made up of several proteins that together actively move  $\text{Na}^+$  out of the cell and  $\text{K}^+$  into the cell. Other active transport mechanisms in the kidneys include the  $\text{H}^+$ -ATPase and  $\text{H}^+$ - $\text{K}^+$ -ATPase mechanisms, which are responsible for  $\text{H}^+$  secretion in the collecting duct (see Chapter 8), and the  $\text{Ca}^{++}$ -ATPase mechanism, which is responsible for  $\text{Ca}^{++}$  movement from the cell cytoplasm into the blood (see Chapter 9). In addition to these transport ATPases, another large group of ATP-dependent transporters exists that is called **ATP-binding cassette**, or **ABC transporters**. To date, seven groups and more than 40 specific ABC transporters have been identified in humans. They transport a diverse group of solutes, including  $\text{Cl}^-$ , cholesterol, bile acids, drugs, iron, and organic anions and cations.

**Endocytosis** is the movement of a substance across the plasma membrane by a process involving the invagination of a piece of membrane until it completely pinches off and forms a vesicle in the cytoplasm. This mechanism is important for the reabsorption of small proteins and macromolecules by the proximal tubule. Because endocytosis requires ATP, it is a form of active transport.


\*Some authors restrict the term *facilitated diffusion* to this type of transport and use as the classic example the glucose uniporter that brings glucose into many cells (e.g., skeletal muscle).

## GENERAL PRINCIPLES OF TRANSEPIHELIAL SOLUTE AND WATER TRANSPORT

As illustrated in Figure 4-1, tight junctions hold renal cells together. Below the tight junctions, the cells are separated by **lateral intercellular spaces**. The tight junctions separate the apical membranes from the basolateral membranes. An epithelium can be compared with a six-pack of soda, in which the cans are the cells and the plastic holder represents the tight junctions.

In the nephron, a substance can be reabsorbed or secreted through cells, the so-called **transcellular pathway**, or between cells, the so-called **paracellular pathway**

(see Figure 4-1).  $\text{Na}^+$  reabsorption by the proximal tubule is a good example of transport by the transcellular pathway.  $\text{Na}^+$  reabsorption in this nephron segment depends on the operation of the  $\text{Na}^+\text{-K}^+\text{-ATPase}$  pump (see Figure 4-1). The  $\text{Na}^+\text{-K}^+\text{-ATPase}$  pump, which is located exclusively in the basolateral membrane, moves  $\text{Na}^+$  out of the cell into the blood and  $\text{K}^+$  into the cell. Thus the operation of the  $\text{Na}^+\text{-K}^+\text{-ATPase}$  pump lowers intracellular  $[\text{Na}^+]$  and increases intracellular  $[\text{K}^+]$ . Because intracellular  $[\text{Na}^+]$  is low (12 mEq/L) and the  $[\text{Na}^+]$  in tubular fluid is high (140 mEq/L),  $\text{Na}^+$  moves across the apical cell membrane, down a chemical concentration gradient from the tubular lumen into the cell. Because the interior of

the cell is electrically negative with respect to the tubular lumen, and depending on the  $\text{Na}^+$  transporter, the energy in this electrical gradient also can drive  $\text{Na}^+$  into the cell across the apical membrane. The  $\text{Na}^+$ - $\text{K}^+$ -ATPase pump senses the addition of  $\text{Na}^+$  to the cell and is stimulated to increase its rate of  $\text{Na}^+$  extrusion into the blood, thereby returning intracellular  $\text{Na}^+$  to normal levels. Thus transcellular  $\text{Na}^+$  reabsorption by the proximal tubule is a two-step process:

1. Movement across the apical membrane into the cell, down a chemical concentration gradient and/or an electrochemical gradient established by the  $\text{Na}^+$ - $\text{K}^+$ -ATPase pump
2. Movement across the basolateral membrane against an electrochemical gradient through the  $\text{Na}^+$ - $\text{K}^+$ -ATPase pump

The reabsorption of  $\text{Ca}^{++}$  and  $\text{K}^+$  across the proximal tubule is a good example of paracellular transport. Some of the water reabsorbed across the proximal tubule traverses the paracellular pathway. Some solutes dissolved in this water, particularly  $\text{Ca}^{++}$  and  $\text{K}^+$ , are entrained in the reabsorbed fluid and thereby reabsorbed by the process of solvent drag.

#### AT THE CELLULAR LEVEL

The tight junction in renal epithelial cells is a specialized membrane domain that creates a barrier that regulates the paracellular diffusion of solutes across the epithelia. Tight junctions are composed of linear arrays of several integral membrane proteins, including occludins, claudins, and several members of the immunoglobulin superfamily. The tight junction complex of proteins has biophysical properties of ion channels, including the ability to allow ions to diffuse selectively across the complex based on size and charge.

## NaCl, SOLUTE, AND WATER REABSORPTION ALONG THE NEPHRON

Quantitatively, the reabsorption of NaCl and water represents the major function of nephrons. Approximately 25,000 mEq/day of  $\text{Na}^+$  and 179 L/day of water are reabsorbed by the renal tubules (see Table 4-1). In addition, renal transport of many other important solutes is

linked either directly or indirectly to  $\text{Na}^+$  reabsorption. In the following sections the NaCl and water transport processes of each nephron segment and its regulation by hormones, along with other factors, are presented.


### Proximal Tubule

The proximal tubule reabsorbs approximately 67% of filtered water,  $\text{Na}^+$ ,  $\text{Cl}^-$ ,  $\text{K}^+$ , and other solutes. In addition, the proximal tubule reabsorbs virtually all the glucose and amino acids filtered by the glomerulus. The key element in proximal tubule reabsorption is the  $\text{Na}^+$ - $\text{K}^+$ -ATPase pump in the basolateral membrane. The reabsorption of every substance, including water, is linked in some manner to the operation of the  $\text{Na}^+$ - $\text{K}^+$ -ATPase pump.

### Na<sup>+</sup> Reabsorption

$\text{Na}^+$  is reabsorbed by different mechanisms in the first and the second halves of the proximal tubule. In the first half of the proximal tubule,  $\text{Na}^+$  is reabsorbed primarily with  $\text{HCO}_3^-$  and a number of other solutes (e.g., glucose, amino acids,  $\text{P}_i$ , and lactate). In contrast, in the second half,  $\text{Na}^+$  is reabsorbed mainly with  $\text{Cl}^-$ . This disparity is mediated by differences in the  $\text{Na}^+$  transport systems in the first and second halves of the proximal tubule and by differences in the composition of tubular fluid at these sites.

In the first half of the proximal tubule,  $\text{Na}^+$  uptake into the cell is coupled with either  $\text{H}^+$  or organic solutes (Figure 4-2). Specific transport proteins mediate  $\text{Na}^+$  entry into the cell across the apical membrane. For example, the  $\text{Na}^+$ - $\text{H}^+$  antiporter (see Figure 4-2, A) couples  $\text{Na}^+$  entry with  $\text{H}^+$  extrusion from the cell.  $\text{H}^+$  secretion results in sodium bicarbonate ( $\text{NaHCO}_3^-$ ) reabsorption (see Chapter 8).  $\text{Na}^+$  also enters proximal tubule cells by several symporter mechanisms, including  $\text{Na}^+$ -glucose,  $\text{Na}^+$ -amino acid,  $\text{Na}^+$ - $\text{P}_i$ , and  $\text{Na}^+$ -lactate (see Figure 4-2, B). The glucose and other organic solutes that enter the cell with  $\text{Na}^+$  leave the cell across the basolateral membrane by passive transport mechanisms. Any  $\text{Na}^+$  that enters the cell across the apical membrane leaves the cell and enters the blood by the  $\text{Na}^+$ - $\text{K}^+$ -ATPase mechanism. In brief, the reabsorption of  $\text{Na}^+$  in the first half of the proximal tubule is coupled to that of  $\text{HCO}_3^-$ ,  $\text{P}_i$ , and a number of organic molecules, and this process generates a negative transepithelial

voltage across the proximal tubule that provides the driving force for the paracellular reabsorption of  $\text{Cl}^-$ . The reabsorption of many organic molecules is so avid that they are almost completely removed from the tubular fluid in the first half of the proximal tubule (Figure 4-3). The reabsorption of  $\text{NaHCO}_3$ ,  $\text{Na}^+$ - $\text{P}_i$ , and  $\text{Na}^+$ -organic solutes across the proximal tubule establishes a transtubular osmotic gradient (i.e., the osmolality of the interstitial fluid bathing the basolateral side of the cells is slightly higher than the osmolality of tubule fluid) that provides the driving force for the passive reabsorption of water by osmosis. Because more water than  $\text{Cl}^-$  is reabsorbed in the first half of the proximal tubule, the  $\text{Cl}^-$  concentration in tubular fluid rises along the length of the proximal tubule (see Figure 4-3).


In the second half of the proximal tubule,  $\text{Na}^+$  is mainly reabsorbed with  $\text{Cl}^-$  across the transcellular pathway (Figure 4-4).  $\text{Na}^+$  is primarily reabsorbed with  $\text{Cl}^-$  rather than organic solutes or  $\text{HCO}_3^-$  as the accompanying anion because the  $\text{Na}^+$  transport mechanisms in the second half of the proximal tubule differ from those in the first half. Furthermore, the tubular fluid that enters the second half contains very little glucose and amino acids, but the high concentration of  $\text{Cl}^-$  (140 mEq/L) in tubule fluid exceeds that in the first half (105 mEq/L). The high  $\text{Cl}^-$  concentration is due to


the preferential reabsorption of  $\text{Na}^+$  with  $\text{HCO}_3^-$  and organic solutes in the first half of the proximal tubule.

The mechanism of transcellular  $\text{Na}^+$  reabsorption in the second half of the proximal tubule is shown in Figure 4-4.  $\text{Na}^+$  enters the cell across the luminal membrane primarily through the parallel operation of a  $\text{Na}^+$ - $\text{H}^+$  antiporter and one or more  $\text{Cl}^-$ -base antiporters. Because the secreted  $\text{H}^+$  and base combine in the tubular fluid and reenter the cell, the operation of the  $\text{Na}^+$ - $\text{H}^+$  and  $\text{Cl}^-$ -base antiporters is equivalent to  $\text{NaCl}$  uptake from tubular fluid into the cell.  $\text{Na}^+$  leaves the cell through the  $\text{Na}^+$ - $\text{K}^+$ -ATPase mechanism, and  $\text{Cl}^-$  leaves the cell and enters the blood through a  $\text{K}^+$ - $\text{Cl}^-$  symporter and a  $\text{Cl}^-$  channel in the basolateral membrane.

Some  $\text{NaCl}$  also is reabsorbed across the second half of the proximal tubule by a **paracellular route**. Paracellular  $\text{NaCl}$  reabsorption occurs because the rise in the  $\text{Cl}^-$  concentration in the tubule fluid in the first half of the proximal tubule creates a  $\text{Cl}^-$  concentration gradient (140 mEq/L in the tubule lumen and 105 mEq/L in the interstitium). This concentration gradient favors the diffusion of  $\text{Cl}^-$  from the tubular lumen across the tight junctions into the lateral intercellular space. Movement of the negatively charged  $\text{Cl}^-$  causes the tubular fluid to become positively charged relative

to the blood. This positive transepithelial voltage causes the diffusion of positively charged Na<sup>+</sup> out of the tubular fluid across the tight junction into the blood. Thus in the second half of the proximal tubule, some Na<sup>+</sup> and Cl<sup>-</sup> are reabsorbed across the tight junctions (the paracellular pathway) by passive diffusion. The reabsorption of NaCl establishes a transtubular osmotic gradient that provides the driving force for the passive reabsorption of water by osmosis.

In summary, the reabsorption of Na<sup>+</sup> and Cl<sup>-</sup> in the proximal tubule occurs across paracellular and transcellular pathways. Approximately 67% of the NaCl filtered each day is reabsorbed in the proximal tubule. Of this amount, two thirds moves across the transcellular pathway, and the remaining one third moves across the paracellular pathway (Table 4-4).

#### IN THE CLINIC

**Fanconi syndrome** is a renal disease that is either hereditary, as a result of an autosomal recessive mutation in *SLC2A2* (the gene that encodes *GLUT2*), or acquired. It often is associated with glucosuria, osteomalacia, acidosis, and hypokalemia. The syndrome results from an impaired ability of the proximal tubule to reabsorb HCO<sub>3</sub><sup>-</sup>, amino acids, glucose, and low-molecular-weight proteins. Because other segments of the nephron cannot reabsorb these solutes and protein, Fanconi syndrome results in increased urinary excretion of HCO<sub>3</sub><sup>-</sup>, amino acids, glucose, inorganic phosphate, and low-molecular-weight proteins.

### Water Reabsorption

The proximal tubule reabsorbs 67% of the filtered water (Table 4-5). The driving force for water reabsorption is a transtubular osmotic gradient established by solute reabsorption (e.g., NaCl and Na<sup>+</sup>-glucose). The reabsorption of Na<sup>+</sup> along with organic solutes, HCO<sub>3</sub><sup>-</sup>, P<sub>i</sub>, and Cl<sup>-</sup> from the tubular fluid into the lateral intercellular spaces reduces the osmolality of the tubular fluid and increases the osmolality of the lateral intercellular space (Figure 4-5). Because the proximal tubule is highly permeable to water, primarily because of the expression of aquaporin water channels (AQP1) in the apical and basolateral membranes, water is reabsorbed across cells by osmosis. However, because the tight junctions in the proximal tubule also are permeable to water, some water is reabsorbed across the paracellular pathway between proximal tubular cells. The accumulation of fluid and solutes within the lateral intercellular space increases the hydrostatic pressure in this compartment. This increased hydrostatic pressure forces fluid and solutes into the capillaries.\* Thus water reabsorption follows solute reabsorption in the proximal tubule. The reabsorbed fluid is slightly hyperosmotic to plasma. However, this difference in osmolality is so small that it is commonly said that proximal tubule reabsorption is isosmotic (i.e., ~67% of the both the filtered solute and water are reabsorbed). Indeed, little difference is seen in the


osmolality of tubular fluid at the start and end of the proximal tubule. An important consequence of osmotic water flow across the proximal tubule is that some solutes, especially K<sup>+</sup> and Ca<sup>++</sup>, are entrained in the reabsorbed fluid and thereby are reabsorbed by the process of solvent drag (see Figure 4-5). The reabsorption of virtually all organic solutes, HCO<sub>3</sub><sup>-</sup>, Cl<sup>-</sup>, P<sub>i</sub>, and other ions, and water is coupled to Na<sup>+</sup> reabsorption. **Therefore changes in Na<sup>+</sup> reabsorption influence the reabsorption of water and other solutes by the proximal tubule.** This point will be discussed later, notably in Chapter 6, and is especially relevant during volume depletion when increased Na<sup>+</sup> reabsorption by the proximal tubule is accompanied by a parallel increase in HCO<sub>3</sub><sup>-</sup> reabsorption, which can lead to metabolic alkalosis (i.e., volume contraction alkalosis).

### Protein Reabsorption

Proteins filtered across the glomerulus are reabsorbed in the proximal tubule. As mentioned previously, peptide hormones, small proteins, and small amounts of large proteins such as albumin are filtered by the glomerulus. Overall, only a small percentage of proteins cross the glomerulus and enter Bowman's space (i.e., the concentration of proteins in the glomerular ultrafiltrate is ~40 mg/L). However, the amount of protein filtered per day is significant because the glomerular filtration rate (GFR) is so high:

$$\begin{aligned}
 \text{Filtered protein} &= \text{GFR} \times [\text{Protein}] \text{ in the ultrafiltrate} \\
 \text{Filtered protein} &= 180 \text{ L/day} \times 40 \text{ mg/L} && (4-1) \\
 &= 7200 \text{ mg/day, or } 7.2 \text{ g/day}
 \end{aligned}$$

\*In addition, the protein oncotic pressure in the peritubular capillaries is elevated because of the process of glomerular filtration (see Chapter 3). This elevated pressure also facilitates fluid and solute uptake into the capillary.

### AT THE CELLULAR LEVEL

Water channels called **aquaporins** (AQPs) mediate the transcellular reabsorption of water across many nephron segments. In 2003, Dr. Peter Agre received the Nobel Prize in Chemistry for his discovery that AQPs regulate and facilitate water transport across cell membranes, a process essential to all living organisms. To date, 14 aquaporins have been identified. The AQP family is divided into two groups on the basis of their permeability characteristics. One group (AQPs) is permeable to water (AQP0, AQP1, AQP2, AQP4, AQP5, AQP6, AQP8, AQP11, and AQP12). The other group (aquaglyceroporins) is permeable to water and small solutes, especially glycerol (AQP3, AQP5, AQP7, AQP9, and AQP10). AQPs form tetramers in the plasma membrane of cells, with each subunit forming a water channel. In the kidneys, AQP1 is expressed in the apical and basolateral membranes of the proximal tubule and portions of the descending thin limb of the loop of Henle (see Chapter 5). The importance of AQP1 in

renal water reabsorption is underscored by studies in which the *AQP1* gene was “knocked out” in mice. These mice have increased urine output (polyuria) and a reduced ability to concentrate the urine. In addition, the osmotic water permeability of the proximal tubule is fivefold less in mice lacking AQP1 than in normal mice. AQP7 and AQP8 also are expressed in the proximal tubule. AQP2 is expressed in the apical plasma membrane of principal cells in the collecting duct, and its expression in the membrane is regulated by AVP. AQP3 and AQP4 are expressed in the basolateral membrane of principal cells in the collecting duct. Mice deficient in AQP3 or AQP4 (i.e., knockout mice) have defects in the ability to concentrate urine. AQPs also are expressed in many other organs in the body, including the lung, eye, skin, secretory glands, and brain, where they play key physiological roles. For example, AQP4 is expressed in cells that form the blood-brain barrier. Knockout of AQP4 in mice affects the water permeability of the blood-brain barrier such that brain edema is reduced after acute water loading and hyponatremia.

### AT THE CELLULAR LEVEL

The endocytosis of protein by the proximal tubule is mediated by apical membrane receptors that specifically bind luminal proteins and peptides. These receptors, called **multiligand endocytic receptors**, can bind a wide range of peptides and proteins and thereby mediate their endocytosis. **Megalin** and **cubilin** mediate protein and peptide endocytosis in the proximal tubule. Both are glycoproteins, with megalin being a member of the low-density lipoprotein receptor gene family.

Filtered proteins are either endocytosed intact or are endocytosed after being partially degraded by enzymes on the surface of the proximal tubule cells. Once the proteins and peptides are inside the cell, enzymes digest them into their constituent amino acids, which then leave the cell across the basolateral membrane by transport proteins and are returned to the blood. Normally this mechanism reabsorbs virtually all of the proteins filtered, and hence the urine is essentially protein free. However, because the mechanism is easily saturated, an increase in filtered proteins causes **proteinuria** (i.e., appearance of protein in the urine). Disruption of the glomerular filtration barrier to proteins increases the filtration of proteins and results in proteinuria, which is frequently found in persons with kidney disease.

### *Organic Anion and Organic Cation Secretion*

Cells of the proximal tubule also secrete organic anions and organic cations into the tubule fluid. Secretion of organic anions and cations by the proximal tubule plays a key role in regulating the plasma levels of xenobiotics (e.g., a variety of antibiotics, diuretics, statins, antivirals, antineoplastics, immunosuppressants, neurotransmitters, and nonsteroidal antiinflammatory agents) and toxic compounds derived from endogenous and exogenous sources. Many of the organic anions and cations (see [Boxes 4-1](#) and [4-2](#)) secreted by the proximal tubule are end products of metabolism that circulate in the plasma. Many of these organic compounds are bound to plasma proteins and are not readily filtered. Therefore only a small portion of these potentially toxic substances are eliminated from the body by excretion resulting from filtration alone. Such

### IN THE CLINIC

Urinalysis is an important and routine tool in disease detection. A thorough analysis of the urine includes macroscopic and microscopic assessments. These assessments are performed by visual assessment of the urine, microscopic examination, and chemical evaluation, which is conducted with use of dipstick reagents strips. The dipstick test is inexpensive and fast (i.e., it can be performed in less than 5 minutes). Dipstick reagent strips test the urine for the presence of many substances, including bilirubin, blood, glucose, ketones, pH, and protein. It is normal to find trace amounts of protein in the urine. Trace amounts of protein in the urine can be derived from two sources: (1) filtration and incomplete reabsorption by the proximal tubule and (2) synthesis by the thick ascending limb of the loop of Henle. Cells in the thick ascending limb produce **Tamm-Horsfall glycoprotein** and secrete it into the tubular fluid. Because the mechanism for protein reabsorption is “upstream” of the thick ascending limb (i.e., proximal tubule), the secreted Tamm-Horsfall glycoprotein appears in the urine. However, more than trace amounts of protein in the urine is indicative of renal disease.

substances also are secreted from the peritubular capillary into the tubular fluid. These secretory mechanisms are very powerful and can remove virtually all organic anions and cations from the plasma that enters the kidneys. Hence these substances are removed from the plasma by both filtration and secretion. Thus it is important to note that when kidney function is reduced by disease, the urinary excretion of organic anions and cations is severely reduced, which can lead to increased plasma levels of xenobiotics and metabolites.

[Figure 4-6](#) illustrates the mechanisms of organic anion ( $\text{OA}^-$ ) transport across the proximal tubule. These secretory pathways have a maximum transport rate and a low specificity (i.e., they transport many organic anions) and are responsible for the secretion of all organic anions listed in [Box 4-1](#).  $\text{OA}^-$ s are taken up into the cell, across the basolateral membrane, and against their chemical gradient in exchange for  $\alpha$ -ketoglutarate ( $\alpha$ -KG) by several  $\text{OA}^-$ - $\alpha$ -KG antiport mechanisms, including OAT1, OAT2, and OAT3.




**FIGURE 4-6** ■ Organic anion ( $OA^-$ ) secretion across the proximal tubule.  $OA^-$ s enter the cell across the basolateral membrane by one of three  $OA^-$ - $\alpha$ -ketoglutarate ( $\alpha$ -KG) antiport mechanisms (organic anion transporter, OAT1, OAT2, OAT3). The uptake of  $\alpha$ -KG into the cell, against its chemical concentration gradient, is driven by the movement of  $Na^+$  into the cell by the  $Na^+$ -dicarboxylate transporter (*NaDC3*). The  $[Na^+]$  inside the cell is low because of the  $Na^+$ - $K^+$ -adenosine triphosphatase pump in the basolateral membrane, which transports  $Na^+$  out the cell in exchange for  $K^+$ . The  $\alpha$ -KG recycles across the basolateral membrane on the OATs in exchange for  $OA^-$ .  $OA^-$ s leave the cell across the apical membrane by multidrug resistance proteins (*MRP2/4*) and breast cancer resistance protein (*BCRP*), which require adenosine triphosphate (*ATP*). OAT4 in the apical membrane also transports  $OA^-$ . OAT4 can reabsorb urate into the cell in exchange for  $\alpha$ -KG, or secrete a number of drugs into the tubule lumen in exchange for  $\alpha$ -KG. *ADP*, adenosine diphosphate.

$\alpha$ -KG accumulates inside the cells by metabolism of glutamate and by an Na<sup>+</sup>- $\alpha$ -KG symporter (i.e., the Na<sup>+</sup>-dicarboxylate transporter [NaDC3]) also present in the basolateral membrane. Thus OA<sup>-</sup> uptake into the cell against an electrochemical gradient is coupled to the exit of  $\alpha$ -KG out of the cell, down its chemical gradient generated by the Na<sup>+</sup>- $\alpha$ -KG antiport mechanism. The exit of OA<sup>-</sup> across the luminal membrane into the tubular fluid is mediated by the multidrug resistance proteins 2 and 4 (MRP2/4) and breast cancer resistance protein 1 (BCRP), which require ATP for their operation (i.e., they are ABC transporters). Recent studies reveal that OAT4 mediates the reabsorption of urate, the end product of purine catabolism, and the secretion of several drugs (see Figure 4-6).

**IN THE CLINIC**

Because many organic anions compete for the same secretory pathways, elevated plasma levels of one anion often inhibit the secretion of the others. For example, infusing para-amino hippurate (PAH) can reduce penicillin secretion by the proximal tubule. Because the kidneys are responsible for eliminating penicillin, the infusion of PAH into persons who receive penicillin reduces penicillin excretion and thereby extends the biologic half-life of the drug. In World War II, when penicillin was in short supply, hippurates were given with the penicillin to extend the drug's therapeutic effect. Similar competition for secretion by the proximal tubule occurs for organic cations. For example, elevated plasma levels of one cation often inhibit the secretion of the others. The H<sub>2</sub> antagonist cimetidine is used to treat gastric ulcers, and organic cation transport mechanisms in the proximal tubule secrete cimetidine. When cimetidine is given to patients who also receive procainamide (a drug used to treat cardiac arrhythmias), cimetidine reduces the urinary excretion of procainamide (also an organic cation) by competing with this antiarrhythmic drug for the secretory pathway. Thus the coadministration of organic cations can increase the plasma concentrations of both drugs to levels much higher than those seen when the drugs are given alone. This effect can lead to drug toxicity.


**FIGURE 4-7** ■ Organic cation (OC<sup>+</sup>) secretion across the proximal tubule. OC<sup>+</sup>s enter the cell across the basolateral membrane primarily by OCT2. The uptake of OC<sup>+</sup>s into the cell, against their chemical concentration gradient, is driven by the cell-negative potential difference. OC<sup>+</sup>s leave the cell across the apical membrane in exchange with H<sup>+</sup> by electrically neutral multidrug and toxin extrusion transporters (*MATE1* and *MATE2-K*), by multidrug resistance protein (*MDR1*) and, possibly, by two OC<sup>+</sup>-H<sup>+</sup> antiporters (*OCTN1/2*, not shown). *ADP*, Adenosine diphosphate; *ATP*, adenosine triphosphate.

Figure 4-7 illustrates the mechanism of organic cation ( $OC^+$ ) transport across the proximal tubule.  $OC^+$ s, including xenobiotics such as the antidiabetic agent metformin, the antiviral agent lamivudine, and the anticancer drug oxilipatin, along with many important monoamine neurotransmitters, including dopamine, epinephrine, histamine, and norepinephrine, are secreted by the proximal tubule.  $OC^+$ s are taken up into the cell, across the basolateral membrane, primarily by the  $OC^+$  transporter 2 (*OCT2*). Uptake of organic cations is driven by the magnitude of the cell-negative potential difference across the basolateral membrane. Organic cation transport across the luminal membrane into the tubular fluid, which is the rate-limiting step in secretion, is mediated primarily by the electrically neutral multidrug and toxin extrusion transporters (*MATEs*) and the ABC transporter *MDR1* (also known as *P-glycoprotein*). These transport mechanisms mediating  $OC^+$  secretion are nonspecific; several  $OC^+$ s usually compete for each transport pathway.

### Henle's Loop

Henle's loop reabsorbs approximately 25% of the filtered  $NaCl$  and 15% of the filtered water. The reabsorption of  $NaCl$  in the loop of Henle occurs in both the thin ascending and thick ascending limbs. The descending thin limb does not reabsorb  $NaCl$ . Water reabsorption occurs exclusively in some portions of the descending thin limb through *AQP1* water channels (see Chapter 5). The ascending limb is impermeable to water. In addition,  $Ca^{++}$  and  $HCO_3^-$  are reabsorbed in the loop of Henle (see Chapters 8 and 9 for more details).

The thin ascending limb reabsorbs  $NaCl$  by a passive mechanism. The reabsorption of water but not  $NaCl$  in the descending thin limb increases the  $[NaCl]$  in tubule fluid entering the ascending thin limb. As the  $NaCl$ -rich fluid moves toward the cortex,  $NaCl$  diffuses out of tubule fluid across the ascending thin limb into the medullary interstitial fluid, down a concentration gradient directed from tubule fluid to interstitium.


**FIGURE 4-8** ■ Transport mechanisms for sodium chloride reabsorption in the thick ascending limb of the loop of Henle. The positive voltage in the lumen plays a major role in driving the passive paracellular reabsorption of cations. Because the apical membrane is conductive primarily to  $K^+$ , the apical membrane voltage is more negative than the basolateral membrane voltage, which is conductive to  $K^+$  and  $Cl^-$ , thereby resulting in a lumen-positive transepithelial potential. Mutations in the gene encoding the apical membrane  $K^+$  channel, the apical membrane  $Na^+K^+-2Cl^-$  symporter (*NKCC2*), or the basolateral  $Cl^-$  channel cause Bartter syndrome (see the clinical box on Bartter syndrome). *AE2*, anion exchanger 2; *ATP*, adenosine triphosphate; *CA*, carbonic anhydrase;  $CO_2$ , carbon dioxide;  $HCO_3^-$ , bicarbonate; *NHE3*,  $Na^+$ - $H^+$  antiporter 3.

The key element in solute reabsorption by the thick ascending limb is the Na<sup>+</sup>-K<sup>+</sup>-ATPase pump in the basolateral membrane (Figure 4-8). As with reabsorption in the proximal tubule, the reabsorption of every solute by the thick ascending limb is linked to Na<sup>+</sup>-K<sup>+</sup>-ATPase. This transporter maintains a low intracellular [Na<sup>+</sup>], which provides a favorable chemical gradient for the movement of Na<sup>+</sup> from the tubular fluid into the cell. The movement of Na<sup>+</sup> across the apical membrane into the cell is mediated by the Na<sup>+</sup>-K<sup>+</sup>-2Cl<sup>-</sup> symporter (NKCC2), which couples the movement of Na<sup>+</sup> with K<sup>+</sup> and 2Cl<sup>-</sup>. Using the potential energy released by the downhill movement of Na<sup>+</sup> and Cl<sup>-</sup>, this symporter drives the uphill movement of K<sup>+</sup> into the cell. The K<sup>+</sup> channel in the apical plasma membrane plays an important role in NaCl reabsorption by the thick ascending limb. This K<sup>+</sup> channel allows the K<sup>+</sup> transported into the cell by NKCC2 to recycle back into tubule fluid. Because the [K<sup>+</sup>] in tubule fluid is relatively low, K<sup>+</sup> recycling is required for the continued operation of NKCC2. An Na<sup>+</sup>-H<sup>+</sup> antiporter in the apical cell membrane also mediates Na<sup>+</sup> reabsorption as well as H<sup>+</sup> secretion (HCO<sub>3</sub><sup>-</sup> reabsorption) in the thick ascending limb (see Chapter 8). Na<sup>+</sup> leaves the cell across the basolateral membrane through the Na<sup>+</sup>-K<sup>+</sup>-ATPase pump, whereas K<sup>+</sup>, Cl<sup>-</sup>, and HCO<sub>3</sub><sup>-</sup> leave the cell across the basolateral membrane by separate pathways.

The voltage across the thick ascending limb is important for the reabsorption of several cations. The tubular fluid is positively charged relative to blood because of the unique location of transport proteins in the apical and basolateral membranes. Two points are important: (1) increased NaCl transport by the thick ascending limb increases the magnitude of the positive voltage in the lumen, and (2) this voltage is an important driving force for the reabsorption of several cations, including Na<sup>+</sup>, K<sup>+</sup>, Mg<sup>++</sup>, and Ca<sup>++</sup> across the paracellular pathway (see Figure 4-8). The importance of the paracellular pathway to solute reabsorption is underscored by the observation that inactivating mutations of the tight junction protein claudin-16 reduces Mg<sup>++</sup> and Ca<sup>++</sup> reabsorption by the ascending thick limb even when the lumen-positive transepithelial voltage is positive.

In summary, salt reabsorption across the thick ascending limb occurs by the transcellular and paracellular pathways. A total of 50% of NaCl reabsorption is transcellular, and 50% is paracellular. The thick ascending limb does not reabsorb **water** because it does not express water channels (i.e., AQP), and thus the reabsorption of NaCl and other solutes reduces the osmolality of tubular fluid to less than 150 mOsm/kg H<sub>2</sub>O. Thus because the thick ascending limb produces a fluid that is dilute relative to plasma, the ascending limb of the Henle loop is called the **diluting segment**.

### AT THE CELLULAR LEVEL

As previously described in this chapter and in Chapter 2, epithelial cells are joined at their apical surfaces by tight junctions (also known as **zonula occludens**). A number of proteins now have been identified as components of the tight junction. These proteins include those that span the membrane of one cell and link to the extracellular portion of the same molecule in the adjacent cell (e.g., occludins and claudins), as well as cytoplasmic linker proteins (e.g., ZO-1, ZO-2, and ZO-3) that link the membrane-spanning proteins to the cytoskeleton of the cell. Of these junctional proteins, claudins appear to be important in determining the permeability characteristics of the tight junction. Claudin-16 and

claudin-19 are critical for determining divalent cation permeability of the tight junctions in the thick ascending limb of the Henle loop. Mutations in human claudin-16 and claudin-19 cause familial hypomagnesemia with hypercalciuria and nephrolithiasis. Claudin-2 is permeable to water and may allow paracellular water reabsorption across the proximal tubule. In cultured kidney cells, claudin-4 has been shown to control the  $Na^+$  permeability of the tight junction, and claudin-15 determines whether a tight junction is permeable to cations or anions. Thus the permeability characteristics of the tight junctions in different nephron segments are determined, at least in part, by the specific claudins expressed by the cells in that segment.

### IN THE CLINIC

**Bartter syndrome** is a set of autosomal recessive genetic diseases characterized by hypokalemia, metabolic alkalosis, and hyperaldosteronism (see [Table 4-3](#)). Inactivating mutations in the gene coding for the Na<sup>+</sup>-K<sup>+</sup>-2Cl<sup>-</sup> symporter (*SLC12A1*), the apical K<sup>+</sup> channel (*KCNJ1*), or the basolateral Cl<sup>-</sup> channel (*CLCNKB*) decrease both sodium chloride (NaCl) and K<sup>+</sup> reabsorption by the ascending thick limb, which in turn causes hypokalemia (i.e., a low plasma [K<sup>+</sup>]) and a decrease in the extracellular fluid (ECF) volume. The decrease in ECF volume stimulates aldosterone secretion, which in turn stimulates NaCl reabsorption and H<sup>+</sup> secretion by the distal tubule and collecting duct (discussed later in this chapter).

### Distal Tubule and Collecting Duct

The distal tubule and collecting duct reabsorb approximately 8% of the filtered NaCl, secrete variable amounts of K<sup>+</sup> and H<sup>+</sup>, and reabsorb a variable amount of water (~8% to 17%). The initial segment of the distal tubule (the early distal tubule) reabsorbs Na<sup>+</sup>, Cl<sup>-</sup>, and Ca<sup>++</sup> and is impermeable to water ([Figure 4-9](#)). NaCl entry into the cell across the apical membrane is mediated by a Na<sup>+</sup>-Cl<sup>-</sup> symporter (NCC). Na<sup>+</sup> leaves the cell through the action of Na<sup>+</sup>-K<sup>+</sup>-ATPase, and

### AT THE CELLULAR LEVEL

**Gitelman syndrome** is an autosomal recessive disorder characterized by metabolic alkalosis, hypokalemia, and hypocalciuria (hypomagnesemia also is seen often). It results from an inactivating mutation of the Na<sup>+</sup>-Cl<sup>-</sup> symporter gene (*SLC12A3*) that is expressed in the early portion of the distal tubule. The fluid and electrolyte disturbances seen in patients with Gitelman syndrome can be mimicked by administration of thiazide diuretics, which act by inhibiting the sodium chloride transporter.

Cl<sup>-</sup> leaves the cell by diffusion through Cl<sup>-</sup> channels. NaCl reabsorption is reduced by thiazide diuretics, which inhibit NCC. Thus dilution of the tubular fluid begins in the thick ascending limb and continues in the early segment of the distal tubule.

The last segment of the distal tubule (late distal tubule) and the collecting duct are composed of two cell types: **principal cells** and **intercalated cells**. As illustrated in [Figure 4-10, A](#), principal cells reabsorb Na<sup>+</sup> and water and secrete K<sup>+</sup>. The α-intercalated cell secretes H<sup>+</sup> and reabsorbs HCO<sub>3</sub><sup>-</sup> and K<sup>+</sup> and thus is important in regulating acid-base balance (see [Chapter 8](#)) and K<sup>+</sup> balance (see [Chapter 7](#)). β-Intercalated cells secrete HCO<sub>3</sub><sup>-</sup> and reabsorb H<sup>+</sup> and Cl<sup>-</sup> ([Figure 4-10, C](#)). α-Intercalated cells also reabsorb K<sup>+</sup> by the

operation of an  $H^+-K^+-ATPase$  mechanism located in the apical plasma membrane (Figure 4-10, B). Both  $Na^+$  reabsorption and  $K^+$  secretion by principal cells depend on the activity of  $Na^+-K^+-ATPase$  in the basolateral membrane (see Figure 4-10, A). By maintaining a low intracellular  $[Na^+]$ , this transporter provides a favorable chemical gradient for the movement of  $Na^+$  from the tubular fluid into the cell. Because  $Na^+$  enters the cell across the apical membrane by diffusion through  $Na^+$ -selective channels in the apical membrane, the negative voltage inside the cell facilitates  $Na^+$  entry.  $Na^+$  leaves the cell across the basolateral membrane and enters the blood through the action of  $Na^+-K^+-ATPase$ .  $Na^+$  reabsorption generates a lumen-negative voltage across the late distal tubule and collecting duct, which provides the driving force for  $Cl^-$  reabsorption across the paracellular pathway. As previously noted,  $Cl^-$  also is reabsorbed by  $\beta$ -intercalated cells (Figure 4-10, C). Chloride enters the  $\beta$ -intercalated cell across the apical membrane via a  $Cl^-/HCO_3^-$  antiporter (Pendrin) and leaves the cell across the basolateral membrane via a  $Cl^-$  channel. A variable amount of water is reabsorbed across principal cells in the late distal tubule and collecting duct. Water reabsorption is mediated by the AQP2 water channel located in the apical plasma membrane and AQP3 and AQP4 water channels located in the basolateral membrane of principal cells. In the presence of arginine vasopressin (AVP), water is reabsorbed. By contrast, in the absence of AVP, the distal tubule and collecting duct reabsorb little water (see Chapter 5).

$K^+$  is secreted from the blood into the tubular fluid by principal cells in two steps (see Figure 4-10, A). First,  $K^+$  uptake across the basolateral membrane is mediated by the action of the  $Na^+-K^+-ATPase$  pump. Second,  $K^+$  leaves the cell by passive diffusion. Because the  $K^+$  concentration inside the cells is high ( $\sim 150$  mEq/L) and the  $K^+$  concentration in tubular fluid is low ( $\sim 10$  mEq/L),  $K^+$  diffuses down its concentration gradient through apical cell membrane  $K^+$  channels into the tubular fluid. Although the negative potential inside the cells tends to retain  $K^+$  within the cell, the electrochemical gradient across the apical membrane favors  $K^+$  secretion from the cell into the tubular fluid (see Chapter 7).  $K^+$  reabsorption by  $\alpha$ -intercalated cells is mediated by


an  $H^+-K^+-ATPase$  pump located in the apical cell membrane (Figure 4-10, B).

## REGULATION OF NaCl AND WATER REABSORPTION

Quantitatively, angiotensin II, aldosterone, catecholamines, natriuretic peptides, and uroguanylin are the most important hormones that regulate NaCl reabsorption and thereby urinary NaCl excretion (Table 4-6). However, other hormones (including dopamine and adrenomedullin), Starling forces, and the phenomenon of glomerulotubular balance influence NaCl reabsorption. AVP is the only major hormone that directly regulates the amount of water excreted by the kidneys.

**Angiotensin II** has a potent stimulatory effect on NaCl and water reabsorption in the proximal tubule. It also has been shown to stimulate  $Na^+$  reabsorption in the thick ascending limb of the Henle loop, as well as the distal tubule and collecting duct. Angiotensin II is one of the most potent hormones that stimulates NaCl and water reabsorption in the proximal tubule. A decrease in the extracellular fluid (ECF) volume activates the renin-angiotensin-aldosterone system (see Chapter 6 for more details), thereby increasing the plasma concentration of angiotensin II.

**Aldosterone**, which is synthesized by the glomerulosa cells of the adrenal cortex, stimulates NaCl reabsorption. It acts on the thick ascending limb of the loop of Henle, the late segment of the distal tubule, and the collecting duct. As described in Chapter 6, the late distal tubule and collecting duct are collectively termed the **aldosterone-sensitive distal nephron** (ASDN). Aldosterone also stimulates  $K^+$  secretion by the late segment of the distal tubule and collecting duct (see Chapter 7). Aldosterone enhances NaCl reabsorption across principal cells in the ASDN by four mechanisms: (1) increasing the amount of  $Na^+-K^+-ATPase$  in the basolateral membrane; (2) increasing the expression of the epithelial sodium channel (ENaC) in the apical cell membrane; (3) elevating serum glucocorticoid-stimulated kinase (Sgk) levels, which also increases the expression of ENaC in the apical cell membrane; and (4) stimulating channel-activating protease (CAP1, also called prostatin), a serine protease, which directly activates ENaC channels by proteolysis. Taken together, these actions increase

the uptake of Na<sup>+</sup> across the apical cell membrane and facilitate the exit of Na<sup>+</sup> from the cell interior into the blood. The increase in the reabsorption of Na<sup>+</sup> generates a lumen-negative transepithelial voltage across the late segment of the distal tubule and collecting duct. This lumen-negative voltage provides the electrochemical driving force for Cl<sup>-</sup> reabsorption across the tight junctions (i.e., paracellular pathway) in the ASDN. Aldosterone secretion is enhanced by hyperkalemia and by volume contraction (i.e., reduced ECF volume) via increased angiotensin II (after activation of the renin-angiotensin system). Aldosterone secretion is decreased by hypokalemia and natriuretic peptides (discussed later in this chapter). Through its stimulation of NaCl reabsorption in the collecting duct, aldosterone also indirectly increases water reabsorption by this nephron segment.

**Atrial natriuretic peptide (ANP) and brain natriuretic peptide (BNP)** inhibit NaCl and water reabsorption. Secretion of ANP by the cardiac atria and BNP by the cardiac ventricles is stimulated by a rise in blood pressure and an increase in the ECF volume. ANP and BNP reduce the blood pressure by decreasing the total peripheral resistance and by enhancing urinary NaCl and water excretion, primarily by increasing GFR and renal blood flow (RBF). These natriuretic peptides vasodilate the afferent and efferent arterioles, which increases GFR and thus the filtration of NaCl, thereby increasing NaCl excretion (see the discussion on glomerulotubular balance later in this chapter for the mechanism). In addition, the increase in RBF decreases the concentration of NaCl in the medullary interstitium, which in turn reduces passive NaCl reabsorption by the thin ascending limb of



### AT THE CELLULAR LEVEL

As previously noted, aldosterone stimulates both sodium chloride (NaCl) reabsorption and  $K^+$  secretion by the collecting duct. Although both a reduction in the extracellular fluid (ECF) volume (i.e., volume contraction; see Chapter 6) and hyperkalemia (see Chapter 7) increase aldosterone levels, the physiologic response of the kidneys with regard to NaCl and  $K^+$  excretion differs in these two conditions. During reduction in the ECF volume, NaCl excretion by the kidneys is reduced, to restore ECF volume, without a change in  $K^+$  excretion. By contrast, during hyperkalemia,  $K^+$  excretion by the kidneys is increased, to return plasma  $[K^+]$  to normal, without a change in NaCl excretion. This phenomenon, the apparent independent effects of aldosterone on net urinary  $Na^+$  and  $K^+$  excretion, is called the **aldosterone paradox**. The paradox can be explained by the observation that although aldosterone increases in both conditions, angiotensin II levels increase only during ECF volume contraction and not during hyperkalemia, and the fact that aldosterone and angiotensin II differentially regulate a number of transport proteins in several nephron segments. The integrated physiological response to a reduction in the ECF volume is depicted in [Figure 4-11, A](#). During volume contraction, angiotensin II stimulates NaCl reabsorption by the proximal tubule (not shown in [Figure 4-11](#)) and by the distal tubule (early segment) by activating with no lysine (K) kinase (WNK), which enhances NaCl reabsorption by activating NCC. Aldosterone stimulates  $Na^+$  reabsorption in principal cells of the collecting duct by activating *SGK1*, which increases the abundance of epithelial sodium channel (ENaC) channels in the apical plasma membrane. Both effects stimulate NaCl reabsorption. Moreover, angiotensin II activates WNK in principal cells, which inhibits  $K^+$  secretion via the renal outer medullary  $K^+$  (ROMK) channel, thereby preventing an increase in  $K^+$  excretion even though aldosterone levels are elevated. The integrated physiological response to hyperkalemia is depicted in [Figure 4-11, B](#). During hyperkalemia, aldosterone stimulates ROMK-mediated  $K^+$  secretion by principal cells in the collecting duct by activating WNK (a different WNK than the one that inhibits ROMK), thereby increasing  $K^+$  excretion by the kidneys. Because the distal tubule (early segment) is not responsive to aldosterone, this hormone does not stimulate NaCl reabsorption in this nephron segment. In fact, because

angiotensin II levels are not elevated during hyperkalemia, the basal activity of WNK is low, resulting in reduced NaCl reabsorption via NCC ([Figure 4-11, B](#)). The lack of effect of WNK on NaCl reabsorption in the distal tubule offsets the stimulatory effect of aldosterone on NaCl reabsorption in principal cells of the collecting duct, resulting in no net change in urinary NaCl excretion during hyperkalemia.



### AT THE CELLULAR LEVEL

Serum glucocorticoid-stimulated kinase (Sgk), a serine/threonine kinase, plays an important role in maintaining sodium chloride (NaCl) and  $K^+$  homeostasis by regulating NaCl and  $K^+$  excretion by the kidneys. Studies in Sgk1 knockout mice reveal that this kinase is required for animals to survive severe NaCl restriction and  $K^+$  loading. NaCl restriction and  $K^+$  loading enhance plasma (aldosterone), which rapidly (in minutes) increases Sgk1 protein expression and phosphorylation. Phosphorylated Sgk1 enhances epithelial sodium channel (ENaC)-mediated sodium reabsorption in the collecting duct, primarily by increasing the number of ENaC channels in the apical plasma membrane of principal cells and also by increasing the number of  $Na^+$ - $K^+$  ATPase pumps in the basolateral membrane. Phosphorylated Sgk1 inhibits Nedd4-2, a ubiquitin ligase, which monoubiquitinates ENaC subunits, targeting them for endocytic removal from the plasma membrane and subsequent destruction in lysosomes. Inhibition of Nedd4-2 by Sgk1 reduces the monoubiquitinylation of ENaC, thereby reducing endocytosis and increasing the number of channels in the membrane. Sgk1 induces a translocation of ROMK from an intracellular pool to the plasma membrane and thereby enhances ROMK-mediated  $K^+$  secretion by principal cells. These effects of Sgk1 precede the aldosterone-stimulated increase in ENaC, ROMK, and  $Na^+$ - $K^+$  ATPase abundance, which leads to a delayed (>4 hours), secondary increase in NaCl and  $K^+$  transport by the collecting duct. Activating polymorphisms in Sgk1 cause an increase in blood pressure, presumably by enhanced NaCl reabsorption by the collecting duct, which increases the extracellular fluid volume and thereby blood pressure.

the loop of Henle (see Chapter 5 for details on NaCl reabsorption by the thin ascending limb of the loop of Henle). ANP and BNP also inhibit NaCl reabsorption by the medullary portion of the collecting duct and inhibit AVP-stimulated water reabsorption across the collecting duct. Moreover, ANP and BNP also reduce the secretion of AVP from the posterior pituitary. These actions of ANP and BNP are mediated by activation of membrane-bound guanylyl cyclase receptors,

which increase intracellular levels of the second messenger cyclic guanosine monophosphate (cGMP). ANP induces a more profound natriuresis and diuresis than does BNP.

**Urodilatin** and ANP are encoded by the same gene and have similar amino acid sequences. Urodilatin is a 32-amino-acid hormone that differs from ANP by the addition of four amino acids to the amino terminus. Urodilatin is secreted by the distal

## IN THE CLINIC

**Liddle syndrome** is a rare genetic disorder characterized by an increase in the extracellular fluid (ECF) volume that causes an increase in blood pressure (i.e., hypertension). Liddle syndrome is caused by activating mutations in either the  $\beta$  or  $\gamma$  subunit of the epithelial  $\text{Na}^+$  channel gene (*ENaC*), which is composed of three subunits,  $\alpha$ ,  $\beta$ , and  $\gamma$ . These mutations increase the number of  $\text{Na}^+$  channels in the apical cell membrane of principal cells and thereby the amount of  $\text{Na}^+$  reabsorbed by each channel. In persons with Liddle syndrome, the rate of renal  $\text{Na}^+$  reabsorption is inappropriately high, which leads to an increase in the ECF volume and hypertension.

Two different forms of **pseudohypoaldosteronism type 1** (PHA1) exist (i.e., the kidneys waste sodium chloride [ $\text{NaCl}$ ] as they do when aldosterone levels are reduced; however, in PHA1, aldosterone levels are elevated). The autosomal recessive form is caused by inactivating mutations in the  $\alpha$ ,  $\beta$ , or  $\gamma$  subunit of *ENaC*. The etiology of the autosomal dominant form is an inactivating mutation in the mineralocorticoid receptor. PHA is characterized by an increase in  $\text{Na}^+$  excretion, a reduction in the ECF volume, hyperkalemia, and hypotension. Some persons with expanded ECF volume and elevated blood pressure are treated with drugs that inhibit **angiotensin-converting enzyme** (ACE) inhibitors (e.g., captopril, enalapril, and lisinopril) and thereby lower fluid volume and blood pressure. The inhibition of ACE blocks the degradation of angiotensin I to angiotensin II and thereby lowers plasma angiotensin II levels (see Chapter 6 for details). The decline in plasma angiotensin II concentration has three effects. First,  $\text{NaCl}$  and water reabsorption by the nephron (especially the proximal tubule) decreases. Second, aldosterone secretion decreases, thus reducing  $\text{NaCl}$  reabsorption in the thick ascending limb, distal tubule, and collecting duct. Third, because angiotensin is a potent vasoconstrictor, a reduction in its concentration permits the systemic arterioles to dilate and thereby lower arterial blood pressure. ACE also degrades the vasodilator hormone bradykinin; thus ACE inhibitors increase the concentration of bradykinin, a vasodilatory hormone. ACE inhibitors decrease the extracellular fluid volume and the arterial blood pressure by promoting renal  $\text{NaCl}$  and water excretion and by reducing total peripheral vascular resistance.

tubule and collecting duct and is not present in the systemic circulation; thus urodilatin influences only the function of the kidneys. Urodilatin secretion is stimulated by a rise in the blood pressure and an increase in the ECF volume. It inhibits  $\text{NaCl}$  and water reabsorption across the medullary portion of the collecting duct. Urodilatin is a more potent natriuretic and diuretic hormone than ANP because some of the ANP that enters the kidneys in the blood is degraded by a neutral endopeptidase that has no effect on urodilatin.

**Uroguanylin** and **guanylin** are produced by neuroendocrine cells in the intestine in response to the oral ingestion of  $\text{NaCl}$ . These hormones enter the circulation and inhibit  $\text{NaCl}$  and water reabsorption by the kidneys by activation of membrane-bound guanylyl cyclase receptors, which increases intracellular levels of cGMP. The natriuretic response of the kidneys to a salt load is more pronounced when given orally than when delivered intravenously because oral administration of salt causes the intestinal secretion of uroguanylin and guanylin.

**Catecholamines** stimulate  $\text{NaCl}$  reabsorption. Catecholamines released from the sympathetic nerves (norepinephrine) and the adrenal medulla (epinephrine) stimulate  $\text{NaCl}$  and water reabsorption by the proximal tubule, the thick ascending limb of the loop of Henle, the distal tubule, and the collecting duct. Although sympathetic nerves are not very active when the ECF volume is normal, when ECF volume declines (e.g., after hemorrhage), sympathetic nerve activity rises dramatically and stimulates  $\text{NaCl}$  and water reabsorption by these four nephron segments.

**Dopamine**, a catecholamine, is synthesized by cells of the proximal tubule. The action of dopamine is opposite to that of norepinephrine and epinephrine. Dopamine secretion is stimulated by an increase in ECF volume, and its secretion directly inhibits  $\text{NaCl}$  and water reabsorption in the proximal tubule.

**Adrenomedullin** is a 52-amino-acid peptide hormone that is produced by a variety of organs including the kidneys. Adrenomedullin induces a marked diuresis and natriuresis, and its secretion is stimulated by congestive heart failure and hypertension. The major effect of adrenomedullin on the kidneys is to increase GFR and RBF and thereby to stimulate indirectly the

excretion of NaCl and water (see the previous discussion regarding ANP/BNP).

**AVP** regulates water reabsorption and is the most important hormone that regulates water reabsorption in the kidneys (see Chapter 5). This hormone is secreted by the posterior pituitary gland in response to an increase in plasma osmolality (1% or more) or a decrease in the ECF volume (>5% to 10% of normal). AVP increases the permeability of the collecting duct to water and thereby increases osmotic water reabsorption across the collecting duct because of the osmotic gradient that exists between tubular fluid and the interstitium (see Chapter 5). AVP has little effect on urinary NaCl excretion.

**Starling forces** regulate NaCl and water reabsorption across the proximal tubule. As previously described,  $\text{Na}^+$ ,  $\text{Cl}^-$ ,  $\text{HCO}_3^-$ , amino acids, glucose, and water are transported into the intercellular space of the proximal tubule. Starling forces between this space and the peritubular capillaries facilitate the movement of the reabsorbed fluid into the capillaries. Starling forces across the wall of the peritubular capillaries are the hydrostatic pressures in the peritubular capillary ( $P_{pc}$ ) and lateral intercellular space ( $P_i$ ) and the oncotic pressures in the peritubular capillary ( $\pi_{pc}$ ) and lateral intercellular space ( $\pi_i$ ). Thus the reabsorption of water resulting from  $\text{Na}^+$  transport from tubular fluid into the lateral intercellular space is modified by the Starling forces. Thus:

$$Q = K_f[(P_{pc} - P_i) + \sigma(\pi_{pc} - \pi_i)] \quad (4-2)$$

where  $Q$  is flow (positive numbers indicate flow from the intercellular space into blood). Starling forces that favor movement from the interstitium into the peritubular capillaries are  $\pi_{pc}$  and  $P_i$  (Figure 4-12). The opposing Starling forces are  $\pi_i$  and  $P_{pc}$ . Normally the sum of the Starling forces favors the movement of solute and water from the interstitial space into the capillary. However, some of the solutes and fluid that enter the lateral intercellular space leak back into the proximal tubular fluid. Starling forces do not affect transport by the loop of Henle, distal tubule, and collecting duct because these segments are less permeable to water than the proximal tubule.


A number of factors can alter the Starling forces across the peritubular capillaries surrounding the

proximal tubule. For example, dilation of the efferent arteriole increases  $P_{pc}$ , whereas constriction of the efferent arteriole decreases it. An increase in  $P_{pc}$  inhibits solute and water reabsorption by increasing the back-leak of NaCl and water across the tight junction, whereas a decrease stimulates reabsorption by decreasing back-leak across the tight junction.

The  $\pi_{pc}$  is partially determined by the rate of formation of the glomerular ultrafiltrate. For example, if one assumes a constant plasma flow in the afferent arteriole, the plasma proteins become less concentrated in the plasma that enters the efferent arteriole and peritubular capillary because less ultrafiltrate is formed (i.e., as GFR decreases). Hence the  $\pi_{pc}$  decreases. The  $\pi_{pc}$  is directly related to the **filtration fraction** (FF) ( $\text{FF} = \text{GFR}/\text{RPF}$ ). A decrease in the FF resulting from a decrease in GFR, at constant RPF, decreases the  $\pi_{pc}$ . This phenomenon in turn increases the backflow of NaCl and water from the lateral intercellular space into the tubular fluid and thereby decreases net solute and water reabsorption across the proximal tubule. An increase in the FF has the opposite effect.

The importance of Starling forces in regulating solute and water reabsorption by the proximal tubule is underscored by the phenomenon of **glomerulotubular (G-T) balance**. Spontaneous changes in GFR markedly alter the filtered load of  $\text{Na}^+$  (filtered load =  $\text{GFR} \times [\text{Na}^+]$ ). Without rapid adjustments in  $\text{Na}^+$  reabsorption to counter the changes in the filtration of  $\text{Na}^+$ , urine  $\text{Na}^+$  excretion would fluctuate widely, disturb the  $\text{Na}^+$  balance of the body, and thus alter ECF volume and blood pressure (see Chapter 6 for more details). However, spontaneous changes in GFR do not alter  $\text{Na}^+$  excretion in the urine or  $\text{Na}^+$  balance when ECF volume is normal because of the phenomenon of G-T balance. When body  $\text{Na}^+$  balance is normal (i.e., ECF volume is normal), G-T balance refers to the fact that  $\text{Na}^+$  and water reabsorption increases in proportion to the increase in GFR and filtered load of  $\text{Na}^+$ . Thus a constant fraction of the filtered  $\text{Na}^+$  and water is reabsorbed from the proximal tubule despite variations in GFR. The net result of G-T balance is to reduce the impact of GFR changes on the amount of  $\text{Na}^+$  and water excreted in the urine.

Two mechanisms are responsible for G-T balance. One is related to the oncotic and hydrostatic pressure

differences between the peritubular capillaries and the lateral intercellular space (i.e., Starling forces). For example, an increase in the GFR (at constant renal blood flow) raises the protein concentration in the glomerular capillary plasma above normal. This protein-rich plasma leaves the glomerular capillaries, flows through the efferent arterioles, and enters the peritubular capillaries. The increased  $\pi_{pc}$  augments the movement of solute and fluid from the lateral intercellular space into the peritubular capillaries. This action increases net solute and water reabsorption by the proximal tubule.

The second mechanism responsible for G-T balance is initiated by an increase in the filtered load of glucose and amino acids. As discussed earlier, the reabsorption of  $\text{Na}^+$  in the first half of the proximal tubule is coupled to that of glucose and amino acids. The rate of

$\text{Na}^+$  reabsorption therefore partially depends on the filtered load of glucose and amino acids. As the GFR and filtered load of glucose and amino acids increase,  $\text{Na}^+$  and water reabsorption also rises.

In addition to G-T balance, another mechanism minimizes changes in the filtered load of  $\text{Na}^+$ . As discussed in Chapter 3, an increase in the GFR (and thus in the amount of  $\text{Na}^+$  filtered by the glomerulus) activates the tubuloglomerular feedback mechanism. This action returns the GFR and filtration of  $\text{Na}^+$  to normal values. Thus spontaneous changes in the GFR (e.g., caused by changes in posture and blood pressure) increase the amount of  $\text{Na}^+$  filtered for only a few minutes. The mechanisms that underlie G-T balance maintain urinary  $\text{Na}^+$  excretion constant and thereby maintain  $\text{Na}^+$  homeostasis (and ECF volume and blood pressure) until the GFR returns to normal.

## S U M M A R Y

1. The four major segments of the nephron (the proximal tubule, the loop of Henle, the distal tubule, and the collecting duct) determine the composition and volume of the urine by the processes of selective reabsorption of solutes and water and secretion of solutes.
2. Tubular reabsorption allows the kidneys to retain the substances that are essential and regulate their levels in the plasma by altering the degree to which they are reabsorbed. The reabsorption of  $\text{Na}^+$ ,  $\text{Cl}^-$ , other anions, and organic anions and cations together with water constitutes the major function of the nephron. Approximately 25200 mEq of  $\text{Na}^+$  and 179 L of water are reabsorbed each day. The proximal tubule cells reabsorb 67% of the glomerular ultrafiltrate, and cells of the Henle loop reabsorb about 25% of the  $\text{NaCl}$  that was filtered and about 15% of the water that was filtered. The distal segments of the nephron (distal tubule and collecting duct system) have a more limited reabsorptive capacity. However, the final adjustments in the composition and volume of the urine and most of the regulation by hormones and other factors occur in distal segments.
3. Secretion of substances into tubular fluid is a means for excreting various byproducts of metabolism, and it also serves to eliminate exogenous organic anions and cations (e.g., drugs) and toxins from the body. Many organic anions and cations are bound to plasma proteins and therefore are unavailable for ultrafiltration. Thus secretion is their major route of excretion in the urine.
4. Various hormones (including angiotensin II, aldosterone, AVP, natriuretic peptides [ANP and BNP], dopamine, urodilatin, uroguanylin, and guanylin), sympathetic nerves, and Starling forces regulate  $\text{NaCl}$  reabsorption by the kidneys. AVP is the major hormone that regulates water reabsorption.

# 5

## REGULATION OF BODY FLUID OSMOLALITY: REGULATION OF WATER BALANCE

### OBJECTIVES

Upon completion of this chapter, the student should be able to answer the following questions:

1. Why do changes in water balance result in alterations in the  $[\text{Na}^+]$  of the extracellular fluid?
2. How is the secretion of arginine vasopressin controlled by changes in the osmolality of the body fluids and in blood volume and pressure?
3. What are the cellular events associated with the action of arginine vasopressin on the collecting duct, and how do they lead to an increase in the water permeability of this segment?
4. What is the role of Henle's loop in the production of both dilute and concentrated urine?
5. What is the composition of the medullary interstitial fluid, and how does it participate in the process of producing concentrated urine?
6. What are the roles of the vasa recta in the process of diluting and concentrating the urine?
7. How is the diluting and concentrating ability of the kidneys quantitated?

# A

s described in Chapter 1, water constitutes approximately 60% of the healthy adult human body. Body water is divided into two compartments (i.e., intracellular fluid and extracellular fluid [ECF]), which are in osmotic equilibrium. Water intake into the body generally occurs orally, and the water ingested is absorbed into the ECF by the gastrointestinal tract via a mechanism similar to that which mediates water absorption by the proximal tubule. However, in clinical situations, intravenous infusion is an important route of water entry. Regardless of the route of entry (oral versus intravenous), water first enters the ECF and then equilibrates with the intracellular fluid. The

kidneys are responsible for regulating water balance and under most conditions are the major route for elimination of water from the body (Table 5-1). Other routes of water loss from the body include evaporation from the cells of the skin and respiratory passages. Collectively, water loss by these routes is termed **insensible water loss** because people are unaware of its occurrence. The production of sweat accounts for the loss of additional water. Water loss by this mechanism can increase dramatically in a hot environment, with exercise, or in the presence of fever (Table 5-2). Finally, water can be lost from the gastrointestinal tract. Fecal water loss is normally small (~100 mL/day) but can increase dramatically with diarrhea (e.g., 20 L/day in persons with cholera). Vomiting also can cause gastrointestinal water loss.

\*In hot weather and during prolonged heavy exercise, water balance is maintained by increased water ingestion. Decreased excretion of water by the kidneys alone is insufficient to maintain water balance.

Although water loss from sweating, defecation, and evaporation from the lungs and skin can vary depending on the environmental conditions or during pathologic conditions, the loss of water by these routes cannot be regulated. In contrast, the renal excretion of water is tightly regulated to maintain whole-body water balance. The maintenance of water balance requires that water intake and loss from the body are precisely matched. If intake exceeds losses, **positive**

**water balance** exists. Conversely, when intake is less than losses, **negative water balance** exists.


When water intake is low or water losses increase, the kidneys conserve water by producing a small volume of urine that is hyperosmotic with respect to plasma. When water intake is high, a large volume of hypoosmotic urine is produced. In a healthy person, the urine osmolality ( $U_{osm}$ ) can vary from approximately 50 to 1200 mOsm/kg  $H_2O$ , and the corresponding urine volume can vary from approximately 18 to 0.5 L/day.

It is important to recognize that disorders of water balance are manifested by alterations in the body fluid osmolality, which usually are measured by changes in

### IN THE CLINIC

When plasma osmolality ( $P_{osm}$ ) is reduced (i.e., hypoosmolality), water moves from the extracellular fluid into cells, causing them to swell. Symptoms associated with hypoosmolality are related primarily to swelling of brain cells. For example, a rapid decrease in  $P_{osm}$  can alter neurologic function and thereby cause nausea, malaise, headache, confusion, lethargy, seizures, and coma. When  $P_{osm}$  is increased (i.e., hyperosmolality), water is lost from cells, causing them to shrink. The symptoms of an increase in  $P_{osm}$  also are primarily neurologic and include lethargy, weakness, seizures, coma, and even death.

The symptoms associated with changes in body fluid osmolality vary depending on how quickly osmolality is changed. Rapid changes in osmolality (i.e., over hours) are less well tolerated than changes that occur more gradually (i.e., over days to weeks). Indeed, when alterations in body fluid osmolality have developed over an extended period, such persons may be entirely asymptomatic. This situation reflects the ability of cells over time either to eliminate intracellular osmoles, as occurs with hypoosmolality, or to generate new intracellular osmoles in response to hyperosmolality and thus minimize changes in cell volume of the neurons. This ability has important clinical implications when treating a patient with an abnormal plasma osmolality. For example, rapid correction of the osmolality of a person who has had long-standing hypoosmolality of the body fluids can lead to the development of osmotic demyelination syndrome. The syndrome can result in paralysis of multiple muscle groups and can be fatal.

plasma osmolality ( $P_{\text{osm}}$ ). Because the major determinant of plasma osmolality is Na<sup>+</sup> (with its anions Cl<sup>-</sup> and HCO<sub>3</sub><sup>-</sup>), these disorders also result in alterations in the plasma [Na<sup>+</sup>] (see Figure 5-1). When an abnormal plasma [Na<sup>+</sup>] is observed in an individual, it is tempting to suspect a problem in Na<sup>+</sup> balance. However, the problem usually is related to water balance, not Na<sup>+</sup> balance. As described in Chapter 6, changes in Na<sup>+</sup> balance result in alterations in the volume of the ECF, not its osmolality.

Under steady-state conditions, the kidneys control water excretion independently of their ability to control the excretion of various other physiologically important substances such as Na<sup>+</sup>, K<sup>+</sup>, and urea (Figure 5-2). Indeed, this ability is necessary for survival because it allows water balance to be achieved without upsetting the other homeostatic functions of the kidneys.


This chapter discusses the mechanisms by which the kidneys maintain water balance by excreting either hypoosmotic (dilute) or hyperosmotic (concentrated)

urine (see Figure 5-2). The control of **arginine vasopressin (AVP)** secretion and its important role in regulating the excretion of water by the kidneys also are explained.

## ARGININE VASOPRESSIN

AVP, also known as **antidiuretic hormone**, acts on the kidneys to regulate the volume and osmolality of the urine. When plasma AVP levels are low, a large volume of urine is excreted (diuresis), and the urine is dilute.\* When plasma levels are high, a small volume of urine is excreted (antidiuresis), and the urine is concentrated. Figure 5-2 illustrates the effect of AVP on the urine flow rate and osmolality. The excretion of

\*Diuresis is simply a large urine output. When the urine contains primarily water, it is referred to as a *water diuresis*, which is in contrast to the diuresis seen with diuretic agents (see Chapter 10). In the latter case, urine output is large, but the urine contains solute plus water, which sometimes is termed a *solute diuresis*.

total solute (e.g.,  $\text{Na}^+$ ,  $\text{K}^+$ , and urea) by the kidneys also is shown. As already noted, AVP does not appreciably alter the excretion of solute, which underscores the fact that AVP controls water excretion and maintains water balance without altering the excretion and homeostatic control of other substances.

AVP is a small peptide that is nine amino acids in length. It is synthesized in neuroendocrine cells located within the supraoptic and paraventricular nuclei of the hypothalamus.\* The synthesized hormone is packaged in granules that are transported down the axon of the cell and stored in the nerve terminals located in the neurohypophysis (posterior pituitary). The anatomy of the hypothalamus and pituitary gland is shown in Figure 5-3.

The secretion of AVP by the posterior pituitary can be influenced by several factors. The two primary physiologic regulators of AVP secretion are the osmolality of the body fluids (osmotic) and volume and pressure of the vascular system (hemodynamic). Other factors that can alter AVP secretion include nausea

\*Neurons within the supraoptic and paraventricular nuclei synthesize either AVP or the related peptide oxytocin. AVP-secreting cells predominate in the supraoptic nucleus, and the oxytocin-secreting neurons are found primarily in the paraventricular nucleus.

### AT THE CELLULAR LEVEL


The gene for arginine vasopressin (AVP) is found on chromosome 20. It contains approximately 2000 base pairs with three exons and two introns. The gene codes for a 145 amino acid prohormone that consists of a signal peptide, the AVP molecule, neurophysin, and a glycopeptide (copeptin). As the cell processes the prohormone, the signal peptide is cleaved off in the rough endoplasmic reticulum. Once packaged in neurosecretory granules, the preprohormone is further cleaved into AVP, neurophysin, and copeptin molecules. The neurosecretory granules are then transported down the axon to the posterior pituitary and stored in the nerve endings until released. When the neurons are stimulated to secrete AVP, the action potential opens  $\text{Ca}^{++}$  channels in the nerve terminal, which raises the intracellular  $[\text{Ca}^{++}]$  and causes exocytosis of the neurosecretory granules. All three peptides are secreted in this process. Neurophysin and copeptin do not have an identified physiologic function.

(stimulates), atrial natriuretic peptide (inhibits), and angiotensin II (stimulates). A number of drugs, prescription and nonprescription, also affect AVP secretion. For example, nicotine stimulates secretion, whereas ethanol inhibits secretion.

### Osmotic Control of Arginine Vasopressin Secretion

Changes in the osmolality of body fluids play the most important role in regulating AVP secretion; changes as minor as 1% are sufficient to alter it significantly. Although the neurons in the supraoptic and paraventricular nuclei respond to changes in body fluid osmolality by altering their secretion of AVP, it is clear that separate cells exist in the anterior hypothalamus that sense changes in body fluid osmolality and regulate the activity of the AVP-secreting neurons.† These cells, termed *osmoreceptors*, appear to sense changes in body

†Osmoreceptors have been identified in the anterior hypothalamus; one of these sites is the organum vasculosum of the lamina terminalis, which is located outside the blood-brain barrier. In addition, the subfornical organ, which is also located in the anterior hypothalamus outside the blood-brain barrier, responds to circulating levels of angiotensin II, which is an important stimulator of AVP secretion.

fluid osmolality by either shrinking or swelling. The osmoreceptors respond only to solutes in plasma that are effective osmoles (see Chapter 1). For example, urea is an ineffective osmole when the function of osmoreceptors is considered. Thus elevation of the plasma urea concentration alone has little or no effect on AVP secretion.


When the effective osmolality of the plasma increases, the osmoreceptors send signals to the AVP synthesizing/secretory cells located in the supraoptic and paraventricular nuclei of the hypothalamus, and AVP synthesis and secretion are stimulated. Conversely, when the effective osmolality of the plasma is reduced, secretion is inhibited. Because AVP is rapidly degraded in the plasma, circulating levels can be reduced to zero within minutes after secretion is inhibited. As a result, the AVP system can respond rapidly to fluctuations in body fluid osmolality.

Figure 5-4, A, illustrates the effect of changes in plasma osmolality on circulating AVP levels. The set point of the system is the plasma osmolality value at which AVP secretion begins to increase. Below this set

point, virtually no AVP is released. Above this set point, the slope of the relationship is quite steep and accounts for the sensitivity of this system. The set point varies among individuals and is genetically determined. In healthy adults, it varies from 275 to 290 mOsm/kg H<sub>2</sub>O (average ~280 to 285 mOsm/kg H<sub>2</sub>O). As described later in this chapter, the set point shifts in response to changes in blood volume and pressure. It also shifts during pregnancy, with the osmolality of the mother's body fluids decreasing during the third trimester. The reasons for the shift of the set point during pregnancy are not completely known but likely involve hormones (e.g., relaxin) whose circulating levels are elevated at this stage of pregnancy.

### Hemodynamic Control of Arginine Vasopressin Secretion

A decrease in blood volume or pressure also stimulates AVP secretion. The receptors responsible for this response are located in both the low-pressure (left

atrium and large pulmonary vessels) and the high-pressure (aortic arch and carotid sinus) sides of the circulatory system. Because the low-pressure receptors are located in the high-compliance side of the circulatory system (i.e., venous) and the majority of blood is in the venous side of the circulatory system, these low-pressure receptors can be viewed as responding to

overall vascular volume. The high-pressure receptors respond to arterial pressure. Both groups of receptors are sensitive to stretch of the wall of the structure in which they are located (e.g., the cardiac atrial wall and the wall of the aortic arch) and are termed **baroreceptors**. Signals from these receptors are carried in afferent fibers of the vagus and glossopharyngeal nerves to the brainstem (solitary tract nucleus of the medulla oblongata), which is part of the center that regulates heart rate and blood pressure. Signals then are relayed from the brainstem to the AVP secretory cells of the supraoptic and paraventricular hypothalamic nuclei. The sensitivity of the baroreceptor system is less than that of the osmoreceptors, and a 5% to 10% decrease in blood volume or pressure is required before AVP secretion is stimulated. This phenomenon is illustrated in Figure 5-4, B. A number of substances have been shown to alter the secretion of AVP through their effects on blood pressure. These substances include bradykinin and histamine, which lower pressure and thus stimulate AVP secretion, and norepinephrine, which increases blood pressure and inhibits AVP secretion.




**FIGURE 5-5** ■ Interaction between osmotic and hemodynamic stimuli for arginine vasopressin (AVP) secretion. With decreased blood volume and pressure, the osmotic set point is shifted to lower plasma osmolality values and the slope is increased. An increase in blood volume and pressure has the opposite effects. *Max*, Maximum.

Alterations in blood volume and pressure also affect the response to changes in body fluid osmolality (Figure 5-5). With a decrease in blood volume or pressure, the set point is shifted to lower osmolality values and the slope of the relationship is steeper. In terms of survival of the individual, this means that when faced with circulatory collapse, the kidneys continue to conserve water, even though by doing so they reduce the osmolality of the body fluids. With an increase in blood volume or pressure, the opposite occurs. The set point is shifted to higher osmolality values, and the slope is decreased.

### Arginine Vasopressin Actions on the Kidneys

The primary action of AVP on the kidneys is to increase the permeability of the collecting duct to water. In addition, and notably, AVP increases the permeability of the medullary portion of the collecting duct to urea. Lastly, AVP stimulates sodium chloride (NaCl) reabsorption by the thick ascending limb of Henle's loop, the distal tubule, and the cortical portion of the collecting duct.


## IN THE CLINIC

Inadequate release of arginine vasopressin (AVP) from the posterior pituitary results in excretion of large volumes of dilute urine (polyuria). To compensate for this loss of water, the individual must ingest large volumes of water (polydipsia) to maintain constant body fluid osmolality. If the individual is deprived of water, the body fluids become hyperosmotic. This condition is called *central diabetes insipidus* or *pituitary diabetes insipidus*. Central diabetes insipidus can be inherited, although this situation is rare. It occurs more commonly after head trauma and with brain neoplasms or infections. Persons with central diabetes insipidus have a urine-concentrating defect that can be corrected by the administration of exogenous AVP.

The inherited (autosomal dominant) form of central diabetes insipidus is caused by a variety of mutations in the AVP gene. In patients with this form of central diabetes insipidus, mutations have been identified in all regions of the AVP gene (i.e., AVP, copeptin, and neurophysin). The most common mutation is found in the neurophysin portion of the gene. In each of these situations, defective trafficking of the peptide occurs, with abnormal accumulation in the endoplasmic reticulum. It is believed that this abnormal accumulation in the endoplasmic reticulum results in death of the AVP secretory cells of the supraoptic and paraventricular nuclei.

The syndrome of inappropriate antidiuretic hormone (ADH) secretion (**SIADH**) is a common clinical problem characterized by plasma AVP levels that are elevated above what would be expected on the basis of body fluid osmolality and blood volume and pressure—hence the term *inappropriate* ADH secretion. In addition, the collecting duct overexpresses water channels, thus augmenting the effect of AVP on the kidney. Persons with SIADH retain water, and their body fluids become progressively hypoosmotic. In addition, their urine is more hyperosmotic than expected on the basis of the low body fluid osmolality. SIADH can be caused by infections and neoplasms of the brain, drugs (e.g., antitumor drugs), pulmonary diseases, and carcinoma of the lung. Many of these conditions stimulate AVP secretion by altering neural input to the AVP secretory cells. However, small cell carcinoma of the lung produces and secretes a number of peptides, including AVP.

Recently, nonpeptide vasopressin receptor antagonists (e.g., conivaptan and tolvaptan) have been

developed that can be used to treat SIADH and other conditions in which AVP-dependent water retention by the kidneys occurs (e.g., congestive heart failure and hepatic cirrhosis).

The actions of AVP on water permeability of the collecting duct have been studied extensively (Figure 5-6). AVP binds to a receptor on the basolateral membrane of the cell. This receptor is termed the  $V_2$  receptor (i.e., vasopressin 2 receptor).<sup>\*</sup> Binding to this receptor, which is coupled to adenylyl cyclase through a stimulatory G protein ( $G_s$ ), increases the intracellular levels of cyclic adenosine monophosphate (cAMP). The rise in intracellular cAMP activates protein kinase A, which ultimately results in an increase in the number of aquaporin (AQP)-2 water channels in the apical membrane of the cell and the synthesis of more AQP-2. With the removal of AVP, the number of AQP-2 water channels in the apical membrane is reduced, thereby rendering the membrane impermeable to water. Because the basolateral

<sup>\*</sup>A different AVP receptor ( $V_1$  receptor) is present on vascular smooth muscle. This receptor mediates the vasoconstrictor response to AVP. It is this action that accounts for the term *vasopressin*.

membrane is freely permeable to water because of the presence of AQP-3 and AQP-4 water channels, any water that enters the cell through apical membrane water channels exits across the basolateral membrane, resulting in net absorption of water from the tubule lumen.

AVP also increases the permeability of the terminal portion of the inner medullary collecting duct to urea. This increase in permeability results in an increase in urea reabsorption and an increase in the osmolality of the medullary interstitial fluid. The inner medullary collecting duct expresses two different urea transporters (UTs: UT-A1 and UT-A3. UT-A1 is found in the apical membrane and UT-A3 is found in the basolateral membrane. AVP, acting through adenyl cyclase

and the cAMP/protein kinase A cascade, increases the permeability of the apical membrane to urea. This increase in permeability is associated with phosphorylation of UT-A1 and UT-A3. Increasing the osmolality of the interstitial fluid of the renal medulla also increases the permeability of the collecting duct to urea. This effect is mediated by the phospholipase C pathway and involves protein kinase C phosphorylation. Thus this effect is separate from and additive to that of AVP.

AVP also stimulates the reabsorption of NaCl by the thick ascending limb of Henle's loop and by the distal tubule and cortical segment of the collecting duct. It is thought that stimulation of thick ascending limb NaCl transport, in particular, may help maintain

### AT THE CELLULAR LEVEL

The gene for the  $V_2$  receptor is located on the X chromosome. It codes for a 371-amino-acid protein that is in the family of receptors that have seven membrane-spanning domains and are coupled to heterotrimeric G proteins. As shown in Figure 5-6, binding of AVP to its receptor on the basolateral membrane activates adenyl cyclase. The increase in intracellular cyclic adenosine monophosphate (cAMP) then activates protein kinase A, which results in phosphorylation of aquaporin (AQP)-2 water channels, which reduces the endocytic removal of AQP-2 from the apical membrane and also results in increased transcription of the AQP-2 gene through activation of a cAMP response element. AVP also increases the rate of insertion of vesicles containing AQP-2 into the apical membrane by facilitating their movement along microtubules driven by the molecular motor dynein. Once near the apical membrane, proteins called SNAREs interact with vesicles containing AQP-2 and facilitate the fusion of these vesicles with the membrane. The net addition of AQP-2 to the apical membrane, resulting from reduced endocytosis and increased insertion, allows more water to enter the cell driven by the osmotic gradient (lumen osmolality < cell osmolality). The water then exits the cell across the basolateral membrane through AQP-3 and AQP-4 water channels, which are constitutively present in the basolateral membrane. When the  $V_2$  receptor is not occupied by AVP, clathrin-mediated endocytosis of AQP-2 is enhanced and the exocytic insertion of AQP-2 is reduced, which decreases the total number of AQP-2 channels in the apical membrane, rendering the apical membrane once again impermeable to water.

Recently, persons have been found who have activating (gain-of-function) mutations in the  $V_2$  receptor gene. Thus the receptor is constitutively activated even in the absence of AVP. These persons have laboratory findings similar to those seen in the syndrome of inappropriate antidiuretic hormone secretion (SIADH), including reduced plasma osmolality, hyponatremia (reduced plasma  $[Na^+]$ ), and urine more concentrated than would be expected from the reduced body fluid osmolality. However, unlike persons with SIADH, in whom circulating levels of AVP are elevated and thus responsible for water retention by the kidneys, these persons have undetectable levels of AVP in their plasma. This new clinical entity has been termed “nephrogenic syndrome of inappropriate antidiuresis.”

### AT THE CELLULAR LEVEL

The collecting ducts of some persons do not respond normally to arginine vasopressin (AVP). These persons cannot maximally concentrate their urine and consequently have polyuria and polydipsia. This clinical entity is termed **nephrogenic diabetes insipidus** to distinguish it from central diabetes insipidus. Nephrogenic diabetes insipidus can result from a number of systemic disorders and, more rarely, occurs as a result of inherited disorders. Many of the acquired forms of nephrogenic diabetes insipidus are the result of decreased expression of aquaporin-2 (AQP-2) in the collecting duct. Decreased expression of AQP-2 has been documented in the urine-concentrating defects associated with hypokalemia, lithium ingestion (some degree of nephrogenic diabetes insipidus develops in 35% of persons who take lithium for bipolar disorder), ureteral obstruction, a low-protein diet, and hypercalcemia. The inherited forms of nephrogenic diabetes insipidus reflect mutations in the AVP receptor ( $V_2$  receptor) gene or the AQP-2 gene. Approximately 90% of hereditary forms of nephrogenic diabetes insipidus are the result of mutations in the  $V_2$  receptor gene, with the other 10% being the result of mutations in the AQP-2 gene. Because the gene for the  $V_2$  receptor is located on the X chromosome, these inherited forms are X-linked. Most of these mutations result in trapping of the receptor in the endoplasmic reticulum of the cell; only a few cases result in the surface expression of a  $V_2$  receptor that does not bind AVP. The gene coding for AQP-2 is located on chromosome 12 and is inherited as both an autosomal recessive and an autosomal dominant defect. As noted in Chapters 1 and 4, aquaporins exist as homotetramers. This homotetramer formation explains the difference between the two forms of nephrogenic diabetes insipidus. In the recessive form, heterozygotes produce both normal AQP-2 and defective AQP-2 molecules. The defective AQP-2 monomer is not delivered to the plasma membrane, and thus the homotetramers that do form contain only normal AQP-2 molecules. Accordingly, mutations in both alleles would be required to produce nephrogenic diabetes insipidus. In the autosomal dominant form, the defective monomers can form tetramers with normal monomers, as well as defective monomers. However, these tetramers cannot be delivered to the plasma membrane.

the hyperosmotic medullary interstitium that is necessary for absorption of water from the medullary portion of the collecting duct (discussed later in this chapter).

## THIRST

In addition to affecting the secretion of AVP, changes in plasma osmolality and blood volume or pressure lead to alterations in the perception of thirst. When body fluid osmolality is increased or the blood volume or pressure is reduced, a person perceives thirst. Of these stimuli, hypertonicity is the more potent. An increase in plasma osmolality of only 2% to 3% produces a strong desire to drink, whereas decreases in blood volume and pressure in the range of 10% to 15% are required to produce the same response.

As already discussed, people have a genetically determined threshold for AVP secretion (i.e., a body fluid osmolality above which AVP secretion increases). Similarly, people have a genetically determined threshold for triggering the sensation of thirst. However, the thirst threshold is higher than the threshold for AVP secretion. On average, the threshold for AVP secretion is approximately 285 mOsm/kg H<sub>2</sub>O, whereas the thirst threshold is approximately 295 mOsm/kg H<sub>2</sub>O. Because of this difference, thirst is stimulated at a body fluid osmolality at which AVP secretion is already stimulated.

The neural centers involved in regulating water intake (the thirst center) are located in the same region of the hypothalamus involved with regulating AVP secretion. However, it is not certain if the same cells serve both functions. Indeed, the thirst response, like the regulation of AVP secretion, occurs only in response to effective osmoles (e.g., NaCl). Even less is known about the pathways involved in the thirst response to decreased blood volume or pressure, but it is believed that the pathways are the same as those involved in the volume- and pressure-related regulation of AVP secretion. Angiotensin II, acting on cells of the thirst center (subfornical organ), also evokes the sensation of thirst. Because angiotensin II levels are increased when blood volume and pressure are reduced, this effect of angiotensin II contributes to the homeostatic response that restores and maintains the body fluids at their normal volumes.

The sensation of thirst is satisfied by the act of drinking even before sufficient water is absorbed from the

gastrointestinal tract to correct the plasma osmolality. Oropharyngeal and upper gastrointestinal receptors appear to be involved in this response. However, relief of the thirst sensation by these receptors is short lived, and thirst is completely satisfied only when the plasma osmolality or blood volume or pressure is corrected.

It should be apparent that the AVP and thirst systems work in concert to maintain water balance. An increase in the plasma osmolality evokes drinking and, through AVP action on the kidneys, the conservation of water. Conversely, when the plasma osmolality is decreased, thirst is suppressed and, in the absence of AVP, renal water excretion is enhanced. However, most of the time fluid intake is dictated by cultural factors and social situations, which is especially the case when thirst is not stimulated. In this situation, maintaining a normal body fluid osmolality relies solely on the ability of the kidneys to excrete water. How the kidney accomplishes this task is discussed in detail in the following sections of this chapter.

## RENAL MECHANISMS FOR DILUTION AND CONCENTRATION OF THE URINE

Under normal circumstances, the excretion of water is regulated separately from the excretion of solutes (see [Figure 5-2](#)). For this separate regulation to occur, the kidneys must be able to excrete urine that is either hypoosmotic or hyperosmotic with respect to the body fluids. This ability to excrete urine of varying osmolality in turn requires that solute be separated from water at some point along the nephron. As discussed in [Chapter 4](#), the reabsorption of solute in the proximal tubule results in the reabsorption of a proportional amount of water. Hence solute and water are not separated in this portion of the nephron. Moreover, this proportionality between proximal tubule water and solute reabsorption occurs regardless of whether the kidneys excrete dilute or concentrated urine. Thus the proximal tubule reabsorbs a large portion of the filtered solute and water but does not produce dilute or concentrated tubular fluid. The loop of Henle, in particular the thick ascending limb, is the major site where solute and water are separated. Thus the excretion of both dilute and concentrated urine requires normal function of the loop of Henle.

## IN THE CLINIC

With adequate access to water, the thirst mechanism can prevent the development of hyperosmolality. Indeed, it is this mechanism that is responsible for the polydipsia seen in response to the polyuria of both central and nephrogenic diabetes insipidus. Water intake also is influenced by social and cultural factors. Thus persons ingest water even in the absence of the thirst sensation. Normally the kidneys are able to excrete this excess water because they can excrete up to 18 L/day of urine. However, in some instances, the volume of water ingested exceeds the kidneys' capacity to excrete water, especially over short periods. When this situation occurs, the body fluids become hypoosmotic. An example of how water intake can exceed the capacity of the kidneys to excrete water is found in long-distance runners. A study of participants in the **Boston Marathon** found that hyponatremia developed in 13% of the runners during the course of the race.\* This finding reflected the practice of some runners of ingesting water, or other hypotonic drinks, during the race to remain "well hydrated." In addition, water is produced from the metabolism of glycogen and triglycerides used as fuels by the exercising muscle. Because over the course of the race they ingested and generated more water through metabolism than their kidneys were able to excrete, hyponatremia developed. In some racers, the hyponatremia was severe enough to elicit the neurologic symptoms described previously.

Throughout the popular media, one can find articles urging us to drink eight 8-oz glasses of water a day (the **8 × 8 recommendation**). Drinking this volume of water is said to provide innumerable health benefits. As a result, it seems that everyone now has a water bottle as his or her constant companion. Although ingesting this volume of water over the course of a day (approximately 2 L) does not harm most persons, no scientific evidence exists to support the beneficial health claims ascribed to the 8 × 8 recommendation.† Indeed, most persons get adequate amounts of water through the foods they ingest and the fluids taken with those meals.

The maximum amount of water that can be excreted by the kidneys depends on the amount of solute excreted, which in turn depends on food intake. For example, with maximally dilute urine (urine osmolality [ $U_{osm}$ ] = 50 mOsm/kg H<sub>2</sub>O), the maximum

urine output of 18 L/day is achieved only if the solute excretion rate is 900 mmol/day.

$$U_{osm} = \text{Solute excretion} / \text{Volume excreted}$$

$$50 \text{ mOsm/kg H}_2\text{O} = 900 \text{ mmol} / 18 \text{ L} \quad (5-1)$$

If solute excretion is reduced, as commonly occurs in elderly people with reduced food intake, the maximum urine output decreases. For example, if solute excretion is only 400 mmol/day, a maximum urine output (at  $U_{osm} = 50 \text{ mOsm/kg H}_2\text{O}$ ) of only 8 L/day can be achieved. Thus persons with reduced food intake have a reduced capacity to excrete water.

The excretion of hypoosmotic urine is relatively easy to understand. The nephron simply must reabsorb solute from the tubular fluid and not allow water reabsorption to occur as well. The reabsorption of solute without concomitant water reabsorption occurs in some portions of the descending limb and along the entire ascending limb of Henle's loop. Under appropriate conditions (i.e., in the absence of AVP), the distal tubule and collecting duct also dilute the tubular fluid. The excretion of hyperosmotic urine is more complex and thus more difficult to understand. This process in essence involves removing water from the tubular fluid without solute. Because water movement is passive, driven by an osmotic gradient, the kidney must generate a hyperosmotic compartment that then reabsorbs water osmotically from the tubular fluid. The compartment in the kidney where this reabsorption occurs is the interstitial space of the renal medulla.

It has long been recognized that Henle's loop is associated with the kidneys' ability to excrete hyperosmotic urine. Indeed, only birds and mammals can excrete hyperosmotic urine, and among vertebrates, only the avian and mammalian kidneys have loops of Henle. Moreover, some animals, such as desert rodents, have extremely long loops of Henle and excrete urine with an osmolality that can exceed 5000 mOsm/kg H<sub>2</sub>O. This

extraordinary ability to concentrate the urine allows the animals to survive without the need to drink water, because they obtain sufficient water in the food (e.g., seeds) that they ingest.

For more than 50 years our understanding of how the loop of Henle is able to generate a hyperosmotic environment within the renal medulla was focused on the process of **countercurrent multiplication**. By this process, solute (principally NaCl) is reabsorbed without water from the ascending limb of Henle's loop into the surrounding medullary interstitium. This reabsorption decreases the osmolality in the tubular fluid and raises the osmolality of the interstitium at this point. The increased osmolality of the interstitium then causes water to be reabsorbed from the descending limb of Henle's loop, thus increasing the tubular fluid osmolality in this segment. Thus at any point along the loop of Henle, the fluid in the ascending limb has an osmolality less than fluid in the adjacent descending limb. This osmotic difference was termed the **single effect**. Because of the countercurrent flow of tubular fluid in the descending (fluid flowing into the medulla) and ascending (fluid flow out of the medulla) limbs, this single effect could be multiplied. The multiplication of this single effect results in an osmotic gradient within the medullary interstitium, where the tip of the papilla has an osmolality of 1200 mOsm/kg H<sub>2</sub>O, compared with 300 mOsm/kg H<sub>2</sub>O at the corticomedullary junction. Although it is simple in concept, it is now clear that countercurrent multiplication cannot fully explain the process by which the loop of Henle generates a hyperosmotic medullary interstitium.\* Given our evolving understanding, specifically of the urine concentrating mechanism, what follows is a

\*Recent anatomic studies have looked at the localization of specific membrane transporters in the nephron segments of the renal medulla and the spatial relationships between these nephron segments and capillaries (i.e., vasa recta), which may create microenvironments that facilitate the concentration of tubular fluid. In addition, it has been proposed that the regular contraction of the renal calyx that surrounds each pyramid (see Chapter 2) also may contribute to the generation of hyperosmotic tubular fluid in water-permeable medullary nephron segments. In this model, compression of glycosaminoglycans in the medullary interstitium during calyx contraction generates a force that upon recoil (i.e., relaxation of the calyx) draws water out of water-permeable nephron segments and thereby concentrates the tubular fluid.


simplified explanation that highlights several key concepts:

1. Urine is concentrated by the AVP-dependent reabsorption of water from the collecting duct.
2. Reabsorption of NaCl from the ascending limb of Henle's loop generates a high [NaCl] in the medullary interstitium (up to 600 mmol/L at the tip of the papilla), which then drives water reabsorption from the collecting duct.
3. Urea accumulates in the medullary interstitium (up to 600 mmol/L), which allows the kidneys to excrete urine with the same high urea concentration. This phenomenon allows large amounts of urea to be excreted with relatively little water.

Figure 5-7 summarizes the essential features of the mechanisms whereby the kidneys excrete either a dilute or a concentrated urine.

First, how the kidneys excrete dilute urine (**water diuresis**) when AVP levels are low or zero is considered. The following numbers refer to those encircled in Figure 5-7, A.

1. Fluid entering the descending thin limb of the loop of Henle from the proximal tubule is isosmotic with respect to plasma. This state reflects the essentially isosmotic nature of solute and water reabsorption in the proximal tubule (see Chapter 4). (Note: Water is reabsorbed from the segments of the proximal tubule via AQP-1).
2. Depending on the nephron type (i.e., short-looped nephrons versus long-looped nephrons [see Figure 2-2]), some water will be reabsorbed by the thin descending limb. Importantly, this water reabsorption is limited to the outer medulla and the outermost portion of the inner medulla. By confining water reabsorption to these outer portions of the medulla, less water is added to the deepest part of the inner medullary interstitial space, thus preserving the hyperosmolality of this region of the medulla. (Note: Water is reabsorbed via AQP-1).
3. In the inner medulla, the terminal portion of the descending thin limb and all of the thin ascending limb is impermeable to water. (Note: AQP-1 is not expressed.) These same nephron segments express the Cl<sup>-</sup> transporter ClC-K1, which

mediates  $\text{Cl}^-$  reabsorption with  $\text{Na}^+$  following passively via the paracellular pathway. This passive reabsorption of NaCl without concomitant water reabsorption begins the process of diluting the tubular fluid.

4. The thick ascending limb of the loop of Henle also is impermeable to water and actively reabsorbs NaCl from the tubular fluid and thereby dilutes it further (see Chapter 4). Dilution occurs to such a degree that this segment often is referred to as the **diluting segment** of the kidney. Fluid leaving the thick ascending limb is hypoosmotic with respect to plasma (approximately 150 mOsm/kg  $\text{H}_2\text{O}$ ).
5. The distal tubule and cortical portion of the collecting duct actively reabsorb NaCl. In the absence of AVP, these segments are not permeable to water (i.e., AQP-2 is not present in the apical membrane of the cells). Thus when AVP is absent or present at low levels (i.e., decreased plasma osmolality), the osmolality of tubule fluid in these segments is reduced further because NaCl is reabsorbed without water. Under this condition, fluid leaving the cortical portion of the collecting duct is hypoosmotic with respect to plasma (approximately 50-100 mOsm/kg  $\text{H}_2\text{O}$ ).
6. The medullary collecting duct actively reabsorbs NaCl. Even in the absence of AVP, this segment is slightly permeable to water, and some water is reabsorbed.
7. The urine has an osmolality as low as approximately 50 mOsm/kg  $\text{H}_2\text{O}$  and contains low concentrations of NaCl. The volume of urine excreted can be as much as 18 L/day, or approximately 10% of the glomerular filtration rate (GFR).

Next, how the kidneys excrete concentrated urine (**antidiuresis**) when plasma osmolality and plasma AVP levels are high is considered. The following numbers refer to those encircled in [Figure 5-7, B](#).

- 1-4. These steps are similar to those for production of dilute urine. An important point in understanding how a concentrated urine is produced is to recognize that while reabsorption of NaCl by the ascending thin and thick limbs of the loop of Henle dilutes the tubular fluid, the reabsorbed NaCl accumulates in the medullary interstitium

and raises the osmolality of this compartment. The accumulation of NaCl in the medullary interstitium is crucial for the production of urine hyperosmotic to plasma because it provides the osmotic driving force for water reabsorption by the medullary collecting duct. As already noted, AVP stimulates NaCl reabsorption by the thick ascending limb of Henle's loop. This action is thought to maintain the medullary interstitial gradient at a time when water is being added to this compartment from the medullary collecting duct, which would tend to dissipate the gradient.

5. Because of NaCl reabsorption by the ascending limb of the loop of Henle, the fluid reaching the collecting duct is hypoosmotic with respect to the surrounding interstitial fluid. Thus an osmotic gradient is established across the collecting duct. In the presence of AVP, which increases the water permeability of the last half of the distal tubule and the collecting duct by increasing the number of AQP-2 water channels in the luminal membrane of the cells, water diffuses out of the tubule lumen, and the tubule fluid osmolality increases. This diffusion of water out of the lumen of the collecting duct begins the process of urine concentration. The maximum osmolality that the fluid in the distal tubule and cortical portion of the collecting duct can attain is approximately 290 mOsm/kg  $\text{H}_2\text{O}$  (i.e., the same as plasma), which is the osmolality of the interstitial fluid and plasma within the cortex of the kidney.
6. As the tubular fluid descends deeper into the medulla, water continues to be reabsorbed from the collecting duct, increasing the tubular fluid osmolality to 1200 mOsm/kg  $\text{H}_2\text{O}$  at the tip of the papilla.
7. The urine produced when AVP levels are elevated has an osmolality of 1200 mOsm/kg  $\text{H}_2\text{O}$  and contains high concentrations of urea and other nonreabsorbed solutes. The urine volume under this condition can be as low as 0.5 L/day.

Under most conditions, a relatively constant volume of tubular fluid is delivered to the AVP-sensitive portions of the nephron (late distal tubule and collecting duct). Plasma AVP levels then determine the amount of water that is reabsorbed by these segments. When AVP levels are low, a relatively small volume of

water is reabsorbed by these segments, and a large volume of hypoosmotic urine is excreted (up to 10% of the filtered water). When AVP levels are high, a large volume of water is reabsorbed by these same segments, and a small volume of hyperosmotic urine is excreted (<1% of filtered water). During antidiuresis, most of the water is reabsorbed in the distal tubule and cortical and outer medullary portions of the collecting duct. Thus a relatively small volume of fluid reaches the inner medullary collecting duct, where it is then reabsorbed. This distribution of water reabsorption along the length of the collecting duct (i.e., cortex > outer medulla > inner medulla) allows for the maintenance of a hyperosmotic interstitial environment in the inner medulla by minimizing the amount of water entering this compartment.

#### AT THE CELLULAR LEVEL

Water movement across the various segments of the nephron occurs through water channels (aquaporins [AQPs]). The proximal tubule and portions of some thin descending limbs of Henle's loop are highly permeable to water, and these segments express high levels of AQP-1 in both the apical and basolateral membranes. The vasa recta also are highly permeable to water and express AQP-1. AQP-7 and AQP-8 also are expressed in the proximal tubule. As already discussed, AQP-2 is responsible for arginine vasopressin (AVP)-regulated water movement across the apical membrane of principal cells of the late distal tubule and collecting duct, and AQP-3 and AQP-4 are responsible for water movement across the basolateral membrane.

Mice lacking the AQP-1 gene have been created. These mice have a urine-concentrating defect with increased urine output. Several persons have been found who also lack the normal AQP-1 gene. Interestingly, these persons do not have polyuria. However, when challenged by water deprivation, they are able to concentrate their urine to only approximately half of what is seen in a healthy person.

### Role of Urea

As noted, a hyperosmotic renal medullary interstitium is critically important in concentrating the urine and provides the driving force for reabsorption of water from the collecting duct. The principal solutes within

the renal medullary interstitium are NaCl and urea, but the concentration of these solutes is not uniform throughout the medulla (i.e., a gradient exists from cortex to papilla). Other solutes also accumulate in the medulla (e.g., ammonium [NH<sub>4</sub><sup>+</sup>] and K<sup>+</sup>), but the most abundant solutes are NaCl and urea. For simplicity, this discussion assumes that NaCl and urea are the only solutes.

At the junction of the medulla with the cortex, the interstitial fluid has an osmolality of approximately 300 mOsm/kg H<sub>2</sub>O, with virtually all osmoles attributable to NaCl.\* The concentrations of both NaCl and urea increase progressively with increasing depth into the medulla. When maximally concentrated urine is excreted, the medullary interstitial fluid osmolality is approximately 1200 mOsm/kg H<sub>2</sub>O at the papilla (Figure 5-6, B). Of this value, approximately 600 mOsm/kg H<sub>2</sub>O is attributed to NaCl and 600 mOsm/kg H<sub>2</sub>O is attributed to urea. As described later, NaCl is an effective osmole in the inner medulla and thus is responsible for driving water reabsorption from the medullary collecting duct. The high urea concentration of the medullary interstitial fluid allows this solute to be excreted at a high concentration (600 mmol/L) in a small volume of urine, thus limiting the amount of water that otherwise would be needed to excrete the daily load of urea.†

The medullary gradient for NaCl results from the accumulation of NaCl reabsorbed by the segments of Henle's loop (see the previous discussion). Urea accumulation within the medullary interstitium is more complex and occurs most effectively when hyperosmotic urine is excreted (i.e., antidiuresis). When dilute urine is produced, especially over extended periods,

\*In the presentation that follows, it is assumed that the osmolality of the interstitial fluid of the medulla progressively increases from the corticomedullary junction to the papillary tip. However, based on new anatomic studies, it is likely that more regional variability in interstitial osmolality exists.

†In a person consuming a typical diet, the kidneys must excrete 450 mmol/day of urea. At a maximal urine [urea] of 600 mmol/L, this amount of urea can be excreted in 0.75 L of urine. However, if the maximal urine [urea] is reduced because of a decrease in the medullary interstitial fluid [urea], a larger volume of water would need to be excreted to excrete the 450 mmol/day of urea (e.g., 2.25 L of urine would be required if the maximal urine [urea] was only 200 mmol/L). This would severely restrict the ability of the kidneys to maintain water balance when P<sub>osm</sub> is elevated.

the osmolality of the medullary interstitium declines (compare Figure 5-7, A and B). This reduced osmolality is almost entirely caused by a decrease in the concentration of urea. This decrease reflects washout by the vasa recta (discussed in a later section of this chapter) and diffusion of urea from the interstitium into the tubular fluid within the medullary portion of the collecting duct. (Note: The cortical and outer medullary portions of the collecting duct have a low permeability to urea, whereas the inner medullary portion has a relatively high permeability because of the presence of UT-A1 and UT-A3.)

Urea is not synthesized in the kidney but is generated by the liver as a product of protein metabolism. It enters the tubular fluid via glomerular filtration. Approximately half of this filtered urea is reabsorbed by the proximal tubule. During antidiuresis, water reabsorption by the cortical and outer medullary portions of the collecting duct leads to an increase in the urea concentration of the tubular fluid. When this fluid reaches the portion of the inner medullary collecting duct that express UT-A1 and UT-A3, urea is reabsorbed. The reabsorption of urea is further enhanced by the high levels of AVP, which increase the expression of the UTs. Some of this reabsorbed urea is secreted into thin descending limbs of Henle's loops via UT-A2, and some enters vasa recta via UT-B. The urea that is secreted into the descending thin limbs of Henle's loops is then trapped in the nephron until it again reaches the medullary collecting duct, where it can reenter the medullary interstitium. Thus urea recycles from the interstitium to the nephron and back into the interstitium. This process of recycling facilitates the accumulation of urea in the medullary interstitium, where it can attain a concentration at the tip of the papilla of 600 mmol/L. It is the high concentration of urea in the interstitial fluid that prevents the diffusion of urea out of the lumen of the inner medullary collecting duct into the interstitium, thereby facilitating urea excretion in the urine.

As described, the hyperosmotic medulla is essential for concentrating the tubular fluid within the collecting duct. Because water reabsorption from the collecting duct is driven by the osmotic gradient established in the medullary interstitium, urine can never be more concentrated than that of the interstitial fluid in the papilla. Thus any condition that reduces the medullary

interstitial osmolality impairs the ability of the kidneys to maximally concentrate the urine. However, because the inner medullary collecting duct is highly permeable to urea, especially in the presence of AVP, urea cannot drive water reabsorption across this nephron segment (i.e., urea is an ineffective osmole). Instead, the urea in the tubular fluid and medullary interstitium equilibrate and a small volume of urine with a high concentration of urea is excreted. It is the medullary interstitial NaCl concentration that is responsible for reabsorbing water from the inner medullary collecting duct and thereby concentrating the nonurea solutes (e.g.,  $\text{NH}_4^+$  salts,  $\text{K}^+$  salts, and creatinine) in the urine.

#### AT THE CELLULAR LEVEL

The expression of the urea transporter (UT-A1) in the inner medullary collecting duct is increased by arginine vasopressin (AVP) via a cyclic adenosine monophosphate-mediated mechanism. UT-A1 expression also is increased by hyperosmolality. This effect is mediated by changes in intracellular  $\text{Ca}^{++}$  and protein kinase C activity. Thus the effects of AVP and hyperosmolality are separate and additive. The expression of UT-A3 and UT-A2 also is increased by AVP. Knockout mice have been created that lack the UT-A1/UT-A3 collecting duct transporters, the UT-A2 thin descending limb transporter, or the UT-B vasa recta transporter. All of these animals have some degree of impairment of urinary concentration. Humans with genetic loss of UT-B exhibit a similar urinary concentrating defect as the knockout mouse model.

#### Vasa Recta Function

The **vasa recta**, the capillary networks that supply blood to the medulla, are highly permeable to solute and water. As with the loop of Henle, the vasa recta form a parallel set of hairpin loops within the medulla (see Chapter 2). Not only do the vasa recta bring nutrients and oxygen to the medullary nephron segments but, more importantly, they also remove the water and solute that is continuously added to the medullary interstitium by these nephron segments. The ability of the vasa recta to maintain the medullary interstitial gradient is flow dependent. A substantial increase in

vasa recta blood flow dissipates the medullary gradient. Alternatively, decreased blood flow reduces oxygen delivery to the nephron segments within the medulla. Because transport of salt and other solutes requires oxygen and adenosine triphosphate, reduced medullary blood flow decreases salt and solute transport by nephron segments in the medulla. As a result, the medullary interstitial osmotic gradient cannot be maintained, which also reduces the ability to concentrate the urine.

## ASSESSMENT OF RENAL DILUTING AND CONCENTRATING ABILITY

Assessment of renal water handling includes measurements of urine osmolality and the volume of urine excreted. The range of urine osmolality is from 50 to 1200 mOsm/kg H<sub>2</sub>O. The corresponding range in urine volume is 18 to as little as 0.5 L/day. These ranges are not fixed, but they vary from person to person and, as noted previously, depend on the amount of water ingested and lost from nonrenal routes, as well as the amount of solute excreted.

As emphasized in this chapter, the ability of the kidneys to dilute or concentrate the urine requires the separation of solute and water. This separation of solute and water in essence generates a volume of water that is “free of solute.” When the urine is dilute, **solute-free water** is excreted from the body. When the urine is concentrated, solute-free water is returned to the body (i.e., conserved). The concept of **free water clearance** ( $C_{H_2O}$ ) provides a way to calculate the amount of solute-free water generated by the kidneys, either when dilute urine is excreted or when concentrated urine is formed. As its name denotes,  $C_{H_2O}$  is directly derived from the concept of renal clearance discussed in Chapter 3.

To calculate  $C_{H_2O}$ , the clearance of total solute by the kidneys must be calculated. This clearance of total solute (i.e., osmoles, whether effective or ineffective) from plasma by the kidneys is termed the **osmolar clearance** ( $C_{osm}$ ) and can be calculated as follows:

$$C_{OSM} = \frac{U_{OSM} \times \dot{V}}{P_{OSM}} \quad (5-2)$$

where  $U_{osm}$  is the urine osmolality,  $\dot{V}$  is the urine flow rate, and  $P_{osm}$  is the osmolality of plasma.  $C_{osm}$  has

units of volume/unit time.  $C_{H_2O}$  is then calculated as follows:

$$C_{H_2O} = \dot{V} - C_{osm} \quad (5-3)$$

By rearranging equation 5-3; it should be apparent that

$$\dot{V} = C_{H_2O} + C_{osm} \quad (5-4)$$

In other words, it is possible to partition the total urine output ( $\dot{V}$ ) into two hypothetical components. One component contains all the urine solutes and has an osmolality equal to that of plasma (i.e.,  $U_{osm} = P_{osm}$ ). This volume is defined by  $C_{osm}$  and represents a volume from which there has been no separation of solute and water. The second component is a volume of solute-free water (i.e.,  $C_{H_2O}$ ).

When dilute urine is produced, the value of  $C_{H_2O}$  is positive, indicating that solute-free water is excreted from the body. When concentrated urine is produced, the value of  $C_{H_2O}$  is negative, indicating that solute-free water is retained in the body. By convention, negative  $C_{H_2O}$  values are expressed as  $T^C_{H_2O}$  (**tubular conservation of water**).

Calculating  $C_{H_2O}$  and  $T^C_{H_2O}$  can provide important information about the function of the portions of the nephron involved in producing dilute and concentrated urine. Whether the kidneys excrete or reabsorb free water depends on the presence of AVP. When AVP is absent or AVP levels are low, solute-free water is excreted. When AVP levels are high, solute-free water is reabsorbed.

The following factors are necessary for the kidneys to excrete a maximal amount of solute-free water ( $C_{H_2O}$ ):

1. AVP must be absent. Without AVP, the collecting duct does not reabsorb a significant amount of water.
2. The tubular structures that separate solute from water (i.e., dilute the luminal fluid) must function normally. In the absence of AVP, the following nephron segments can dilute the luminal fluid:
  - Thin ascending limb of Henle’s loop
  - Thick ascending limb of Henle’s loop
  - Distal tubule
  - Collecting duct

Because of its high transport rate, the thick ascending limb is quantitatively the most important of these segments involved in the separation of solute and water.

3. An adequate amount of tubular fluid must be delivered to the aforementioned nephron sites for maximal separation of solute and water. Factors that reduce delivery (e.g., decreased GFR or enhanced proximal tubule reabsorption) impair the kidneys' ability to excrete solute-free water.

Similar requirements also apply to the conservation of water by the kidneys ( $T_{H_2O}^C$ ). For the kidneys to conserve water maximally, the following conditions must exist:

1. An adequate amount of tubular fluid must be delivered to the nephron segments in which separation of solute from water occurs. The important segment in the separation of solute and water is the thick ascending limb of Henle's loop. Delivery of tubular fluid to Henle's loop depends on GFR and proximal tubule reabsorption.
2. Reabsorption of NaCl by the nephron segments must be normal; again, the most important segment is the thick ascending limb of Henle's loop.
3. A hyperosmotic medullary interstitium must be present. The interstitial fluid osmolality is maintained by NaCl reabsorption by Henle's loop (conditions 1 and 2) and by effective accumulation of urea. Urea accumulation in turn depends on adequate dietary protein intake.
4. Maximum levels of AVP must be present and the collecting duct must respond normally to AVP.

### IN THE CLINIC

The concept of free-water clearance as just described does not distinguish between effective and ineffective osmoles, either in the plasma or in the urine. However, urea, which can account for half of total urine osmoles, is not an effective osmole when the movement of water between intracellular fluid and extracellular fluid is considered (see Chapter 1). Accordingly, when one wants to understand how the handling of

water by the kidneys contributes to the maintenance of whole-body water balance, it is more appropriate to consider only the solutes that are effective osmoles. For plasma (i.e., extracellular fluid), the effective osmoles are  $\text{Na}^+$  and its attendant anions. For urine, they are the nonurea solutes.

The importance of using effective osmoles in determining the impact of renal water handling on whole-body water balance (i.e., body fluid osmolality) is illustrated by the following example. A patient has an elevated plasma [urea], and his plasma  $[\text{Na}^+]$  also is increased to 150 mEq/L. His total plasma osmolality (including urea) is 320 mOsm/kg  $\text{H}_2\text{O}$ , but his effective plasma osmolality (calculated as  $2 \times$  plasma  $[\text{Na}^+]$ ) is only 300 mOsm/kg  $\text{H}_2\text{O}$ . His urine osmolality is 600 mOsm/kg  $\text{H}_2\text{O}$ , with 300 mOsm/kg  $\text{H}_2\text{O}$  related to urea and 300 mOsm/kg  $\text{H}_2\text{O}$  related to nonurea solutes. His urinary flow rate is 3 L/day.

According to equations 5-2 and 5-3, his total osmolar clearance ( $C_{\text{OSM}}$ ) and free-water clearance ( $C_{\text{H}_2\text{O}}$ ) are as follows:

$$C_{\text{OSM}} = \frac{600 \text{ mOsm/kg H}_2\text{O} \times 3 \text{ L/day}}{320 \text{ mOsm/kg H}_2\text{O}} = 5.6 \text{ L/day} \quad (5-5)$$

$$C_{\text{H}_2\text{O}} = 3 \text{ L/day} - 5.6 \text{ L/day} = -2.6 \text{ L/day} (T_{\text{H}_2\text{O}}^C) \quad (5-6)$$

Thus it appears that the kidneys are conserving 2.6 L/day of solute-free water, which would be an appropriate response to correct the elevated plasma osmolality. However, when  $C_{\text{OSM}}$  and  $C_{\text{H}_2\text{O}}$  are analyzed from the perspective of effective osmoles, the following results are obtained:

$$C_{\text{OSM}} = \frac{300 \text{ mOsm/kg H}_2\text{O} \times 3 \text{ L/day}}{300 \text{ mOsm/kg H}_2\text{O}} = 3 \text{ L/day} \quad (5-7)$$

$$C_{\text{H}_2\text{O}} = 3 \text{ L/day} - 3 \text{ L/day} = 0 \text{ L/day} \quad (5-8)$$

When viewed from the more appropriate perspective of effective osmoles, it thus is apparent that the kidneys are not reabsorbing solute-free water and the patient's kidneys are not correcting the hyperosmolality.

## S U M M A R Y

1. The osmolality and volume of the body fluids are maintained within a narrow range despite wide variations in water and solute intake. The kidneys play the central role in this regulatory process by virtue of their ability to vary the excretion of water and solutes.
2. Regulation of body fluid osmolality requires that water intake and loss from the body be equal. This process involves the integrated interaction of the AVP secretory and thirst centers of the hypothalamus and the ability of the kidneys to excrete urine that is either hypoosmotic or hyperosmotic with respect to the body fluids.
3. When body fluid osmolality increases, AVP secretion and thirst are stimulated. AVP acts on the kidneys to increase the permeability of the collecting duct to water. Hence water is reabsorbed from the lumen of the collecting duct, and a small volume of hyperosmotic urine is excreted. This renal conservation of water, together with increased water intake, restores body fluid osmolality to normal.
4. When body fluid osmolality decreases, AVP secretion and thirst are suppressed. In the absence of AVP, the collecting duct is impermeable to water and a large volume of hypoosmotic urine is excreted. With this increased excretion of water and a decreased intake of water caused by suppression of thirst, the osmolality of the body fluids is restored to normal.
5. Central to the process of concentrating and diluting the urine is Henle's loop. The transport of NaCl by Henle's loop allows the separation of solute and water, which is essential for the elaboration of hypoosmotic urine. By the same mechanism, the interstitial fluid in the medullary portion of the kidney is rendered hyperosmotic. This hyperosmotic medullary interstitial fluid in turn provides the osmotic driving force for the reabsorption of water from the lumen of the collecting duct when AVP is present.
6. Disorders of water balance result in alterations in body fluid osmolality. Because  $\text{Na}^+$  and its attendant anions ( $\text{Cl}^-$  and  $\text{HCO}_3^-$ ) are the major osmotically active particles in the ECF, changes in body fluid osmolality are manifested by a change in the

plasma  $[\text{Na}^+]$ . Positive water balance (intake > excretion) results in a decrease in the body fluid osmolality and thus hyponatremia. Negative water balance (intake < excretion) results in an increase in body fluid osmolality and thus hypernatremia.

7. The handling of water by the kidneys is quantitated by measuring the amount of solute-free water that is either excreted ( $C_{\text{H}_2\text{O}}$ ) or reabsorbed ( $T_{\text{H}_2\text{O}}^{\text{C}}$ ). Maximal excretion of solute-free water requires normal nephron function (especially the thick ascending limb of Henle's loop), adequate delivery of tubular fluid to the nephrons, and the absence of AVP. Maximal reabsorption of solute-free water requires normal nephron function (especially the thick ascending limb of Henle's loop), adequate delivery of tubular fluid to the nephrons, a hyperosmotic medullary interstitium, the presence of AVP, and responsiveness of the collecting duct to AVP.

## REGULATION OF EXTRACELLULAR FLUID VOLUME AND NaCl BALANCE

---

### OBJECTIVES



6. What are the mechanisms involved in the formation of edema, and what role do the kidneys play in this process?

# T

he major solutes of the extracellular fluid (ECF) are the salts of  $\text{Na}^+$ . Of these, sodium chloride ( $\text{NaCl}$ ) is the most abundant. Because  $\text{NaCl}$  is also the major determinant of ECF osmolality, alterations in  $\text{Na}^+$  balance commonly are assumed to disturb ECF osmolality. However, under normal circumstances, this is not the case because the arginine vasopressin (AVP) and thirst systems maintain body fluid osmolality within a very narrow range. For example, the addition of  $\text{NaCl}$  to the ECF (without water) increases the  $\text{Na}^+$  concentration and osmolality of this compartment (intracellular fluid osmolality also increases because of osmotic equilibration with the ECF) (Figure 6-1). This increase in osmolality in turn stimulates thirst and the release of AVP from the posterior pituitary. The

increased ingestion of water in response to thirst, together with the AVP-induced decrease in water excretion by the kidneys (so-called **antidiuresis**), quickly restores ECF osmolality to normal. However, the volume of the ECF increases in proportion to the amount of water ingested, which in turn depends on the amount of  $\text{NaCl}$  added to the ECF. Thus in the new steady state, the addition of  $\text{NaCl}$  to the ECF is equivalent to adding an isosmotic solution, and the volume of this compartment increases. Conversely, a decrease in the  $\text{NaCl}$  content of the ECF lowers the volume of this compartment (see Figure 6-1). The kidneys are the major route for excretion of  $\text{NaCl}$  from the body. Only about 10% of the  $\text{Na}^+$  lost from the body each day is lost by nonrenal routes (e.g., in perspiration and feces).



**FIGURE 6-1** ■ Impact of changes in  $\text{Na}^+$  balance on the volume of the extracellular fluid (ECF). 1, Addition of sodium chloride (NaCl) (without water) to the ECF increases  $[\text{Na}^+]$  and osmolality. 2, The increase in ECF osmolality stimulates the secretion of arginine vasopressin (AVP) from the posterior pituitary, which then acts on the kidneys to conserve water. 3, Decreased renal excretion of water together with water ingestion restores plasma osmolality and plasma  $[\text{Na}^+]$  to normal. However, the volume of the ECF is now increased by 1 L. 4, Removal of NaCl (without water) from the ECF decreases the plasma  $[\text{Na}^+]$  and plasma osmolality. 5, The decrease in ECF osmolality inhibits AVP secretion. In response to the decrease in plasma AVP, the kidneys excrete water. 6, Increased renal excretion of water returns the plasma  $[\text{Na}^+]$  and plasma osmolality to normal. However, the volume of the ECF is now decreased by 1 L. As illustrated, changes in  $\text{Na}^+$  balance alter the volume of the ECF because of the efficiency of the AVP system in maintaining a normal body fluid osmolality.

Thus the kidneys are critically important in regulating the volume of the ECF. Under normal conditions, the kidneys keep the volume of the ECF constant by adjusting the excretion of NaCl to match the amount ingested in the diet. If ingestion exceeds excretion, ECF volume increases above normal, whereas the opposite occurs if excretion exceeds ingestion.

### IN THE CLINIC

It has been observed that the kidneys excrete sodium chloride (NaCl) more quickly when the NaCl is administered orally versus by an intravenous infusion. This observation has led to the search for factors within the gastrointestinal tract that might modulate the

renal excretion of NaCl. Indeed, neuroendocrine cells that produce the peptide hormones **uroguanylin** and **guanylin** in response to NaCl ingestion have been identified in the intestine. These hormones increase NaCl and water excretion by the kidneys (uroguanylin > guanylin) by inhibiting  $\text{Na}^+$  reabsorption in both the proximal tubule and collecting duct. Interestingly, the kidneys also produce uroguanylin and guanylin, suggesting that they also might play a paracrine role in the intrarenal regulation of NaCl excretion. The potential importance of these peptides in regulating renal NaCl excretion is seen in mice lacking the uroguanylin gene. These mice have a blunted natriuretic response to an oral NaCl load, and they also have increased blood pressure.

The typical diet contains approximately 140 mEq/day of  $\text{Na}^+$  (8 g of NaCl), and thus daily  $\text{Na}^+$  excretion is also about 140 mEq/day. However, the kidneys can vary the excretion of  $\text{Na}^+$  over a wide range. Excretion rates as low as 10 mEq/day can be attained when persons are placed on a low-salt diet. Conversely, the kidneys can increase their excretion rate to more than 1000 mEq/day when challenged by the ingestion of a high-salt diet. These changes in  $\text{Na}^+$  excretion can occur with only modest changes in the ECF volume and steady-state  $\text{Na}^+$  content of the body.

The response of the kidneys to abrupt changes in NaCl intake typically takes several hours to several days, depending on the magnitude of the change. During this transition period, the intake and excretion of  $\text{Na}^+$  are not matched as they are in the steady state. Thus the individual experiences either **positive  $\text{Na}^+$  balance** (intake > excretion) or **negative  $\text{Na}^+$  balance** (intake < excretion). However, by the end of the transition period, a new steady state is established, and intake once again equals excretion. Provided that the AVP and thirst systems are intact and normal, alterations in  $\text{Na}^+$  balance change the volume, but not the  $\text{Na}^+$  concentration, of the ECF. Changes in ECF volume can be monitored by measuring body weight because 1 L of ECF equals 1 kg of body weight.

In this chapter the physiology of the receptors that monitor ECF volume is reviewed and the various signals that act on the kidneys to regulate NaCl excretion and thereby ECF volume are explained. In addition, the responses of the various portions of the nephron to these signals are considered. Finally, the pathophysiologic mechanisms involved in the formation of edema are presented, with emphasis on the role of NaCl handling by the kidneys.

## CONCEPT OF EFFECTIVE CIRCULATING VOLUME

As described in Chapter 1, the ECF is subdivided into two compartments: blood plasma and interstitial fluid. Plasma volume is a determinant of vascular volume and thus blood pressure and cardiac output. The maintenance of  $\text{Na}^+$  balance, and thus ECF volume, involves a complex system of sensors and effector signals that act primarily on the kidneys to regulate the excretion of NaCl. As can be appreciated from the

dependence of vascular volume, blood pressure, and cardiac output on ECF volume, this complex system is designed to ensure adequate tissue perfusion. Because the primary sensors of this system are located in the large vessels of the vascular system, changes in vascular volume, blood pressure, and cardiac output are the principal factors regulating renal NaCl excretion (described later in this chapter).

In a healthy person, changes in ECF volume result in parallel changes in vascular volume, blood pressure, and cardiac output. Thus a decrease in ECF volume, a situation termed **volume contraction**, results in reduced vascular volume, blood pressure, and cardiac output. Conversely, an increase in ECF volume, a situation termed **volume expansion**, results in increased vascular volume, blood pressure, and cardiac output. The degree to which these cardiovascular parameters change depends on the degree of volume contraction or expansion and the effectiveness of cardiovascular reflex mechanisms. When a person is in negative  $\text{Na}^+$  balance, ECF volume is decreased and renal NaCl excretion is reduced. Conversely, with positive  $\text{Na}^+$  balance, an increase in ECF volume occurs, which results in enhanced renal NaCl excretion (i.e., **natriuresis**).

However, in some pathologic conditions (e.g., congestive heart failure and hepatic cirrhosis), the renal excretion of NaCl is not reflective of the ECF volume. In both of these situations, the volume of the ECF is increased. However, instead of increased renal NaCl excretion, as would be expected, a reduction in the renal excretion of NaCl occurs. To explain renal  $\text{Na}^+$  handling in these situations, it is necessary to understand the concept of **effective circulating volume (ECV)**. Unlike the ECF, the ECV is not a measurable and distinct body fluid compartment. The ECV refers to the portion of the ECF that is contained within the vascular system and is “effectively” perfusing the tissues (*effective blood volume* is another commonly used term). More specifically, the ECV reflects the perfusion of those portions of the vascular system that contain the volume sensors (described later in this chapter).

In healthy persons, ECV varies directly with the volume of the ECF and, in particular, the volume of the vascular system (arterial and venous), the arterial blood pressure, and cardiac output. However, as noted, this is not the case in certain pathologic conditions. In the remaining sections of this chapter, the

### IN THE CLINIC

Patients with congestive heart failure frequently have an increase in the volume of the extracellular fluid (ECF), which is manifested as accumulation of fluid in the lungs (**pulmonary edema**) and peripheral tissues (**peripheral edema**). This excess fluid is the result of sodium chloride (NaCl) and water retention by the kidneys. The kidneys' response (i.e., retention of NaCl and water) appears paradoxical because the ECF volume is increased. However, because of poor cardiac performance, perfusion of the portions of the vascular system that contain the volume sensors is reduced (i.e., decreased effective circulating volume). Therefore the volume sensors misinterpret these signals as indicative of ECF volume contraction and respond by increasing NaCl and water retention by the kidneys, thereby exacerbating a vicious cycle of impaired cardiac function and increased NaCl and water reabsorption.

Large volumes of fluid accumulate in the peritoneal cavity of patients with advanced hepatic cirrhosis. This fluid, called **ascites**, is a component of the ECF and results from NaCl and water retention by the kidneys. Again, the response of the kidneys in this situation seems paradoxical if only ECF volume is considered. With advanced hepatic cirrhosis, blood pools in the splanchnic circulation (i.e., the damaged liver impedes the drainage of blood from the splanchnic circulation by the portal vein). Thus volume and pressure are reduced in the portions of the vascular system where the volume sensors are found and, as in the case of congestive heart failure, the volume sensors interpret reduced effective circulating volume as decreased ECF volume and respond accordingly. Hence the kidneys respond as they normally would to ECF volume contraction, resulting in NaCl and water retention and an increase in ECF volume, which results in the accumulation of ascites fluid.

relationship between ECF volume and renal NaCl excretion in healthy adults, where changes in ECV and ECF volume occur in parallel, is examined.

### VOLUME-SENSING SYSTEMS

The ECF volume (or ECV) is monitored by multiple sensors (Box 6-1). A number of the sensors are located in the vascular system, and they monitor its fullness and pressure. These receptors typically are

called volume receptors; because they respond to pressure-induced stretch of the walls of the receptor (e.g., blood vessels or cardiac atria), they also are referred to as baroreceptors (see Chapter 5). The sensors within the liver and central nervous system (CNS) are less well understood and do not seem to be as important as the vascular sensors in monitoring the ECF volume.

#### Volume Sensors in the Low-Pressure Cardiopulmonary Circuit

Volume sensors (i.e., baroreceptors), which are located within the walls of the cardiac atria, right ventricle, and large pulmonary vessels, respond to distention of these structures. Because the low-pressure venous side of the circulatory system has a high compliance, these sensors respond mainly to the “fullness” of the vascular system. These baroreceptors send signals to the brainstem through afferent fibers in the glossopharyngeal and vagus nerves. The activity of these sensors modulates both sympathetic nerve outflow and AVP secretion. For example, a decrease in filling of the pulmonary vessels and cardiac atria increases sympathetic nerve activity and stimulates AVP secretion. Conversely, distention of these structures decreases sympathetic nerve activity. In general, 5% to 10% changes in blood volume and pressure are necessary to evoke a response.

The cardiac atria possess an additional mechanism related to the control of renal NaCl excretion. The

myocytes of the atria synthesize and store a peptide hormone. This hormone, termed **atrial natriuretic peptide (ANP)**, is released when the atria are distended, which, by mechanisms outlined later in this chapter, reduces blood pressure and increases the excretion of NaCl and water by the kidneys. The ventricles of the heart also produce a natriuretic peptide termed **brain natriuretic peptide (BNP)**, so named because it was first isolated from the brain. Like ANP, BNP is released from the ventricular myocytes by distention of the ventricles. Its actions are similar to those of ANP.

### Volume Sensors in the High-Pressure Arterial Circuit

Baroreceptors also are present in the arterial side of the circulatory system; they are located in the wall of the aortic arch, carotid sinus, and afferent arterioles of the kidneys. The aortic arch and carotid baroreceptors send input to the brainstem through afferent fibers in the glossopharyngeal and vagus nerves. The response to this input alters sympathetic outflow and AVP secretion. Thus a decrease in blood pressure increases sympathetic nerve activity and AVP secretion. An increase in pressure tends to reduce sympathetic nerve activity (and activate parasympathetic nerve activity). The sensitivity of the high-pressure baroreceptors is similar to that in the low-pressure side of the vascular system; 5% to 10% changes in pressure are needed to evoke a response.

The **juxtaglomerular apparatus** of the kidneys (see Chapter 2), particularly the afferent arteriole, responds directly to changes in pressure. If perfusion pressure in the afferent arteriole is reduced, renin is released from the myocytes. Renin secretion is suppressed when perfusion pressure is increased. As described later in this chapter, renin determines blood levels of angiotensin II and aldosterone, both of which play an important role in regulating renal NaCl excretion.

Of the two classes of baroreceptors, those on the high-pressure side of the vascular system appear to be more important in influencing sympathetic tone and AVP secretion. For example, patients with congestive heart failure often have an increased vascular volume with dilation of the atria and ventricles, which would be expected to decrease sympathetic tone and inhibit AVP secretion via the low-pressure baroreceptors.

### IN THE CLINIC

Constriction of a renal artery by an atherosclerotic plaque, for example, reduces perfusion pressure to that kidney. This reduced perfusion pressure is sensed by the afferent arteriole of the juxtaglomerular apparatus and results in the secretion of renin. The elevated renin levels increase the production of angiotensin II, which in turn increases systemic blood pressure by its vasoconstrictor effect on arterioles throughout the vascular system. The increased systemic blood pressure is sensed by the juxtaglomerular apparatus of the contralateral kidney (i.e., the kidney without stenosis of its renal artery), and renin secretion from that kidney is suppressed. In addition, the high levels of angiotensin II act to inhibit renin secretion by the contralateral kidney (negative feedback). The treatment of patients with constricted renal arteries includes surgical repair of the stenotic artery, administration of angiotensin II receptor blockers, or administration of an inhibitor of angiotensin-converting enzyme. The angiotensin-converting enzyme inhibitor blocks the conversion of angiotensin I to angiotensin II.

However, sympathetic tone often is increased and AVP secretion often is stimulated in these patients (the renin-angiotensin-aldosterone system also is activated). This phenomenon reflects the activation of baroreceptors in the high-pressure arterial circuit in response to reduced blood pressure and cardiac output secondary to the failing heart (i.e., the high-pressure baroreceptors detect a reduced ECV and misinterpret this signal as indicative of reduced ECF volume).

### Hepatic Sensors

The liver also contains volume sensors that can modulate renal NaCl excretion, although they are not as important as the vascular sensors. One type of hepatic sensor responds to pressure within the hepatic vasculature and therefore functions in a manner similar to the baroreceptors in the low- and high-pressure vascular circuits. A second type of sensor also appears to exist in the liver. This sensor responds to  $[Na^+]$  of the portal blood entering the liver. Afferent signals from

both types of sensors are sent to the same area of the brainstem where afferent fibers from both the low- and high-pressure circuit baroreceptors converge. Increased pressure within the hepatic vasculature or an increase in portal blood  $[Na^+]$  results in a decrease in efferent sympathetic nerve activity.\* As described later in this chapter, this decreased sympathetic nerve activity leads to an increase in renal NaCl excretion.

### Central Nervous System $Na^+$ Sensors

As with the hepatic sensors, the CNS sensors do not appear to be as important as the vascular sensors in monitoring the ECF volume and controlling renal NaCl excretion. Nevertheless, alterations in the  $[Na^+]$  of blood carried to the brain in the carotid arteries or the  $[Na^+]$  of the cerebrospinal fluid modulate renal NaCl excretion. For example, if the  $[Na^+]$  in either the carotid artery blood or the cerebrospinal fluid is increased, a decrease in renal sympathetic nerve activity occurs, which in turn leads to an increase in renal NaCl excretion. The hypothalamus appears to be the site where these sensors are located. Angiotensin II and natriuretic peptides are generated in the hypothalamus. These locally generated signals, together with systemically generated angiotensin II and natriuretic peptides, appear to play a role in modulating the CNS  $Na^+$ -sensing system.

Of the volume and  $Na^+$  sensors just described, those located in the vascular system are better understood. Moreover, their function in health and disease explains quite effectively the regulation of renal NaCl excretion. Therefore the remainder of this chapter focuses on the vascular volume sensors (i.e., baroreceptors) and their role in regulating renal NaCl excretion.

### Volume Sensor Signals

When the vascular volume sensors have detected a change in ECV, which under normal conditions reflects ECF volume, they send signals to the kidneys, which result in appropriate adjustments in NaCl and

\*The hepatic sensors also appear to be involved in the regulation of gastrointestinal NaCl absorption. For example, when  $[Na^+]$  of the portal vein blood is increased, a reflex reduction in jejunal NaCl absorption occurs.

water excretion. Accordingly, when the ECF volume is expanded, renal NaCl and water excretion are increased. Conversely, when the ECF volume is contracted, renal NaCl and water excretion are reduced. The signals involved in coupling the volume sensors to the kidneys are both neural and hormonal. These signals are summarized in Box 6-2, as are their effects on renal NaCl and water excretion.

### Renal Sympathetic Nerves

As described in Chapter 2, sympathetic nerve fibers innervate the afferent and efferent arterioles of the

glomerulus, as well as the nephron cells. With negative  $\text{Na}^+$  balance (i.e., ECF volume contraction), baroreceptors in both the low- and high-pressure vascular circuits stimulate the sympathetic input to the kidneys. This stimulation has the following effects:

1. The afferent and efferent arterioles constrict in response to  $\alpha$ -adrenergic stimulation. This vasoconstriction predominantly affects the afferent arteriole, effectively reducing hydrostatic pressure within the glomerular capillary lumen and decreasing glomerular filtration. The resulting reduction in the glomerular filtration rate (GFR) reduces the filtered load of  $\text{Na}^+$  to the nephrons.
2. Renin secretion is stimulated by the cells of the afferent arterioles in response to  $\beta$ -adrenergic receptor stimulation. As described later, renin ultimately increases the circulating levels of angiotensin II and aldosterone.
3.  $\text{NaCl}$  reabsorption along the nephron is directly stimulated by  $\alpha$ -adrenergic stimulation, effectively reducing the fraction of filtered  $\text{Na}^+$  that is ultimately excreted. Quantitatively, the most important segment influenced by sympathetic nerve activity is the proximal tubule.

As a result of these combined actions, increased renal sympathetic nerve activity decreases net  $\text{NaCl}$  excretion, an adaptive response that works to restore ECF volume to normal, which is a state termed **euvolemia**. With positive  $\text{Na}^+$  balance (i.e., ECF volume expansion), renal sympathetic nerve activity is reduced, which generally reverses the effects just described.

### Renin-Angiotensin-Aldosterone System

Cells in the afferent arterioles (**juxtaglomerular cells**) are the site of synthesis, storage, and release of the proteolytic enzyme renin. Three factors are important in stimulating renin secretion:

1. *Perfusion pressure.* When perfusion pressure to the kidneys is reduced, renin secretion by the afferent arteriole is stimulated. Conversely, an increase in perfusion pressure inhibits renin release by the afferent arteriole.

### AT THE CELLULAR LEVEL

A new “renal hormone” has been discovered recently, a flavin adenine dinucleotide-dependent amine oxidase named **renalase**. Renalase is similar in structure to monoamine oxidase and breaks down catecholamines (e.g., epinephrine and norepinephrine). Several tissues (e.g., skeletal muscle, heart, and small intestine) express renalase, but the kidneys secrete the enzyme into the circulation. Because persons with chronic renal failure have very low levels of renalase in their plasma, the kidney is probably the primary source of the circulating enzyme. In experimental animals, infusion of renalase decreases blood pressure and heart contractility. Although the precise role of renalase in cardiovascular function and blood pressure regulation is not known, it may be important in modulating the effects of the sympathetic nervous system and especially the effects of the sympathetic nerves on the kidney.

2. *Sympathetic nerve activity.* Activation of the sympathetic nerve fibers that innervate the afferent arterioles increases renin secretion via  $\beta$ -adrenergic receptor stimulation. Renin secretion is decreased as renal sympathetic nerve activity is decreased.
3. *Delivery of  $\text{NaCl}$  to the macula densa.* Delivery of  $\text{NaCl}$  to the macula densa regulates the GFR by a process termed **tubuloglomerular feedback** (see Chapter 3). In addition, the macula densa plays a role in renin secretion. When  $\text{NaCl}$  delivery to the macula densa is decreased, renin secretion is enhanced. Conversely, an increase in  $\text{NaCl}$  delivery inhibits renin secretion. It is likely that macula densa-mediated renin secretion helps to maintain systemic arterial pressure under conditions of a reduced intravascular volume. For example, when intravascular volume is reduced, perfusion of body tissues (including the kidneys) decreases, which in turn decreases the GFR and the filtered amount of  $\text{NaCl}$ . The reduced delivery of  $\text{NaCl}$  to the macula densa then stimulates renin secretion, which acts through angiotensin II (a potent vasoconstrictor) to increase the blood pressure and thereby maintain tissue perfusion.


### AT THE CELLULAR LEVEL

Although many tissues express renin (e.g., brain, heart, and adrenal gland tissues), the primary source of circulating renin is the kidneys. Renin is secreted by juxtaglomerular cells located in the afferent arteriole. At the cellular level, renin secretion is mediated by the fusion of renin-containing granules with the luminal membrane of the cell. This process is stimulated by a *decrease* in intracellular  $[Ca^{++}]$ , a response opposite to that of most secretory cells where secretion is normally stimulated by an *increase* in intracellular  $[Ca^{++}]$ . Renin release is also stimulated by an increase in intracellular cyclic adenosine monophosphate levels. Thus anything that increases intracellular  $[Ca^{++}]$  inhibits renin secretion, which includes stretch of the afferent arteriole (myogenic control of renin secretion), angiotensin II (feedback inhibition), and endothelin. Conversely, anything that increases intracellular cyclic adenosine monophosphate stimulates renin secretion, which includes norepinephrine acting through  $\beta$ -adrenergic receptors and prostaglandin  $E_2$ .

Increases in intracellular cyclic guanosine monophosphate have been shown to stimulate renin secretion in some situations and to inhibit secretion in others. Notably, two substances that increase intracellular cyclic guanosine monophosphate are natriuretic peptides and nitric oxide. Nitric oxide stimulates renin secretion, whereas atrial natriuretic peptide and brain natriuretic peptide are inhibitory. The control of renin secretion by the macula densa (see Chapter 3) may involve paracrine factors such as prostaglandin  $E_2$  (which stimulates renin secretion when NaCl delivery to the macula densa is decreased) and adenosine (which inhibits renin secretion when NaCl delivery to the macula densa is increased).

Figure 6-2 summarizes the essential components of the renin-angiotensin-aldosterone system. Renin alone does not have a physiological function; it functions as a proteolytic enzyme. Its principal substrate is a circulating protein, **angiotensinogen**, which is

produced by the liver. Angiotensinogen is cleaved by renin to yield a 10-amino-acid peptide, **angiotensin I**. Angiotensin I also has no known physiological function, and it is further cleaved to an 8-amino-acid peptide, **angiotensin II**, by a converting enzyme (**angiotensin-converting enzyme [ACE]**) found on the surface of vascular endothelial cells. Pulmonary and renal endothelial cells are important sites for the bioconversion of angiotensin I to angiotensin II. ACE also degrades bradykinin, a potent vasodilator. Angiotensin II has several important physiologic functions, including:

1. Stimulation of aldosterone secretion by the adrenal cortex
2. Arteriolar vasoconstriction, which increases blood pressure
3. Stimulation of AVP secretion and thirst
4. Enhancement of NaCl reabsorption by the proximal tubule, thick ascending limb of Henle's loop, the distal tubule, and even the collecting duct; of these segments, the effect on the proximal tubule is quantitatively the largest

Angiotensin II is an important secretagogue for **aldosterone**. An increase in the plasma  $K^+$  concentration is the other important stimulus for aldosterone secretion (see Chapter 7). Aldosterone is a steroid hormone produced by the glomerulosa cells of the adrenal cortex. Aldosterone acts in a number of ways on the kidneys (see Chapter 4). With regard to the regulation of the ECF volume, aldosterone reduces NaCl excretion by stimulating its reabsorption by the thick ascending limb of the loop of Henle, portions of the distal tubule, and the collecting duct. (The portions of the distal tubule that functionally respond to aldosterone together with the collecting duct are referred to as the **aldosterone-sensitive distal nephron [ASDN]**.) The effect of aldosterone on renal NaCl excretion depends mainly on its ability to stimulate  $Na^+$  reabsorption in the ASDN.

Aldosterone has many cellular actions in cells of the ASDN (see Chapter 4 for details). Notably, it increases the abundance of the apical membrane  $Na^+Cl^-$  symporter in the cells of the distal tubule (DCT2 segment; see previous At the Cellular Level box) and the abundance of the epithelial  $Na^+$  channel in the

### AT THE CELLULAR LEVEL

The distal tubule can be divided into three distinct segments based on the presence of specific membrane transporters. The first segment after the macula densa (DCT1) expresses a  $Na^+Cl^-$  symporter, which is specifically inhibited by the thiazide class of diuretics (see Chapter 10). The next segment (DCT2) expresses the  $Na^+Cl^-$  symporter and the epithelial  $Na^+$  channel. The last segment of the distal tubule (connecting tubule), like the collecting duct, expresses only the epithelial  $Na^+$  channel.

Aldosterone selectivity and sensitivity are conferred by the presence of mineralocorticoid receptors, as well as the presence of the enzyme **11 $\beta$ -hydroxysteroid dehydrogenase 2** (11 $\beta$ -HSD2). Because the mineralocorticoid receptor also binds glucocorticoids, 11 $\beta$ -HSD2 is required for aldosterone specificity because it metabolizes glucocorticoids and thus prevents them from binding to the mineralocorticoid receptor. The mineralocorticoid receptor is found throughout the distal tubule and collecting duct. However, 11 $\beta$ -HSD2 is only found in the DCT2, the connecting tubule, and collecting duct. Thus the aldosterone-sensitive distal nephron consists of the DCT2 and connecting tubule (collectively termed the late distal tubule) and the collecting duct. Accordingly, the DCT1 segment is referred to as the early distal tubule.

apical membrane of principal cells in the late portion of the distal tubule and collecting duct. By this action,  $Na^+$  entry into the cells across the apical membrane is increased. Extrusion of  $Na^+$  from the cell across the basolateral membrane occurs via the  $Na^+K^+$ -adenosine triphosphatase (ATPase) pump, the abundance of which is also increased by aldosterone. Thus aldosterone increases net reabsorption of  $Na^+$  from the tubular fluid by ASDN segments, and reduced levels of aldosterone decrease the amount of  $Na^+$  reabsorbed by these segments.

As noted, aldosterone also enhances  $Na^+$  reabsorption by cells of the thick ascending limb of the loop of Henle. This action probably reflects increased entry of  $Na^+$  into the cell across the apical membrane (probably by the apical membrane  $Na^+K^+2Cl^-$  symporter) and increased extrusion from the cell by the basolateral membrane  $Na^+K^+$ -ATPase pump.

### IN THE CLINIC

Diseases of the adrenal cortex can alter aldosterone levels and thereby impair the ability of the kidneys to maintain  $\text{Na}^+$  balance and euolemia. With decreased secretion of aldosterone (hypoaldosteronism), the reabsorption of  $\text{Na}^+$  by the aldosterone-sensitive distal nephron (late distal tubule and collecting duct) is reduced, and sodium chloride ( $\text{NaCl}$ ) is lost in the urine. Because urinary  $\text{NaCl}$  loss can exceed the amount of  $\text{NaCl}$  ingested in the diet, negative  $\text{Na}^+$  balance ensues, and the extracellular fluid (ECF) volume decreases. In response to the ensuing ECF volume contraction, sympathetic tone is increased, and levels of renin, angiotensin II, and arginine vasopressin are elevated. With increased aldosterone secretion (hyperaldosteronism), the opposite effects are observed:  $\text{Na}^+$  reabsorption by the aldosterone-sensitive distal nephron is enhanced and excretion of  $\text{NaCl}$  is reduced. Consequently, ECF volume is increased, sympathetic tone is decreased, and the levels of renin, angiotensin II, and arginine vasopressin are decreased. As described later in this chapter, atrial natriuretic peptide and brain natriuretic peptide levels also are elevated in this setting.

As summarized in **Box 6-2**, activation of the renin-angiotensin-aldosterone system, as occurs with ECF volume depletion, decreases the excretion of  $\text{NaCl}$  by the kidneys. Conversely, this system is suppressed by ECF volume expansion, thereby enhancing renal  $\text{NaCl}$  excretion.

### Natriuretic Peptides


The body produces a number of substances, including ANP and BNP, that act on the kidneys to increase  $\text{Na}^+$  excretion.\* Of these substances, natriuretic

\*Uroguanylin and adrenomedullin are two additional examples of these substances. Uroguanylin increases renal  $\text{NaCl}$  excretion and may serve to regulate the renal excretion of ingested  $\text{NaCl}$ . Adrenomedullin is produced by many tissues, including the heart, kidneys, and the adrenal medulla (from whence its name is derived). It is secreted in response to a number of factors (e.g., cytokines, angiotensin II, endothelin, and increased shear stress on endothelial cells). Although structurally distinct from ANP and BNP, its actions are similar in that it reduces blood pressure, increases GFR, suppresses angiotensin II-induced secretion of aldosterone, and causes increased  $\text{NaCl}$  excretion.

peptides produced by the heart and kidneys are best understood and are the focus of the following discussion.

The heart produces two natriuretic peptides. Atrial myocytes primarily produce and store the peptide hormone ANP, and ventricular myocytes primarily produce and store BNP. Both peptides are secreted in response to myocardial wall stretch (i.e., during cardiac dilatation that accompanies volume expansion and/or heart failure), and they act to relax vascular smooth muscle and promote  $\text{NaCl}$  and water excretion by the kidneys. The kidneys also produce a related natriuretic peptide termed **urodilatin**. Its actions are limited to promoting  $\text{NaCl}$  excretion by the kidneys. In general, the actions of these natriuretic peptides, as they relate to renal  $\text{NaCl}$  and water excretion, antagonize those of the renin-angiotensin-aldosterone system. Natriuretic peptide actions include:

1. Afferent arteriolar vasodilation and efferent arteriolar vasoconstriction within the glomerulus, which increases the GFR and the filtered amount of  $\text{Na}^+$ .
2. Inhibition of renin secretion by the juxtaglomerular cells of the afferent arterioles.
3. Inhibition of aldosterone secretion by the glomerulosa cells of the adrenal cortex. This inhibition occurs by two mechanisms: (1) inhibition of renin secretion by the juxtaglomerular cells, thereby reducing angiotensin II-induced aldosterone secretion, and (2) direct inhibition of aldosterone secretion by the glomerulosa cells of the adrenal cortex.
4. Inhibition of  $\text{NaCl}$  reabsorption by the collecting duct, which also is caused in part by reduced levels of aldosterone. However, the natriuretic peptides also act directly on the collecting duct cells. Through the second messenger, cyclic guanosine monophosphate, natriuretic peptides inhibit  $\text{Na}^+$  channels in the apical membrane and thereby decrease  $\text{Na}^+$  reabsorption. This effect occurs predominantly in the medullary portion of the collecting duct.
5. Inhibition of AVP secretion by the posterior pituitary and AVP action on the collecting duct. These effects decrease water reabsorption by the collecting duct and thus increase excretion of water in the urine.

These effects of the natriuretic peptides increase the net excretion of NaCl and water by the kidneys. Hypothetically, a reduction in the circulating levels of these peptides would be expected to decrease NaCl and water excretion, but convincing evidence for this effect has not been reported.

### Arginine Vasopressin

As discussed in Chapter 5, a decreased ECF volume stimulates AVP secretion by the posterior pituitary. The elevated levels of AVP decrease water and NaCl excretion by the kidneys, which serve to reestablish euvoemia.


## CONTROL OF RENAL NaCl EXCRETION DURING EUVOLEMIA

The maintenance of Na<sup>+</sup> balance and therefore euvoemia requires the precise matching of the amount of NaCl ingested and the amount excreted from the body. As already noted, the kidneys are the major route for NaCl excretion. Accordingly, in a euvoemic person, we can equate daily urine NaCl excretion with daily NaCl intake.

The amount of NaCl excreted by the kidneys can vary widely. Under conditions of salt restriction (i.e., a low NaCl diet), virtually no Na<sup>+</sup> appears in the urine.

Conversely, in persons who ingest large quantities of NaCl, renal Na<sup>+</sup> excretion can exceed 1000 mEq/day. The kidneys require several days to respond maximally to variations in dietary NaCl intake. During the transition period, excretion does not match intake, and the person is in either positive (intake > excretion) or negative (intake < excretion) Na<sup>+</sup> balance. This phenomenon is illustrated in Figure 6-3. When Na<sup>+</sup> balance is altered during these transition periods, the ECF volume changes in parallel. Water excretion, regulated by AVP, also is adjusted to keep plasma osmolality constant, effectively resulting in isosmotic changes in ECF volume. Thus with positive Na<sup>+</sup> balance, the ECF volume expands, whereas with negative Na<sup>+</sup> balance, the ECF volume contracts (see Figure 6-1). In both cases no change in plasma [Na<sup>+</sup>] occurs. These changes in ECF volume can be detected by monitoring changes in body weight. Ultimately, renal excretion reaches a new steady state and NaCl excretion once again is matched to intake. The time course for the adjustment of renal NaCl excretion varies (from hours to days) and depends on the magnitude of the change in NaCl intake. Adaptation to large changes in NaCl intake requires a longer time than adaptation to small changes in intake.

The general features of Na<sup>+</sup> handling along the nephron must be understood to comprehend how renal Na<sup>+</sup> excretion is regulated. (See Chapter 4 for the

cellular mechanisms of Na<sup>+</sup> transport along the nephron.) Most (67%) of the filtered amount of Na<sup>+</sup> is reabsorbed by the proximal tubule. An additional 25% is reabsorbed by the thick ascending limb of the loop of Henle, and the remainder is largely reabsorbed by the distal tubule and collecting duct (Figure 6-4).

In a normal adult, the filtered amount of Na<sup>+</sup> is approximately 25,000 mEq/day.

$$\begin{aligned} \text{Filtered amount of Na}^+ &= (\text{GFR})(\text{plasma [Na}^+]) \\ &= (180 \text{ L/day})(140 \text{ mEq/L}) \\ &= 25,200 \text{ mEq/day} \end{aligned} \quad (6-1)$$

With a typical diet, less than 1% of this filtered amount is excreted in the urine (approximately 140 mEq/day).<sup>\*</sup> Because of the large amount of filtered Na<sup>+</sup>, small changes in Na<sup>+</sup> reabsorption by the nephron can profoundly affect Na<sup>+</sup> balance and thus the volume of the ECF. For example, an increase in Na<sup>+</sup>

excretion from 1% to 3% of the filtered amount represents an additional loss of approximately 500 mEq/day of Na<sup>+</sup>. Because the ECF Na<sup>+</sup> concentration is 140 mEq/L, such an Na<sup>+</sup> loss would decrease the ECF volume by more than 3 L (i.e., water excretion would parallel the loss of Na<sup>+</sup> to maintain body fluid osmolality constant:  $[500 \text{ mEq/day}]/[140 \text{ mEq/L}] = 3.6 \text{ L/day}$  of fluid loss). Such fluid loss in a person weighing 70 kg would represent a 26% decrease in the ECF volume (see Chapter 1).

In euvolemic subjects, the nephron segments distal to the loop of Henle, namely the distal tubule and collecting duct, are the main nephron segments where Na<sup>+</sup> reabsorption is adjusted to maintain excretion at a level appropriate for dietary intake. However, this does not mean that the other portions of the nephron are not involved in this process. Because the reabsorptive capacity of the distal tubule and collecting duct is limited, the upstream segments of the nephron (i.e., the proximal tubule and loop of Henle) must reabsorb the bulk of the filtered amount of Na<sup>+</sup>. Thus during euvoemia, Na<sup>+</sup> handling by the nephron can be explained by two general processes:

1. Na<sup>+</sup> reabsorption by the proximal tubule and loop of Henle is regulated so that a relatively constant portion of the filtered amount of Na<sup>+</sup> is delivered to the distal tubule. The combined action of the proximal tubule and loop of Henle reabsorbs approximately 92% of the filtered amount of Na<sup>+</sup>, and thus 8% of the filtered amount is delivered to the distal tubule.
2. Reabsorption of this remaining portion of the filtered amount of Na<sup>+</sup> by the distal tubule and collecting duct is regulated so that the amount of Na<sup>+</sup> excreted in the urine closely matches the amount ingested in the diet at steady state. Thus these later nephron segments make final adjustments in Na<sup>+</sup> excretion to maintain the euvolemic state.

### Mechanisms for Maintaining Constant Na<sup>+</sup> Delivery to the Distal Tubule

A number of mechanisms maintain delivery of a constant fraction of the filtered amount of Na<sup>+</sup> to the beginning of the distal tubule. These processes are

<sup>\*</sup>The percentage of the filtered amount excreted in the urine is termed fractional excretion (amount excreted/amount filtered). In this example, the fractional excretion of Na<sup>+</sup> is  $140 \text{ mEq/day} \div 25,200 \text{ mEq/day} = 0.005$ , or 0.5%.

autoregulation of the GFR (a mechanism that keeps the filtered amount of  $\text{Na}^+$  constant), glomerulotubular balance, and load dependence of  $\text{Na}^+$  reabsorption by the loop of Henle.

Autoregulation of the GFR (see Chapter 3) allows maintenance of a relatively constant filtration rate over a wide range of perfusion pressures. Because the filtration rate is constant, the delivery of filtered  $\text{Na}^+$  to the nephrons also is kept constant. Despite the autoregulatory control of the GFR, small variations in GFR occur. If these changes were not compensated for by an appropriate adjustment in  $\text{Na}^+$  reabsorption by the nephron,  $\text{Na}^+$  excretion would change markedly. Fortunately,  $\text{Na}^+$  reabsorption in the euvolemic state, especially by the proximal tubule, changes in parallel with changes in the GFR. This phenomenon is termed **glomerulotubular (G-T) balance** (see Chapter 4). Thus if the GFR increases, the amount of  $\text{Na}^+$  reabsorbed by the proximal tubule increases proportionately. The opposite occurs if the GFR decreases.

The final mechanism that helps maintain the constant delivery of  $\text{Na}^+$  to the beginning of the collecting duct involves the ability of the loop of Henle to increase its reabsorptive rate in response to increased delivery of  $\text{Na}^+$ .

### Regulation of Distal Tubule and Collecting Duct $\text{Na}^+$ Reabsorption

When delivery of  $\text{Na}^+$  is constant, small adjustments in distal tubule and, to a lesser degree, collecting duct  $\text{Na}^+$  reabsorption are sufficient to balance excretion with intake. (As already noted, as little as a 2% change in fractional  $\text{Na}^+$  excretion produces more than a 3 L change in the volume of the ECF.) Aldosterone is the primary regulator of  $\text{Na}^+$  reabsorption by the distal tubule and collecting duct and thus of  $\text{Na}^+$  excretion under this condition. When aldosterone levels are elevated,  $\text{Na}^+$  reabsorption by these segments is increased (excretion is decreased). When aldosterone levels are decreased,  $\text{Na}^+$  reabsorption is decreased (excretion is increased).

In addition to aldosterone, a number of other factors, including natriuretic peptides, prostaglandins, uroguanylin, adrenomedullin, and sympathetic nerves, alter  $\text{Na}^+$  reabsorption by the distal tubule

and collecting duct. However, the relative effects of these other factors on the regulation of  $\text{Na}^+$  reabsorption by these segments during euvoemia are unclear.

As long as variations in the dietary intake of NaCl are minor, the mechanisms previously described can regulate renal  $\text{Na}^+$  excretion appropriately and thereby maintain euvoemia. However, these mechanisms cannot effectively handle significant changes in NaCl intake. When NaCl intake changes significantly, ECF volume expansion or ECF volume contraction occurs. In such cases, additional factors are invoked to act on the kidneys to adjust  $\text{Na}^+$  excretion and thereby reestablish the euvolemic state.

The excretion rate of  $\text{Na}^+$  by the kidneys can be quantitated in the following way:

$$U_{\text{Na}^+} \times \dot{V} = \text{GFR} \times P_{\text{Na}^+} - R \quad (6-2)$$


where  $U_{\text{Na}^+} \times \dot{V}$  is the excretion rate in mEq/time ( $U_{\text{Na}^+}$  is the urine  $[\text{Na}^+]$  and  $\dot{V}$  is the urine flow rate),  $\text{GFR} \times P_{\text{Na}^+}$  is the filtered amount of  $\text{Na}^+$  (GFR is the glomerular filtration rate and  $P_{\text{Na}^+}$  is the plasma  $[\text{Na}^+]$ ), and  $R$  is the amount of  $\text{Na}^+$  reabsorbed by the nephron.

### CONTROL OF $\text{Na}^+$ EXCRETION WITH VOLUME EXPANSION

During ECF volume expansion, baroreceptors in both the high- and low-pressure vascular circuits send signals to the kidneys. These signals result in increased excretion of NaCl and water. The signals acting on the kidneys include:

1. Decreased activity of the renal sympathetic nerves
2. Increased release of ANP and BNP from the heart and urodilatin by the kidneys
3. Inhibition of AVP secretion from the posterior pituitary and decreased AVP action on the collecting duct
4. Decreased renin secretion and thus decreased production of angiotensin II
5. Decreased aldosterone secretion, which is a consequence of reduced angiotensin II levels, and elevated natriuretic peptide levels

The integrated response of the nephron to these signals is illustrated in Figure 6-5. Three general

responses to ECF volume expansion occur (the numbers correlate with those circled in Figure 6-5):

1. *The GFR increases.* The GFR increases mainly as a result of the decrease in sympathetic nerve activity. Sympathetic fibers innervate the afferent and efferent arterioles of the glomerulus and control their diameter. Decreased sympathetic nerve activity leads to arteriolar dilation. Because afferent arteriolar dilation is greater than efferent dilation, the hydrostatic pressure within the glomerular capillary is increased, thereby increasing the filtration pressure and the GFR. Note that the corresponding filtration fraction decreases

because the renal plasma flow increases to a greater degree than the GFR. Natriuretic peptides, which are increased during ECF volume expansion, also promote an increase in GFR via differential direct effects on the afferent (vasodilation) and efferent (vasoconstriction) arterioles. With the increase in the GFR, the filtered amount of  $Na^+$  increases.

2. *The reabsorption of  $Na^+$  decreases in the proximal tubule and loop of Henle.* Several mechanisms act to reduce  $Na^+$  reabsorption by the proximal tubule, but the precise role of each of these mechanisms remains unresolved. Because activation of the sympathetic nerve fibers that innervate this nephron

segment stimulates  $\text{Na}^+$  reabsorption, the decreased sympathetic nerve activity that results from ECF volume expansion decreases  $\text{Na}^+$  reabsorption. In addition, angiotensin II directly stimulates  $\text{Na}^+$  reabsorption by the proximal tubule. Because angiotensin II levels also are reduced by ECF volume expansion, proximal tubule  $\text{Na}^+$  reabsorption decreases accordingly. Increased hydrostatic pressure within the glomerular capillaries also increases the hydrostatic pressure within the peritubular capillaries. In addition, the decrease in filtration fraction reduces the peritubular oncotic pressure. These alterations in the capillary Starling forces reduce the absorption of solute (e.g., NaCl) and water from the lateral intercellular space and thus reduce proximal tubular reabsorption. (See Chapter 4 for a complete description of this mechanism.) Both the increase in the filtered amount of NaCl and the decrease in NaCl reabsorption by the proximal tubule result in the delivery of more NaCl to the loop of Henle. Because activation of the sympathetic nerves and aldosterone stimulate NaCl reabsorption by the loop of Henle, the reduced nerve activity and low aldosterone levels that occur with ECF volume expansion serve to reduce NaCl reabsorption by this nephron segment. Thus the fraction of the filtered amount delivered to the distal tubule is increased.

3.  *$\text{Na}^+$  reabsorption decreases in the distal tubule and collecting duct.* As noted, the amount of  $\text{Na}^+$  delivered to the distal tubule exceeds that observed in the euvolemic state (the amount of  $\text{Na}^+$  delivered to the distal tubule varies in proportion to the degree of ECF volume expansion). This increased amount of delivered  $\text{Na}^+$  can overwhelm the reabsorptive capacity of the distal tubule and the collecting duct, an effect heightened by the reduced reabsorptive capacity of these segments associated with increased circulating natriuretic peptides and decreased circulating aldosterone levels.

The final component in the response to ECF volume expansion is the excretion of water. As  $\text{Na}^+$  excretion increases, plasma osmolality begins to fall, which decreases the secretion of AVP. AVP secretion also is decreased in response to the elevated levels of natriuretic peptides. In addition, these natriuretic peptides inhibit the action of AVP on the collecting

duct. Together, these effects decrease water reabsorption by the collecting duct and thereby increase water excretion by the kidneys. Thus the excretion of  $\text{Na}^+$  and water occur in concert; euvoemia is restored, and body fluid osmolality remains constant. The time course of this response (hours to days) depends on the magnitude of the ECF volume expansion. Thus if the degree of ECF volume expansion is small, the mechanisms just described generally restore euvoemia within 24 hours. However, with larger degrees of ECF volume expansion, the response can take several days.

In brief, the renal response to ECF volume expansion involves the integrated action of all parts of the nephron: (1) the filtered amount of  $\text{Na}^+$  is increased, (2) the proximal tubule and loop of Henle reabsorption is reduced (the glomerular filtration rate is increased and proximal reabsorption is decreased, and thus G-T balance does not occur under this condition), and (3) the delivery of  $\text{Na}^+$  to the distal tubule is increased. This increased delivery, along with the inhibition of distal tubule and collecting duct reabsorption, results in the excretion of a larger fraction of the filtered amount of  $\text{Na}^+$  and thus restores euvoemia.


## CONTROL OF $\text{Na}^+$ EXCRETION WITH VOLUME CONTRACTION

During ECF volume contraction, volume sensors in both the high- and low-pressure vascular circuits send signals to the kidneys that reduce NaCl and water excretion. The signals that act on the kidneys include:

1. Increased renal sympathetic nerve activity
2. Increased secretion of renin, which results in elevated angiotensin II levels and thus increased secretion of aldosterone by the adrenal cortex
3. Stimulation of AVP secretion by the posterior pituitary

The integrated response of the nephron to these signals is illustrated in [Figure 6-6](#). The general response is as follows (the numbers correlate with those circled in [Figure 6-6](#)):

1. *The GFR decreases.* Afferent and efferent arteriolar constriction occurs as a result of increased renal

sympathetic nerve activity. The effect is greater on the afferent than on the efferent arteriole. This vasoconstriction causes the hydrostatic pressure in the glomerular capillary to fall and thereby decreases the GFR. The filtration fraction increases because the renal plasma flow decreases more than the GFR, but the absolute decrease in the GFR reduces the filtered load of  $Na^+$ .

2.  $Na^+$  reabsorption by the proximal tubule and loop of Henle is increased. Several mechanisms augment  $Na^+$  reabsorption in the proximal tubule. For example, increased sympathetic nerve activity and angiotensin II levels directly stimulate  $Na^+$  reabsorption. The decreased hydrostatic

pressure within the glomerular capillaries also leads to a decrease in the hydrostatic pressure within the peritubular capillaries. In addition, the increased filtration fraction results in an increase in the peritubular oncotic pressure. These alterations in the capillary Starling forces facilitate the movement of fluid from the lateral intercellular space into the capillary and thereby stimulate the reabsorption of solute (e.g.,  $NaCl$ ) and water by the proximal tubule. (See Chapter 4 for a complete description of this mechanism). The reduced amount of filtered  $Na^+$  and enhanced proximal tubule reabsorption decrease the delivery of  $Na^+$  to the loop of Henle. Increased

sympathetic nerve activity, as well as elevated levels of angiotensin II and aldosterone, stimulate  $\text{Na}^+$  reabsorption by the thick ascending limb. Because sympathetic nerve activity is increased and angiotensin II and aldosterone levels are elevated during ECF volume contraction, increased  $\text{Na}^+$  reabsorption by this segment is expected. Thus less  $\text{Na}^+$  is delivered to the distal tubule.

3.  *$\text{Na}^+$  reabsorption by the distal tubule and collecting duct is enhanced.* The small amount of  $\text{Na}^+$  that is delivered to the distal tubule is almost completely reabsorbed because transport in this segment and the collecting duct is enhanced. This stimulation of  $\text{Na}^+$  reabsorption by the distal tubule and collecting duct is induced by increased angiotensin II and aldosterone levels (increased sympathetic nerve activity also will stimulate  $\text{Na}^+$  reabsorption).

Finally, water reabsorption by the late portion of the distal tubule and the collecting duct is enhanced by AVP (AVP also stimulates limited  $\text{Na}^+$  reabsorption in the late distal tubule and collecting duct), the levels of which are elevated through activation of the low- and high-pressure vascular volume sensors and by the elevated levels of angiotensin II. As a result, water excretion is reduced.

Because both water and  $\text{Na}^+$  are retained by the kidneys in equal proportions, euvoemia is reestablished and body fluid osmolality remains constant. The time course of this expansion of the ECF (hours to days) and the degree to which euvoemia is attained depend on the magnitude of the ECF volume contraction and the dietary intake of  $\text{Na}^+$ . Thus the kidneys reduce  $\text{Na}^+$  excretion and euvoemia can be restored more quickly if additional NaCl is ingested in the diet.

In brief, the nephron's response to ECF volume contraction involves the integrated action of all its segments: (1) the filtered amount of  $\text{Na}^+$  is decreased, (2) proximal tubule and loop of Henle reabsorption is enhanced (the GFR is decreased and proximal reabsorption is increased and thus G-T balance does not occur under this condition), and (3) the delivery of  $\text{Na}^+$  to the distal tubule is reduced. This decreased delivery, together with enhanced  $\text{Na}^+$  reabsorption by the distal tubule and collecting duct, virtually eliminates  $\text{Na}^+$  from the urine.

## EDEMA

**Edema** is the accumulation of excess fluid within the interstitial space. As described in Chapter 1, Starling forces across the capillary wall determine the movement of fluid into and out of the vascular compartment in exchange with the extravascular interstitial compartment. Alterations of these forces under pathologic conditions can lead to increased movement of fluid from the vascular space into the interstitium, resulting in edema formation.

The role of the kidneys in the formation of edema can be appreciated by recognizing that the interstitial compartment typically must contain 2 to 3 L of excess fluid before edema is clinically evident (e.g., swelling of the ankles). The source of this fluid is the vascular compartment (i.e., plasma), which has a volume of 3 to 4 L in healthy persons. Alterations in the Starling forces that would accompany a 2 to 3 L fluid shift out of the vascular compartment into the interstitial compartment would be predicted to limit such marked fluid movement and the decline in blood pressure that would attend such a marked fluid shift. However, retention of NaCl and water by the kidneys maintains intravascular compartment volume, thereby maintaining the blood pressure and facilitating interstitial fluid redistribution and edema development.

### Alterations in Starling Forces

In Chapter 1, the Starling forces and their effect on fluid movement across the capillary wall were explained. Edema results from changes in the Starling forces that alter these fluid dynamics. Recall that fluid movement across a capillary wall is driven by hydrostatic and oncotic pressure gradients:

$$\text{Filtration rate} = K_f[(P_c - P_i) - \sigma(\pi_c - \pi_i)] \quad (6-3)$$

where  $K_f$  is the filtration coefficient of the capillary wall (a measure of the intrinsic wall permeability and the surface area available for fluid flow),  $P_c$  and  $P_i$  are the hydrostatic pressures within the lumen of the capillary and the interstitium, respectively,  $\sigma$  is the reflection coefficient for protein across the capillary wall (approximately 0.9 for skeletal muscle), and  $\pi_c$  and  $\pi_i$

are the oncotic pressures generated by protein within the capillary lumen and the interstitium, respectively.

### Capillary Hydrostatic Pressure ( $P_c$ )

Increasing the  $P_c$  favors the movement of fluid out of the capillary or retards its movement into the capillary, thereby promoting edema formation. Normally the resistance of the precapillary arteriole is well regulated such that changes in systemic blood pressure do not result in marked alterations in  $P_c$ . However, postcapillary resistance is not regulated to the same degree, and thus alterations in the pressure within the venous side of the circulation have significant effects on  $P_c$ . Consequently, an increase in the venous pressure elevates  $P_c$ , which increases the movement of fluid into the interstitium, resulting in the accumulation of edema fluid. Common causes for increased venous pressure include venous thrombosis and congestive heart failure.

### Plasma Oncotic Pressure ( $\pi_c$ )

A decrease in  $\pi_c$  would be expected to favor movement of fluid out of the capillary lumen and inhibit its reabsorption from the interstitium. Because albumin is the most abundant plasma protein, alterations in  $\pi_c$  result primarily from changes in the plasma [albumin]. However, it is important to remember that changes in plasma protein concentration result in parallel changes in the protein concentration of the interstitial fluid. This phenomenon reflects the fact that the reflection coefficient for protein is 0.9 and thus proteins can cross the capillary wall. Because of the parallel changes in capillary and interstitial fluid protein concentration, the oncotic pressure gradient across the capillary wall ( $\pi_c - \pi_i$ ) may not change appreciably.

### Lymphatic Obstruction

As noted in Chapter 1, the lymphatic system serves to return interstitial fluid formed by capillary filtration to the vascular system. Obstruction of a lymphatic duct interferes with this process, and as a result interstitial fluid accumulates in the portion of the body drained by the obstructed duct (i.e., edema forms). As this interstitial fluid accumulates, the interstitial hydrostatic pressure increases, and eventually a new steady state is reached where the Starling forces are once again balanced and no additional fluid accumulates. However, unless the obstruction is corrected, the area

## IN THE CLINIC

Edema can be classified as localized or generalized. **Localized edema**, as the name denotes, represents the abnormal accumulation of interstitial fluid in a specific area or region of the body. Common causes of localized edema include insect stings and lymphatic obstruction. The venom of many stinging or biting insects contains substances that either directly increase capillary permeability or cause the release of mediators of inflammation that have a similar effect. In addition, the venom or inflammatory mediators may cause vasodilation. Increasing the permeability of the capillary, or in some cases the postcapillary venule, increases the filtration coefficient ( $K_f$ ) and also can decrease the protein reflection coefficient. Both effects can increase fluid movement out of the capillary, with the latter effect also altering the Starling forces by changing the protein oncotic pressure gradient. Starling forces are further altered in response to the vasodilation (i.e., capillary hydrostatic pressure [ $P_c$ ] is increased). The net effect of these changes is that more fluid moves out of the capillary into the interstitium and localized swelling occurs. Lymphatic obstruction often accompanies surgical treatment of tumors. For example, in some women with breast cancer, regional lymph nodes that drain the affected breast are surgically removed. When those located in the axilla are removed, the draining of lymph from that arm may be impaired. As a result, edema may develop in the arm.

**Generalized edema** results when Starling forces across all capillary beds are altered. Edema may be present in the lungs (i.e., **pulmonary edema**) or throughout the systemic circulation (i.e., **peripheral edema**). Peripheral edema is most commonly observed in the feet, ankles, and legs, where the force of gravity magnifies the changes in Starling forces (i.e., further increases  $P_c$ ) and thereby causes more fluid to leave the capillary and enter the interstitium. One of the most common causes of generalized edema is congestive heart failure. In this condition, blood accumulates in the venous side of the circulation, raising  $P_c$ , which in turn causes fluid to move out of the capillary into the interstitium.

Generalized edema is also seen with renal diseases associated with the **nephrotic syndrome**. In the nephrotic syndrome, glomerular capillary permeability is altered, allowing large quantities of albumin to be lost in the urine (**albuminuria**). If the rate of loss

exceeds the rate at which albumin is synthesized by the liver, the plasma [albumin] falls. The reduction in plasma protein concentration, and thus  $\pi_c$ , was thought to be the primary cause of edema formation in patients with the nephrotic syndrome. Because the oncotic pressure gradient across the capillary wall may not change appreciably (i.e., interstitial protein oncotic pressure also falls), it is likely that other factors are responsible for, or at least contribute to, the abnormal accumulation of fluid in the interstitial compartment. Supporting this notion is the observation that edema does not spontaneously develop in rats deficient for albumin. It is now known that one of these other factors is primary NaCl retention by the distal tubule and collecting duct. With damage to the glomerular filtration barrier, the serum protein plasminogen enters the renal tubules where it is cleaved to form plasmin by the serine protease urokinase (produced by proximal tubule cells). Plasmin, also a serine protease, then cleaves the  $\gamma$ -subunit of the epithelial  $\text{Na}^+$  channels present in the apical membrane of cells in the late distal tubule and collecting duct, thereby increasing the open time of these channels. This phenomenon results in increased  $\text{Na}^+$  (and  $\text{Cl}^-$ ) reabsorption. The ensuing retention of NaCl (along with water) increases vascular volume and thereby leads to an increase in  $P_c$ , increased movement of fluid into the interstitial compartment, and thus edema formation.


drained by the obstructed lymphatic duct remains edematous even in this new steady state.

### Capillary Permeability

An increase in capillary permeability favors increased movement of fluid across the capillary wall and thus accumulation of excess fluid in the interstitial compartment. The increased permeability also can alter the capillary reflection coefficient for protein(s), allowing more protein across the capillary and thus altering the protein oncotic pressure gradient ( $\pi_c - \pi_i$ ).

### Role of the Kidneys

The role of the kidneys in edema-forming states is best illustrated by considering the situation that exists with heart failure (Figure 6-7). Because of decreased cardiac performance, venous pressure is elevated and

perfusion of the kidneys impaired. The increase in venous pressure alters the Starling forces (i.e., increased  $P_c$ ) and causes fluid to accumulate in the interstitium. At the same time, decreased cardiac performance (decreased cardiac output and blood pressure) reduces the ECV, which is misinterpreted by the body's vascular volume sensors as a decrease in ECF volume. The fall in ECF volume activates the renal sympathetic nerves and the renin-angiotensin-aldosterone system and causes AVP secretion. In response to these signals, the kidneys retain NaCl and water, as

already described. This retention of isotonic fluid expands the ECF volume and thus blood volume, thereby helping perpetuate a vicious cycle of fluid accumulation that can further exacerbate congestive heart failure. Intravascular volume expansion also contributes to the increased  $P_c$ , increased interstitial fluid accumulation, and edema formation.

As fluid begins to accumulate in the interstitium, it is taken up by the lymphatics and returned to the systemic circulation. As noted in Chapter 1, thoracic duct and right lymphatic duct flow is approximately 1 to 4 L/day. The lymphatic system can increase this flow up to 20 L/day. Because a significant amount of lymph returns to the circulation at the level of regional lymph nodes, the actual amount of interstitial fluid returned

to the systemic circulation by the lymphatic system can exceed 20 L/day. Nevertheless, the capacity of the lymphatic system has a limit. When this limit is reached, edema fluid begins to accumulate.

The importance of NaCl retention by the kidneys in edema formation provides two approaches for treatment. The first involves dietary manipulation. The ultimate source of NaCl is the diet. Thus if dietary intake of NaCl is restricted, the amount that can be retained by the kidneys is reduced and edema formation is limited. The second approach is to inhibit the kidneys' ability to retain NaCl. This inhibition is accomplished clinically by the use of diuretics, which, as described in Chapter 10, inhibit  $\text{Na}^+$  transport mechanisms in the nephron. Thus NaCl excretion is increased and NaCl retention is blunted.

## S U M M A R Y

1. The volume of the ECF is determined by  $\text{Na}^+$  balance. When  $\text{Na}^+$  intake exceeds excretion, the ECF volume increases (positive  $\text{Na}^+$  balance). Conversely, when  $\text{Na}^+$  excretion exceeds intake, the ECF volume decreases (negative  $\text{Na}^+$  balance). The kidneys are the primary route for  $\text{Na}^+$  excretion.
2. The kidneys adjust NaCl excretion in response to changes in ECV. The ECV reflects adequate tissue perfusion and is dependent on the ECF volume, the intravascular volume, arterial blood pressure, and cardiac output. ECF is sensed primarily by the vascular volume sensors. In the absence of disease, ECV, ECF volume, vascular volume, arterial blood pressure, and cardiac output change in parallel (i.e., they increase with positive  $\text{Na}^+$  balance and decrease with negative  $\text{Na}^+$  balance). In some pathologic conditions (e.g., congestive heart failure), changes in ECV, ECF volume, vascular volume, arterial blood pressure, and cardiac output are uncoupled and do not occur in parallel. The kidneys always adjust  $\text{Na}^+$  excretion to changes in the ECV (decreased  $\text{Na}^+$  excretion with decreased ECV and increased  $\text{Na}^+$  excretion with increased ECV) as detected by the vascular volume sensors.
3. The coordination of  $\text{Na}^+$  intake and excretion and thus the maintenance of a normal ECF volume involves neural (renal sympathetic nerves) and hormonal (renin-angiotensin-aldosterone, uroguanylin, natriuretic peptides, and AVP) regulatory factors and effector mechanisms.
4. Under normal conditions (euvoemia),  $\text{Na}^+$  excretion by the kidneys is matched to the amount of  $\text{Na}^+$  ingested in the diet. The kidneys accomplish this feat by reabsorbing virtually all of the filtered amount of  $\text{Na}^+$  (typically less than 1% of the filtered load is excreted). During euvoemia, the distal tubule and collecting duct are responsible for making small adjustments in urinary  $\text{Na}^+$  excretion to maintain  $\text{Na}^+$  balance. The major factor regulating distal tubule and collecting duct  $\text{Na}^+$  reabsorption is aldosterone, which acts to stimulate  $\text{Na}^+$  reabsorption.
5. With ECF volume expansion, volume sensors in both the low- and high-pressure vascular circuits initiate responses that contribute to increased excretion of  $\text{Na}^+$  by the kidneys and a return to the euvoemic state. The components of this response include a decrease in sympathetic outflow to the kidney, a suppression of the renin-angiotensin-aldosterone system, and release of natriuretic peptides from the heart (ANP and BNP) and kidneys (urodilatin). The combined actions of these effectors serve to enhance the GFR, increase the filtered amount of  $\text{Na}^+$ , and reduce  $\text{Na}^+$  reabsorption by

the nephron. Together, these changes in renal  $\text{Na}^+$  handling enhance net NaCl excretion.

6. With ECF volume contraction, the aforementioned sequence of events is reversed (increased sympathetic outflow to the kidney, activation of the renin-angiotensin-aldosterone system, and suppression of natriuretic peptide secretion). This reversal decreases the GFR, enhances reabsorption of  $\text{Na}^+$  by the nephron, and thus reduces NaCl excretion.
7. The development of generalized edema requires alterations in the Starling forces across capillary walls favoring the accumulation of fluid in the interstitium and retention of NaCl and water by the kidneys.



## REGULATION OF POTASSIUM BALANCE

---


## P

otassium, which is one of the most abundant cations in the body, is critical for many cell functions, including cell volume regulation, intracellular pH regulation, DNA and protein synthesis, growth, enzyme function, resting membrane potential, and cardiac and neuromuscular activity. Despite wide fluctuations in dietary  $K^+$  intake,  $[K^+]$  in cells and extracellular fluid (ECF) remains remarkably constant. Two sets of regulatory mechanisms safeguard  $K^+$  homeostasis. First, several mechanisms regulate the  $[K^+]$  in the ECF. Second, other mechanisms maintain the amount of  $K^+$  in the body constant by adjusting renal  $K^+$  excretion to match dietary  $K^+$  intake. The kidneys regulate  $K^+$  excretion.

### OVERVIEW OF $K^+$ HOMEOSTASIS

Total body  $K^+$  is 50 mEq/kg of body weight, or 3500 mEq for a person weighing 70 kg. A total of 98% of the  $K^+$  in the body is located within cells, where its average  $[K^+]$  is 150 mEq/L. A high intracellular  $[K^+]$  is required for many cell functions, including cell growth and division and volume regulation. Only 2% of total body  $K^+$  is located in the ECF, where its normal concentration is approximately 4 mEq/L.  $[K^+]$  in the ECF that exceeds 5.0 mEq/L constitutes **hyperkalemia**. Conversely,  $[K^+]$  in the ECF of less than 3.5 mEq/L constitutes **hypokalemia**.

Hypokalemia is one of the most common electrolyte disorders in clinical practice and can be observed in as


many as 20% of hospitalized patients. The most common causes of hypokalemia include administration of diuretic drugs (see Chapter 10), surreptitious vomiting (i.e., bulimia), and severe diarrhea. Gitelman syndrome (a genetic defect in the  $Na^+-Cl^-$  symporter in the apical membrane of distal tubule cells) also causes hypokalemia (see Chapter 4, Table 4-3). Hyperkalemia also is a common electrolyte disorder and is seen in 1% to 10% of hospitalized patients. Hyperkalemia often is seen in patients with renal failure, in persons taking drugs such as angiotensin-converting enzyme inhibitors and  $K^+$ -sparing diuretics (see Chapter 10), in persons with hyperglycemia (i.e., high blood sugar), and in the elderly. **Pseudohyperkalemia**, a falsely high plasma  $[K^+]$ , is caused by traumatic lysis of red blood cells while blood is being drawn. Red blood cells, like all cells, contain  $K^+$ , and lysis of red blood cells releases  $K^+$  into the plasma, artificially elevating the plasma  $[K^+]$ .

The large concentration difference of  $K^+$  across cell membranes (approximately 146 mEq/L) is maintained by the operation of sodium–potassium–adenosine triphosphatase ( $Na^+-K^+-ATPase$ ). This  $K^+$  gradient is important in maintaining the potential difference across cell membranes. Thus  $K^+$  is critical

for the excitability of nerve and muscle cells and for the contractility of cardiac, skeletal, and smooth muscle cells (Figure 7-1).

#### IN THE CLINIC

**Cardiac arrhythmias** are produced by both hypokalemia and hyperkalemia. The electrocardiogram (ECG; Figure 7-2) monitors the electrical activity of the heart and is a quick and easy way to determine whether changes in plasma  $[K^+]$  influence the heart and other excitable cells. In contrast, measurements of the plasma  $[K^+]$  by the clinical laboratory require a blood sample, and values often are not immediately available. The first sign of hyperkalemia is the appearance of tall, thin T waves on the ECG. Further increases in the plasma  $[K^+]$  prolong the PR interval, depress the ST segment, and lengthen the QRS interval on the ECG. Finally, as the plasma  $[K^+]$  approaches 10 mEq/L, the P wave disappears, the QRS interval broadens, the ECG appears as a sine wave, and the ventricles fibrillate (i.e., manifest rapid, uncoordinated contractions of muscle fibers). Hypokalemia prolongs the QT interval, inverts the T wave, and lowers the ST segment on the ECG.

After a meal, the  $K^+$  absorbed by the gastrointestinal tract enters the ECF within minutes (Figure 7-3). If the  $K^+$  ingested during a normal meal ( $\approx 33$  mEq) were to remain in the ECF compartment (14 L), the plasma  $[K^+]$  would increase by a potentially lethal 2.4 mEq/L (33 mEq added to 14 L of ECF):


$$33 \text{ mEq}/14 \text{ L} = 2.4 \text{ mEq/L} \quad (7-1)$$

This rise in the plasma  $[K^+]$  is prevented by the rapid uptake (within minutes) of  $K^+$  into cells. Because the excretion of  $K^+$  by the kidneys after a meal is relatively slow (within hours), the uptake of  $K^+$  by cells is essential to prevent life-threatening hyperkalemia. Maintaining total body  $K^+$  constant requires all the  $K^+$  absorbed by the gastrointestinal tract to eventually be excreted by the kidneys. This process requires about 6 hours.

## REGULATION OF PLASMA $[K^+]$

As illustrated in Figure 7-3 and Box 7-1, several hormones, including epinephrine, insulin, and aldosterone, increase  $K^+$  uptake into skeletal muscle, liver, bone, and red blood cells by stimulating  $Na^+-K^+-ATPase$ , the  $Na^+-K^+-2Cl^-$  symporter, and the  $Na^+-Cl^-$  symporter in these cells. Acute stimulation of  $K^+$  uptake (i.e., within minutes) is mediated by an increased turnover rate of existing  $Na^+-K^+-ATPase$ ,  $Na^+-K^+-2Cl^-$ , and  $Na^+-Cl^-$  transporters, whereas the chronic increase in  $K^+$  uptake (i.e., within hours to days) is mediated by an increase in the quantity of  $Na^+-K^+-ATPase$ . A rise in the plasma  $[K^+]$  that follows  $K^+$  absorption by the gastrointestinal tract stimulates insulin secretion from the pancreas, aldosterone release from the adrenal cortex, and epinephrine secretion from the adrenal medulla. In

contrast, a decrease in the plasma  $[K^+]$  inhibits the release of these hormones. Whereas insulin and epinephrine act within a few minutes, aldosterone requires about 1 hour to stimulate  $K^+$  uptake into cells.

### Epinephrine

Catecholamines affect the distribution of  $K^+$  across cell membranes by activating  $\alpha$ - and  $\beta_2$ -adrenergic receptors. The stimulation of  $\alpha$ -adrenoceptors releases  $K^+$  from cells, especially in the liver, whereas the stimulation of  $\beta_2$ -adrenoceptors promotes  $K^+$  uptake by cells. For example, the activation of  $\beta_2$ -adrenoceptors after exercise is important in preventing hyperkalemia. The rise in plasma  $[K^+]$  after a  $K^+$ -rich meal is greater if the patient has been pretreated with propranolol, a  $\beta_2$ -adrenoceptor antagonist. Furthermore, the release of epinephrine during stress (e.g., myocardial ischemia) can lower the plasma  $[K^+]$  rapidly.

### Insulin

Insulin also stimulates  $K^+$  uptake into cells. The importance of insulin is illustrated by two observations. First, the rise in plasma  $[K^+]$  after a  $K^+$ -rich meal is greater in patients with diabetes mellitus (i.e., insulin deficiency) than in healthy people. Second, insulin (and glucose to prevent insulin-induced hypoglycemia) can be infused to correct hyperkalemia. Insulin is the most important hormone that shifts  $K^+$  into cells after the ingestion of  $K^+$  in a meal.

### Aldosterone

Aldosterone, like catecholamines and insulin, also promotes  $K^+$  uptake into cells. A rise in aldosterone levels (e.g., primary aldosteronism) causes hypokalemia, whereas a fall in aldosterone levels (e.g., in persons with Addison disease) causes hyperkalemia. As discussed later, aldosterone also stimulates urinary  $K^+$  excretion. Thus aldosterone alters the plasma  $[K^+]$  by

acting on  $K^+$  uptake into cells and by altering urinary  $K^+$  excretion.

**ALTERATIONS OF PLASMA  $[K^+]$** 

Several factors can alter the plasma  $[K^+]$  (see Box 7-1). These factors are not involved in the regulation of the plasma  $[K^+]$  but rather alter the movement of  $K^+$  between the intracellular fluid and ECF and thus cause the development of hypokalemia or hyperkalemia.

**Acid-Base Balance**

Metabolic acidosis increases the plasma  $[K^+]$ , whereas metabolic alkalosis decreases it. Respiratory alkalosis causes hypokalemia. Metabolic acidosis produced by the addition of inorganic acids (e.g., HCl and sulfuric acid) increases the plasma  $[K^+]$  much more than an equivalent acidosis produced by the accumulation of organic acids (e.g., lactic acid, acetic acid, and keto acids). The reduced pH—that is, increased  $[H^+]$ —promotes the movement of  $H^+$  into

cells and the reciprocal movement of  $K^+$  out of cells to maintain electroneutrality. This effect of acidosis occurs in part because acidosis inhibits the transporters that accumulate  $K^+$  inside cells, including the  $Na^+-K^+-ATPase$  and the  $Na^+-K^+-2Cl^-$  symporter. In addition, the movement of  $H^+$  into cells occurs as the cells buffer changes in the  $[H^+]$  of the ECF (see Chapter 8). As  $H^+$  moves across the cell membranes,  $K^+$  moves in the opposite direction; thus cations are neither gained nor lost across cell membranes. Metabolic alkalosis has the opposite effect; the plasma  $[K^+]$  decreases as  $K^+$  moves into cells and  $H^+$  exits.

Although organic acids produce a metabolic acidosis, they do not cause significant hyperkalemia. Two explanations have been suggested for the reduced ability of organic acids to cause hyperkalemia. First, the organic anion may enter the cell with  $H^+$  and thereby eliminate the need for  $K^+/H^+$  exchange across the membrane. Second, organic anions may stimulate insulin secretion, which moves  $K^+$  into cells. This movement may counteract the direct effect of the acidosis, which moves  $K^+$  out of cells.

**Plasma Osmolality**

The osmolality of the plasma also influences the distribution of  $K^+$  across cell membranes. An increase in the osmolality of the ECF enhances  $K^+$  release by cells and thus increases extracellular  $[K^+]$ . The plasma  $[K^+]$  may increase by 0.4 to 0.8 mEq/L for an elevation of 10 mOsm/kg  $H_2O$  in plasma osmolality. In patients with diabetes mellitus who do not take insulin, plasma  $K^+$  often is elevated in part because of the lack of insulin and in part because of the increase in the concentration of glucose in plasma (i.e., from a normal value of ~100 mg/dL to as high as ~1200 mg/dL), which increases plasma osmolality. Hypoosmolality has the opposite action. The alterations in plasma  $[K^+]$  associated with changes in osmolality are related to changes in cell volume. For example, as plasma osmolality increases, water leaves cells because of the osmotic gradient across the plasma membrane (see Chapter 1). Water leaves cells until the intracellular osmolality equals that of the ECF. This loss of water shrinks cells and causes the cell  $[K^+]$  to rise. The rise in intracellular  $[K^+]$  provides a driving force for the exit of  $K^+$  from cells. This sequence increases plasma

[K<sup>+</sup>]. A fall in plasma osmolality has the opposite effect.

### Cell Lysis

Cell lysis causes hyperkalemia, which results from the addition of intracellular K<sup>+</sup> to the ECF. Severe trauma (e.g., burns) and some conditions such as **tumor lysis syndrome** (i.e., chemotherapy-induced destruction of tumor cells) and **rhabdomyolysis** (i.e., destruction of skeletal muscle) destroy cells and release K<sup>+</sup> and other cell solutes into the ECF. In addition, gastric ulcers may cause the seepage of red blood cells into the gastrointestinal tract. The blood cells are digested, and the K<sup>+</sup> released from the cells is absorbed and can cause hyperkalemia.

### Exercise

During exercise, more K<sup>+</sup> is released from skeletal muscle cells than during rest. The ensuing hyperkalemia depends on the degree of exercise. In people walking slowly, the plasma [K<sup>+</sup>] increases by 0.3 mEq/L. The plasma [K<sup>+</sup>] may increase by 2.0 mEq/L with vigorous exercise.

#### IN THE CLINIC

Exercise-induced changes in the plasma [K<sup>+</sup>] usually do not produce symptoms and are reversed after several minutes of rest. However, vigorous exercise can lead to life-threatening hyperkalemia in persons (1) who have endocrine disorders that affect the release of insulin, epinephrine (a  $\beta$ -adrenergic agonist), or aldosterone; (2) whose ability to excrete K<sup>+</sup> is impaired (e.g., because of renal failure); or (3) who take certain medications, such as  $\beta_2$ -adrenergic blockers. For example, during vigorous exercise, the plasma [K<sup>+</sup>] may increase by at least 2 to 4 mEq/L in persons who take  $\beta_2$ -adrenergic receptor antagonists for hypertension.


Because acid-base balance, plasma osmolality, cell lysis, and exercise do not maintain the plasma [K<sup>+</sup>] at a normal value, they do not contribute to K<sup>+</sup> homeostasis (see [Box 7-1](#)). The extent to which these pathophysiologic states alter the plasma [K<sup>+</sup>] depends on the integrity of the homeostatic mechanisms that regulate plasma [K<sup>+</sup>] (e.g., the secretion of epinephrine, insulin, and aldosterone).

## K<sup>+</sup> EXCRETION BY THE KIDNEYS

The kidneys play a major role in maintaining K<sup>+</sup> balance. As illustrated in [Figure 7-3](#), the kidneys excrete 90% to 95% of the K<sup>+</sup> ingested in the diet. Excretion equals intake even when intake increases by as much as 10-fold. This balance of urinary excretion and dietary intake underscores the importance of the kidneys in maintaining K<sup>+</sup> homeostasis. Although small amounts of K<sup>+</sup> are lost each day in feces and sweat (approximately 5% to 10% of the K<sup>+</sup> ingested in the diet), this amount is essentially constant (except during severe diarrhea), is not regulated, and therefore is relatively less important than the K<sup>+</sup> excreted by the kidneys. K<sup>+</sup> secretion from the blood into the tubular fluid by the cells of the distal tubule and collecting duct system is the key factor in determining urinary K<sup>+</sup> excretion ([Figure 7-4](#)).

Because K<sup>+</sup> is not bound to plasma proteins, it is freely filtered by the glomerulus. When individuals ingest 100 mEq of K<sup>+</sup> per day, urinary K<sup>+</sup> excretion is about 15% of the amount filtered. Accordingly, K<sup>+</sup> must be reabsorbed along the nephron. When dietary K<sup>+</sup> intake increases, however, K<sup>+</sup> excretion can, in extreme circumstances, exceed the amount filtered. Thus K<sup>+</sup> also can be secreted.

The proximal tubule reabsorbs about 67% of the filtered K<sup>+</sup> under most conditions. Approximately 20% of the filtered K<sup>+</sup> is reabsorbed by the loop of Henle, and, as with the proximal tubule, the amount reabsorbed is a constant fraction of the amount filtered. In contrast to these nephron segments, which can only reabsorb K<sup>+</sup>, the distal tubule and collecting duct are able to reabsorb or secrete K<sup>+</sup>. The rate of K<sup>+</sup> reabsorption or secretion by the distal tubule and collecting duct depends on a variety of hormones and factors. When ingesting 100 mEq/day of K<sup>+</sup>, K<sup>+</sup> is secreted by these nephron segments. A rise in dietary K<sup>+</sup> intake increases K<sup>+</sup> secretion. K<sup>+</sup> secretion can increase the amount of K<sup>+</sup> that appears in the urine so that it approaches 80% of the amount filtered (see [Figure 7-4](#)). In contrast, a low-K<sup>+</sup> diet activates K<sup>+</sup> reabsorption along the distal tubule and collecting duct so that urinary excretion falls to about 1% of the K<sup>+</sup> filtered by the glomerulus (see [Figure 7-4](#)). Because the kidneys cannot reduce K<sup>+</sup> excretion to the same low levels as they can for Na<sup>+</sup> (i.e., 0.2%), hypokalemia can develop

in persons who have a  $K^+$ -deficient diet. Because the magnitude and direction of  $K^+$  transport by the distal tubule and collecting duct are variable, the overall rate of urinary  $K^+$  excretion is determined by these tubular segments.


### IN THE CLINIC

In persons with advanced **renal disease**, the kidneys are unable to eliminate  $K^+$  from the body, and thus the plasma  $[K^+]$  rises. The resulting hyperkalemia reduces the resting membrane potential (i.e., the voltage becomes less negative), which decreases the excitability of neurons, cardiac cells, and muscle cells by inactivating fast  $Na^+$  channels, which are critical for the depolarization phase of the action potential (see Figure 7-1). Severe, rapid increases in

the plasma  $[K^+]$  can lead to cardiac arrest and death. In contrast, in patients taking diuretic drugs for hypertension, urinary  $K^+$  excretion often exceeds dietary  $K^+$  intake. Accordingly, the  $K^+$  balance is negative, and hypokalemia develops. This decline in the extracellular  $[K^+]$  hyperpolarizes the resting cell membrane (i.e., the voltage becomes more negative) and reduces the excitability of neurons, cardiac cells, and muscle cells.

Severe hypokalemia can lead to paralysis, cardiac arrhythmias, and death. Hypokalemia also can impair the ability of the kidneys to concentrate the urine and can stimulate the renal production of ammonium, which affects acid-base balance (see Chapter 8). Therefore the maintenance of a high intracellular  $[K^+]$ , a low extracellular  $[K^+]$ , and a high  $K^+$  concentration gradient across cell membranes is essential for a number of cellular functions.

### CELLULAR MECHANISMS OF $K^+$ TRANSPORT BY PRINCIPAL CELLS AND INTERCALATED CELLS IN THE DISTAL TUBULE AND COLLECTING DUCT

Figure 7-5, A, illustrates the cellular mechanism of  $K^+$  secretion by principal cells in the distal tubule and collecting duct. Secretion from the blood into the tubule lumen is a two-step process: (1)  $K^+$  uptake from the blood across the basolateral membrane by  $Na^+$ - $K^+$ -ATPase and (2) diffusion of  $K^+$  from the cell into the tubular fluid through  $K^+$  channels (the renal outer medullary  $K^+$  channel and the  $Ca^{++}$ -activated  $K^+$

[BK] channel). A  $K^+$ - $Cl^-$  symporter in the apical plasma membrane also secretes  $K^+$ .  $Na^+$ - $K^+$ -ATPase creates a high intracellular  $[K^+]$ , which provides the chemical driving force for  $K^+$  exit across the apical membrane through  $K^+$  channels. Although  $K^+$  channels also are present in the basolateral membrane,  $K^+$  preferentially leaves the cell across the apical membrane and enters the tubular fluid.  $K^+$  transport follows this route for two reasons. First, the electrochemical gradient of  $K^+$  across the apical membrane favors its downhill movement into the tubular fluid. Second, the permeability of the apical membrane to  $K^+$  is greater than that of the basolateral membrane. Therefore  $K^+$  preferentially diffuses across the apical

membrane into the tubular fluid.  $K^+$  secretion across the apical membrane via the  $K^+-Cl^-$  symporter is driven by the favorable concentration gradient of  $K^+$  between the cell and tubular fluid. The three major factors that control the rate of  $K^+$  secretion by the distal tubule and the collecting duct are:

1. The activity of  $Na^+-K^+-ATPase$
2. The driving force (electrochemical gradient for  $K^+$  channel and the chemical concentration gradient for the  $K^+-Cl^-$  symporter) for  $K^+$  movement across the apical membrane
3. The permeability of the apical membrane to  $K^+$

Every change in  $K^+$  secretion by principal cells results from an alteration in one or more of these factors.

$\alpha$ -Intercalated cells reabsorb  $K^+$  by an  $H^+-K^+-ATPase$  transport mechanism located in the apical membrane (see Figure 7-5, B, and Chapter 4). This transporter mediates  $K^+$  uptake across the apical plasma membrane in exchange for  $H^+$ .  $K^+$  exit from intercalated cells into the blood is mediated by a  $K^+$  channel. The reabsorption of  $K^+$  is activated by a low- $K^+$  diet. Intercalated cells also express the  $Ca^{++}$ -activated, BK channels in the apical plasma membrane.  $K^+$  secretion by BK channels in intercalated cells (most likely  $\alpha$ -intercalated cells) is activated by increased tubule flow rate, which enhances  $Ca^{++}$  uptake across the apical plasma membrane by activating a transient receptor potential channel also located in the apical plasma membrane (not shown in Figure 7-5, B). Increased intracellular  $Ca^{++}$  stimulates protein kinase C, which activates BK channels.

## REGULATION OF $K^+$ SECRETION BY THE DISTAL TUBULE AND COLLECTING DUCT

The regulation of  $K^+$  excretion is achieved mainly by alterations in  $K^+$  secretion by principal cells of the distal tubule and collecting duct. Plasma  $[K^+]$  and aldosterone are the major physiologic regulators of  $K^+$  secretion. Ingestion of a  $K^+$ -rich meal also activates renal  $K^+$  excretion by a mechanism involving an unknown gut-dependent mechanism. Arginine vasopressin (AVP) also stimulates  $K^+$  secretion; however, it is less important than the plasma  $[K^+]$  and aldosterone.

### BOX 7-2



Other factors, including the flow rate of tubular fluid and acid-base balance, influence  $K^+$  secretion by the distal tubule and collecting duct. However, they are not homeostatic mechanisms because they disturb  $K^+$  balance (Box 7-2).

### Plasma $[K^+]$

Plasma  $[K^+]$  is an important determinant of  $K^+$  secretion by the distal tubule and collecting duct (Figure 7-6). Hyperkalemia (e.g., resulting from a high- $K^+$  diet or from rhabdomyolysis) stimulates  $K^+$  secretion within minutes. Several mechanisms are involved. First, hyperkalemia stimulates  $Na^+-K^+-ATPase$  and thereby increases  $K^+$  uptake across the basolateral membrane. This uptake raises the intracellular  $[K^+]$  and increases the electrochemical driving force for  $K^+$  exit across the apical membrane. Second, hyperkalemia also increases the permeability of the apical membrane to  $K^+$ . Third, hyperkalemia stimulates aldosterone secretion by the adrenal cortex, which acts synergistically with the plasma  $[K^+]$  to stimulate  $K^+$  secretion. Fourth, hyperkalemia also increases the flow rate of tubular fluid, which stimulates  $K^+$  secretion by the distal tubule and collecting duct.

Hypokalemia (e.g., caused by a low- $K^+$  diet or  $K^+$  loss in diarrhea) decreases  $K^+$  secretion by actions opposite to those described for hyperkalemia. Hence hypokalemia inhibits  $Na^+-K^+-ATPase$ , decreases the electrochemical driving force for  $K^+$  efflux across the apical membrane, reduces the permeability of the

apical membrane to K<sup>+</sup>, and reduces plasma aldosterone levels.

### IN THE CLINIC

**Chronic hypokalemia**—that is, plasma K<sup>+</sup> concentration ([K<sup>+</sup>]) <3.5 mEq/L—occurs most often in patients who receive diuretics for hypertension. Thus the excretion of K<sup>+</sup> by the kidneys exceeds the dietary intake of K<sup>+</sup>. Hypokalemia also occurs in patients who vomit, have nasogastric suction, have diarrhea, abuse laxatives, or have hyperaldosteronism. Vomiting, nasogastric suction, diuretics, and diarrhea all can decrease the extracellular fluid volume, which in turn stimulates aldosterone secretion (see Chapter 6). Because aldosterone stimulates K<sup>+</sup> excretion by the kidneys, its action contributes to the development of hypokalemia.


**Chronic hyperkalemia** (plasma [K<sup>+</sup>] >5.0 mEq/L) occurs most frequently in persons with reduced urine flow, low plasma aldosterone levels, and renal disease in which the glomerular filtration rate falls below 20% of normal. In these persons, hyperkalemia occurs because the excretion of K<sup>+</sup> by the kidneys is less than the dietary intake of K<sup>+</sup>. Less common causes for hyperkalemia occur in people with deficiencies of insulin, epinephrine, and aldosterone secretion or in people with metabolic acidosis caused by inorganic acids.

### Aldosterone

A chronic (i.e., 24 hours or more) elevation in the plasma aldosterone concentration enhances K<sup>+</sup> secretion across principal cells in the distal tubule and collecting duct (Figure 7-7) by five mechanisms: (1) increasing the amount of Na<sup>+</sup>-K<sup>+</sup>-ATPase in the basolateral membrane; (2) increasing the expression of the sodium channel (ENaC) in the apical cell membrane; (3) elevating serum glucocorticoid stimulated kinase (Sgk1) levels, which also increases the expression of ENaC in the apical membrane and activates K<sup>+</sup> channels; (4) stimulating channel activating protease 1 (CAP1, also called **prostatin**), which directly activates ENaC; and (5) stimulating the permeability of the apical membrane to K<sup>+</sup>.

The cellular mechanisms by which aldosterone affects the expression and activity of Na<sup>+</sup>-K<sup>+</sup>-ATPase and ENaC (preceding actions 1 to 4) have been described (see Chapter 4). Aldosterone increases the apical membrane K<sup>+</sup> permeability by increasing the number of K<sup>+</sup> channels in the membrane. However, the cellular mechanisms involved in this response are not completely known. Increased expression of Na<sup>+</sup>-K<sup>+</sup>-ATPase facilitates K<sup>+</sup> uptake across the basolateral membrane into cells and thereby elevates intracellular [K<sup>+</sup>]. The increase in the number and activity of Na<sup>+</sup> channels enhances Na<sup>+</sup> entry into the cell from tubule fluid, an effect that depolarizes the apical membrane voltage. The depolarization of the apical membrane and increased intracellular [K<sup>+</sup>] enhance the electrochemical driving force for K<sup>+</sup> secretion from the cell into the tubule fluid. Taken together, these actions increase the cell [K<sup>+</sup>] and enhance the driving force for K<sup>+</sup> exit across the apical membrane. Aldosterone secretion is increased by hyperkalemia and by angiotensin II (after activation of the renin-angiotensin system). Aldosterone secretion is decreased by hypokalemia and natriuretic peptides released from the heart.

Although an acute increase in aldosterone levels (i.e., within hours) enhances the activity of Na<sup>+</sup>-K<sup>+</sup>-ATPase, K<sup>+</sup> excretion does not increase. The reason for this phenomenon is related to the effect of aldosterone on Na<sup>+</sup> reabsorption and tubular flow. Aldosterone stimulates Na<sup>+</sup> reabsorption and water reabsorption and thus decreases tubular flow. The decrease in flow in turn decreases K<sup>+</sup> secretion (discussed in more detail later in this chapter). However, chronic stimulation of

Na<sup>+</sup> reabsorption expands the ECF and thereby returns tubular flow to normal. These actions allow the direct stimulatory effect of aldosterone on the distal tubule and collecting duct to enhance K<sup>+</sup> excretion.

### Arginine Vasopressin

Although AVP does not affect net urinary K<sup>+</sup> excretion, this hormone does stimulate K<sup>+</sup> secretion by the distal tubule and collecting duct (Figure 7-8). AVP increases the electrochemical driving force for K<sup>+</sup> exit across the apical membrane of principal cells by stimulating Na<sup>+</sup> uptake across the apical membrane of principal cells. The increased Na<sup>+</sup> uptake reduces the electrochemical driving force for K<sup>+</sup> exit across the apical membrane (i.e., the interior of the cell becomes less negatively charged). Despite this effect, AVP does not change K<sup>+</sup> secretion by these nephron segments. The reason for this phenomenon is related to the effect of AVP on tubular fluid flow. AVP decreases tubular fluid flow by stimulating water reabsorption. The decrease in tubular flow in turn reduces K<sup>+</sup> secretion (explained later in this chapter). The inhibitory effect of decreased flow of tubular fluid offsets the stimulatory effect of


AVP on the electrochemical driving force for K<sup>+</sup> exit across the apical membrane (see Figure 7-8). If AVP did not increase the electrochemical driving force favoring K<sup>+</sup> secretion, urinary K<sup>+</sup> excretion would decrease as AVP levels increase and urinary flow rates decrease. Hence K<sup>+</sup> balance would change in response to alterations in water balance. Thus the effects of AVP on the electrochemical driving force for K<sup>+</sup> exit across the apical membrane and tubule flow enable urinary K<sup>+</sup> excretion to be maintained constant despite wide fluctuations in water excretion.

### FACTORS THAT PERTURB K<sup>+</sup> EXCRETION

Whereas plasma [K<sup>+</sup>], aldosterone, and AVP play important roles in regulating K<sup>+</sup> balance, the factors and hormones discussed next perturb K<sup>+</sup> balance (see Box 7-2).


#### Flow of Tubular Fluid

A rise in the flow of tubular fluid (e.g., with diuretic treatment and ECF volume expansion) stimulates K<sup>+</sup> secretion within minutes, whereas a fall (e.g., ECF

volume contraction caused by hemorrhage, severe vomiting, or diarrhea) reduces K<sup>+</sup> secretion by the distal tubule and collecting duct (Figure 7-9). Increments in tubular fluid flow are more effective in stimulating K<sup>+</sup> secretion as dietary K<sup>+</sup> intake is increased. Studies of

the primary cilium in principal cells have elucidated some of the mechanisms whereby increased flow stimulates K<sup>+</sup> secretion. As described in Chapter 2, increased flow bends the primary cilium in principal cells, which activates the PKD1/PKD2 Ca<sup>++</sup> conducting channel

complex. This mechanism allows more  $\text{Ca}^{++}$  to enter principal cells and increases intracellular  $[\text{Ca}^{++}]$ . The increase in  $[\text{Ca}^{++}]$  activates BK channels in the apical plasma membrane, which enhances  $\text{K}^+$  secretion from the cell into the tubule fluid. Increased flow also activates BK-mediated  $\text{K}^+$  secretion by intercalated cells. Increased flow also may stimulate  $\text{K}^+$  secretion by other mechanisms. As flow increases, for example, following the administration of diuretics or as the result of an increase in the ECF volume, so does the  $\text{Na}^+$  concentration of tubule fluid. This increase in  $\text{Na}^+$  concentration ( $[\text{Na}^+]$ ) facilitates  $\text{Na}^+$  entry across the apical membrane of distal tubule and collecting duct cells, thereby decreasing the interior negative membrane potential of the cell. This depolarization of the cell membrane potential increases the electrochemical driving force that promotes  $\text{K}^+$  secretion across the apical cell membrane into tubule fluid. In addition, increased  $\text{Na}^+$  uptake into cells activates the  $\text{Na}^+-\text{K}^+-\text{ATPase}$  in the basolateral membrane, thereby increasing  $\text{K}^+$  uptake across the basolateral membrane and elevating cell  $[\text{K}^+]$ . However, it is important to note that an increase in flow rate during a water diuresis does not have a significant effect on  $\text{K}^+$  excretion (see Figure 7-9), most likely because during a water diuresis the  $[\text{Na}^+]$  of tubule fluid does not increase as flow rises.


### Acid-Base Balance

Another factor that modulates  $\text{K}^+$  secretion is the  $[\text{H}^+]$  of the ECF (Figure 7-10). Acute alterations (within minutes to hours) in the pH of the plasma influence  $\text{K}^+$  secretion by the distal tubule and collecting duct. Alkalosis (i.e., a plasma pH above normal) increases  $\text{K}^+$  secretion, whereas acidosis (i.e., a plasma pH below normal) decreases it. An acute acidosis reduces  $\text{K}^+$  secretion by two mechanisms: (1) it inhibits  $\text{Na}^+-\text{K}^+-\text{ATPase}$  and thereby reduces the cell  $[\text{K}^+]$  and the electrochemical driving force for  $\text{K}^+$  exit across the apical membrane, and (2) it reduces the permeability of the apical membrane to  $\text{K}^+$ . Alkalosis has the opposite effects.


The effect of a metabolic acidosis on  $\text{K}^+$  excretion is time dependent. When metabolic acidosis lasts for several days, urinary  $\text{K}^+$  excretion is stimulated (Figure 7-11). This stimulation occurs because chronic metabolic acidosis decreases the reabsorption of water and solutes (e.g., sodium chloride  $[\text{NaCl}]$ ) by the

### AT THE CELLULAR LEVEL

Renal outer medullary  $\text{K}^+$  (ROMK) (*KCNJ1*) channels in the apical membrane of principal cells mediate  $\text{K}^+$  secretion. Four ROMK subunits make up a single channel. Interestingly, knockout of the *KCNJ1* gene (ROMK) causes increased sodium chloride ( $\text{NaCl}$ ) and  $\text{K}^+$  excretion by the kidneys, leading to reduced extracellular fluid volume and hypokalemia. Although this effect is somewhat perplexing, it should be noted that ROMK also is expressed in the apical membrane of the thick ascending limb of Henle's loop, where it plays an important role in  $\text{K}^+$  recycling across the apical membrane, an effect that is critical for the operation of the  $\text{Na}^+-\text{K}^+-2\text{Cl}^-$  symporter (see Chapter 4). In the absence of ROMK,  $\text{NaCl}$  reabsorption by the thick ascending limb is reduced, which leads to  $\text{NaCl}$  loss in the urine. Reduction of  $\text{NaCl}$  reabsorption by the thick ascending limb also reduces the lumen-positive transepithelial voltage, which is the driving force for  $\text{K}^+$  reabsorption by this nephron segment. Thus the reduction in paracellular  $\text{K}^+$  reabsorption by the thick ascending limb increases urinary  $\text{K}^+$  excretion, even when the cortical collecting duct is unable to secrete the normal amount of  $\text{K}^+$  because of a lack of ROMK channels. The cortical collecting duct, however, does secrete  $\text{K}^+$  even in ROMK knockout mice through the flow and  $\text{Ca}^{++}$ -dependent BK channels and by the operation of a  $\text{K}^+-\text{Cl}^-$  symporter expressed in the apical membrane of principal cells.

proximal tubule by inhibiting  $\text{Na}^+\text{-K}^+\text{-ATPase}$ . Hence the flow of tubular fluid is augmented along the distal tubule and collecting duct. The inhibition of proximal tubular water and  $\text{NaCl}$  reabsorption also decreases the ECF volume and thereby stimulates aldosterone secretion. In addition, chronic acidosis, caused by inorganic acids, increases the plasma  $[\text{K}^+]$ , which stimulates aldosterone secretion. The rise in tubular fluid flow, plasma  $[\text{K}^+]$ , and aldosterone levels offsets the effects of acidosis on the cell  $[\text{K}^+]$  and apical membrane permeability, and  $\text{K}^+$  secretion rises. Thus metabolic acidosis may either inhibit or stimulate  $\text{K}^+$  excretion, depending on the duration of the disturbance.

#### AT THE CELLULAR LEVEL

The cellular mechanisms whereby changes in the  $\text{K}^+$  content of the diet and acid-base balance regulate  $\text{K}^+$  secretion by the distal tubule and collecting duct have been elucidated. Elevated  $\text{K}^+$  intake increases  $\text{K}^+$  secretion by several mechanisms, all related to increased serum  $\text{K}^+$  concentration. Hyperkalemia increases the activity of the renal outer medullary  $\text{K}^+$  (ROMK) channel in the apical plasma membrane of principal cells. Moreover, hyperkalemia inhibits proximal tubule sodium chloride ( $\text{NaCl}$ ) and water reabsorption, thereby increasing distal tubule and collecting duct flow rate, a potent stimulus to  $\text{K}^+$  secretion. Hyperkalemia also enhances aldosterone concentration, which increases  $\text{K}^+$  secretion by three mechanisms. First, aldosterone increases the number of  $\text{K}^+$  channels in the apical plasma membrane. Second, aldosterone stimulates  $\text{K}^+$  uptake across the basolateral membrane by enhancing the number of  $\text{Na}^+\text{-K}^+\text{-ATPase}$  pumps, thereby enhancing the electrochemical gradient driving  $\text{K}^+$  secretion across the apical membrane. Third, aldosterone increases  $\text{Na}^+$  entry across the apical membrane, which depolarizes the apical plasma membrane voltage, thereby increasing the electrochemical gradient, promoting  $\text{K}^+$  secretion. A low- $\text{K}^+$  diet dramatically reduces  $\text{K}^+$  secretion by the distal tubule and collecting duct by increasing the activity of protein tyrosine kinase, which causes ROMK channels to be removed from the apical plasma membrane, thereby reducing  $\text{K}^+$  secretion. Acidosis decreases  $\text{K}^+$  secretion by inhibiting the activity of ROMK channels, whereas alkalosis stimulates  $\text{K}^+$  secretion by enhancing ROMK channel activity.

As noted, acute metabolic alkalosis stimulates  $\text{K}^+$  excretion. Chronic metabolic alkalosis, especially in association with ECF volume contraction, significantly increases renal  $\text{K}^+$  excretion because of the associated increased levels of aldosterone.

#### Glucocorticoids

Glucocorticoids increase urinary  $\text{K}^+$  excretion. This effect is in part mediated by an increase in the glomerular filtration rate, which enhances urinary flow rate, a potent stimulus of  $\text{K}^+$  excretion, and by stimulating  $\text{Sgk1}$  activity (discussed in a previous section).

As discussed earlier, the rate of urinary  $\text{K}^+$  excretion is frequently determined by simultaneous changes in hormone levels, acid-base balance, or the flow rate of tubule fluid (Table 7-1). The powerful effect of flow often enhances or opposes the response of the distal tubule and collecting duct to hormones and changes in acid-base balance. This interaction can be beneficial in the case of hyperkalemia, in which the change in flow enhances  $\text{K}^+$  excretion and thereby facilitates  $\text{K}^+$  homeostasis. However, this interaction also can be detrimental, as in the case of alkalosis, in which changes in flow and acid-base status alter  $\text{K}^+$  homeostasis.

## S U M M A R Y

1.  $K^+$  homeostasis is maintained by the kidneys, which adjust  $K^+$  excretion to match dietary  $K^+$  intake, and by the hormones insulin, epinephrine, and aldosterone, which regulate the distribution of  $K^+$  between the intracellular fluid and ECF.
2. Other events, such as cell lysis, exercise, and changes in acid-base balance and plasma osmolality, disturb  $K^+$  homeostasis and the plasma  $[K^+]$ .
3.  $K^+$  excretion by the kidneys is determined by the rate and direction of  $K^+$  transport by the distal tubule and collecting duct.  $K^+$  secretion by these tubular segments is regulated by the plasma  $[K^+]$ , aldosterone, and AVP. In contrast, changes in tubular fluid flow and acid-base disturbances perturb  $K^+$  excretion by the kidneys. In  $K^+$ -depleted states,  $K^+$  secretion is inhibited and the distal tubule and collecting duct reabsorb  $K^+$ .

## REGULATION OF ACID-BASE BALANCE

---

he concentration of  $\text{H}^+$  in the body fluids is low compared with that of other ions. For example,  $\text{Na}^+$  is present at a concentration some 3 million times greater than that of  $\text{H}^+$  ( $[\text{Na}^+] = 140 \text{ mEq/L}$  and  $[\text{H}^+] = 40 \text{ nEq/L}$ ). Because of the low  $[\text{H}^+]$  of the body fluids, it is commonly expressed as the negative logarithm, or pH.


Virtually all cellular, tissue, and organ processes are sensitive to pH. Indeed, life cannot exist outside a range of body fluid pH from 6.8 to 7.8 (160 to 16 nEq/L of  $\text{H}^+$ ). Each day, acid and alkali are ingested in

the diet. Also, cellular metabolism produces a number of substances that have an impact on the pH of body fluids. Without appropriate mechanisms to deal with this daily acid and alkali load and thereby maintain acid-base balance, many processes necessary for life could not occur. This chapter reviews the maintenance of whole-body acid-base balance. Although the emphasis is on the role of the kidneys in this process, the roles of the lungs and liver also are considered. In addition, the impact of diet and cellular metabolism

on acid-base balance is presented. Finally, disorders of acid-base balance are considered, primarily to illustrate the physiologic processes involved. Throughout this chapter, **acid** is defined as any substance that adds  $H^+$  to the body fluids, whereas **alkali** is defined as a substance that removes  $H^+$  from the body fluids.

## HCO<sub>3</sub><sup>-</sup> BUFFER SYSTEM

Bicarbonate ( $HCO_3^-$ ) is an important buffer of the extracellular fluid (ECF). With a normal plasma  $[HCO_3^-]$  of 23 to 25 mEq/L and a volume of 14 L (for a person weighing 70 kg), the ECF potentially can buffer 350 mEq of  $H^+$ . The  $HCO_3^-$  buffer system differs from the other buffer systems of the body (e.g., phosphate) because it is regulated by both the lungs and the kidneys. This situation is best appreciated by considering the following reaction.



As indicated, the first reaction (hydration/dehydration of  $CO_2$ ) is the rate-limiting step. This normally slow reaction is greatly accelerated in the presence of carbonic anhydrase.\* The second reaction, the ionization of carbonic acid ( $H_2CO_3$ ) to  $H^+$  and  $HCO_3^-$ , is virtually instantaneous.

The Henderson-Hasselbalch equation is used to quantitate how changes in  $CO_2$  and  $HCO_3^-$  affect pH:

$$pH = pK' + \log \frac{[HCO_3^-]}{\alpha P_{CO_2}} \quad (8-2)$$

or

$$pH = 6.1 + \log \frac{[HCO_3^-]}{0.03 P_{CO_2}} \quad (8-3)$$

In these equations, the amount of  $CO_2$  is determined from the partial pressure of  $CO_2$  ( $P_{CO_2}$ ) and its solubility ( $\alpha$ ). For plasma at 37° C,  $\alpha$  has a value of 0.03. Also,  $pK'$  is the negative logarithm of the overall dissociation constant for the reaction in equation 8-1 and has a value for plasma at 37° C of 6.1. Alternatively,

the relationships among  $HCO_3^-$ ,  $CO_2$ , and  $[H^+]$  can be determined as follows:

$$[H^+] = \frac{24 \times P_{CO_2}}{[HCO_3^-]} \quad (8-4)$$

Inspection of equations 8-3 and 8-4 shows that the pH and the  $[H^+]$  vary when either the  $[HCO_3^-]$  or the  $P_{CO_2}$  is altered. Disturbances of acid-base balance that result from a change in the  $[HCO_3^-]$  are termed *metabolic acid-base disorders*, whereas those that result from a change in the  $P_{CO_2}$  are termed *respiratory acid-base disorders*. These disorders are considered in more detail in a subsequent section. The kidneys are primarily responsible for regulating the  $[HCO_3^-]$  of the ECF, whereas the lungs control the  $P_{CO_2}$ .


## OVERVIEW OF ACID-BASE BALANCE

The diet of humans contains many constituents that are either acid or alkali. In addition, cellular metabolism produces acid and alkali. Finally, alkali is normally lost each day in the feces. As described later in this chapter, the net effect of these processes is the addition of acid to the body fluids. For acid-base balance to be maintained, acid must be excreted from the body at a rate equivalent to its addition. If acid addition exceeds excretion, **acidosis** results. Conversely, if acid excretion exceeds addition, **alkalosis** results.

As summarized in Figure 8-1, the major constituents of the diet are carbohydrates and fats. When tissue perfusion is adequate,  $O_2$  is available to tissues, and insulin is present at normal levels, carbohydrates and fats are metabolized to  $CO_2$  and  $H_2O$ . On a daily basis, 15 to 20 moles of  $CO_2$  are generated through this process. Normally, this large quantity of  $CO_2$  is effectively eliminated from the body by the lungs. Therefore this metabolically derived  $CO_2$  has no impact on acid-base balance.  $CO_2$  usually is termed **volatile acid**, reflecting the fact that it has the potential to generate  $H^+$  after hydration with  $H_2O$  (see equation 8-1). Acid not derived directly from the hydration of  $CO_2$  is termed **nonvolatile acid** (e.g., lactic acid).

The cellular metabolism of other dietary constituents also has an impact on acid-base balance (see Figure 8-1). For example, cysteine and methionine, which are


sulfur-containing amino acids, yield sulfuric acid when metabolized, whereas hydrochloric acid results from the metabolism of lysine, arginine, and histidine. A portion of this nonvolatile acid load is offset by the production of  $HCO_3^-$  through the metabolism of the amino acids aspartate and glutamate. On average, the metabolism of dietary amino acids yields net nonvolatile acid production. The metabolism of certain organic anions (e.g., citrate) results in the production of  $HCO_3^-$ , which offsets nonvolatile acid production to some degree. Overall, in persons who ingest a diet containing meat, acid production exceeds  $HCO_3^-$  production. In addition to the metabolically derived acids and alkalis, the foods ingested contain acid and alkali. For example, the presence of phosphate ( $H_2PO_4^-$ ) in ingested food increases the dietary acid load. Finally, during digestion, some  $HCO_3^-$  is normally lost in the feces. This loss is equivalent to the addition of nonvolatile acid to the body. Together, dietary intake, cellular metabolism, and fecal  $HCO_3^-$  loss result in the addition of approximately 1 mEq/kg body weight of nonvolatile acid to the body each day (50 to 100 mEq/day for most adults). This acid, referred to as **net endogenous acid production (NEAP)**, results in an equivalent loss of  $HCO_3^-$  from the body that must be replaced. Importantly, the kidneys excrete acid and in that process generate  $HCO_3^-$ .

### IN THE CLINIC

When insulin levels are normal, carbohydrates and fats are completely metabolized to  $CO_2 + H_2O$ . However, if insulin levels are abnormally low (e.g., in persons with **diabetes mellitus**), the metabolism of carbohydrates leads to the production of several organic keto acids (e.g.,  $\beta$ -hydroxybutyric acid).

In the absence of adequate levels of  $O_2$  (**hypoxia**), anaerobic metabolism by cells also can lead to the production of organic acids (e.g., lactic acid) rather than  $CO_2 + H_2O$ . This phenomenon frequently occurs in healthy persons during vigorous exercise. Poor tissue perfusion, such as occurs with reduced cardiac output, also can lead to anaerobic metabolism by cells and thus to acidosis. In these conditions, the organic acids accumulate and the pH of the body fluids decreases (acidosis). Treatment (e.g., administration of insulin in the case of diabetes) or improved delivery of adequate levels of  $O_2$  to the tissues (e.g., in the case of poor tissue perfusion) results in the metabolism of these organic acids to  $CO_2 + H_2O$ , which consumes  $H^+$  and thereby helps correct the acid-base disorder.

Nonvolatile acids do not circulate throughout the body but are immediately neutralized by the  $\text{HCO}_3^-$  in the ECF:



This neutralization process yields the  $\text{Na}^+$  salts of the strong acids and removes  $\text{HCO}_3^-$  from the ECF. Thus  $\text{HCO}_3^-$  minimizes the effect of these strong acids on the pH of the ECF. As noted previously, the ECF contains approximately 350 mEq of  $\text{HCO}_3^-$ . If this  $\text{HCO}_3^-$  was not replenished, the daily production of nonvolatile acids ( $\approx 70$  mEq/day) would deplete the ECF of  $\text{HCO}_3^-$  within 5 days. Systemic acid-base balance is maintained when **renal net acid excretion** (RNAE) equals NEAP.

## RENAL NET ACID EXCRETION

Under normal conditions, the kidneys excrete an amount of acid equal to NEAP and in so doing replenish the  $\text{HCO}_3^-$  that is lost by neutralization of the nonvolatile acids. In addition, the kidneys must prevent the loss of  $\text{HCO}_3^-$  in the urine. The latter task is quantitatively more important because the filtered load of  $\text{HCO}_3^-$  is approximately 4320 mEq/day ( $24 \text{ mEq/L} \times 180 \text{ L/day} = 4320 \text{ mEq/day}$ ), compared with only 50 to 100 mEq/day needed to balance NEAP.

Both the reabsorption of filtered  $\text{HCO}_3^-$  and the excretion of acid are accomplished by  $\text{H}^+$  secretion by the nephrons. Thus in a single day the nephrons must secrete approximately 4390 mEq of  $\text{H}^+$  into the tubular fluid. Most of the secreted  $\text{H}^+$  serves to reabsorb the filtered load of  $\text{HCO}_3^-$ . Only 50 to 100 mEq of  $\text{H}^+$ , an amount equivalent to nonvolatile acid production, is excreted in the urine. As a result of this acid excretion, the urine is normally acidic.

The kidneys cannot excrete urine more acidic than pH 4.0 to 4.5. Even at a pH of 4.0, only 0.1 mEq/L of  $\text{H}^+$  can be excreted. Thus to excrete sufficient acid, the kidneys excrete  $\text{H}^+$  with urinary buffers such as inorganic phosphate ( $\text{P}_i$ ).<sup>\*</sup> Other

constituents of the urine also can serve as buffers (e.g., creatinine), although their role is less important than that of  $\text{P}_i$ . Collectively, the various urinary buffers are termed *titratable acid*. This term is derived from the method by which these buffers are quantitated in the laboratory. Typically, alkali ( $\text{OH}^-$ ) is added to a urine sample to titrate its pH to that of plasma (i.e., 7.4). The amount of alkali added is equal to the  $\text{H}^+$  titrated by these urine buffers and is termed titratable acid.

The excretion of  $\text{H}^+$  as a titratable acid is insufficient to balance NEAP. An additional and important mechanism by which the kidneys contribute to the maintenance of acid-base balance is through the synthesis and excretion of **ammonium** ( $\text{NH}_4^+$ ). The mechanisms involved in this process are discussed in more detail later in this chapter. With regard to the renal regulation of acid-base balance, each  $\text{NH}_4^+$  excreted in the urine results in the return of one  $\text{HCO}_3^-$  to the systemic circulation, which replenishes the  $\text{HCO}_3^-$  lost during neutralization of the nonvolatile acids. Thus the production and excretion of  $\text{NH}_4^+$ , like the excretion of titratable acid, are equivalent to the excretion of acid by the kidneys.


In brief, the kidneys contribute to acid-base homeostasis by reabsorbing the filtered load of  $\text{HCO}_3^-$  and excreting an amount of acid equivalent to NEAP. This overall process is termed RNAE, and it can be quantitated as follows:

$$\text{RNAE} = [(U_{\text{NH}_4^+} \times \dot{V}) + (U_{\text{TA}} \times \dot{V})] - (U_{\text{HCO}_3^-} \times \dot{V}) \quad (8-7)$$

where  $(U_{\text{NH}_4^+} \times \dot{V})$  and  $(U_{\text{TA}} \times \dot{V})$  are the rates of excretion (mEq/day) of  $\text{NH}_4^+$  and titratable acid and  $(U_{\text{HCO}_3^-} \times \dot{V})$  is the amount of  $\text{HCO}_3^-$  lost in the urine (equivalent to adding  $\text{H}^+$  to the body).<sup>†</sup> Again, maintenance of acid-base balance means that RNAE must equal NEAP. Under most conditions, very little  $\text{HCO}_3^-$  is excreted in the urine. Thus RNAE essentially reflects titratable acid and  $\text{NH}_4^+$  excretion. Quantitatively, TA accounts for approximately one third and  $\text{NH}_4^+$  for two thirds of RNAE.

<sup>\*</sup>The titration reaction is  $\text{HPO}_4^{2-} + \text{H}^+ \leftrightarrow \text{H}_2\text{PO}_4^-$ . This reaction has a pK of approximately 6.8.

<sup>†</sup>This equation ignores the small amount of free  $\text{H}^+$  excreted in the urine. As already noted, urine with pH = 4.0 contains only 0.1 mEq/L of  $\text{H}^+$ .




**FIGURE 8-2** ■ Segmental reabsorption of bicarbonate ( $\text{HCO}_3^-$ ). The fraction of the filtered  $\text{HCO}_3^-$  reabsorbed by the various segments of the nephron is shown. Normally, the entire filtered  $\text{HCO}_3^-$  is reabsorbed and little or no  $\text{HCO}_3^-$  appears in the urine. CCD, Cortical collecting duct; DT, distal tubule; IMCD, inner medullary collecting duct; PT, proximal tubule; TAL, thick ascending limb.

## $\text{HCO}_3^-$ REABSORPTION ALONG THE NEPHRON

As indicated by equation 8-7, RNAE is maximized when little or no  $\text{HCO}_3^-$  is excreted in the urine. Indeed, under most circumstances, very little  $\text{HCO}_3^-$  appears in the urine. Because  $\text{HCO}_3^-$  is freely filtered at the glomerulus, approximately 4320 mEq/day are delivered to the nephrons and are then reabsorbed. Figure 8-2 summarizes the contribution of each nephron segment to the reabsorption of the filtered  $\text{HCO}_3^-$ .

The proximal tubule reabsorbs the largest portion of the filtered load of  $\text{HCO}_3^-$ . Figure 8-3 summarizes the primary transport processes involved.  $\text{H}^+$  secretion across the apical membrane of the cell occurs by both a  $\text{Na}^+$ - $\text{H}^+$  antiporter and  $\text{H}^+$ -adenosine triphosphatase ( $\text{H}^+$ -ATPase). The  $\text{Na}^+$ - $\text{H}^+$  antiporter (NHE3) is the predominant pathway for  $\text{H}^+$  secretion (accounts for approximately two thirds of  $\text{HCO}_3^-$  reabsorption) and uses the lumen-to-cell  $[\text{Na}^+]$  gradient to drive this process (i.e., secondary active secretion of  $\text{H}^+$ ). Within the cell,  $\text{H}^+$  and  $\text{HCO}_3^-$  are produced in a reaction catalyzed by carbonic anhydrase (CA-II). The  $\text{H}^+$  is secreted into the tubular fluid, whereas the  $\text{HCO}_3^-$  exits the cell across the basolateral membrane and returns to the peritubular blood.  $\text{HCO}_3^-$  movement out of the cell across the basolateral membrane is coupled to other ions. The majority of  $\text{HCO}_3^-$  exits

through a symporter that couples the efflux of  $\text{Na}^+$  with  $3\text{HCO}_3^-$  (sodium bicarbonate cotransporter, NBCe1). In addition, some of the  $\text{HCO}_3^-$  may exit in exchange for  $\text{Cl}^-$  (via a  $\text{Cl}^-$ - $\text{HCO}_3^-$  antiporter; AE1). As noted in Figure 8-3, CA-IV also is present in the brush border of the proximal tubule cells. This enzyme catalyzes the dehydration of  $\text{H}_2\text{CO}_3$  in the luminal fluid and thereby facilitates the reabsorption of  $\text{HCO}_3^-$ . CA-IV also is present in the basolateral membrane (not shown in Figure 8-3), where it may facilitate the exit of  $\text{HCO}_3^-$  from the cell.

### AT THE CELLULAR LEVEL

**Carbonic anhydrases** (CAs) are zinc-containing enzymes that catalyze the hydration of  $\text{CO}_2$  (see equation 8-1). The isoform CA-I is found in red blood cells and is critical for the cells' ability to carry  $\text{CO}_2$ . Two isoforms, CA-II and CA-IV, play important roles in urine acidification. The CA-II isoform is localized to the cytoplasm of many cells along the nephron, including the proximal tubule, thick ascending limb of Henle's loop, and intercalated cells of the distal tubule and collecting duct. The CA-IV isoform is membrane bound and exposed to the contents of the tubular fluid. It is found in the apical membrane of both the proximal tubule and thick ascending limb of Henle's loop, where it facilitates the reabsorption of the large amount of  $\text{HCO}_3^-$  reabsorbed by these segments. CA-IV has also been demonstrated in the basolateral membrane of the proximal tubule and thick ascending limb of Henle's loop. Its function at this site is thought to facilitate the exit of  $\text{HCO}_3^-$  from the cell.

The cellular mechanism for  $\text{HCO}_3^-$  reabsorption by the thick ascending limb of the loop of Henle is very similar to that in the proximal tubule.  $\text{H}^+$  is secreted by an  $\text{Na}^+$ - $\text{H}^+$  antiporter and a vacuolar  $\text{H}^+$ -ATPase. As in the proximal tubule, the  $\text{Na}^+$ - $\text{H}^+$  antiporter is the predominant pathway for  $\text{H}^+$  secretion.  $\text{HCO}_3^-$  exit from the cell involves both a  $\text{Na}^+$ - $\text{HCO}_3^-$  symporter and a  $\text{Cl}^-$ - $\text{HCO}_3^-$  antiporter. However, the isoforms for these transporters differ from those in the proximal tubule. The  $\text{Na}^+$ - $\text{HCO}_3^-$  symporter is electrically neutral, exchanging equal numbers of  $\text{Na}^+$  for  $\text{HCO}_3^-$ . The  $\text{Cl}^-$ - $\text{HCO}_3^-$  antiporter is the anion exchanger 2. Recently, evidence has been obtained for the presence of a  $\text{K}^+$ - $\text{HCO}_3^-$  symporter in the



basolateral membrane, which also may contribute to  $\text{HCO}_3^-$  exit from the cell.

The distal tubule\* and collecting duct reabsorb the small amount of  $\text{HCO}_3^-$  that escapes reabsorption by the proximal tubule and loop of Henle. Figure 8-4 shows the cellular mechanism of  $\text{HCO}_3^-$  reabsorption by the collecting duct, where  $\text{H}^+$  secretion occurs through the intercalated cell (see Chapter 2). Within the cell,  $\text{H}^+$  and  $\text{HCO}_3^-$  are produced by the hydration of  $\text{CO}_2$ ; this reaction is catalyzed by carbonic anhydrase (CA-II).  $\text{H}^+$  is secreted into the tubular fluid by two mechanisms. The first mechanism involves an apical membrane vacuolar  $\text{H}^+$ -ATPase. The second mechanism couples the secretion of  $\text{H}^+$  with the reabsorption of  $\text{K}^+$  through an  $\text{H}^+$ - $\text{K}^+$ -ATPase similar to that found in the stomach. The  $\text{HCO}_3^-$  exits the cell across the basolateral membrane in exchange for  $\text{Cl}^-$  (through a  $\text{Cl}^-$ - $\text{HCO}_3^-$  antiporter, anion exchanger-1) and enters the peritubular capillary blood.  $\text{Cl}^-$  exit from the cell across the basolateral membrane occurs via a  $\text{Cl}^-$  channel, and perhaps also via a  $\text{K}^+$ - $\text{Cl}^-$  symporter (KCC4).

A second population of intercalated cells within the collecting duct secretes  $\text{HCO}_3^-$  rather than  $\text{H}^+$  into the tubular fluid.† In these intercalated cells, in contrast to the intercalated cells previously described, the  $\text{H}^+$ -ATPase is located in the basolateral membrane (and to some degree also in the apical membrane), and a  $\text{Cl}^-$ - $\text{HCO}_3^-$  antiporter is located in the apical membrane (see Figure 8-4). The apical membrane  $\text{Cl}^-$ - $\text{HCO}_3^-$  antiporter is different from the one found in the basolateral membrane of the  $\text{H}^+$ -secreting intercalated cell and has been identified as pendrin. The activity of the  $\text{HCO}_3^-$ -secreting intercalated cell is increased during metabolic alkalosis, when the kidneys must excrete excess  $\text{HCO}_3^-$ . However, under normal conditions,  $\text{H}^+$  secretion predominates in the collecting duct.

\*Here and in the remainder of the chapter the focus is on the function of intercalated cells. The early portion of the distal tubule, which does not contain intercalated cells, also reabsorbs  $\text{HCO}_3^-$ . The cellular mechanism is similar to that already described for the thick ascending limb of Henle's loop, although transporter isoforms may be different.

†The  $\text{HCO}_3^-$ -secreting intercalated cells are termed either *type B* (or  $\beta$ -intercalated cells), or simply *non-type-A intercalated cells*. The  $\text{H}^+$  secreting intercalated cells are termed *type A* (or  $\alpha$ -intercalated cells).

The apical membrane of collecting duct cells is not very permeable to  $H^+$ , and thus the pH of the tubular fluid can become quite acidic. Indeed, the most acidic tubular fluid along the nephron (pH = 4.0 to 4.5) is produced there. In comparison, the permeability of the

proximal tubule to  $H^+$  and  $HCO_3^-$  is much higher, and the tubular fluid pH falls to only 6.5 in this segment. As explained later, the ability of the collecting duct to lower the pH of the tubular fluid is critically important for the excretion of urinary titratable acids and  $NH_4^+$ .

## REGULATION OF H<sup>+</sup> SECRETION

A number of factors regulate the secretion of H<sup>+</sup>, and thus the reabsorption of HCO<sub>3</sub><sup>-</sup>, by the cells of the nephron. From a physiologic perspective, the primary factor that regulates H<sup>+</sup> secretion by the nephron is a change in systemic acid-base balance. Thus acidosis stimulates RNAE, whereas RNAE is reduced during alkalosis.

The response of the kidneys to metabolic acidosis has been extensively studied and includes both immediate changes in the activity or number of transporters in the membrane, or both, and longer term changes in the synthesis of transporters. For example, with metabolic acidosis, the pH of the cells of the nephron decreases. This decrease stimulates H<sup>+</sup> secretion by multiple mechanisms, depending on the particular nephron segment. First, the decrease in intracellular pH creates a more favorable cell-to-tubular fluid H<sup>+</sup> gradient and thereby makes the secretion of H<sup>+</sup> across the apical membrane more energetically favorable. Second, the decrease in pH can lead to allosteric changes in transport proteins, thereby altering their kinetics. Lastly, transporters may be shuttled to the plasma membrane from intracellular vesicles. With long-term acidosis, the abundance of transporters is increased, either by increased transcription of appropriate transporter genes or by increased translation of transporter messenger ribonucleic acid.

Although some of the effects just described may be attributable directly to the decrease in intracellular pH that occurs with metabolic acidosis, most of these changes in cellular H<sup>+</sup> transport are mediated by hormones or other factors. Three known mediators of the renal response to acidosis are endothelin (ET-1), cortisol, and angiotensin-II. ET-1 is produced by endothelial and proximal tubule cells. With acidosis, ET-1 secretion is enhanced. In the proximal tubule ET-1 stimulates the phosphorylation and subsequent insertion into the apical membrane of the Na<sup>+</sup>-H<sup>+</sup> antiporter and insertion of the Na<sup>+</sup>-3HCO<sub>3</sub><sup>-</sup> symporter into the basolateral membrane. ET-1 may mediate the response to acidosis in other nephron segments as well. With acidosis, the secretion of the glucocorticoid hormone cortisol by the adrenal cortex is stimulated. It, in turn, acts on the kidneys to increase the transcription of the Na<sup>+</sup>-H<sup>+</sup> antiporter and Na<sup>+</sup>-3HCO<sub>3</sub><sup>-</sup> symporter genes in the proximal tubule. Angiotensin

## AT THE CELLULAR LEVEL

In response to metabolic acidosis, H<sup>+</sup> secretion along the nephron is increased. Several mechanisms responsible for the increase in H<sup>+</sup> secretion have been elucidated. For example, the intracellular acidification that occurs during metabolic acidosis has been reported to lead to allosteric changes in the Na<sup>+</sup>-H<sup>+</sup> antiporter (NHE3) in the proximal tubule, thereby increasing its transport kinetics. Transporters also are shuttled to the plasma membrane from intracellular vesicles. This mechanism occurs in both the intercalated cells of the collecting duct, where acidosis stimulates the exocytic insertion of H<sup>+</sup> adenosine triphosphatase (H<sup>+</sup>-ATPase) into the apical membrane, and in the proximal tubule, where apical membrane insertion of the Na<sup>+</sup>-H<sup>+</sup> antiporter and H<sup>+</sup>-ATPase has been reported, as has insertion of the Na<sup>+</sup>-3HCO<sub>3</sub><sup>-</sup> symporter (NBCe1) into the basolateral membrane. With long-term acidosis, the abundance of transporters is increased, either by increased transcription of appropriate transporter genes or by increased translation of transporter messenger ribonucleic acid. Examples of this phenomenon include NHE3 and NBCe1 in the proximal tubule and the H<sup>+</sup>-ATPase and Cl<sup>-</sup>-HCO<sub>3</sub><sup>-</sup> antiporter (anion exchanger 1) in the acid-secreting intercalated cells. Additionally, acidosis reduces the expression of pendrin in the HCO<sub>3</sub><sup>-</sup>-secreting intercalated cells.

II increases with acidosis and stimulates H<sup>+</sup> secretion by increasing the activity of the Na<sup>+</sup>-H<sup>+</sup> antiporter throughout the nephron. In the proximal tubule, angiotensin II also stimulates ammonium production and its secretion into the tubular fluid, which, as described later in this chapter, is an important component of the kidneys' response to acidosis.

Acidosis also stimulates the secretion of parathyroid hormone. The increased levels of parathyroid hormone act on the proximal tubule to inhibit phosphate reabsorption (see Chapter 9). In so doing, more phosphate is delivered to the distal nephron, where it can serve as a urinary buffer and thus increase the capacity of the kidneys to excrete titratable acid.

As noted, the response of the kidneys to alkalosis is less well characterized. Clearly RNAE is decreased,

which occurs in part by increased  $\text{HCO}_3^-$  excretion but also by a decrease in the excretion of ammonium and titratable acid. The signals that regulate this response are not well characterized.

### AT THE CELLULAR LEVEL

Cells in the kidney and many other organs express  $\text{H}^+$  and  $\text{HCO}_3^-$  receptors that play key roles in the adaptive response to changes in acid base balance. For example, G protein-coupled receptors that are regulated by extracellular  $[\text{H}^+]$  (i.e., they are inactive when the pH is  $>7.5$  and maximally activated when the pH is 6.8) recently have been identified (OGR1, GPR4, and TDAG8). When activated by extracellular acidification, these receptors increase the production of cyclic adenosine monophosphate (via stimulation of adenylyl cyclase) and/or  $\text{IP}_3$  and diacylglycerol (via stimulation of phospholipase C), which regulate a variety of acid-base transporters. By contrast,  $\text{Pyk2}$  is activated by intracellular acidification, and its activation in the proximal tubule increases  $\text{H}^+$  secretion via the  $\text{Na}^+\text{-H}^+$  antiporter (NHE3) located in the apical membrane and  $\text{HCO}_3^-$  absorption via NBCe1 across the basolateral membrane. Two signaling enzymes, soluble adenylyl cyclase and guanylyl cyclase-D, are regulated by changes in intracellular  $\text{HCO}_3^-$ . When activated, soluble adenylyl cyclase increases cyclic adenosine monophosphate production, which activates protein kinase A, an effect that increases the amount of  $\text{H}^+\text{-ATPase}$  in the apical membrane of  $\alpha$ -intercalated cells in the kidney collecting duct.

Other factors not necessarily related to the maintenance of acid-base balance can influence the secretion of  $\text{H}^+$  by the cells of the nephron. Because a significant  $\text{H}^+$  transporter in the nephron is the  $\text{Na}^+\text{-H}^+$  antiporter, factors that alter  $\text{Na}^+$  reabsorption can secondarily affect  $\text{H}^+$  secretion. For example, with volume contraction (negative  $\text{Na}^+$  balance),  $\text{Na}^+$  reabsorption by the nephron is increased (see Chapter 6), including reabsorption of  $\text{Na}^+$  via the  $\text{Na}^+\text{-H}^+$  antiporter. As a result,  $\text{H}^+$  secretion is enhanced. This phenomenon occurs by several mechanisms. One mechanism involves the renin-angiotensin-aldosterone system, which is activated by volume contraction. Angiotensin


II acts on the proximal tubule to stimulate the apical membrane  $\text{Na}^+\text{-H}^+$  antiporter and the basolateral  $\text{Na}^+\text{-3HCO}_3^-$  symporter. This stimulatory effect includes increased activity of the transporters and insertion of transporters into the membrane. To a lesser degree, angiotensin II stimulates  $\text{H}^+$  secretion in the thick ascending limb of Henle's loop and the early portion of the distal tubule, a process also mediated by the  $\text{Na}^+\text{-H}^+$  antiporter. The primary action of aldosterone on the distal tubule and collecting duct is to stimulate  $\text{Na}^+$  reabsorption by principal cells (see Chapter 6). However, it also stimulates intercalated cells in these segments to secrete  $\text{H}^+$ . This effect is both indirect and direct. By stimulating  $\text{Na}^+$  reabsorption by principal cells, aldosterone hyperpolarizes the transepithelial voltage (i.e., the lumen becomes more electrically negative). This change in transepithelial voltage then facilitates the secretion of  $\text{H}^+$  by the intercalated cells. In addition to this indirect effect, aldosterone (and angiotensin II) acts directly on intercalated cells to stimulate  $\text{H}^+$  secretion via the  $\text{H}^+\text{-ATPase}$ . The precise mechanisms for this stimulatory effect are not fully understood.

Another mechanism by which ECF volume contraction enhances  $\text{H}^+$  secretion ( $\text{HCO}_3^-$  reabsorption) is through changes in peritubular capillary Starling forces. As described in Chapters 4 and 6, ECF volume contraction alters the peritubular capillary Starling forces such that overall proximal tubule reabsorption is enhanced. With this enhanced reabsorption, more of the filtered load of  $\text{HCO}_3^-$  is reabsorbed.

Potassium balance influences the secretion of  $\text{H}^+$  by the proximal tubule.  $\text{H}^+$  secretion is stimulated by hypokalemia and inhibited by hyperkalemia. It is thought that  $\text{K}^+$ -induced changes in intracellular pH are responsible, at least in part, for this effect, with the cells being acidified by hypokalemia and alkalinized by hyperkalemia. Hypokalemia also stimulates  $\text{H}^+$  secretion by the collecting duct, which occurs as a result of increased expression of the  $\text{H}^+\text{-K}^+\text{-ATPase}$  in intercalated cells.

### FORMATION OF NEW $\text{HCO}_3^-$

As discussed previously, reabsorption of the filtered  $\text{HCO}_3^-$  is important for maximizing RNAE. However,  $\text{HCO}_3^-$  reabsorption alone does not replenish




**FIGURE 8-5** ■ General scheme for the excretion of  $H^+$  with non-bicarbonate (non- $HCO_3^-$ ) urinary buffers (titratable acid). The primary urinary buffer is phosphate ( $HPO_4^{2-}$ ). An  $H^+$ -secreting intercalated cell is shown. For simplicity, only the  $H^+$  adenosine triphosphatase (V-ATPase) is depicted.  $H^+$  secretion by  $H^+$ - $K^+$ -ATPase also titrates luminal buffers. AE1, anion exchanger 1; CA, carbonic anhydrase; V-ATPase, vacuolar adenosine triphosphatase.

the  $HCO_3^-$  lost during the buffering of the nonvolatile acids produced during metabolism. To maintain acid-base balance, the kidneys must replace this lost  $HCO_3^-$  with new  $HCO_3^-$ . A portion of the new  $HCO_3^-$  is produced when urinary buffers (primarily  $P_i$ ) are excreted as titratable acid. This process is illustrated in Figure 8-5. In the distal tubule and collecting duct, where the tubular fluid contains little or no  $HCO_3^-$  because of “upstream” reabsorption,  $H^+$  secreted into the tubular fluid combines with a urinary buffer. Thus  $H^+$  secretion results in the excretion of  $H^+$  with a buffer, and the  $HCO_3^-$  produced in the cell from the hydration of  $CO_2$  is added to the blood. The amount of  $P_i$  excreted each day and thus available to serve as a urinary buffer is not sufficient to allow adequate generation of new  $HCO_3^-$ . However, as noted, increased excretion of  $P_i$  does occur with acidosis and therefore contributes to the kidneys’ response to the acidosis. Nevertheless, this amount of  $P_i$  is inadequate to allow the kidneys to excrete sufficient net acid. In comparison,  $NH_4^+$  is produced by the kidneys and its synthesis, and subsequent excretion adds  $HCO_3^-$  to the ECF. In addition, the synthesis of  $NH_4^+$  and the subsequent production of  $HCO_3^-$  are regulated in response to the acid-base requirements of the body. Because of this process,  $NH_4^+$  excretion is critically involved in the formation of new  $HCO_3^-$ .

$NH_4^+$  is produced in the kidneys through the metabolism of **glutamine**. Essentially, the kidneys metabolize glutamine, excrete  $NH_4^+$ , and add  $HCO_3^-$  to the body. However, the formation of new  $HCO_3^-$  by this process depends on the kidneys’ ability to excrete  $NH_4^+$  in the urine. If  $NH_4^+$  is not excreted in the urine but enters the systemic circulation instead, it is converted into urea by the liver. This conversion process generates  $H^+$ , which is then buffered by  $HCO_3^-$ . Thus the production of urea from renally generated  $NH_4^+$  consumes  $HCO_3^-$  and negates the formation of  $HCO_3^-$  through the synthesis and excretion of  $NH_4^+$  by the kidneys. However, normally, the kidneys excrete  $NH_4^+$  in the urine and thereby produce new  $HCO_3^-$ .

The process by which the kidneys excrete  $NH_4^+$  is complex. Figure 8-6 illustrates the essential features of this process.  $NH_4^+$  is produced from glutamine in the cells of the proximal tubule, a process termed **ammoniogenesis**. Each glutamine molecule produces two molecules of  $NH_4^+$  and the divalent anion 2-oxoglutarate<sup>-2</sup>. The metabolism of this anion ultimately provides two molecules of  $HCO_3^-$ . The  $HCO_3^-$  exits the cell across the basolateral membrane and enters the peritubular blood as new  $HCO_3^-$ .  $NH_4^+$  exits the cell across the apical membrane and enters the tubular fluid. The primary mechanism for the secretion of  $NH_4^+$  into the tubular fluid involves the  $Na^+$ - $H^+$  antiporter, with  $NH_4^+$  substituting for  $H^+$ . In addition,  $NH_3$  can diffuse out of the

cell across the plasma membrane into the tubular fluid, where it is protonated to  $\text{NH}_4^+$ .

A significant portion of the  $\text{NH}_4^+$  secreted by the proximal tubule is reabsorbed by the loop of Henle. The thick ascending limb is the primary site of this  $\text{NH}_4^+$  reabsorption, with  $\text{NH}_4^+$  substituting for  $\text{K}^+$  on the  $\text{Na}^+-\text{K}^+-2\text{Cl}^-$  symporter. In addition, the lumen-positive transepithelial voltage in this segment drives the paracellular reabsorption of  $\text{NH}_4^+$  (see Chapter 4).

The  $\text{NH}_4^+$  reabsorbed by the thick ascending limb of the loop of Henle accumulates in the medullary interstitium, where it exists in chemical equilibrium with  $\text{NH}_3$  ( $\text{pK} = 9.0$ ).  $\text{NH}_4^+$  is then secreted into the tubular fluid of the collecting duct. The mechanisms by which  $\text{NH}_4^+$  is secreted by the collecting duct include (1) transport into intercalated cells by the  $\text{Na}^+-\text{K}^+-\text{ATPase}$  ( $\text{NH}_4^+$  substituting for  $\text{K}^+$ ) and exit from the cell across the apical membrane of intercalated cells by the  $\text{H}^+-\text{K}^+-\text{ATPase}$  ( $\text{NH}_4^+$  substituting for  $\text{H}^+$ ) and (2) the process of **nonionic diffusion** and **diffusion trapping**. Of these mechanisms for  $\text{NH}_4^+$  secretion, quantitatively the

most important is nonionic diffusion and diffusion trapping. By this mechanism,  $\text{NH}_3$  diffuses from the medullary interstitium into the lumen of the collecting duct. As previously described,  $\text{H}^+$  secretion by the intercalated cells of the collecting duct acidifies the luminal fluid (a luminal fluid pH as low as 4.0 to 4.5 can be achieved). Consequently,  $\text{NH}_3$  diffusing from the medullary interstitium into the collecting duct lumen (nonionic diffusion) is protonated to  $\text{NH}_4^+$  by the acidic tubular fluid. Because the collecting duct is less permeable to  $\text{NH}_4^+$  than to  $\text{NH}_3$ ,  $\text{NH}_4^+$  is trapped in the tubule lumen (diffusion trapping) and eliminated from the body in the urine. Ammonia diffusion across the collecting duct occurs via Rh glycoproteins.\* Two Rh glycoproteins have been identified thus far in the kidney (RhBG and RhCG) and are localized to the dis-

\*Rh glycoproteins, or rhesus glycoproteins, are so named because of their homology to the rhesus proteins found on red blood cells, which are responsible for hemolytic disease of the newborn. They are a class of membrane proteins that transport  $\text{NH}_3$  and perhaps  $\text{NH}_4^+$ .

tal tubule and collecting duct. RhBG is localized to the basolateral membrane, whereas RhCG is found in both the apical and basolateral membranes. Both RhBG and RhCG are expressed to a greater degree in intercalated cells versus principal cells.

### IN THE CLINIC

Assessing  $\text{NH}_4^+$  excretion by the kidneys is done indirectly because assays of urine  $\text{NH}_4^+$  are not routinely available. In metabolic acidosis, the appropriate renal response is to increase net acid excretion. Accordingly, little or no  $\text{HCO}_3^-$  appears in the urine, the urine is acidic, and  $\text{NH}_4^+$  excretion is increased. To assess  $\text{NH}_4^+$  production, and especially the amount of  $\text{NH}_4^+$  excreted, the urinary net charge, or urine anion gap, can be calculated by measuring the urinary concentrations of  $\text{Na}^+$ ,  $\text{K}^+$ , and  $\text{Cl}^-$ :

$$\text{Urine anion gap} = ([\text{Na}^+] + [\text{K}^+]) - [\text{Cl}^-] \quad (8-8)$$

The concept of urine anion gap during a metabolic acidosis assumes that the major cations in the urine are  $\text{Na}^+$ ,  $\text{K}^+$ , and  $\text{NH}_4^+$  and that the major anion is  $\text{Cl}^-$  (with urine pH less than 6.5, virtually no  $\text{HCO}_3^-$  is present). As a result, the urine anion gap yields a negative value when adequate amounts of  $\text{NH}_4^+$  are being excreted and thereby reflects the amount of  $\text{NH}_4^+$  excreted in the urine. Indeed, the absence of a urine anion gap or the existence of a positive value indicates a renal defect in  $\text{NH}_4^+$  production and excretion.

$\text{H}^+$  secretion by the collecting duct is critical for the excretion of  $\text{NH}_4^+$ . If collecting duct  $\text{H}^+$  secretion is inhibited, the  $\text{NH}_4^+$  reabsorbed by the thick ascending limb of Henle's loop is not excreted in the urine. Instead, it is returned to the systemic circulation, where, as described previously, it is converted to urea by the liver, consuming  $\text{HCO}_3^-$  in the process. Thus new  $\text{HCO}_3^-$  is produced during the metabolism of glutamine by cells of the proximal tubule. However, the overall process is not complete until the  $\text{NH}_4^+$  is excreted (i.e., the production of urea from  $\text{NH}_4^+$  by the liver is prevented). Thus  $\text{NH}_4^+$  excretion in the urine can be used as a "marker" of glutamine metabolism in the proximal tubule. In the net, one new  $\text{HCO}_3^-$  is returned to the systemic circulation for each  $\text{NH}_4^+$  excreted in the urine.

### IN THE CLINIC

**Renal tubule acidosis (RTA)** refers to conditions in which net acid excretion by the kidneys is impaired. Under these conditions, the kidneys are unable to excrete a sufficient amount of net acid (renal net acid excretion [RNAE]) to balance net endogenous acid production, and acidosis results. RTA can be caused by a defect in  $\text{H}^+$  secretion in the proximal tubule (**proximal RTA**) or distal tubule (**distal RTA**) or by inadequate production and excretion of  $\text{NH}_4^+$ .

Proximal RTA can be caused by a variety of hereditary and acquired conditions (e.g., **cystinosis**, **Fanconi syndrome**, or administration of carbonic anhydrase inhibitors). The majority of cases of proximal RTA result from generalized tubule dysfunction rather than a selective defect in one of the proximal tubule acid-base transporters. However, autosomal recessive and autosomal dominant forms of proximal RTA have been identified. An autosomal recessive form of proximal RTA results from a mutation in the  $\text{Na}^+\text{-HCO}_3^-$  symporter (NBCe1). Because this transporter also is expressed in the eye, these patients also have ocular abnormalities. Another autosomal recessive form of proximal RTA occurs in persons who lack carbonic anhydrase (CA-II). Because CA-II is required for normal distal acidification, this defect includes a distal RTA component as well. Finally, an autosomal dominant form of proximal RTA has been identified. However, the transporter involved has not been identified. Regardless of the cause, if  $\text{H}^+$  secretion by the cells of the proximal tubule is impaired, there is decreased reabsorption of the filtered  $\text{HCO}_3^-$ . Consequently,  $\text{HCO}_3^-$  is lost in the urine, the plasma  $[\text{HCO}_3^-]$  decreases, and acidosis ensues.

Distal RTA also occurs in a number of hereditary and acquired conditions (e.g., **medullary sponge kidney**, certain drugs such as **amphotericin B**, and conditions secondary to urinary obstruction). Both autosomal dominant and autosomal recessive forms of distal RTA have been identified. An autosomal dominant form results from mutations in the gene coding for the  $\text{Cl}^-\text{-HCO}_3^-$  antiporter (anion exchanger-1) in the basolateral membrane of the acid-secreting intercalated cell. Autosomal recessive forms are caused by mutations in various subunits of vacuolar  $[\text{H}^+]$ -adenosine triphosphatase ( $\text{H}^+$ -ATPase). In some patients with Sjögren syndrome, an

autoimmune disease, distal RTA develops as a result of antibodies directed against  $H^+$ -ATPase. Lastly,  $H^+$  secretion by the distal tubule and the collecting duct may be normal, but the permeability of the cells to  $H^+$  is increased. This effect occurs with the antifungal drug amphotericin B, the administration of which leads to the development of distal RTA. Regardless of the cause of distal RTA, the ability to acidify the tubular fluid in the distal tubule and collecting duct is impaired. Consequently, titratable acid excretion is reduced, and nonionic diffusion and diffusion trapping of  $NH_4^+$  are impaired. This situation, in turn, decreases RNAE, with the subsequent development of acidosis.

Failure to produce and excrete sufficient quantities of  $NH_4^+$  also can reduce net acid excretion by the kidneys. This situation occurs as a result of generalized dysfunction of the distal tubule and collecting duct with impaired  $H^+$ ,  $NH_4^+$ , and  $K^+$  secretion. Generalized distal nephron dysfunction is seen in persons with loss of function mutations in the  $Na^+$  channel (ENaC), which are inherited in an autosomal recessive pattern. An autosomal dominant form also is seen with loss of function mutations in the mineralocorticoid receptor. More commonly,  $NH_4^+$  production and excretion are impaired in patients with hyporeninemic hypoaldosteronism. These patients typically have moderate degrees of renal failure with reduced levels of renin and, thus, aldosterone. As a result, distal tubule and collecting duct function is impaired. Finally, a number of drugs also can result in distal tubule and collecting duct dysfunction. These drugs block the  $Na^+$  channel (e.g., amiloride), block the production or action of angiotensin II (angiotensin-converting enzyme inhibitor, angiotensin I receptor blockers), or block the action of aldosterone (e.g., spironolactone). Regardless of the cause, the impaired function of the distal tubule and collecting duct results in the development of hyperkalemia, which in turn impairs ammoniogenesis by the proximal tubule.  $H^+$  secretion by the distal tubule and collecting duct and thus  $NH_4^+$  secretion also are impaired by these drugs. Thus RNAE is less than net endogenous acid production, and metabolic acidosis develops.

If the acidosis that results from any of these forms of RTA is severe, individuals must ingest alkali (e.g., baking soda or a solution containing citrate\*) to

maintain acid-base balance. In this way, the  $HCO_3^-$  lost each day in the buffering of nonvolatile acid is replenished by the extra  $HCO_3^-$  ingested in the diet.

\*One of the byproducts of citrate metabolism is  $HCO_3^-$ . Ingestion of drinks containing citrate often is more palatable to patients than ingesting baking soda.

An important feature of the renal  $NH_4^+$  system is that it can be regulated by systemic acid-base balance. As already noted, cortisol levels increase during acidosis and cortisol stimulates ammoniogenesis (i.e.,  $NH_4^+$  production from glutamine). Angiotensin II also stimulates ammoniogenesis and secretion of  $NH_4^+$  into the tubular fluid. The expression of RhCG in the distal tubule and collecting duct is increased with acidosis (in some species, expression of RhBG is also increased). Thus in response to acidosis, both  $NH_4^+$  production and excretion are stimulated. Because this response involves the synthesis of new enzymes, it requires several days for complete adaptation.

Other factors can alter renal  $NH_4^+$  excretion. For example, the  $[K^+]$  of the ECF alters  $NH_4^+$  production. Hyperkalemia inhibits  $NH_4^+$  production, whereas hypokalemia stimulates  $NH_4^+$  production. The mechanism by which plasma  $[K^+]$  alters  $NH_4^+$  production is not fully understood. Alterations in the plasma  $[K^+]$  may change the intracellular pH of proximal tubule cells and in that way influence glutamine metabolism. By this mechanism, hyperkalemia would raise intracellular pH and thereby inhibit glutamine metabolism. The opposite would occur during hypokalemia.

## RESPONSE TO ACID-BASE DISORDERS

The pH of the ECF is maintained within a very narrow range (7.35 to 7.45).\* Inspection of equation 8-3 shows

\*For simplicity of presentation in this chapter, the value of 7.40 for body fluid pH is used as normal, even though the normal range is from 7.35 to 7.45. Similarly, the normal range for  $P_{CO_2}$  is 35 to 45 mm Hg. However, a  $P_{CO_2}$  of 40 mm Hg is used as the normal value. Finally, a value of 24 mEq/L is considered a normal ECF  $[HCO_3^-]$ , even though the normal range is 22 to 28 mEq/L.

that the pH of the ECF varies when either the  $[\text{HCO}_3^-]$  or  $\text{Pco}_2$  is altered. As already noted, disturbances of acid-base balance that result from a change in the  $[\text{HCO}_3^-]$  of the ECF are termed **metabolic acid-base disorders**, whereas those resulting from a change in the  $\text{Pco}_2$  are termed **respiratory acid-base disorders**. The kidneys are primarily responsible for regulating the  $[\text{HCO}_3^-]$ , whereas the lungs regulate the  $\text{Pco}_2$ .

When an acid-base disturbance develops, the body uses a series of mechanisms to defend against the change in the pH of the ECF. These defense mechanisms do not correct the acid-base disturbance but merely minimize the change in pH imposed by the disturbance. Restoration of the blood pH to its normal value requires correction of the underlying process or processes that produced the acid-base disorder. The body has three general mechanisms to compensate for, or defend against, changes in body fluid pH produced by acid-base disturbances: (1) extracellular and intracellular buffering, (2) adjustments in blood  $\text{Pco}_2$  by alterations in the ventilatory rate of the lungs, and (3) adjustments in the RNAE.

### Extracellular and Intracellular Buffers

The first line of defense against acid-base disorders is extracellular and intracellular buffering. The response of the extracellular buffers is virtually instantaneous, whereas the response to intracellular buffering is slower and can take several minutes.

Metabolic disorders that result from the addition of nonvolatile acid or alkali to the body fluids are buffered in both the extracellular and intracellular compartments. The  $\text{HCO}_3^-$  buffer system is the principal ECF buffer. When nonvolatile acid is added to the body fluids (or alkali is lost from the body),  $\text{HCO}_3^-$  is consumed during the process of neutralizing the acid load, and the  $[\text{HCO}_3^-]$  of the ECF is reduced. Conversely, when nonvolatile alkali is added to the body fluids (or acid is lost from the body),  $\text{H}^+$  is consumed, causing more  $\text{HCO}_3^-$  to be produced from the dissociation of  $\text{H}_2\text{CO}_3$ . Consequently, the  $[\text{HCO}_3^-]$  increases.

Although the  $\text{HCO}_3^-$  buffer system is the principal ECF buffer,  $\text{P}_i$  and plasma proteins provide additional extracellular buffering. The combined action of the ECF buffering processes for  $\text{HCO}_3^-$ ,  $\text{P}_i$ , and

plasma protein accounts for approximately 50% of the buffering of a nonvolatile acid load and 70% of that of a nonvolatile alkali load. The remainder of the buffering under these two conditions occurs intracellularly. Intracellular buffering involves the movement of  $\text{H}^+$  into cells (during buffering of nonvolatile acid) or the movement of  $\text{H}^+$  out of cells (during buffering of nonvolatile alkali).  $\text{H}^+$  is titrated inside the cell by  $\text{HCO}_3^-$ ,  $\text{P}_i$ , and the histidine groups on proteins.

Bone represents an additional source of extracellular buffering. With acidosis, buffering by bone results in its demineralization because  $\text{Ca}^{++}$  is released from bone as salts containing  $\text{Ca}^{++}$  bind  $\text{H}^+$  in exchange for  $\text{Ca}^{++}$ .

When respiratory acid-base disorders occur, the pH of body fluids changes as a result of alterations in the  $\text{Pco}_2$ . Virtually all buffering in respiratory acid-base disorders occurs intracellularly. When the  $\text{Pco}_2$  rises (respiratory acidosis),  $\text{CO}_2$  moves into the cell, where it combines with  $\text{H}_2\text{O}$  to form  $\text{H}_2\text{CO}_3$ .  $\text{H}_2\text{CO}_3$  then dissociates to  $\text{H}^+$  and  $\text{HCO}_3^-$ . Some of the  $\text{H}^+$  is buffered by cellular protein, and  $\text{HCO}_3^-$  exits the cell and raises the plasma  $[\text{HCO}_3^-]$ . This process is reversed when the  $\text{Pco}_2$  is reduced (respiratory alkalosis). Under this condition, the hydration reaction ( $\text{H}_2\text{O} + \text{CO}_2 \leftrightarrow \text{H}_2\text{CO}_3$ ) is shifted to the left by the decrease in  $\text{Pco}_2$ . As a result, the dissociation reaction ( $\text{H}_2\text{CO}_3 \leftrightarrow \text{H}^+ + \text{HCO}_3^-$ ) also shifts to the left, thereby reducing the plasma  $[\text{HCO}_3^-]$ .

### Respiratory Compensation

The lungs are the second line of defense against acid-base disorders. As indicated by the Henderson-Hasselbalch equation (see equation 8-3), changes in the  $\text{Pco}_2$  alter the blood pH; a rise decreases the pH, and a reduction increases the pH.

The ventilatory rate determines the  $\text{Pco}_2$ . Increased ventilation decreases  $\text{Pco}_2$ , whereas decreased ventilation increases it. The blood  $\text{Pco}_2$  and pH are important regulators of the ventilatory rate. Chemoreceptors located in the brainstem (ventral surface of the medulla) and periphery (carotid and aortic bodies) sense changes in  $\text{Pco}_2$  and  $[\text{H}^+]$  and alter the ventilatory rate appropriately. Thus when metabolic acidosis occurs, a rise in the  $[\text{H}^+]$  (decrease in pH) increases the

ventilatory rate. Conversely, during metabolic alkalosis, a decreased  $[H^+]$  (increase in pH) leads to a reduced ventilatory rate. With maximal hyperventilation, the  $PCO_2$  can be reduced to approximately 10 mm Hg. Because hypoxia, a potent stimulator of ventilation,

also develops with hypoventilation, the degree to which the  $PCO_2$  can be increased is limited. In an otherwise healthy person, hypoventilation cannot raise the  $PCO_2$  above 60 mm Hg. The respiratory response to metabolic acid-base disturbances may be initiated within minutes but may require several hours to complete.

### IN THE CLINIC

Metabolic acidosis can develop in patients with insulin-dependent diabetes (secondary to the production of keto acids) if insulin dosages are not adequate. As a compensatory response to this acidosis, deep and rapid breathing develops. This breathing pattern is termed **Kussmaul respiration**. With prolonged Kussmaul respiration, the muscles involved can become fatigued. When this muscle fatigue happens, respiratory compensation is impaired, and the acidosis can become more severe.

### IN THE CLINIC

Loss of gastric contents from the body (i.e., through vomiting or nasogastric suction) produces metabolic alkalosis as a result of the loss of HCl. If the loss of gastric fluid is significant, extracellular fluid volume contraction occurs. Under this condition, the kidneys cannot excrete sufficient quantities of  $HCO_3^-$  to compensate for the metabolic alkalosis. Bicarbonate ( $HCO_3^-$ ) is not excreted because the volume contraction enhances  $Na^+$  reabsorption by the proximal tubule and increases angiotensin II and aldosterone levels (see Chapter 6). These responses in turn limit  $HCO_3^-$  excretion because a significant amount of  $Na^+$  reabsorption in the proximal tubule is coupled to  $H^+$  secretion through the  $Na^+-H^+$  antiporter. As a result,  $HCO_3^-$  reabsorption is increased because of the need to reduce  $Na^+$  excretion. In addition, the elevated aldosterone levels stimulate  $H^+$  secretion by the distal tubule and collecting duct. Thus in persons who lose gastric contents, metabolic alkalosis and, paradoxically, acidic urine characteristically occur. Correction of the alkalosis occurs only when euolemia is reestablished. With restoration of euolemia, by the addition of sodium chloride (NaCl) with fluid (e.g., isotonic saline),  $HCO_3^-$  reabsorption by the proximal tubule decreases, as does  $H^+$  secretion by the distal tubule and collecting duct. As a result,  $HCO_3^-$  excretion increases, and the plasma concentration of  $HCO_3^-$  ( $[HCO_3^-]$ ) returns to normal.

### IN THE CLINIC

When nonvolatile acid is added to the body fluids, as in **diabetic ketoacidosis**, the concentration of  $H^+$  ( $[H^+]$ ) increases (pH decreases) and the concentration of  $HCO_3^-$  ( $[HCO_3^-]$ ) decreases. In addition, the concentration of the anion associated with the nonvolatile acid increases. This change in the anion concentration provides a convenient way to analyze the cause of a metabolic acidosis by calculating what is termed the **anion gap**. The anion gap represents the difference between the concentration of the major extracellular fluid cation ( $Na^+$ ) and the major extracellular fluid anions ( $Cl^-$  and  $HCO_3^-$ ):

$$\text{Anion gap} = [Na^+] - ([Cl^-] + [HCO_3^-]) \quad (8-9)$$

Under normal conditions, the anion gap ranges from 8 to 16 mEq/L. It is important to recognize that an anion gap does not actually exist. All cations are balanced by anions. The gap simply reflects the parameters that are measured. In reality:


$$[Na^+] + [\text{unmeasured cations}] = [Cl^-] + [HCO_3^-] + [\text{unmeasured anions}] \quad (8-10)$$

If the anion of the nonvolatile acid is  $Cl^-$ , the anion gap is normal; that is, the decrease in the  $[HCO_3^-]$  is matched by an increase in  $[Cl^-]$ . The metabolic acidosis associated with diarrhea or renal tubular acidosis has a normal anion gap. In contrast, if the anion of the nonvolatile acid is not  $Cl^-$  (e.g., lactate and  $\beta$ -hydroxybutyrate), the anion gap increase (i.e., the decrease in the  $[HCO_3^-]$  is not matched by an increase in the  $[Cl^-]$  but rather by an increase in the concentration of the unmeasured anion). The anion gap is increased in metabolic acidosis associated with renal failure, diabetes mellitus (ketoacidosis), lactic acidosis, and the ingestion of large quantities of aspirin. Thus calculation of the anion gap is a useful way to identify the etiology of metabolic acidosis in the clinical setting.

## Renal Compensation

The third and final line of defense against acid-base disorders is the kidneys. In response to an alteration in the plasma pH and  $P_{CO_2}$ , the kidneys make appropriate adjustments in the excretion of  $HCO_3^-$  and net acid. The renal response may require several days to reach completion because it takes hours to days to increase the synthesis and activity of key  $H^+$  and  $HCO_3^-$  transporters and the proximal tubule enzymes involved in  $NH_4^+$  production. In the case of acidosis (increased  $[H^+]$  or  $P_{CO_2}$ ), the secretion of  $H^+$  by the nephron is stimulated, and the entire filtered load of  $HCO_3^-$  is reabsorbed. Titratable acid excretion is increased, the production and excretion of  $NH_4^+$  are also stimulated, and thus RNAE is increased (see equation 8-7 and Figure 8-7). The new  $HCO_3^-$  generated during the process of net acid excretion is added to the body, and the plasma  $[HCO_3^-]$  increases.

When alkalosis exists (decreased  $[H^+]$  or  $P_{CO_2}$ ), the secretion of  $H^+$  by the nephron is inhibited. As a result,  $HCO_3^-$  reabsorption is reduced, as is the excretion of both titratable acid and  $NH_4^+$ . Thus RNAE is decreased and  $HCO_3^-$  appears in the urine. Also, some  $HCO_3^-$  is secreted into the urine by the  $HCO_3^-$ -secreting intercalated cells of the distal tubule and collecting duct. With enhanced excretion of  $HCO_3^-$ , the plasma  $[HCO_3^-]$  decreases.



## SIMPLE ACID-BASE DISORDERS

Table 8-1 summarizes the primary alterations and the subsequent compensatory or defense mechanisms of the various simple acid-base disorders. In all acid-base disorders the compensatory response does not correct the underlying disorder but simply reduces the magnitude of the change in pH. Correction of the acid-base disorder requires treatment of its cause.

### Metabolic Acidosis

Metabolic acidosis is characterized by a decreased ECF  $[HCO_3^-]$  and pH. It can develop through addition of nonvolatile acid to the body (e.g., diabetic ketoacidosis), loss of nonvolatile alkali (e.g.,  $HCO_3^-$  loss caused by diarrhea), or failure of the kidneys to excrete sufficient net acid to replenish the  $HCO_3^-$  used to neutralize nonvolatile acids (e.g., renal tubular acidosis and renal failure). As previously described, the buffering of  $H^+$  occurs in both the ECF and intracellular fluid (ICF) compartments. When the pH falls, the respiratory centers are stimulated, and the ventilatory rate is increased (respiratory compensation). This process reduces the  $P_{CO_2}$ , which further minimizes the decrease in plasma pH. In general, a decrease of 1.2 mm Hg occurs in the  $P_{CO_2}$  for every 1 mEq/L decrease in ECF  $[HCO_3^-]$ . Thus

if the  $[\text{HCO}_3^-]$  was reduced to 14 mEq/L from a normal value of 24 mEq/L, the expected decrease in  $\text{Pco}_2$  would be 12 mm Hg and the measured  $\text{Pco}_2$  would decrease to 28 mm Hg (normal  $\text{Pco}_2 = 40$  mm Hg).

Finally, in metabolic acidosis, RNAE is increased. This increase occurs through the elimination of all  $\text{HCO}_3^-$  from the urine (enhanced reabsorption of filtered  $\text{HCO}_3^-$ ) and through increased titratable acid and  $\text{NH}_4^+$  excretion (enhanced production of new  $\text{HCO}_3^-$ ). If the process that initiated the acid-base disturbance is corrected, the enhanced net acid excretion by the kidneys ultimately returns the pH and  $[\text{HCO}_3^-]$  to normal. After correction of the pH, the ventilatory rate also returns to normal.

### Metabolic Alkalosis

Metabolic alkalosis is characterized by an increased ECF  $[\text{HCO}_3^-]$  and pH. It can occur through the addition of nonvolatile alkali to the body (e.g., ingestion of antacids), as a result of volume contraction (e.g., hemorrhage), or, more commonly, from the loss of nonvolatile acid (e.g., loss of gastric HCl because of prolonged vomiting). Buffering occurs predominantly in the ECF compartment and to a lesser degree in the ICF compartment. The increase in the pH inhibits the respiratory centers, the ventilatory rate is reduced, and thus the  $\text{Pco}_2$  is

elevated (respiratory compensation). With appropriate respiratory compensation, a 0.7 mm Hg increase in  $\text{Pco}_2$  is expected for every 1 mEq/L rise in ECF  $[\text{HCO}_3^-]$ .

The renal compensatory response to metabolic alkalosis is to increase the excretion of  $\text{HCO}_3^-$  by reducing its reabsorption along the nephron. Normally, this process occurs quite rapidly (within minutes to hours) and effectively. However, as already noted, when alkalosis occurs with ECF volume contraction (e.g., vomiting in which fluid loss occurs with  $\text{H}^+$  loss),  $\text{HCO}_3^-$  is not excreted. In volume-depleted individuals, renal excretion of  $\text{HCO}_3^-$  is impaired and alkalosis is corrected, only with restoration of euolemia. Enhanced renal excretion of  $\text{HCO}_3^-$  eventually returns the pH and  $[\text{HCO}_3^-]$  to normal, provided that the underlying cause of the initial acid-base disturbance is corrected. When the pH is corrected, the ventilatory rate also returns to normal.

### Respiratory Acidosis

Respiratory acidosis is characterized by an elevated  $\text{Pco}_2$  and reduced ECF pH. It results from decreased gas exchange across the alveoli as a result of either inadequate ventilation (e.g., drug-induced depression of the respiratory centers) or impaired gas diffusion (e.g., pulmonary edema, such as that which occurs in cardiovascular or lung disease). In contrast to metabolic acid-base disorders, buffering during respiratory acidosis occurs almost entirely in the ICF compartment. The increase in the  $\text{Pco}_2$  and the decrease in pH stimulate both  $\text{HCO}_3^-$  reabsorption by the nephron and titratable acid and  $\text{NH}_4^+$  excretion (renal compensation). Together, these responses increase RNAE and generate new  $\text{HCO}_3^-$ . The renal compensatory response takes several days to develop fully. Consequently, respiratory acid-base disorders are commonly divided into acute and chronic phases. In the acute phase, the time for the renal compensatory response is not sufficient, and the body relies on ICF buffering to minimize the change in pH. During this phase, and because of the buffering, a 1 mEq/L increase in ECF  $[\text{HCO}_3^-]$  occurs for every 10 mm Hg rise in  $\text{Pco}_2$ . In the chronic phase, renal compensation occurs, and a 3.5 mEq/L increase in ECF  $[\text{HCO}_3^-]$  occurs for each 10 mm Hg rise in  $\text{Pco}_2$ . Correction of the underlying disorder returns the  $\text{Pco}_2$  to normal, and renal net acid excretion decreases to its initial level.

## Respiratory Alkalosis

Respiratory alkalosis is characterized by a reduced  $P_{CO_2}$  and an increased ECF pH. It results from increased gas exchange in the lungs, usually caused by increased ventilation from stimulation of the respiratory centers (e.g., by drugs or disorders of the central nervous system). Hyperventilation also occurs at high altitude and as a result of anxiety, pain, or fear. As noted, buffering is primarily in the ICF compartment. As with respiratory acidosis, respiratory alkalosis has both acute and chronic phases reflecting the time required for renal compensation to occur. In the acute phase of respiratory alkalosis, which reflects intracellular buffering, the ECF  $[HCO_3^-]$  decreases 2 mEq/L for every 10 mm Hg decrease in  $P_{CO_2}$ . With renal compensation, the elevated pH and reduced  $P_{CO_2}$  inhibit  $HCO_3^-$  reabsorption by the nephron and reduce TA and  $NH_4^+$  excretion. As a result of these two effects, net acid excretion is reduced. With complete renal compensation, an expected 5 mEq/L decrease in ECF  $[HCO_3^-]$  occurs for every 10 mm Hg reduction in  $P_{CO_2}$ . Correction of the underlying disorder returns the  $P_{CO_2}$  to normal, and renal excretion of acid then increases to its initial level.

## ANALYSIS OF ACID-BASE DISORDERS

The analysis of an acid-base disorder is directed at identifying the underlying cause so that appropriate therapy can be initiated. The patient's medical history and associated physical findings often provide valuable clues about the nature and origin of an acid-base disorder. In addition, the analysis of an arterial blood sample is frequently required. Such an analysis is straightforward if approached systematically. For example, consider the following data:

pH	7.35
$[HCO_3^-]$	16 mEq/L
$P_{CO_2}$	30 mm Hg


The acid-base disorder represented by these values, or any other set of values, can be determined using the following three-step approach (Figure 8-8):

1. *Examination of the pH:* When the pH is considered first, the underlying disorder can be

classified as either an acidosis or an alkalosis. The defense mechanisms of the body cannot correct an acid-base disorder by themselves. Thus even if the defense mechanisms are completely operative, the change in pH indicates the acid-base disorder. In the example provided, the pH of 7.35 indicates acidosis.

2. *Determination of metabolic versus respiratory disorder:* Simple acid-base disorders are either metabolic or respiratory. To determine which disorder is present, the clinician must next examine the ECF  $[HCO_3^-]$  and  $P_{CO_2}$ . As previously discussed, acidosis could be the result of a decrease in the  $[HCO_3^-]$  (metabolic) or an increase in the  $P_{CO_2}$  (respiratory). Alternatively, alkalosis could be the result of an increase in the ECF  $[HCO_3^-]$  (metabolic) or a decrease in the  $P_{CO_2}$  (respiratory). For the example provided, the ECF  $[HCO_3^-]$  is reduced from normal (normal = 24 mEq/L), as is the  $P_{CO_2}$  (normal = 40 mm Hg). The disorder therefore must be metabolic acidosis; it cannot be a respiratory acidosis because the  $P_{CO_2}$  is reduced.
3. *Analysis of a compensatory response:* Metabolic disorders result in compensatory changes in ventilation and thus in the  $P_{CO_2}$ , whereas respiratory disorders result in compensatory changes in RNAE and thus in the ECF  $[HCO_3^-]$ . In an appropriately compensated metabolic acidosis, the  $P_{CO_2}$  is decreased, whereas it is elevated in compensated metabolic alkalosis. With respiratory acidosis, compensation results in an elevation of the  $[HCO_3^-]$ . Conversely, the ECF  $[HCO_3^-]$  is reduced in response to respiratory alkalosis. In this example, the  $P_{CO_2}$  is reduced from normal, and the magnitude of this reduction (10 mm Hg decrease in  $P_{CO_2}$  for an 8 mEq/L increase in ECF  $[HCO_3^-]$ ) is as expected (see Figure 8-8). Therefore the acid-base disorder is a simple metabolic acidosis with appropriate respiratory compensation.

If the appropriate compensatory response is not present, a **mixed acid-base disorder** should be suspected. Such a disorder reflects the presence of two or more underlying causes for the acid-base disturbance. A mixed disorder should be suspected when analysis of the arterial blood gas indicates that appropriate

compensation has not occurred. For example, consider the following data:

pH	6.96
$[\text{HCO}_3^-]$	12 mEq/L
$\text{PCO}_2$	55 mm Hg

When the three-step approach is followed, it is evident that the disturbance is an acidosis that has both a metabolic component (ECF  $[\text{HCO}_3^-] < 24$  mEq/L) and a respiratory component ( $\text{PCO}_2 > 40$  mm Hg). Thus this disorder is mixed. Mixed acid-base disorders can occur, for example, in a person who has a history of a chronic pulmonary disease such as emphysema (i.e., chronic respiratory acidosis) and who experiences an acute gastrointestinal illness with

diarrhea. Because diarrhea fluid contains  $\text{HCO}_3^-$ , its loss from the body results in the development of metabolic acidosis.

A mixed acid-base disorder also is indicated when a patient has abnormal  $\text{PCO}_2$  and ECF  $[\text{HCO}_3^-]$  values but the pH is normal. Such a condition can develop in a patient who has ingested a large quantity of aspirin. The salicylic acid (which is the active ingredient in aspirin) produces metabolic acidosis, and at the same time it stimulates the respiratory centers, causing hyperventilation and respiratory alkalosis. Thus the patient has a reduced ECF  $[\text{HCO}_3^-]$  and a reduced  $\text{PCO}_2$ . (Note: The  $\text{PCO}_2$  is lower than would occur with normal respiratory compensation of a metabolic acidosis.)

## S U M M A R Y

1. The pH of the body fluids is maintained within a narrow range by the coordinated function of the lungs and kidneys. These organs maintain acid-base balance by balancing the excretion of acid and alkali with the amounts ingested in the diet and produced by metabolism.
2. The kidneys maintain acid-base balance through the excretion of an amount of acid equal to the amount of nonvolatile acid produced by metabolism and the quantity ingested in the diet. The kidneys also prevent the loss of  $\text{HCO}_3^-$  in the urine by reabsorbing virtually all the  $\text{HCO}_3^-$  filtered at the glomeruli. Both the reabsorption of filtered  $\text{HCO}_3^-$  and the excretion of acid are accomplished by the secretion of  $\text{H}^+$  by the nephrons.
3. RNAE is quantitated as:

$$\text{RNAE} = [(U_{\text{NH}_4^+} \times \dot{V}) + (U_{\text{TA}} \times \dot{V})] - (U_{\text{HCO}_3^-} \times \dot{V})$$

where  $(U_{\text{NH}_4^+} \times \dot{V})$  and  $(U_{\text{TA}} \times \dot{V})$  are the rates of excretion (mEq/day) of  $\text{NH}_4^+$  and titratable acid and  $(U_{\text{HCO}_3^-} \times \dot{V})$  is the amount of  $\text{HCO}_3^-$  lost in the urine (equivalent to adding  $\text{H}^+$  to the body).

4. The primary titratable urinary buffer is  $\text{P}_i$  (titratable acid). The excretion of titratable acid together with the production (from glutamine metabolism) and excretion of  $\text{NH}_4^+$  are critical to the generation of new  $\text{HCO}_3^-$  by the kidneys.
5. The body uses three lines of defense to minimize the impact of acid-base disorders on body fluid pH: (1) ECF and ICF buffering, (2) respiratory compensation, and (3) renal compensation.
6. Metabolic acid-base disorders result from primary alterations in the ECF  $[\text{HCO}_3^-]$ , which in turn results from the addition of acid to or loss of alkali from the body. In response to metabolic acidosis, pulmonary ventilation is increased, which decreases the  $\text{Pco}_2$ , and renal net acid excretion is increased. An increase in the ECF  $[\text{HCO}_3^-]$  causes alkalosis. This condition decreases pulmonary ventilation, which elevates the  $\text{Pco}_2$ . Renal net acid excretion is decreased, and net alkali excretion results. The pulmonary response to metabolic acid-base disorders occurs in a matter of minutes. The renal response may take several days to develop fully.
7. Respiratory acid-base disorders result from primary alterations in the  $\text{Pco}_2$ . Elevation of the  $\text{Pco}_2$  produces acidosis, and the kidneys respond with an increase in net acid excretion. Conversely, reduction of the  $\text{Pco}_2$  produces alkalosis, and renal net acid excretion is reduced. The kidneys respond to respiratory acid-base disorders over several hours to days.

## REGULATION OF CALCIUM AND PHOSPHATE HOMEOSTASIS

# C

$\text{Ca}^{++}$  and inorganic phosphate ( $\text{P}_i$ )\* are multivalent ions that subserve many complex and vital functions.  $\text{Ca}^{++}$  is an important cofactor in many enzymatic reactions, it is a key second messenger in numerous signaling pathways, it plays an important role in the excitability of nerve and muscle, signal transduction, blood clotting, and muscle contraction, and it is a critical component of the extracellular matrix, cartilage, teeth, and bone.  $\text{P}_i$ , like  $\text{Ca}^{++}$ , is a key component

of bone.  $\text{P}_i$  is important for metabolic processes, including formation of adenosine triphosphate, and it is an important component of nucleotides, nucleosides, and phospholipids. Phosphorylation of proteins is an important mechanism of cellular signaling, and  $\text{P}_i$  is an important buffer in cells, plasma, and urine.

In adults, the kidneys play important roles in regulating total body  $\text{Ca}^{++}$  and  $\text{P}_i$  by excreting the amount of  $\text{Ca}^{++}$  and  $\text{P}_i$  that is absorbed by the intestinal tract (normal bone remodeling results in no net addition of  $\text{Ca}^{++}$  and  $\text{P}_i$  to the bone or  $\text{Ca}^{++}$  and  $\text{P}_i$  release from the bone). If the plasma concentrations of  $\text{Ca}^{++}$  and  $\text{P}_i$  decline substantially, intestinal absorption, bone

\*At physiologic pH, inorganic phosphate exists as  $\text{HPO}_4^{2-}$  and  $\text{H}_2\text{PO}_4^-$  ( $\text{pK} = 6.8$ ). For simplicity, these ion species are collectively referred to as  $\text{P}_i$ .

resorption (i.e., the loss of  $\text{Ca}^{++}$  and  $\text{P}_i$  from bone), and renal tubular reabsorption increase and return plasma concentrations of  $\text{Ca}^{++}$  and  $\text{P}_i$  to normal levels. During growth and pregnancy, intestinal absorption exceeds urinary excretion, and these ions accumulate in newly formed fetal tissue and bone. In contrast, bone disease (e.g., osteoporosis) or a decline in lean body mass increases urinary  $\text{Ca}^{++}$  and  $\text{P}_i$  loss without a change in intestinal absorption. These conditions produce a net loss of  $\text{Ca}^{++}$  and  $\text{P}_i$  from the body. Finally, during chronic renal failure,  $\text{P}_i$  accumulates in the body because absorption by the intestinal tract exceeds excretion in the urine. This situation can lead to the accumulation of  $\text{P}_i$  in the body and changes in bone (see In The Clinic on page 157).

The kidneys, in conjunction with the intestinal tract and bone, play a major role in maintaining plasma  $\text{Ca}^{++}$  and  $\text{P}_i$  levels as well as  $\text{Ca}^{++}$  and  $\text{P}_i$  balance. Accordingly, this chapter discusses  $\text{Ca}^{++}$  and  $\text{P}_i$  handling by the kidneys, with an emphasis on the hormones and factors that regulate urinary excretion.

## CALCIUM






FIGURE 9-1 ■ Distribution of  $\text{Ca}^{++}$  in plasma.

Cellular processes in which  $\text{Ca}^{++}$  plays an important role include bone formation, cell division and growth, blood coagulation, hormone-response coupling, and electrical stimulus-response coupling (e.g., muscle contraction and neurotransmitter release). A total of 99% of  $\text{Ca}^{++}$  is stored in bone and teeth, approximately 1% is found in the intracellular fluid (ICF), and 0.1% is located in the extracellular fluid (ECF). The total  $\text{Ca}^{++}$  concentration ( $[\text{Ca}^{++}]$ ) in plasma is 10 mg/dL (2.5 mmol/L, or 5 mEq/L), and its concentration is normally maintained within very narrow limits. Approximately 50% of the  $\text{Ca}^{++}$  in plasma is ionized, 40% is bound to plasma proteins (mainly albumin), and 10% is complexed to several anions, including  $\text{P}_i$ , bicarbonate ( $\text{HCO}_3^-$ ), citrate, and  $\text{SO}_4^{=}$  (Figure 9-1). The pH of plasma influences this distribution (Figure 9-2). Acidemia increases the percentage of ionized  $\text{Ca}^{++}$  at the expense of  $\text{Ca}^{++}$  bound to proteins, whereas alkalemia decreases the percentage of ionized  $\text{Ca}^{++}$ , again by altering the  $\text{Ca}^{++}$  bound to proteins. Persons with alkalemia are susceptible to **tetany** (tonic muscular spasms), whereas persons with acidemia are less susceptible to tetany, even when total plasma  $\text{Ca}^{++}$  levels

are reduced. The increase in  $[\text{H}^+]$  in patients with metabolic acidosis causes more  $\text{H}^+$  to bind to plasma proteins,  $\text{P}_i$ ,  $\text{HCO}_3^-$ , citrate, and  $\text{SO}_4^{=}$ , thereby displacing  $\text{Ca}^{++}$ . This displacement increases the plasma concentration of ionized  $\text{Ca}^{++}$ . In alkalemia, the  $[\text{H}^+]$  of plasma decreases. Some  $\text{H}^+$  ions dissociate from plasma proteins,  $\text{P}_i$ ,  $\text{HCO}_3^-$ , citrate, and  $\text{SO}_4^{=}$  in exchange for  $\text{Ca}^{++}$ , thereby decreasing the plasma concentration of ionized  $\text{Ca}^{++}$ . In addition, the plasma albumin concentration also affects ionized plasma  $[\text{Ca}^{++}]$ . **Hypoalbuminemia** increases the ionized  $[\text{Ca}^{++}]$ , whereas **hyperalbuminemia** decreases ionized plasma  $[\text{Ca}^{++}]$ . The total measured plasma  $[\text{Ca}^{++}]$  does not reflect the total ionized  $[\text{Ca}^{++}]$ , which is the physiologic relevant measure of plasma  $[\text{Ca}^{++}]$ . A low ionized plasma  $[\text{Ca}^{++}]$  (**hypocalcemia**) increases the excitability of nerve and muscle cells and can lead to hypocalcemic tetany. Tetany associated with hypocalcemia occurs because hypocalcemia causes the threshold potential to shift to more negative values (i.e., closer to the resting membrane voltage; see Figure 9-3). An elevated ionized plasma  $[\text{Ca}^{++}]$  (**hypercalcemia**) may decrease neuromuscular excitability or produce cardiac arrhythmias, lethargy, disorientation, and even death.\* This effect of

\*In clinical practice, the terms “hypercalcemia” and “hypocalcemia” often are used to describe a high or low total plasma  $[\text{Ca}^{++}]$ , respectively, even though this usage is not the physiologically correct usage of hypercalcemia and hypocalcemia.

hypercalcemia occurs because an elevated plasma  $[Ca^{++}]$  causes the threshold potential to shift to less negative values (i.e., further from the resting membrane voltage). Plasma  $[Ca^{++}]$  is regulated within a very narrow range primarily by **parathyroid hormone** (PTH), **calcitriol** (1,25-dihydroxyvitamin D), the active metabolite of vitamin D<sub>3</sub>, and plasma  $Ca^{++}$ .

Within cells,  $Ca^{++}$  is sequestered in the endoplasmic reticulum and mitochondria, or it is bound to proteins. Thus the free intracellular  $[Ca^{++}]$  is very low (~100 nmol). The large concentration gradient for  $[Ca^{++}]$  across cell membranes is maintained by a  $Ca^{++}$ -adenosine triphosphatase (ATPase) pump (PMCa1b) in all cells and by a  $3Na^{+}$ - $Ca^{++}$  exchanger (NCX1) in some cells.




FIGURE 9-4 ■ Overview of  $\text{Ca}^{++}$  homeostasis. *PTH*, Parathyroid hormone.

### Overview of $\text{Ca}^{++}$ Homeostasis

$\text{Ca}^{++}$  homeostasis depends on two factors: (1) the total amount of  $\text{Ca}^{++}$  in the body and (2) the distribution of  $\text{Ca}^{++}$  between bone and the ECF. The total body  $\text{Ca}^{++}$  level is determined by the relative amounts of  $\text{Ca}^{++}$  absorbed by the intestinal tract and excreted by the kidneys (Figure 9-4). The intestinal tract absorbs  $\text{Ca}^{++}$  through an active, carrier-mediated transport mechanism that is stimulated by calcitriol, the active metabolite of vitamin  $\text{D}_3$  that is produced in the proximal tubule of the kidneys. Net  $\text{Ca}^{++}$  absorption by the intestine is normally 200 mg/day (5 mmol/day), but it can increase to 600 mg/day (15 mmol/day) when calcitriol levels rise. In adults,  $\text{Ca}^{++}$  excretion by the kidneys equals the amount absorbed by the gastrointestinal tract (200 mg/day), and it changes in parallel with intestinal absorption. Thus in adults,  $\text{Ca}^{++}$  balance is maintained because the amount of  $\text{Ca}^{++}$  ingested in an average diet (1000 mg/day or 25 mmol/day) equals the amount lost in the feces (800 mg/day or 20 mmol/day), the amount that escapes absorption by the intestinal tract, plus the amount excreted in the urine (200 mg/day).

The second factor that controls  $\text{Ca}^{++}$  homeostasis is the distribution of  $\text{Ca}^{++}$  between bone and the ECF

(see Figure 9-4). Two hormones (PTH and calcitriol\*) regulate the distribution of  $\text{Ca}^{++}$  between bone and the ECF and thereby, in concert with the kidneys, regulate the plasma  $[\text{Ca}^{++}]$ . PTH is secreted by the parathyroid glands, and its secretion is stimulated by a decline in the plasma  $[\text{Ca}^{++}]$  (i.e., hypocalcemia). Plasma  $\text{Ca}^{++}$  is an agonist of the **calcium-sensing receptor** (CaSR), which is located in the plasma membrane of chief cells in parathyroid glands (see the discussion that follows). Hypercalcemia activates the CaSR, which decreases PTH release, whereas hypocalcemia reduces CaSR activity, which in turn increases PTH release. PTH increases the plasma  $[\text{Ca}^{++}]$  by (1) stimulating bone resorption, (2) increasing  $\text{Ca}^{++}$  reabsorption by the distal tubule of the kidney, and (3) stimulating the production of calcitriol, which in turn increases  $\text{Ca}^{++}$  absorption by the intestinal tract and facilitates PTH-mediated

\*Calcitonin is secreted by thyroid C-cells (also known as parafollicular cells), and its secretion is stimulated by hypercalcemia. Calcitonin decreases the plasma  $[\text{Ca}^{++}]$  mainly by stimulating bone formation (i.e., deposition of  $\text{Ca}^{++}$  in bone). Although calcitonin plays an important role in  $\text{Ca}^{++}$  homeostasis in lower vertebrates, it plays only a minor role in  $\text{Ca}^{++}$  homeostasis in humans and thus is not discussed further in this book.


bone resorption. The production of calcitriol in the kidney is stimulated by hypocalcemia and hypophosphatemia. Calcitriol increases the plasma  $[Ca^{++}]$  primarily by stimulating  $Ca^{++}$  absorption from the intestinal tract. It also facilitates the action of PTH on bone and enhances  $Ca^{++}$  reabsorption in the kidneys by increasing the expression of key  $Ca^{++}$  transport and binding proteins in the kidneys. In addition, hypercalcemia activates the CaSR in the thick ascending limb of Henle's loop, inhibiting  $Ca^{++}$  reabsorption in this segment, which results in an increase in urinary  $Ca^{++}$  excretion and thereby reduces plasma  $[Ca^{++}]$ . Hypocalcemia has the opposite effect. Importantly, regulation of  $Ca^{++}$  excretion by the kidneys is one of the major ways that the body regulates plasma  $[Ca^{++}]$ .

### IN THE CLINIC

Conditions that lower parathyroid hormone (PTH) levels (e.g., hypoparathyroidism after parathyroidectomy for an adenoma) reduce plasma  $[Ca^{++}]$ , which can cause **hypocalcemic tetany** (intermittent muscular contractions). In severe cases, hypocalcemic tetany can cause death by asphyxiation. Hypercalcemia also can cause lethal cardiac arrhythmias and decreased neuromuscular excitability. Clinically, the most common causes of hypercalcemia are primary hyperparathyroidism and malignancy-associated hypercalcemia. Primary hyperparathyroidism results most often from the overproduction of PTH caused by a benign tumor of the parathyroid glands. In contrast, malignancy-associated hypercalcemia, which occurs in 10% to 20% of all patients with cancer, is caused by the secretion of **parathyroid hormone-related peptide**, a PTH-like hormone secreted by carcinomas in various organs. Increased levels of PTH and parathyroid hormone-related peptide cause hypercalcemia and hypercalciuria.

### $Ca^{++}$ Transport Along the Nephron

The  $Ca^{++}$  available for glomerular filtration consists of the ionized fraction and the amount complexed with anions. Thus about 60% of the  $Ca^{++}$  in the plasma is available for glomerular filtration. Normally, 99% of the filtered  $Ca^{++}$  is reabsorbed by the

nephron (Figure 9-5). The proximal tubule reabsorbs about 50% to 60% of the filtered  $Ca^{++}$ . Another 15% is reabsorbed in the loop of Henle (mainly the cortical portion of the thick ascending limb), about 10% to 15% is reabsorbed by the distal tubule, and <1% is reabsorbed by the collecting duct. About 1% (200 mg/day) is excreted in the urine. This fraction is equal to the net amount absorbed daily by the intestinal tract.

$Ca^{++}$  reabsorption by the proximal tubule occurs primarily via the paracellular pathway (see Figure 4-1). This passive, paracellular reabsorption of  $Ca^{++}$  is driven by the lumen-positive transepithelial voltage across the second half of the proximal tubule and by a favorable concentration gradient of  $Ca^{++}$ , both of which are established by transcellular sodium and water reabsorption in the first half of the proximal tubule.


$Ca^{++}$  reabsorption by the loop of Henle also occurs primarily via the paracellular pathway. Like the proximal tubule,  $Ca^{++}$  and  $Na^{+}$  reabsorption in the thick ascending limb parallel each other. These processes are parallel because of the significant component of  $Ca^{++}$  reabsorption that occurs via passive, paracellular

reabsorption secondary to  $\text{Na}^+$  reabsorption that generates a lumen-positive transepithelial voltage. Loop diuretics inhibit  $\text{Na}^+$  reabsorption by the thick ascending limb of the loop of Henle, and in so doing reduce the magnitude of the lumen-positive transepithelial voltage (see Chapter 10). This action in turn inhibits the reabsorption of  $\text{Ca}^{++}$  via the paracellular pathway. Thus loop diuretics are used to increase renal  $\text{Ca}^{++}$  excretion in patients with hypercalcemia.

In the distal tubule, where the voltage in the tubule lumen is electrically negative with respect to the blood,  $\text{Ca}^{++}$  reabsorption is entirely active because  $\text{Ca}^{++}$  is reabsorbed against its electrochemical gradient (Figure 9-6). Thus  $\text{Ca}^{++}$  reabsorption by the distal tubule is exclusively transcellular. Calcium enters the cell across the apical membrane by a  $\text{Ca}^{++}$ -permeable ion channel (TRPV5). Inside the cell,  $\text{Ca}^{++}$  binds to calbindin- $\text{D}_{28\text{k}}$ . The calbindin- $\text{Ca}^{++}$  complex carries  $\text{Ca}^{++}$  across the cell and delivers it to the basolateral membrane, where it is extruded from the cell primarily by the  $3\text{Na}^+/\text{Ca}^{++}$  antiporter (NCX1); however, the

## IN THE CLINIC

Mutations in the tight junction protein **claudin-16** (CLDN16) alter the diffusive movement of  $\text{Ca}^{++}$  across tight junctions in the thick ascending limb of Henle's loop. Familial hypomagnesemic hypercalciuria, an autosomal recessive disorder, is caused by mutations in claudin-16 (previously termed paracellin 1 [PCLN1]), a protein that is a component of the tight junctions in thick ascending limb cells. This disorder is characterized by enhanced excretion of  $\text{Ca}^{++}$  and  $\text{Mg}^{++}$  because of a decrease in the passive reabsorption of these ions across the paracellular pathway in the thick ascending limb. The mutation in the claudin-16 gene reduces the permeability of the paracellular pathway to  $\text{Ca}^{++}$  and  $\text{Mg}^{++}$ , thereby reducing passive, paracellular reabsorption of both ions. These persons have high levels of  $\text{Ca}^{++}$  in their urine, which leads to stone formation (nephrolithiasis).

$\text{Ca}^{++}$  ATPase (PMCA1b) also may contribute. Urinary  $\text{Na}^{+}$  and  $\text{Ca}^{++}$  excretion usually change in parallel. However, excretion of these ions does not always change in parallel because the reabsorption of  $\text{Ca}^{++}$  and  $\text{Na}^{+}$  by the distal tubule is independent and is differentially regulated. For example, **thiazide diuretics** inhibit  $\text{Na}^{+}$  reabsorption by the distal tubule and stimulate  $\text{Ca}^{++}$  reabsorption by this segment. Accordingly, the net effects of thiazide diuretics are to increase urinary  $\text{Na}^{+}$  excretion and reduce urinary  $\text{Ca}^{++}$  excretion (see Chapter 10). Accordingly, because thiazide diuretics reduce urinary  $\text{Ca}^{++}$  excretion, they often are given to reduce the urinary  $[\text{Ca}^{++}]$  in persons who produce kidney stones that contain  $\text{Ca}^{++}$ .

### Regulation of Urinary $\text{Ca}^{++}$ Excretion

Several hormones and factors influence urinary  $\text{Ca}^{++}$  excretion (Table 9-1). Of these hormones and factors, PTH exerts the most powerful control on renal  $\text{Ca}^{++}$  excretion, and it is the primary hormone/factor responsible for maintaining  $\text{Ca}^{++}$  homeostasis. Overall, this hormone stimulates  $\text{Ca}^{++}$  reabsorption by the

kidneys (i.e., reduces  $\text{Ca}^{++}$  excretion). Although PTH inhibits the reabsorption of  $\text{NaCl}$  and fluid, and therefore  $\text{Ca}^{++}$  reabsorption by the proximal tubule, PTH stimulates  $\text{Ca}^{++}$  reabsorption by the thick ascending limb of the loop of Henle and the distal tubule. Thus the net effect of PTH is to enhance renal  $\text{Ca}^{++}$  reabsorption. Changes in the plasma  $[\text{Ca}^{++}]$  also regulate urinary  $\text{Ca}^{++}$  excretion, with hypercalcemia increasing excretion and hypocalcemia decreasing excretion. Hypercalcemia increases urinary  $\text{Ca}^{++}$  excretion by (1) reducing proximal tubule  $\text{Ca}^{++}$  reabsorption (reduced paracellular reabsorption due to increased interstitial fluid  $[\text{Ca}^{++}]$ ); (2) inhibiting  $\text{Ca}^{++}$  reabsorption by the thick ascending limb of the loop of Henle via activation of the  $\text{CaSR}$  located in the basolateral membrane of these cells ( $\text{NaCl}$  reabsorption is decreased, thereby reducing the magnitude of the lumen-positive transepithelial voltage); and (3) suppressing  $\text{Ca}^{++}$  reabsorption by the distal tubule by reducing PTH levels. As a result, urinary  $\text{Ca}^{++}$  excretion increases. Hypocalcemia has the opposite effect on urinary  $\text{Ca}^{++}$  excretion, primarily by increasing  $\text{Ca}^{++}$  reabsorption by the proximal tubule and thick ascending limb. Calcitriol

enhances  $\text{Ca}^{++}$  reabsorption by the distal tubule, but it is less effective than PTH.

Several factors disturb  $\text{Ca}^{++}$  excretion. An increase in the plasma  $[\text{P}_i]$  (e.g., caused by a dramatic increase in the dietary intake of  $\text{P}_i$  or by reduced kidney function) elevates PTH levels both directly and by decreasing the ionized plasma  $[\text{Ca}^{++}]$ , and thereby decreases  $\text{Ca}^{++}$  excretion. A decline in the plasma  $[\text{P}_i]$  (e.g., caused by dietary  $\text{P}_i$  depletion) has the opposite effect. (Note: With normal kidney function, changes in dietary  $\text{P}_i$  intake over a sevenfold range have no effect on plasma  $[\text{P}_i]$ .) Changes in the ECF volume alter  $\text{Ca}^{++}$  excretion mainly by affecting sodium chloride (NaCl) and fluid reabsorption in the proximal tubule. Volume contraction increases NaCl and water reabsorption by the proximal tubule and thereby enhances  $\text{Ca}^{++}$  reabsorption. Accordingly, urinary  $\text{Ca}^{++}$  excretion declines. Volume expansion has the opposite effect. Acidemia increases  $\text{Ca}^{++}$  excretion, whereas alkalemia decreases excretion. The regulation of  $\text{Ca}^{++}$  reabsorption by pH occurs primarily in the distal tubule. Alkalosis stimulates the apical membrane  $\text{Ca}^{++}$  channel (TRPV5), thereby increasing  $\text{Ca}^{++}$  reabsorption. By contrast, acidosis inhibits the same channel, thereby reducing  $\text{Ca}^{++}$  reabsorption. Finally, as previously noted, loop diuretics inhibit  $\text{Ca}^{++}$  reabsorption by the thick ascending limb (TAL), and thiazide diuretics stimulate  $\text{Ca}^{++}$  reabsorption by the distal tubule.

### Calcium-Sensing Receptor

The CaSR is a receptor expressed in the plasma membrane of cells involved in regulating  $\text{Ca}^{++}$  homeostasis. The CaSR senses small changes in extracellular  $[\text{Ca}^{++}]$ .  $\text{Ca}^{++}$  binds to CaSR receptors in PTH-secreting cells of the parathyroid gland and calcitriol-producing cells of the proximal tubule. Activation of the receptor by an increase in plasma  $[\text{Ca}^{++}]$  results in inhibition of PTH secretion and the production of calcitriol by the proximal tubule. Moreover, the reduction in PTH secretion also contributes to decreased production of calcitriol because PTH is a potent stimulus of calcitriol synthesis. By contrast, a decrease in plasma  $[\text{Ca}^{++}]$  has the opposite effect on PTH and calcitriol secretion.

The CaSR also maintains  $\text{Ca}^{++}$  homeostasis by directly regulating  $\text{Ca}^{++}$  excretion by the kidneys.

CaSRs in the thick ascending limb respond directly to changes in plasma  $[\text{Ca}^{++}]$  and regulate  $\text{Ca}^{++}$  absorption. An increase in plasma  $[\text{Ca}^{++}]$  activates CaSR in the TAL and inhibits  $\text{Ca}^{++}$  absorption, thereby stimulating urinary  $\text{Ca}^{++}$  excretion. By contrast, a decrease in plasma  $[\text{Ca}^{++}]$  leads to an increase in  $\text{Ca}^{++}$  absorption by the TAL and a corresponding decrease in urinary  $\text{Ca}^{++}$  excretion. Thus the direct effect of plasma  $[\text{Ca}^{++}]$  on CaSRs in the TAL acts in concert with changes in PTH, which regulates  $\text{Ca}^{++}$  reabsorption by the distal tubule to regulate urinary  $\text{Ca}^{++}$  excretion and thereby maintain  $\text{Ca}^{++}$  homeostasis.

### IN THE CLINIC

Mutations in the gene coding for the calcium-sensing receptor (**CaSR**) cause disorders in  $\text{Ca}^{++}$  homeostasis. **Familial hypocalciuric hypercalcemia** is an autosomal dominant disease caused by an inactivating mutation of CaSR. The hypercalcemia is caused by deranged  $\text{Ca}^{++}$ -regulated parathyroid hormone (PTH) secretion; that is, the set point for  $\text{Ca}^{++}$ -regulated PTH secretion is shifted such that PTH levels are elevated at any level of plasma  $[\text{Ca}^{++}]$  and are not suppressed in the setting of hypercalcemia. The hypocalciuria is caused by enhanced  $\text{Ca}^{++}$  reabsorption in the thick ascending limb and distal tubule as a result of elevated PTH levels and defective CaSR regulation of  $\text{Ca}^{++}$  transport in the kidneys. **Autosomal dominant hypoparathyroidism** is caused by an activating mutation in CaSR. Activation of CaSRs causes deranged  $\text{Ca}^{++}$ -regulated PTH secretion (i.e., the set point for  $\text{Ca}^{++}$ -regulated PTH secretion is shifted such that PTH levels are decreased at any level of plasma  $[\text{Ca}^{++}]$ ). Hypercalciuria results and is caused by decreased PTH levels and defective CaSR-regulated  $\text{Ca}^{++}$  transport in the kidneys.

### PHOSPHATE

$\text{P}_i$  is an important component of many organic molecules, including deoxyribonucleic acid, ribonucleic acid, adenosine triphosphate, nucleotides, nucleosides, and phospholipids and intermediates of metabolic pathways. Like  $\text{Ca}^{++}$ ,  $\text{P}_i$  is a major constituent of bone. Its concentration in plasma is an important determinant of bone formation and resorption. In addition, urinary  $\text{P}_i$  is an important buffer (titratable

acid) involved in the maintenance of acid-base balance (see Chapter 8). Eighty-five percent of  $P_i$  is located in bone and teeth, approximately 14% is located in the ICF, and 1% is located in the ECF. The normal plasma  $[P_i]$  is 3 to 4 mg/dL (1-1.5 mmol/L).  $P_i$  in the plasma is ionized (45%), complexed (30%), and bound to protein (25%). Phosphate deficiency causes muscle weakness, rhabdomyolysis, and reduced bone mineralization, resulting in **rickets** (in children) and **osteomalacia** (in adults).

### Overview of $P_i$ Homeostasis

A general scheme of  $P_i$  homeostasis is shown in Figure 9-7. The maintenance of  $P_i$  homeostasis depends on two factors: (1) the amount of  $P_i$  in the body and (2) the distribution of  $P_i$  between the ICF and ECF compartments. Total body  $P_i$  levels are determined by the relative amount of  $P_i$  absorbed by the intestinal tract versus the amount excreted by the kidneys.  $P_i$  absorption by the intestinal tract occurs via active and passive mechanisms;  $P_i$  absorption increases as dietary  $P_i$  rises, and it is stimulated by calcitriol. Despite variations in  $P_i$  intake between 800 and 1500 mg/day, in adults (i.e., the steady state), the kidneys maintain total body  $P_i$  balance constant by excreting an amount of  $P_i$  in the urine equal to the amount absorbed by the intestinal


tract (normal bone remodeling results in no net addition of  $P_i$  to, or  $P_i$  release from, the bone). By contrast, during growth,  $P_i$  is accumulated in the body. Renal  $P_i$  excretion is the primary mechanism by which the body regulates  $P_i$  balance and thereby  $P_i$  homeostasis.

The second factor that maintains  $P_i$  homeostasis is the distribution of  $P_i$  among bone and the ICF and ECF compartments. Two hormones, PTH and calcitriol, in concert with the kidneys, regulate plasma  $[P_i]$  (see Figures 9-7 and 9-8). The release of  $P_i$  from bone is stimulated by the same hormones (i.e., PTH and calcitriol) that release  $Ca^{++}$  from this pool. Thus the release of  $P_i$  is always accompanied by a release of  $Ca^{++}$ .


The kidneys also make an important contribution to maintaining plasma  $[P_i]$  within a narrow range (1-1.5 mmol/L).  $P_i$  excretion by the kidneys is regulated by PTH and calcitriol (see Figure 9-7).

PTH increases  $P_i$  excretion, whereas calcitriol inhibits  $P_i$  excretion. Plasma  $[P_i]$  is determined by (1) intestinal absorption, (2) storage in bone, and (3)  $P_i$  excretion by the kidneys. Maintenance of plasma  $[P_i]$  is essential for optimal  $Ca^{++}$ - $P_i$  complex formation required for bone mineralization without deposition of  $Ca^{++}$ - $P_i$  in vascular and other soft tissues.

A rise in the plasma  $[P_i]$  directly stimulates PTH synthesis and release and also decreases the ionized


[Ca<sup>++</sup>], which stimulates PTH release by its interaction with CaSR. PTH enhances urinary P<sub>i</sub> excretion by inhibiting proximal tubule P<sub>i</sub> reabsorption. Hyperphosphatemia also decreases calcitriol production by the proximal tubule, which leads to a reduction in P<sub>i</sub> absorption by the intestine. Both the increase in PTH and the decrease in calcitriol reduce plasma [P<sub>i</sub>].

### P<sub>i</sub> Transport Along the Nephron

Figure 9-8 summarizes P<sub>i</sub> transport by the various portions of the nephron. The proximal tubule reabsorbs 80% of the P<sub>i</sub> filtered by the glomerulus, and the loop of Henle, distal tubule, and the collecting duct reabsorb negligible amounts of P<sub>i</sub>. Therefore approximately 20% of the P<sub>i</sub> filtered across the glomerular capillaries is excreted in the urine.

P<sub>i</sub> reabsorption by the proximal tubule occurs by a transcellular route (Figure 9-9). P<sub>i</sub> uptake across the apical membrane of the proximal tubule occurs via two Na<sup>+</sup>-P<sub>i</sub> symporters (IIa and IIc). Type IIa transports 3Na<sup>+</sup> with one divalent P<sub>i</sub> (HPO<sub>4</sub><sup>2-</sup>), and carries positive charge into the cell. Type IIc transports 2Na<sup>+</sup> with one monovalent P<sub>i</sub> (H<sub>2</sub>PO<sub>4</sub><sup>-</sup>) and is electrically neutral. P<sub>i</sub> exits across the basolateral membrane by a P<sub>i</sub>-inorganic anion antiporter that has not been characterized.

## Regulation of Urinary P<sub>i</sub> Excretion


Several hormones and factors regulate urinary P<sub>i</sub> excretion (Table 9-2 and Figure 9-10). PTH, the most important hormone that controls P<sub>i</sub> excretion, inhibits P<sub>i</sub> reabsorption by the proximal tubule and thereby increases P<sub>i</sub> excretion. PTH reduces P<sub>i</sub> reabsorption by stimulating the endocytic removal of Na<sup>+</sup>-P<sub>i</sub> transporters from the brush border membrane of the proximal tubule. Dietary P<sub>i</sub> intake also regulates P<sub>i</sub> excretion by mechanisms unrelated to changes in PTH levels. P<sub>i</sub> loading increases excretion, whereas P<sub>i</sub> depletion decreases it. Changes in dietary P<sub>i</sub> intake modulate P<sub>i</sub> transport by altering the transport rate of each Na<sup>+</sup>-P<sub>i</sub> symporter and the number of symporters in the apical membrane of the proximal tubule.

### IN THE CLINIC

In patients with **chronic renal failure**, the kidneys cannot excrete inorganic phosphate (P<sub>i</sub>). Because of continued P<sub>i</sub> absorption by the intestinal tract, P<sub>i</sub> accumulates in the body, and the plasma [P<sub>i</sub>] rises. The excess P<sub>i</sub> complexes with Ca<sup>++</sup> and reduces the ionized plasma concentration of Ca<sup>++</sup> ([Ca<sup>++</sup>]). P<sub>i</sub> accumulation also decreases the production of calcitriol. This response reduces Ca<sup>++</sup> absorption by the intestine, an effect that further reduces the plasma [Ca<sup>++</sup>]. This reduction in plasma [Ca<sup>++</sup>] increases parathyroid hormone secretion and Ca<sup>++</sup> release from bone. These actions result in **renal osteodystrophy** (i.e., increased bone resorption with replacement by fibrous tissue, which renders bone more susceptible to fracture). Chronic hyperparathyroidism (i.e., elevated parathyroid hormone levels due to the decrease in plasma [Ca<sup>++</sup>]) during chronic renal failure can lead to metastatic calcifications in which Ca<sup>++</sup> and P<sub>i</sub> precipitate in arteries, soft tissues, and viscera. The deposition of Ca<sup>++</sup> and P<sub>i</sub> in the heart may cause myocardial failure. The prevention and treatment of hyperparathyroidism and P<sub>i</sub> retention include a low-P<sub>i</sub> diet or the administration of a “phosphate binder” (i.e., an agent that forms insoluble P<sub>i</sub> salts and thereby renders P<sub>i</sub> unavailable for absorption by the intestinal tract) in the diet. Supplemental Ca<sup>++</sup> and calcitriol also are prescribed to increase plasma [Ca<sup>++</sup>].

ECF volume also affects P<sub>i</sub> excretion. Expansion of the ECF enhances P<sub>i</sub> excretion by (1) increasing glomerular filtration rate and thus the filtered load of P<sub>i</sub>;

(2) decreasing Na-P<sub>i</sub> coupled reabsorption, which reduces the ECF volume; and (3) reducing the plasma [Ca<sup>++</sup>], thereby increasing PTH, which inhibits P<sub>i</sub> reabsorption in the proximal tubule. Acid-base balance also influences P<sub>i</sub> excretion; chronic acidosis

increases  $P_i$  excretion, and chronic alkalosis decreases it. These effects of acid-base balance, like the effect of PTH, are mediated by changes of expression of the  $Na-P_i$  symporters in the apical membrane. As described in Chapter 8, systemic acidosis causes glucocorticoid secretion, and these glucocorticoids increase the excretion of  $P_i$  by inhibiting  $P_i$  reabsorption by the proximal tubule. This inhibition, together with the direct effect of acidosis on  $P_i$  reabsorption by the proximal tubule, enables the distal tubule and collecting duct to secrete

### IN THE CLINIC

In the absence of glucocorticoids (e.g., in **Addison disease**), inorganic phosphate ( $P_i$ ) excretion is depressed, as is the ability of the kidneys to excrete titratable acid and to generate new bicarbonate ( $HCO_3^-$ ). Growth hormone also has an important effect on  $P_i$  homeostasis. Growth hormone increases the reabsorption of  $P_i$  by the proximal tubule. As a result, growing children are in positive  $P_i$  balance and have a higher plasma  $[P_i]$  than do adults, and this elevated  $[P_i]$  is important for the formation of bone.

### IN THE CLINIC

Phosphate homeostasis is altered by mutations in the fibroblast growth factor 23 (FGF-23) gene by mutations in **PHEX**, an endopeptidase, and by tumors that produce excess amounts of FGF-23. For example, in **tumor-induced osteomalacia**, excessive production of FGF-23 leads to hypophosphatemia, renal phosphate wasting, and a defect in bone mineralization. This phenotype also is observed in patients with autosomal dominant hypophosphatemic rickets (caused by mutations in the FGF-23 gene that make FGF-23 resistant to proteolysis), autosomal recessive hypophosphatemic rickets (caused by elevated levels of FGF-23), and X-linked hypophosphatemic rickets (caused by inactivating mutations in PHEX). In contrast, an inactivating mutation in the FGF-23 gene causes hyperphosphatemia, hypophosphaturia, and calcification of soft tissues.


more  $H^+$  as titratable acid and to generate more  $HCO_3^-$  because  $P_i$  is an important urinary buffer. Growth hormone decreases  $P_i$  excretion.

Fibroblast growth factor 23 (FGF-23) regulates renal  $P_i$  excretion and thereby contributes to the regulation of plasma  $[P_i]$ . FGF-23 is secreted by osteocytes and osteoblasts and inhibits  $P_i$  reabsorption and calcitriol production by the proximal tubule (see **Figure 9-8**). Secretion of FGF-23 is stimulated by sustained hyperphosphatemia, PTH, and calcitriol. Activating mutations in the FGF-23 gene cause hypophosphatemia, low plasma calcitriol, and rickets/osteomalacia, whereas inactivating mutations cause hyperphosphatemia, high serum calcitriol, and calcification of soft tissue.

## INTEGRATIVE REVIEW OF PARATHYROID HORMONE AND CALCITRIOL ON $Ca^{++}$ AND $P_i$ HOMEOSTASIS

Hypocalcemia is the major stimulus of PTH secretion. As summarized in **Figure 9-11**, PTH has numerous effects on  $Ca^{++}$  and  $P_i$  homeostasis. PTH stimulates bone resorption, increases urinary  $P_i$  excretion, decreases urinary  $Ca^{++}$  excretion, and stimulates the production of calcitriol, which stimulates  $Ca^{++}$  and  $P_i$  absorption by the intestine. Because changes in  $P_i$  handling in bone, the intestines, and the kidneys tend to balance out, PTH increases the plasma  $[Ca^{++}]$  while having little effect on the plasma  $[P_i]$ . Overall, a rise in the plasma PTH levels in response to hypocalcemia returns the plasma  $[Ca^{++}]$  to the normal range. A decline in plasma  $[Ca^{++}]$  has the opposite effect.


Calcitriol (the active form of vitamin D) also plays an important role in  $Ca^{++}$  and  $P_i$  homeostasis (see **Figure 9-12**). The primary action of calcitriol is to stimulate  $Ca^{++}$  and  $P_i$  absorption by the intestine. To a lesser degree it acts with PTH to release  $Ca^{++}$  and  $P_i$  from the bone and decreases  $Ca^{++}$  excretion by the kidneys. The net effect of calcitriol is to increase the plasma  $[Ca^{++}]$  and  $[P_i]$ . Thus the major stimuli of calcitriol production are hypocalcemia via PTH and hypophosphatemia (i.e., a low plasma  $[P_i]$ ).

## S U M M A R Y

1. The kidneys, in conjunction with the intestinal tract and bone, play a vital role in regulating the plasma  $[\text{Ca}^{++}]$  and  $[\text{P}_i]$ .
2. Plasma  $\text{Ca}^{++}$  is regulated by PTH and calcitriol. Calcitonin is not a major regulatory hormone in humans.  $\text{Ca}^{++}$  excretion by the kidneys is regulated by PTH, plasma  $[\text{Ca}^{++}]$ , and calcitriol, and is altered by changes in acid-base status, extracellular fluid volume, and plasma  $\text{P}_i$ .
3.  $\text{Ca}^{++}$  reabsorption by the thick ascending limb and distal tubule are regulated by PTH and calcitriol, both of which stimulate  $\text{Ca}^{++}$  reabsorption, and by plasma  $[\text{Ca}^{++}]$ .
4. The plasma  $[\text{P}_i]$  is regulated by PTH, FGF-23, and calcitriol.  $\text{P}_i$  excretion is regulated by PTH, FGF-23, dietary phosphate, and growth hormone, and it is altered by acid-base balance, ECFV expansion, and glucocorticoids. Bone tumors secrete FGF-23, which enhances renal  $\text{P}_i$  excretion and thereby causes hypophosphatemia, hyperphosphatemia, and a defect in bone mineralization (i.e., osteomalacia).

## PHYSIOLOGY OF DIURETIC ACTION

---

### OBJECTIVES

**Diuretics**, as the name implies, are drugs that cause an increase in urine output. It is important, however, to distinguish this diuresis from that which occurs after the ingestion of large volumes of water. In the latter case, the urine is primarily made up of water, and solute excretion is not increased. In contrast, diuretics result in the enhanced excretion of both solute and water.

All diuretics (with the exception of aquaretics, which will be discussed) have as their common mode of action the primary inhibition of  $\text{Na}^+$  reabsorption by the nephron. Consequently, they cause an increase in the excretion of  $\text{Na}^+$ , termed **natriuresis**. However, the effects of diuretics are not limited to  $\text{Na}^+$  handling.

The renal handling of many other solutes also is influenced, usually as a consequence of alterations in  $\text{Na}^+$  transport. Recently, drugs have been developed that block the action of arginine vasopressin (AVP) on the distal tubule and collecting duct. These drugs, called **aquaretics**, cause a **water diuresis**. This chapter reviews the cellular mechanisms of action of various diuretics and the nephron sites at which these diuretics act. In addition to their effects on  $\text{Na}^+$  handling by the nephron, their effects on the renal handling of other solutes (e.g.,  $\text{K}^+$ ,  $\text{Ca}^{++}$ , inorganic phosphate [ $\text{P}_i$ ], and bicarbonate [ $\text{HCO}_3^-$ ]) and of water are considered. The effects of aquaretics on water excretion also are discussed.

## GENERAL PRINCIPLES OF DIURETIC ACTION

The primary action of diuretics is to increase the excretion of  $\text{Na}^+$ . As described in Chapter 6, alterations in  $\text{Na}^+$  excretion by the kidneys result in alterations in the volume of the extracellular fluid (ECF) compartment. Consequently, diuretics decrease the volume of the ECF. Indeed, diuretics commonly are given in clinical situations when the ECF compartment is expanded, with the intent of reducing its volume. Because the ECF volume also determines blood volume and pressure, diuretics commonly are used in the therapy of hypertension.


Although generally predictable for a particular class of diuretics, the effects of diuretic administration can be quite variable. Several factors are important in determining the overall effect of a particular diuretic:

1. The nephron segment where the diuretic acts
2. The response of nephron segments not directly affected by the diuretic
3. The delivery of sufficient quantities of the diuretic to its site of action
4. The volume of the ECF

### Sites of Action of Diuretics

Figure 10-1 depicts the nephron sites at which the different classes of diuretics act. The osmotic diuretics act along the proximal tubule and portions of the thin descending limb of Henle's loop (i.e., those portions of the nephron that have a high water permeability). The carbonic anhydrase inhibitors act primarily in the proximal tubule. The thick ascending limb of Henle's loop is the site of action of the loop diuretics. The early portion of the distal tubule is the site of action of the thiazide diuretics, and the  $\text{K}^+$ -sparing diuretics act primarily on the late portion of the distal tubule and the cortical portion of the collecting duct where they not only inhibit  $\text{Na}^+$  reabsorption but also  $\text{K}^+$  secretion. This same class of diuretics also can inhibit  $\text{Na}^+$  reabsorption in portions of the collecting duct that do not secrete  $\text{K}^+$ .

The site of action of a diuretic in turn determines the magnitude of the associated natriuresis (Table 10-1). For example, diuretics acting on the thick

ascending limb of Henle's loop cause a larger diuresis than diuretics acting on the early portion of the distal tubule, because a larger portion of the filtered  $\text{Na}^+$  is absorbed by the thick ascending limb (see Chapters 4 and 6). The effect diuretics have on the handling of solutes other than  $\text{Na}^+$  also depends on the site of action. Examples illustrating this point are given in subsequent sections.

### Response of Other Nephron Segments

When a diuretic inhibits  $\text{Na}^+$  reabsorption at one nephron site, it causes increased delivery of  $\text{Na}^+$  and water to more distal segments. The function of these more distal segments and their ability or inability to handle this increased load ultimately determine the overall effect of the diuretic on urinary solute and water excretion. Examples of this phenomenon are considered in detail with discussion of each of the various diuretics. In addition, diuretic-induced changes in ECF volume (discussed later in this chapter) may modulate  $\text{Na}^+$  transport in segments of the nephron not directly affected by the diuretic and thereby influence the degree of natriuresis.

### Adequate Delivery of Diuretics to Their Site of Action

The effect of a diuretic on Na<sup>+</sup> excretion also depends on the delivery of adequate quantities of the drug to its site of action. With the exception of the aldosterone antagonists, which act intracellularly, diuretics act from the lumen of the nephron (carbonic anhydrase inhibitors have both luminal and intracellular sites of action). Diuretics gain access to the lumen by glomerular filtration and through secretion by the organic anion and organic cation secretory systems located in the proximal tubule (see Chapter 4). Because some diuretics are bound to plasma proteins (e.g., loop diuretics), their secretion by the proximal tubule is the primary mechanism for delivery of the diuretic to its site of action in the lumen of the nephron. Thus the effect of a diuretic can be blunted if, for example, it is administered with another drug that competes for the same organic anion and organic cation secretory mechanism.

### Volume of the Extracellular Fluid


The effect of a diuretic also depends on the volume of the ECF. As described in Chapter 6, when the volume of the ECF is decreased, the glomerular filtration rate (GFR) is reduced, thereby reducing the amount of filtered Na<sup>+</sup>. In addition, Na<sup>+</sup> reabsorption by the nephron is enhanced. Thus the effect of a diuretic that acts

on the distal tubule would be blunted if administered in the setting of a reduced ECF volume. Under this condition, the decreased GFR (i.e., decreased filtered Na<sup>+</sup>), together with enhanced Na<sup>+</sup> reabsorption by the proximal tubule, would result in the delivery of a smaller quantity of Na<sup>+</sup> to the distal tubule. Thus even if the diuretic completely inhibited Na<sup>+</sup> reabsorption in the distal tubule, the associated natriuresis would be less than would occur if the ECF volume were normal.

### DIURETIC BRAKING PHENOMENON

As illustrated in Figure 10-2, administration of a diuretic to a person with fixed Na<sup>+</sup> intake results in a short-lived natriuresis. The transient response, called the **diuretic braking phenomenon**, reflects several changes in renal function that are both a direct effect of the diuretic and secondary to changes in the volume of the ECF. One component of this response is that diuretic-induced inhibition of Na<sup>+</sup> reabsorption in the targeted nephron segment increases Na<sup>+</sup> delivery to more distal nephron segments and stimulates Na<sup>+</sup> reabsorption at these sites. A second important component of this response is that loss of sodium chloride (NaCl) and water from the body as a result of diuretic action decreases the volume of the ECF. This decrease in turn is sensed by the body's vascular baroreceptors

and effector mechanisms, prompting them to increase  $\text{NaCl}$  and water conservation by the kidneys (see Chapter 6 for details).

#### AT THE CELLULAR LEVEL

Studies in experimental animals have shown that loop and thiazide diuretics increase the expression of the transporters they inhibit. For example, loop diuretics, which inhibit the  $\text{Na}^+\text{-K}^+\text{-2Cl}^-$  cotransporter (NKCC2) in the apical membrane of the cells of the thick ascending limb of Henle's loop, also increase the expression of the transporter in this segment. Similarly, thiazide diuretics, which inhibit the  $\text{Na}^+\text{-Cl}^-$  symporter (NCC) in the apical membrane of the early portion of the distal tubule, also increase the expression of these transporters in this segment. In addition, both loop and thiazide diuretics increase the expression of the  $\text{Na}^+$  channel (epithelial sodium channel [ENaC]) in the late portion of the distal tubule and collecting duct. Thiazide diuretics also increase the expression of aquaporin-2 in the principal cells of the late portion of the distal tubule and the collecting duct. Whether this effect is direct or indirect (i.e., related to changes in ECF volume) is uncertain. Regardless of the mechanism, the increased expression of aquaporin-2 is expected to increase water reabsorption by the arginine vasopressin (AVP)-sensitive nephron segments.

With the diuretic-induced decrease in the ECF volume, the renin-angiotensin-aldosterone system is

activated, renal sympathetic nerve activity is increased, and AVP secretion is stimulated, which in combination act to reduce urinary sodium chloride ( $\text{NaCl}$ ) and water excretion (see Chapter 6 for details). At the cellular level, angiotensin II increases the expression of the  $\text{Na}^+\text{-Cl}^-$  symporter in the early portion of the distal tubule, and aldosterone increases the expression of ENaC in the late distal tubule and collecting duct. AVP also increases the expression of key transporters. Specifically, AVP increases the expression of NKCC2 in the thick ascending limb of Henle's loop, NCC in the early portion of the distal tubule, and ENaC in the late distal tubule and collecting duct. Finally, angiotensin II increases the abundance of the  $\text{Na}^+\text{-H}^+$  antiporter (NHE3) in the proximal tubule. Upregulation of these transporters by diuretics reduces their efficacy, and when the diuretic administration is terminated, results in a rapid increase in  $\text{NaCl}$  reabsorption.

As a result of the braking phenomenon, a new steady state is reached where even with continued administration of the diuretic, urinary  $\text{Na}^+$  excretion once again equals intake. However, this steady state occurs at a reduced ECF volume, which is detected as a decrease in body weight. When diuretic therapy is discontinued, renal  $\text{Na}^+$  excretion is reduced. After a period of positive  $\text{Na}^+$  balance, during which the ECF returns to normal (i.e., return of body weight to its original value), a new steady state is again achieved.

The concept of steady state deserves special emphasis. Normally, persons are in steady-state balance with regard to solute (e.g.,  $\text{Na}^+$ ) and water, with intake equaling excretion. Administration of a diuretic temporarily disrupts this balance by increasing solute and water excretion, and a negative balance exists. However, solute and water excretion cannot exceed intake indefinitely, and a new steady state eventually is achieved. In this new steady state, intake and excretion are again balanced, but the ECF volume is reduced as a result of diuretic-induced excretion of  $\text{NaCl}$  and water. In general, when a person has been taking a diuretic for several days or longer, a new steady state is achieved. If  $\text{Na}^+$  intake is not increased, the ECF volume is decreased in proportion to the degree of negative  $\text{Na}^+$  balance.

## MECHANISMS OF ACTION OF DIURETICS

### Osmotic Diuretics

Osmotic diuretics, as the name implies, are agents that inhibit the reabsorption of solute and water by altering osmotic driving forces along the nephron. Unlike the other classes of diuretics, osmotic diuretics do not inhibit a specific membrane transport protein; they simply affect water transport across the cells of the nephron through the generation of an osmotic pressure gradient. The best example of an exogenous osmotic diuretic is the sugar mannitol. When present in abnormally high concentrations, freely filtered endogenous substances such as glucose (i.e., in patients with diabetes mellitus) and urea (i.e., in patients with renal disease whose plasma urea levels are elevated) also can act as osmotic diuretics.

Osmotic diuretics (e.g., mannitol) gain access to the proximal tubular fluid by glomerular filtration. Because they are not reabsorbed or are only poorly reabsorbed, they remain within the tubular lumen, where they can exert an osmotic pressure that inhibits tubular fluid reabsorption. Osmotic diuretics affect fluid reabsorption in the segments that have high permeability to water (i.e., the proximal tubule and portions of the thin descending limb of Henle's loop). Because of the large volumes of filtrate reabsorbed in the proximal tubule (60% to 70% of the filtrate), this

nephron site is most important when considering the action of osmotic diuretics.

As described in Chapter 4, reabsorption of tubular fluid by the proximal tubule is essentially an isosmotic process (i.e., the osmolality of the reabsorbed fluid is only slightly hyperosmotic compared with that of tubular fluid). Solute (primarily  $\text{NaCl}$ ) is actively reabsorbed by the proximal tubule cells. This reabsorption sets up a small osmotic pressure difference across the tubule, with the tubular fluid being 3 to 5 mOsm/kg  $\text{H}_2\text{O}$  hypoosmotic with respect to the interstitial fluid. Given the fact that water is readily able to cross the proximal tubule, this small osmotic pressure gradient is sufficient to cause water reabsorption. Also, as water flows from the lumen to the interstitium, it brings additional solute with it by solvent drag.

When an osmotic diuretic is present in the tubular fluid, its concentration increases progressively as a result of  $\text{NaCl}$  and water reabsorption by the nephron. With this increase in concentration, an osmotic gradient develops opposite to the normal gradient generated by  $\text{NaCl}$  reabsorption. As a result, both  $\text{NaCl}$  (solvent drag component) and water reabsorption are reduced. With an osmotic diuresis, an increase in blood flow to the medulla of the kidney also occurs. This increase in blood flow dissipates the standing interstitial osmotic gradient (see Chapter 5) and thus also impairs water reabsorption by the descending limb of Henle's loop and the medullary collecting duct.

Some of the  $\text{Na}^+$  that is not reabsorbed by the proximal tubule is reabsorbed downstream by the thick ascending limb, distal tubule, and collecting duct. Thus the degree of natriuresis seen with osmotic diuretics is less than expected on the basis of the magnitude of proximal tubule reabsorption. Although  $\text{Na}^+$  excretion rates as high as 60% of the filtered  $\text{Na}^+$  have been seen in experimental situations, the usual natriuresis seen in persons treated with osmotic diuretics is only about 10% of the filtered  $\text{Na}^+$ .

### Carbonic Anhydrase Inhibitors

Carbonic anhydrase inhibitors (e.g., acetazolamide) reduce  $\text{Na}^+$  reabsorption by their effect on carbonic anhydrase. This enzyme is abundant in the proximal tubule and therefore represents the major site of

action of these diuretics. Carbonic anhydrase also is present in other cells along the nephron (e.g., thick ascending limb of Henle's loop and intercalated cells of the collecting duct), and administration of carbonic anhydrase inhibitors affects the activity of the enzyme at these sites as well. However, the effects of these diuretics are almost entirely attributed to their inhibition of the enzyme in the proximal tubule. This phenomenon reflects the fact that approximately one third of proximal tubule  $\text{Na}^+$  reabsorption occurs in exchange for  $\text{H}^+$  (through the  $\text{Na}^+$ - $\text{H}^+$  antiporter) and thus depends on the activity of carbonic anhydrase (see Chapter 8).

Even though one third of proximal tubule  $\text{Na}^+$  reabsorption is coupled to the secretion of  $\text{H}^+$ , inhibition of this process by the carbonic anhydrase inhibitors does not result in a large natriuresis for several reasons. First, even with complete inhibition of carbonic anhydrase, some  $\text{Na}^+$  reabsorption (linked to bicarbonate reabsorption) still occurs. Second, downstream nephron segments increase their reabsorption of  $\text{Na}^+$  (e.g., the thick ascending limb, distal tubule, and collecting duct), and third, increased delivery of  $\text{Na}^+$  to the macula densa leads to a reduction in the GFR by the tubuloglomerular feedback mechanism. Finally, with long-term administration, a metabolic acidosis develops, which further decreases the effect of carbonic anhydrase inhibitors by reducing the filtration of  $\text{HCO}_3^-$  (i.e., the percentage of  $\text{Na}^+$  reabsorbed with  $\text{HCO}_3^-$  in the proximal tubule is reduced). Typically, administration of carbonic anhydrase inhibitors results in  $\text{Na}^+$  excretion rates that are 5% to 10% of the filtered  $\text{Na}^+$ .

### Loop Diuretics

Loop diuretics (e.g., furosemide, bumetanide, torsemide, and ethacrynic acid) are organic anions that enter the tubular lumen primarily through secretion by the organic anion secretory system of the proximal tubule (see Chapter 4). They directly inhibit  $\text{Na}^+$  reabsorption by the thick ascending limb of Henle's loop by blocking the  $\text{Na}^+$ - $\text{K}^+$ - $2\text{Cl}^-$  symporter located in the apical membrane of these cells (see Chapter 4). By this action, they not only inhibit  $\text{Na}^+$  reabsorption but also disrupt the ability of the kidneys to dilute and concentrate the urine. Dilution is impaired because solute

( $\text{NaCl}$ ) reabsorption by the water-impermeable thick ascending limb of Henle's loop is inhibited.  $\text{NaCl}$  reabsorption by the medullary portion of the thick ascending limb also is critical for the generation and maintenance of an elevated medullary interstitial fluid osmolality. Therefore inhibition of  $\text{NaCl}$  transport by loop diuretics results in a decrease in the osmolality of the medullary interstitial fluid. With a decrease in medullary interstitial fluid osmolality, water reabsorption from the collecting duct is impaired, and the concentrating ability of the kidneys is reduced. Water reabsorption from some portions of the thin descending limb of Henle's loop also is impaired by loop diuretics, again because of the decrease in medullary interstitial fluid osmolality. This decrease in thin descending limb water reabsorption accounts in part for the increase in water excretion seen with loop diuretics.

Loop diuretics are the most potent diuretics available, increasing the excretion of  $\text{Na}^+$  to as much as 25% of the amount filtered. This large natriuresis reflects the fact that the thick ascending limb normally reabsorbs approximately 20% to 25% of the filtered  $\text{Na}^+$  and that downstream segments of the nephron have a limited ability to reabsorb the excess  $\text{Na}^+$  delivered as a consequence of loop diuretic action.

### Thiazide Diuretics

Like the loop diuretics, thiazide diuretics (e.g., hydrochlorothiazide, chlorthalidone, and metolazone)\* are organic anions. Because they largely are bound to plasma proteins, they gain access to the tubular lumen primarily by secretion in the proximal tubule. They act to inhibit  $\text{Na}^+$  reabsorption in the early portion of the distal tubule by blocking the  $\text{Na}^+$ - $\text{Cl}^-$  symporter in the apical membrane of these cells (see Chapter 4). Because water cannot cross this portion of the nephron, it is a site where the urine is diluted. Therefore thiazides reduce the ability to dilute the urine maximally by inhibiting  $\text{NaCl}$  reabsorption. Because thiazide diuretics act in the cortex and not the medulla, they do not

\*Metolazone and chlorthalidone are not in the same chemical class of drugs as the thiazides. However, because their site of action is the same, they are grouped with this class of drugs and often are referred to as "thiazidelike" diuretics.

affect the ability of the kidneys to concentrate the urine maximally. Natriuresis with thiazide diuretics is 5% to 10% of the filtered  $\text{Na}^+$ .

### **K<sup>+</sup>-Sparing Diuretics**

K<sup>+</sup>-sparing diuretics act on the region of the nephron where K<sup>+</sup> secretion occurs (i.e., the late portion of the distal tubule and cortical collecting duct). They produce a small natriuresis (3% to 5% of the filtered  $\text{Na}^+$ ), reflecting the amount of  $\text{Na}^+$  reabsorbed by this region of the nephron. As the name implies, their utility lies in their ability to inhibit K<sup>+</sup> secretion by this region of the nephron.

There are two classes of K<sup>+</sup>-sparing diuretics: one acts by antagonizing the action of aldosterone on the principal cell (e.g., spironolactone and eplerenone), whereas the other class blocks the entry of  $\text{Na}^+$  into the same cells through the  $\text{Na}^+$ -selective channels (epithelial sodium channels [ENaC]) in the apical membrane (e.g., amiloride and triamterene). Amiloride and triamterene are organic cations that enter the tubular lumen primarily by secretion by the organic cation secretory system of the proximal tubule (see Chapter 4).

As described in detail in Chapters 6 and 7, aldosterone stimulates both  $\text{Na}^+$  reabsorption and K<sup>+</sup> secretion by the principal cells of the late distal tubule and collecting duct. Thus in the presence of an aldosterone antagonist, these effects are inhibited and both  $\text{Na}^+$  reabsorption and K<sup>+</sup> secretion are reduced.

The ability of the  $\text{Na}^+$  channel blockers amiloride and triamterene to inhibit  $\text{Na}^+$  reabsorption and K<sup>+</sup> secretion is similar to that of spironolactone, but the cellular mechanism is different. Amiloride and triamterene block the entry of  $\text{Na}^+$  into the principal cell by directly inhibiting the  $\text{Na}^+$  channel (ENaC) in the apical membrane. With decreased  $\text{Na}^+$  entry, reduced  $\text{Na}^+$  extrusion occurs across the basolateral membrane through  $\text{Na}^+$ -K<sup>+</sup>-adenosine triphosphatase (ATPase). This effect in turn reduces cellular K<sup>+</sup> uptake and ultimately its secretion into the tubular fluid. Inhibition of apical membrane  $\text{Na}^+$  channels also alters the electrical profile across the luminal membrane, with the voltage across this membrane increasing in magnitude. Because of this voltage change, the electrochemical gradient for K<sup>+</sup> movement out of the cell is reduced.

This membrane voltage effect also contributes to the inhibition of K<sup>+</sup> secretion.

### **IN THE CLINIC**

Trimethoprim is an antibiotic used to treat *Pneumocystis jirovecii* infections. *P. jirovecii* infections are commonly seen in persons whose immune systems are compromised (e.g., persons with acquired immunodeficiency syndrome). Hyperkalemia may occur in persons treated with trimethoprim as a result of reduced renal K<sup>+</sup> excretion. K<sup>+</sup> excretion is reduced because trimethoprim inhibits K<sup>+</sup> secretion by the principal cells of the late distal tubule and cortical collecting duct. The mechanism for this inhibition of K<sup>+</sup> secretion is similar to that of amiloride and triamterene (i.e., direct inhibition of the  $\text{Na}^+$  channel [ENaC] in the apical membrane of the cell).

### **Aquaretics**

In recent years, drugs that are antagonists of the AVP receptor ( $V_2$ ) have been developed (e.g., tolvaptan and lixivaptan). These drugs act on the late portion of the distal tubule and the collecting duct to block the action of AVP. As a result of their action, the urine cannot be concentrated and dilute urine is excreted, reflecting the fact that tubular fluid reaching these AVP-sensitive segments of the nephron is hypoosmotic to the ECF (see Chapter 5). These drugs are particularly helpful in treating patients whose ECF is hypoosmotic as a result of the failure of the kidneys to excrete solute-free water because AVP levels are elevated by nonosmotic and nonhemodynamic mechanisms (e.g., syndrome of inappropriate AVP secretion [SIADH]\*).

### **EFFECT OF DIURETICS ON THE EXCRETION OF WATER AND SOLUTES**

Through their effects on  $\text{Na}^+$  handling along the nephron, diuretics also influence the handling of water and solutes. Table 10-1 summarizes the effects of the

various diuretics on the handling of some of these solutes and the ability of the kidneys to excrete ( $C_{H_2O}$ ) and reabsorb ( $T_{H_2O}^C$ ) solute-free water.

### Solute-Free Water

As discussed in Chapter 5, the ability of the kidneys to excrete or reabsorb solute-free water depends on several factors. With regard to the action of diuretic agents, the factors of concern are as follows:

1. The normal function of the nephron segments (particularly the thick ascending limb)
2. The delivery of adequate solute to Henle's loop
3. The maintenance of a hyperosmotic medullary interstitium (selective reabsorption of solute-free water)

The thick ascending limb of Henle's loop is the most important site for the separation of solute and water. As noted, this separation not only dilutes the tubular fluid but also, by establishing a hyperosmotic medullary interstitium, allows water reabsorption from the collecting duct and thus concentration of the urine. Inhibition of thick ascending limb  $Na^+$  reabsorption by loop diuretics therefore results in inhibition of both solute-free water excretion ( $C_{H_2O}$ ) and solute-free water reabsorption ( $T_{H_2O}^C$ ).

The early portion of the distal tubule is also a site of solute and water separation and thus tubular fluid dilution. Accordingly, inhibition of  $Na^+$  reabsorption by the thiazide diuretics impairs dilution of the urine. However, thiazide diuretics impair urine dilution to a lesser degree than do loop diuretics, reflecting the difference in the  $NaCl$  reabsorptive capacity between the distal tubule (5% of the filtered  $Na^+$ ) and the thick ascending limb (25% of the filtered  $Na^+$ ). In contrast to the loop diuretics, thiazide diuretics do not significantly impair the ability of the kidneys to concentrate the urine. As already noted, concentration of the urine requires a hyperosmotic medullary interstitium so that water can be reabsorbed from the collecting duct in the presence of AVP. Because thiazide diuretics act on distal tubules that are located in the cortex, their action at this site does not appreciably alter the medullary interstitial osmotic gradient. Consequently, urine-concentrating ability is unaffected by thiazide diuretics.

The action of diuretics in the proximal tubule (osmotic diuretics and carbonic anhydrase inhibitors) results in an increase in the delivery of  $NaCl$  and water to Henle's loop. In view of the ability of the thick ascending limb to increase its transport rate in response to an increased delivered load of  $NaCl$ , the separation of solute and water increases. As a result, these diuretic agents increase the ability of the kidneys to excrete solute-free water and reabsorb solute-free water. Thus diuretics that act on the proximal tubule enhance the ability to concentrate and dilute the urine.

Although the late portion of the distal tubule and the collecting duct are able to dilute the luminal fluid in the absence of AVP,  $Na^+$  transport in these segments is not of sufficient magnitude to contribute significantly to the excretion of solute-free water. Consequently, the  $K^+$ -sparing diuretics do not appreciably alter free-water excretion. Like thiazide diuretics,  $K^+$ -sparing diuretics do not alter solute-free water reabsorption because the nephron sites of action are located in the cortex. Aquaretics, because they act directly on the medullary portion of the collecting duct, increase solute-free water excretion and impair solute-free water reabsorption.

### $K^+$ Excretion

One of the major consequences of diuretic use (excluding the  $K^+$ -sparing diuretics) is increased excretion of  $K^+$ , which can be of sufficient magnitude to result in hypokalemia. The basis for this diuretic-induced increase in renal  $K^+$  excretion lies in the fact that when a diuretic inhibits  $Na^+$  and water reabsorption in segments upstream from the late portion of the distal tubule and cortical collecting duct ( $K^+$  secretory site of the nephron), tubular fluid flow rate increases. The increased tubular fluid flow rate stimulates  $K^+$  secretion at this site (see Chapter 7 for details). In addition, by their action on  $Na^+$  balance, diuretics decrease the ECF volume. This mechanism, in turn, leads to increased secretion of aldosterone by the adrenal cortex (see Chapter 6), which acts at this site to stimulate  $K^+$  secretion.

The decrease in ECF volume also stimulates AVP secretion. As described in Chapter 7, AVP stimulates  $K^+$  secretion by the principal cells of the late distal tubule and collecting duct. This stimulatory effect normally is offset by the inhibitory effect of the reduced

tubular flow rate, which also is induced by AVP. As a result, AVP does not normally alter renal  $K^+$  excretion. However, in the presence of a diuretic that is acting upstream to the late portion of the distal tubule and the collecting duct, AVP does increase renal  $K^+$  excretion because in this setting tubular fluid flow is elevated by the action of the diuretics.

Because  $K^+$ -sparing diuretics prevent the increase in  $K^+$  excretion caused by the other diuretics, they usually are given in combination with these other diuretics to prevent or at least minimize the development of hypokalemia.

### $HCO_3^-$ Excretion

By inhibiting  $H^+$  secretion in the proximal tubule and thereby increasing  $HCO_3^-$  excretion, carbonic anhydrase inhibitors can result in the development of a metabolic acidosis.

Although only carbonic anhydrase inhibitors directly alter  $H^+$  secretion by the nephron, all diuretics can affect systemic acid-base balance secondarily. Both loop and thiazide diuretics can induce a metabolic alkalosis, which is a consequence of the decrease in ECF volume that accompanies their use. With a decrease in the ECF volume,  $Na^+$  is more avidly reabsorbed by the nephron. In the proximal tubule, this enhanced  $Na^+$  reabsorption results in enhanced  $H^+$  secretion through the  $Na^+$ - $H^+$  antiporter. Thus a greater fraction of the filtered  $HCO_3^-$  is reabsorbed. In addition, the reduction in ECF volume stimulates aldosterone secretion by the adrenal cortex. As discussed in Chapter 8, aldosterone stimulates  $H^+$  secretion by intercalated cells of the distal tubule and collecting duct. Because, as noted, proximal tubule  $HCO_3^-$  reabsorption is increased, virtually none of the filtered  $HCO_3^-$  reaches the distal tubule. Therefore the increased  $H^+$  secretion that occurs in the distal tubule and collecting duct results in the production of new  $HCO_3^-$  as the  $H^+$  is excreted with non- $HCO_3^-$  urinary buffers (i.e., titratable acid). The increased secretion of  $H^+$  in the distal tubule and collecting duct also enhances the excretion of  $NH_4^+$ , which results in the addition of new  $HCO_3^-$  to the ECF. As a result, net acid excretion by the kidneys is increased and metabolic alkalosis develops.

By inhibiting  $Na^+$  reabsorption in the late portion of the distal tubule and cortical collecting duct,  $K^+$ -sparing

diuretics secondarily inhibit  $H^+$  secretion and thus can lead to the development of a metabolic acidosis.  $H^+$  secretion by these nephron segments is facilitated by the lumen-negative transepithelial voltage. Normally,  $Na^+$  reabsorption in these nephron segments results in the generation of such a voltage. By inhibiting  $Na^+$  reabsorption and thus the negative luminal voltage,  $K^+$ -sparing diuretics reduce  $H^+$  secretion. With reduced  $H^+$  secretion, insufficient quantities of net acid are excreted and a metabolic acidosis ensues.

### $Ca^{++}$ and $P_i$ Excretion

With the exception of  $K^+$ -sparing diuretics, all the diuretics can significantly alter  $Ca^{++}$  excretion by the kidney. With inhibition of proximal tubule solute and water reabsorption (osmotic diuretics and carbonic anhydrase inhibitors), reduced reabsorption of  $Ca^{++}$  and thus increased excretion occurs. The amount of  $Ca^{++}$  excreted is less than expected from inhibition of proximal tubule transport. This situation again reflects the ability of the downstream segments (particularly the thick ascending limb of Henle's loop) to increase reabsorption after an increased delivery of  $Ca^{++}$ . The mechanism by which these diuretics inhibit proximal tubule  $Ca^{++}$  reabsorption is related to their ability to reduce solvent drag (see Chapter 9). With the use of carbonic anhydrase inhibitors, increased  $Ca^{++}$  excretion occurs in the setting of an alkaline urine (increased urinary  $[HCO_3^-]$ ). Because  $Ca^{++}$  is less soluble in alkaline urine, the potential exists for the formation of renal stones that contain  $Ca^{++}$ .

Loop diuretics also increase  $Ca^{++}$  excretion, an action explained by the effect of these diuretics on the transepithelial voltage of the thick ascending limb of Henle's loop. Normally, the transepithelial voltage of this segment is oriented lumen positive (see Chapter 4), providing a driving force for the movement of  $Ca^{++}$  from the lumen to blood through the paracellular pathway (see Chapter 9). When transport of  $NaCl$  by Henle's loop is blocked by loop diuretics, this lumen-positive voltage is abolished, and thus the driving force for  $Ca^{++}$  reabsorption is reduced. Normally, Henle's loop reabsorbs about 15% of the filtered  $Ca^{++}$  (see Chapter 9). Inhibition of  $Ca^{++}$  reabsorption by loop diuretics therefore can have a significant effect on  $Ca^{++}$  excretion. For this reason, loop diuretics

often are used to treat hypercalcemia. Despite this action of loop diuretics, hypercalcemia can occur with their long-term use. The mechanism responsible for this effect is related to the diuretic-induced decrease in the ECF volume. When the ECF volume is decreased, proximal tubule reabsorption is enhanced, which increases  $\text{Ca}^{++}$  reabsorption at this site and therefore decreases urinary  $\text{Ca}^{++}$  excretion.

Thiazide diuretics stimulate  $\text{Ca}^{++}$  reabsorption by the cells of the distal tubule and thus reduce  $\text{Ca}^{++}$  excretion. The distal tubule normally reabsorbs approximately 10% to 15% of the filtered  $\text{Ca}^{++}$  (see Chapter 9). The reabsorption of  $\text{Ca}^{++}$  at this site is an active, transcellular process involving entry of  $\text{Ca}^{++}$  into the cell through channels in the apical membrane and extrusion from the cell across the basolateral membrane by the  $\text{Ca}^{++}$ -ATPase and  $3\text{Na}^{+}$ - $\text{Ca}^{++}$  antiporter. Thiazide diuretics, by inhibiting the entry of  $\text{NaCl}$  into the cell, cause the membrane potential to hyperpolarize (i.e., the cell interior becomes more electrically negative).<sup>\*</sup> This hyperpolarization in turn activates the  $\text{Ca}^{++}$  channel (TRPV5) in the apical

<sup>\*</sup>Hyperpolarization of the membrane potential occurs as a result of a decrease in the intracellular  $[\text{Cl}^{-}]$ . The basolateral membrane of the distal tubule cell contains  $\text{Cl}^{-}$  channels; thus the membrane potential is determined in part by the  $\text{Cl}^{-}$  equilibrium potential. A decrease in the intracellular  $[\text{Cl}^{-}]$  therefore increases the magnitude of this equilibrium potential (i.e., it becomes more negative).

membrane of the cell and increases the electrochemical gradient for  $\text{Ca}^{++}$  entry into the cell. The increased entry of  $\text{Ca}^{++}$  into the cell is matched by increased extrusion across the basolateral membrane by the  $\text{Ca}^{++}$ -ATPase and  $3\text{Na}^{+}$ - $\text{Ca}^{++}$  antiporter (extrusion of  $\text{Ca}^{++}$  via the  $3\text{Na}^{+}$ - $\text{Ca}^{++}$  antiporter is stimulated because the intracellular concentration of  $\text{Na}^{+}$  is decreased as a result of the diuretic blocking  $\text{Na}^{+}$  entry into the cell across the apical membrane). The net effect is an increase in  $\text{Ca}^{++}$  reabsorption. With long-term use of thiazide diuretics, the associated decrease in ECF volume stimulates proximal tubule reabsorption (see Chapter 6), including that of  $\text{Ca}^{++}$ . Because thiazides reduce urinary  $\text{Ca}^{++}$  excretion, they sometimes are used to lower the incidence of the formation of stones containing  $\text{Ca}^{++}$  in persons who normally excrete high levels of  $\text{Ca}^{++}$  in their urine.

With the exception of the  $\text{K}^{+}$ -sparing diuretics, all diuretics acutely increase  $\text{P}_i$  excretion. However, the cellular mechanisms for this effect are not completely understood. The effect is modified, however, with long-term diuretic therapy. With the decrease in ECF volume that accompanies long-term diuretic use, proximal tubule  $\text{Na}^{+}$  reabsorption is stimulated. Because the proximal tubule reabsorbs the largest portion of the filtered  $\text{P}_i$  and because this reabsorptive process is coupled with  $\text{Na}^{+}$  (see Chapters 4 and 9),  $\text{P}_i$  excretion is reduced in this setting.

## S U M M A R Y

1. Diuretics inhibit solute (primarily  $\text{NaCl}$ ) transport at various sites along the nephron. As a result of their action, the net excretion of solute and water by the kidneys increases.
2. By increasing the excretion of  $\text{NaCl}$  by the kidneys, diuretics cause a decrease in the volume of the ECF. This decreased ECF volume results in a loss of body weight because 1 L of ECF fluid weighs 1 kg.
3. The ability of a particular diuretic to increase solute and water excretion depends on several factors, including the nephron segment(s) where the diuretic acts, the ability of other nephron segments not directly affected by the diuretic to increase their reabsorption of solute and water, the delivery of sufficient quantities of the diuretic to its site of action, and diuretic-induced changes in ECF volume that may affect renal solute and water transport.
4. Osmotic diuretics inhibit solute and water reabsorption in the proximal tubule and descending thin limb of Henle's loop. Quantitatively, the proximal tubule is the most important site of action.

5. Carbonic anhydrase inhibitors act primarily in the proximal tubule to inhibit  $\text{Na}^+$ ,  $\text{HCO}_3^-$ , and water reabsorption.
6. Loop diuretics inhibit  $\text{NaCl}$  reabsorption by the thick ascending limb of Henle's loop. They are the most potent diuretic and can increase  $\text{Na}^+$  excretion to as much as 25% of the filtered  $\text{NaCl}$ .
7. Thiazide diuretics inhibit  $\text{NaCl}$  reabsorption in the early portion of the distal tubule.
8.  $\text{K}^+$ -sparing diuretics act at the late portion of the distal tubule and the cortical collecting duct. They inhibit  $\text{Na}^+$  reabsorption and in doing so inhibit  $\text{K}^+$  secretion. Their most important use is related to their ability to reduce renal  $\text{K}^+$  excretion.
9. Osmotic diuretics block the AVP receptor ( $\text{V}_2$ ) in the late portion of the distal tubule and the collecting duct. They impair the ability of the kidneys to concentrate the urine, leading to the excretion of solute-free water.
10. Osmotic diuretics and carbonic anhydrase inhibitors increase the kidneys' ability to excrete and reabsorb solute-free water (i.e. both urinary diluting and concentrating mechanisms, respectively). The loop diuretics impair both solute-free water reabsorption (i.e., the ability to produce concentrated urine) and excretion (i.e., the ability to produce dilute urine), whereas the thiazide diuretics impair only solute-free water excretion (i.e., the ability to produce dilute urine). The  $\text{K}^+$ -sparing diuretics do not have a significant effect on solute-free water excretion. Osmotic diuretics increase solute-free water excretion and impair solute-free water reabsorption.
11. All diuretics, with the exception of the  $\text{K}^+$ -sparing diuretics, increase the renal excretion of  $\text{K}^+$ . This effect is in response to increased delivery of tubular fluid to the  $\text{K}^+$  secretory portion of the nephron (distal tubule and cortical collecting duct) and increased aldosterone and AVP levels secondary to the diuretic-induced decrease in ECF volume.
12. The carbonic anhydrase inhibitors and  $\text{K}^+$ -sparing diuretics can induce a metabolic acidosis. The loop diuretics and thiazide diuretics can cause a metabolic alkalosis.
13. Acutely, loop diuretics increase  $\text{Ca}^{++}$  excretion. By reducing the ECF volume, chronic administration

of loop diuretics can secondarily enhance proximal  $\text{Ca}^{++}$  reabsorption and limit net  $\text{Ca}^{++}$  excretion. Thiazide diuretics decrease  $\text{Ca}^{++}$  excretion.

14. With the exception of  $\text{K}^+$ -sparing diuretics, all diuretics acutely increase  $\text{P}_i$  excretion. When the ECF volume is decreased by chronic diuretic use,  $\text{P}_i$  excretion is reduced.

### SELF-STUDY PROBLEMS

1. Patients with nephrogenic diabetes insipidus can obtain symptomatic relief from their polyuria with long-term use of a thiazide diuretic. What are the mechanisms by which long-term thiazide therapy produces a decrease in urine volume in these patients?

3. The antibiotic penicillin is secreted into the urine by the organic anion secretory system of the proximal tubule. If an infection requiring penicillin develops in a person taking a thiazide diuretic for hypertension, what effect, if any, could this have on the action of the diuretic?
4. A diuretic is administered to two individuals for several weeks. Individual A receives a loop diuretic and individual B receives a thiazide diuretic. Both ingest a diet that contains 100 mEq/day of  $\text{Na}^+$ . After these persons have taken their respective diuretics for 2 weeks, consider the following questions:
  - a. How much  $\text{Na}^+$  does each person excrete in a day, and why?
  - b. Both individuals are deprived of water. Individual A is able to concentrate the urine to 400 mOsm/kg  $\text{H}_2\text{O}$ . Individual B is able to concentrate the urine to 1000 mOsm/kg  $\text{H}_2\text{O}$ . How do you explain the difference in response of these two individuals to water deprivation?
  - c. Both individuals are water loaded. Individual A is able to dilute his urine to 300 mOsm/kg  $\text{H}_2\text{O}$ . Individual B is able to dilute his urine to 250 mOsm/kg  $\text{H}_2\text{O}$ . How do you explain the inability of these individuals to dilute their urine maximally?

# APPENDIX A

## INTEGRATIVE CASE STUDIES

### CASE 1

A 65-year-old man has congestive heart failure. He is seen by his physician because he has run out of his medications. He presents with easy fatigability, shortness of breath, and swelling of his ankles. On physical examination he is found to have distended neck veins and pitting edema of the ankles. His breathing is rapid (20 breaths/min), and rales (i.e., fluid in the lungs) are heard bilaterally at the bases of the lungs. He is afebrile, with a pulse rate of 110 beats/min and a blood pressure of 110/70 mm Hg. A blood sample is obtained, and the following abnormalities are noted:

Serum  $[\text{Na}^+] = 130 \text{ mEq/L}$

Serum  $[\text{K}^+] = 3.0 \text{ mEq/L}$

Serum [creatinine] = 1.4 mg/dL

### Questions

- 1a. Is the extracellular fluid (ECF) volume in this man increased or decreased from normal? What evidence in the physical examination supports your conclusion?
- 1b. Is the effective circulating volume (ECV) in this man increased or decreased from normal?
- 1c. What would you predict to be the levels (activities) of atrial natriuretic peptide, brain natriuretic peptide, arginine vasopressin, renin-angiotensin-aldosterone, and the sympathetic nervous system in this man, and why?
- 1d. How would you characterize renal  $\text{Na}^+$  handling in this man? What evidence in the physical examination supports this conclusion?
- 1e. What is the mechanism for the development of hyponatremia in this man?
- 1f. What is the mechanism for the development of hypokalemia in this man?
- 1g. The physician treating this man prescribes a loop diuretic to reduce  $\text{Na}^+$  retention and reduce his edema. It is known that patients with congestive heart failure do not respond as well to loop diuretics as healthy patients would (i.e., the degree of natriuresis is less). What explains the decreased effect of the loop diuretic in a patient with congestive heart failure?
- 1h. What effect will the loop diuretic have on this man's ECF volume and ECV?
- 1i. While he is taking the loop diuretic, the serum  $[\text{K}^+]$  of this man decreases from 3.0 to 2.5 mEq/L. What is the mechanism for this diuretic-induced hypokalemia?
- 1j. After administration of the diuretic, the serum [creatinine] increases from 1.4 to 1.8 mg/dL. Why was the serum [creatinine] elevated, and why did it increase further after treatment with the loop diuretic?

### CASE 2

A 49-year-old woman sees her physician because of weakness, easy fatigability, and loss of appetite. During the past month she has lost 7 kg (15 lb). On physical examination she is found to have hyperpigmentation, especially of the oral mucosa and gums. She is hypotensive, and her blood pressure (BP) falls when she assumes an upright posture (BP = 100/60 mm Hg supine and 80/50 mm Hg erect). The following laboratory data are obtained:

Serum  $[\text{Na}^+] = 132 \text{ mEq/L}$

Serum  $[\text{K}^+] = 6.5 \text{ mEq/L}$

Serum  $[\text{HCO}_3^-] = 20 \text{ mEq/L}$

Urine  $[\text{Na}^+] = 20 \text{ mEq/L}$

### Questions

- 2a. The plasma level of what hormone(s) would be expected to be below normal in this woman?
- 2b. How do you explain the urine  $[\text{Na}^+]$  of 20 mEq/L in this woman? What would you expect the urine  $[\text{Na}^+]$  to be in an individual who is volume depleted? What relationship does this have to the hypotension in this woman?
- 2c. What is the mechanism for development of hyponatremia in this woman?
- 2d. Why does this woman have hyperkalemia?
- 2e. What is the acid-base disturbance in this woman, and what is its cause?

### CASE 3

A 70-year-old man with lung cancer develops the syndrome of inappropriate antidiuretic hormone secretion (SIADH). He is admitted to the hospital, and the following data are obtained. His vital signs are normal, as is the physical examination. There is no evidence of ECF volume contraction or ECF volume expansion.

Body weight = 70 kg

Serum  $[\text{Na}^+] = 120 \text{ mEq/L}$  (normal = 135-147 mEq/L)

Urine osmolality = 600 mOsm/kg  $\text{H}_2\text{O}$

Urine  $[\text{Na}^+]$  excretion = 80 mEq/day

### Questions

- 3a. What determines the amount of  $\text{Na}^+$  that is excreted in the urine, and is  $\text{Na}^+$  excretion in this patient normal (assume that he ingests approximately 80 mEq/day of  $\text{Na}^+$ )?
- 3b. 1 L of isotonic saline is administered intravenously with the goal of raising the serum  $[\text{Na}^+]$ . How much of the infused  $\text{NaCl}$  will be excreted in the urine (for simplicity, assume that 1 L of isotonic saline contains 150 mmol/L of  $\text{NaCl}$ )? What effect will this infusion have on the plasma  $[\text{Na}^+]$ ?

3c. What effect would the administration of 1 L of hypertonic saline (3%  $\text{NaCl}$  solution) have on the plasma  $[\text{Na}^+]$ ?

3d. What other therapies could be used to treat this man's hyponatremia?

### CASE 4

An 18-year-old man with insulin-dependent (type 1) diabetes mellitus is seen in the emergency department. He reports not taking his insulin during the previous 24 hours because he did not feel well and was not eating. He now has weakness, nausea, thirst, and frequent urination. His blood pressure is 100/60 mm Hg supine and 80/50 mm Hg erect. His pulse rate increases from 100 beats/min supine to 110 beats/min when erect. On physical examination he is found to have deep and rapid respiration (Kussmaul's respiration). At 1:00 AM the following laboratory data are obtained:

Plasma  $[\text{Na}^+] = 140 \text{ mEq/L}$

Serum  $[\text{Cl}^-] = 95 \text{ mEq/L}$

Plasma  $[\text{K}^+] = 6.5 \text{ mEq/L}$

Plasma  $[\text{HCO}_3^-] = 7 \text{ mEq/L}$

Blood pH = 6.99

Arterial  $\text{Pco}_2 = 18 \text{ mm Hg}$

Plasma [glucose] = 600 mg/dL

Urine contains glucose and ketones

The diagnosis of diabetic ketoacidosis is made, and the man is admitted to the hospital. Saline is administered intravenously and insulin therapy begun. The results of therapy are illustrated in the following table.

# APPENDIX D

## ANSWERS TO SELF-STUDY PROBLEMS

### CHAPTER 1

1.

2. The cell will swell when placed in the solution because the solute is only a partially effective osmole (i.e., this is a hypotonic solution). Because the reflection coefficient ( $\sigma$ ) is 0.5, the effective osmolality of the solution is only 150 mOsm/kg H<sub>2</sub>O. The solution would have to contain 600 mmol/L of this solute to be isotonic.

3. Na<sup>+</sup>, with its anions Cl<sup>-</sup> and HCO<sub>3</sub><sup>-</sup>, constitutes the majority of particles in the ECF and is therefore the major determinant of plasma osmolality. Consequently, plasma osmolality can be estimated by simply doubling the plasma [Na<sup>+</sup>]. Thus the estimated plasma osmolality in this individual is as follows:

$$P_{\text{osm}} = 2(130) = 260 \text{ mOsm/kg H}_2\text{O}$$

This value is well below the normal range of 285 to 295 mOsm/kg H<sub>2</sub>O and will result in movement of water from the ECF into the ICF. Because ions move freely across the capillary wall, the [Na<sup>+</sup>] (and osmolality) of the plasma and interstitial fluid will be the same. Therefore, water movement across the capillary endothelium will not be affected.

4. The increase in venous pressure causes increased movement of fluid out of the capillary. As a result,

fluid accumulates in the interstitial space. Some of this fluid will be taken up by the lymphatics, and lymphatic flow will increase. However, when the capacity of the lymphatics to remove this fluid is exceeded, the volume of the interstitial space increases, and edema forms (see also Chapter 6).

5. This is an isotonic solution and will therefore remain confined initially to the ECF. The ECF volume will increase by 1 L, and ICF volume will be unchanged (initial volumes being 10 L [ECF] and 20 L [ICF], respectively). Plasma [Na<sup>+</sup>] will decrease because of the addition of 1 L of Na<sup>+</sup>-free solution to the ECF. The new plasma [Na<sup>+</sup>] is calculated by:

$$\begin{aligned} \text{Initial ECF Na}^+ \text{ content} &= 145 \text{ mEq/L} \times 10 \text{ L} \\ &= 1450 \text{ mEq} \\ \text{New [Na}^+] &= 1450 \text{ mEq}/11 \text{ L} \\ &= 132 \text{ mEq/L} \end{aligned}$$

Therefore the immediate effect is:

ECF volume	11 L
ICF volume	20 L
Plasma [Na <sup>+</sup> ]	132 mEq/L

In the long term, the dextrose will be metabolized to CO<sub>2</sub> and H<sub>2</sub>O. Thus infusion of a dextrose solution is equivalent to infusion of solute-free water. After metabolism of dextrose (several hours) and equilibration, the 1 L of infused H<sub>2</sub>O will distribute into both the ICF and ECF in proportion to the ratio of their volumes (two thirds into the ICF and one third into the ECF):

ICF volume	= 20 L + 0.67 L	= 20.67 L
ECF volume	= 10 L + 0.33 L	= 10.33 L
New [Na <sup>+</sup> ]	= 1450 mEq/10.33 L	= 141 mEq/L

Therefore the long-term effect is:

ECF volume	10.3 L
ICF volume	20.7 L
Plasma $[\text{Na}^+]$	141 mEq/L

As noted previously, a dextrose solution is equivalent to solute-free water. Therefore, these solutions would be used when the patient had lost solute-free water and body fluid osmolality is elevated (i.e., hypernatremia).

6. A 0.9% NaCl solution is isotonic saline. Therefore, the entire infused volume will remain in the ECF. In this example, the ECF will increase by 1 L and the ICF will not change. One approach to this problem is to calculate the amount of  $\text{Na}^+$  in the infused volume and then determine the effect on the plasma  $[\text{Na}^+]$ . For example:

0.9% NaCl	= 154 mEq/L
Amount of infused $\text{Na}^+$	= 1 L $\times$ 154 mEq/L = 154 mEq
New ECF $\text{Na}^+$ content	= 1450 mEq + 154 mEq = 1604 mEq
New plasma $[\text{Na}^+]$	= 1604 mEq/11 L = 146 mEq/L

Therefore the immediate effect is:

ECF volume	11 L
ICF volume	20 L
Plasma $[\text{Na}^+]$	146 mEq/L

The long-term effect of this infusion is identical to that seen immediately. Thus the long-term effect is:

ECF volume	11 L
ICF volume	20 L
Plasma $[\text{Na}^+]$	146 mEq/L

From this it is apparent that infusion of isotonic saline into an individual with a normal serum  $[\text{Na}^+]$  will result in an increase in the volume of the ECF, equal to the entire infused volume, with no appreciable change in the serum  $[\text{Na}^+]$ .

7. The initial volumes of the body fluid compartments and the osmoles in these compartments are

calculated as follows (osmolality is estimated as  $2 \times [\text{Na}^+] = 280 \text{ mOsm/kg H}_2\text{O}$ ):

Initial total body water	= 0.6(60 kg) = 36 L
Initial ICF volume	= 0.4(60 kg) = 24 L
Initial ECF volume	= 0.2(60 kg) = 12 L
Initial total body osmoles	= (total body water)(body fluid osmolality) = (36 L)(280 mOsm/kg $\text{H}_2\text{O}$ ) = 10,080 mOsm
Initial ICF osmoles	= (ICF volume)(body fluid osmolality) = (24 L)(280 mOsm/kg $\text{H}_2\text{O}$ ) = 6720 mOsm
Initial ECF osmoles	= Total body osmoles – ICF osmoles = 10,080 mOsm – 6720 mOsm = 3360 mOsm

Four kilograms of body weight are lost. It is assumed that this entire weight reduction reflects fluids lost through vomiting and diarrhea. Thus 4 L of fluid are lost. Because the plasma  $[\text{Na}^+]$  is unchanged, a proportional amount of solute was also lost (isotonic loss of fluid). No fluid shifts occur between the ECF and ICF because of the absence of an osmotic gradient between these compartments. Therefore the ECF loses 4 L of volume, and  $4 \times 280 = 1120 \text{ mOsm}$  of solute.

New total body water	= 36 L – 4 L = 32 L
New ICF volume	= 24 L (unchanged)
New ECF volume	= 12 L – 4 L = 8 L
New total body osmoles	= 10,080 mOsm – 1120 mOsm = 8960 mOsm
New ICF osmoles	= 6720 mOsm (unchanged)
New ECF osmoles	= 3360 mOsm – 1120 mOsm = 2240 mOsm

8. The initial volumes of the body fluid compartments and the osmoles in these compartments are calculated as in problem 7:

Initial total body water	= 0.6(50 kg) = 30 L
Initial ICF volume	= 0.4(50 kg) = 20 L
Initial ECF volume	= 0.2(50 kg) = 10 L
Initial total body osmoles	= (total body water) $\times$ (body fluid osmolality) = (30 L)(290 mOsm/kg $\text{H}_2\text{O}$ ) = 8700 mOsm
Initial ICF osmoles	= (ICF volume)(body fluid osmolality) = (20 L)(290 mOsm/kg $\text{H}_2\text{O}$ ) = 5800 mOsm

 &= 8700 \text{ mOsm} - 5800 \text{ mOsm} \\

The total amount of mannitol added to the ECF must be calculated to determine its effect on body fluids. At 5 g/kg, a total of 250 g was added to the ECF (1.374 moles of mannitol). Because mannitol is a single particle in solution, this adds 1374 mOsm to the ECF. The mannitol will raise ECF osmolality and result in the shift of fluid from the ICF into the ECF.

 \text{New total body osmoles} &= 8700 \text{ mOsm} + 1374 \text{ mOsm} \\
 &= 10,074 \text{ mOsm} \\

 \text{New ECF osmoles} &= 2900 \text{ mOsm} + 1374 \text{ mOsm} \\
 &= 4274 \text{ mOsm} \\
 \text{New plasma osmolality} &= \text{New total osmoles} / \text{Total body water} \\
 &= 10,074 \text{ mOsm} / 30 \text{ L} \\
 &= 336 \text{ mOsm/kg H}_2\text{O} \\
 \text{New ICF volume} &= \text{ICF osmoles} / \text{New } P_{\text{osm}} \\

Because mannitol increases the osmolality of the ECF, 2.7 L of fluid shifts from the ICF into the ECF. To calculate the new plasma  $[\text{Na}^+]$ , assume that the amount of  $\text{Na}^+$  in the ECF is unchanged after mannitol infusion. Originally, there were 2900 mOsm attributable to  $\text{Na}^+$  ( $2 \times [\text{Na}^+] = \text{ECF volume}$ ) in the ECF. Because the  $\text{Na}^+$  osmoles are unchanged but are now present in a larger volume, the new plasma  $[\text{Na}^+]$  is calculated as follows:

$$\begin{aligned}
 \text{New plasma Na}^+ \text{ osmoles} &= 2900 \text{ mOsm from Na}^+ / 12.7 \text{ L} \\
 &= 228 \text{ mOsm/L} \\
 \text{New plasma } [\text{Na}^+] &= \text{Na}^+ \text{ Osm} / 2 \\
 &= 228 \text{ mOsm/L} \\
 &= 114 \text{ mEq/L}
 \end{aligned}$$

9. Both individuals start out with the same total body water (36 L) and total body osmoles (10,440 mOsm) assuming a plasma  $[\text{Na}^+]$  of 145 mEq/L and a plasma osmolality of 290 mOsm/kg  $\text{H}_2\text{O}$ . Subject A loses 1 L of total body water and 1000 osmoles of

total body solute, resulting in a new plasma osmolality of:

$$\begin{aligned}
 P_{\text{osm}} &= (10,440 \text{ mOsm} - 1000 \text{ mOsm}) / 35 \text{ L} \\
 &= 270 \text{ mOsm/kg H}_2\text{O}
 \end{aligned}$$

Subject B loses 4 L of total body water and 1600 mOsm of total body solute, resulting in a new plasma osmolality of:

 P_{\text{osm}} &= (10,440 \text{ mOsm} - 1600 \text{ mOsm}) / 32 \text{ L} \\
 &= 276 \text{ mOsm/kg H}_2\text{O}
 \end{aligned}$$

## CHAPTER 2

1. The gross anatomic features of the kidney include the cortex, medulla, nephrons, blood vessels, lymphatics, nerves, renal pyramids, papilla, minor calyx, major calyces, and pelvis.
2. The nephron consists of a renal corpuscle, proximal tubule, loop of Henle, distal tubule, and collecting duct system.
3. The renal artery branches progressively to form the interlobar artery, the arcuate artery, the interlobular artery, and the afferent arteriole, which leads into the glomerular capillaries (i.e., glomerulus). The glomerular capillaries come together to form the efferent arteriole, which leads into a second capillary network, the peritubular capillaries, which supply blood to the nephron. The vessels of the venous system run parallel to the arterial vessels and progressively form the interlobular vein, arcuate vein, interlobar vein, and renal vein, which courses beside the ureter.
4. The renal corpuscle is the first part of the nephron and is composed of glomerular capillaries and Bowman's capsule.
5. The glomerular capillary endothelium, basement membrane, and foot processes of podocytes form the so-called *filtration barrier*. Proteins are filtered on the basis of size.
6. Structures that compose the juxtaglomerular apparatus include the macula densa of the thick ascending limb, extraglomerular mesangial cells, and the renin-producing granular cells of the afferent arterioles.

7. The juxtaglomerular apparatus is one component of a feedback mechanism (i.e., tubuloglomerular feedback) that regulates renal blood flow and glomerular filtration rate. It also regulates renin secretion by the granular cells of the afferent arteriole.
8. The mesangium consists of mesangial cells and the mesangial matrix. Mesangial cells, which possess many properties of smooth muscle cells, surround the glomerular capillaries, provide structural support for the glomerular capillaries, secrete the extracellular matrix, exhibit phagocytic activity that removes macromolecules from the mesangium, and secrete prostaglandins and proinflammatory cytokines. Because they also contract and are adjacent to glomerular capillaries, mesangial cells may influence the GFR by regulating blood flow through the glomerular capillaries or by altering the capillary surface area. Mesangial cells located outside the glomerulus (between the afferent and efferent arterioles) are called extraglomerular mesangial cells.
9. Renal nerves regulate renal blood flow, glomerular filtration rate, and salt and water reabsorption by the nephron. The nerve supply to the kidneys consists of sympathetic nerve fibers that originate in the celiac plexus. There is no parasympathetic innervation. Adrenergic fibers that innervate the kidneys release norepinephrine. The adrenergic fibers lie adjacent to the smooth muscle cells of the major branches of the renal artery (interlobar, arcuate, and interlobular arteries) and the afferent and efferent arterioles. Moreover, sympathetic nerves innervate the renin-producing granular cells of the afferent arterioles. Renin secretion is stimulated by increased sympathetic activity. Nerve fibers also innervate the proximal tubule, loop of Henle, distal tubule, and collecting duct; activation of these nerves enhances  $\text{Na}^+$  reabsorption by these nephron segments.

### CHAPTER 3

1. Before phlorhizin administration:

Before treatment with phlorhizin, the filtered load of glucose ( $\text{GFR} \times \text{serum [glucose]}$ ) is 100 mg/min (GFR calculated from inulin clearance). With this filtered load of glucose, all the glucose is reabsorbed and none is excreted. Thus, the clearance of glucose is zero. After phlorhizin the filtered load is unchanged, but there is no glucose reabsorption. Therefore, all the glucose that is filtered is excreted, and the clearance of glucose equals that of inulin.

2. a. Although the appearance of red cells in the urine can result from damage to the glomerular filtration barrier, red cells can also appear in the urine for other reasons. For example, they can appear as a result of bleeding in any part of the lower urinary tract. Such bleeding is seen with kidney stones and occasionally as a result of a bacterial infection of the lower urinary tract, which causes bleeding. Thus, the appearance of blood in the urine does not necessarily mean the glomerular filtration barrier is damaged.
- b. Because glucose is filtered and completely reabsorbed by the proximal tubule, it is not normally found in the urine. Its presence in the urine indicates an elevated serum glucose level such that the filtered load (i.e.,  $\text{GFR} \times \text{serum [glucose]}$ ) is greater than the ability of the proximal tubule to reabsorb glucose. Because glucose is freely filtered by the normal glomerulus, damage to the ultrafiltration barrier would not increase its filtration.
- c. In healthy individuals,  $\text{Na}^+$  normally appears in the urine. Like glucose,  $\text{Na}^+$  is freely filtered by the normal glomerulus. Therefore damage to the filtration barrier does not increase the rate of  $\text{Na}^+$  excretion.

- d. This is the correct answer. Normally, the urine contains essentially no protein. The glomerulus prevents the filtration of plasma proteins. However, when the glomerulus is damaged, large amounts of plasma proteins are filtered. If the amount filtered overwhelms the reabsorptive capacity of the proximal tubule, protein appears in the urine (proteinuria).
3. The equation for blood flow through an organ is  $Q = \Delta P/R$ . Sympathetic agonists, angiotensin II, and prostaglandins change blood flow by altering the resistance (R). Whereas sympathetic agonists and angiotensin II increase R and thereby decrease renal blood flow (RBF), prostaglandins decrease R and thereby increase RBF.
4. Normally, renal prostaglandin production is low, and nonsteroidal antiinflammatory drugs (NSAIDs) do not have an appreciable effect on prostaglandin production. However, during reductions in GFR and RBF, elevated prostaglandin levels cause vasodilation of the afferent and efferent arterioles. This effect prevents excessive decreases in RBF and GFR. Administration of NSAIDs to patients with low GFR and RBF inhibits prostaglandin production and further reduces GFR and RBF.

## CHAPTER 4

1. The glomeruli filter 25,200 mEq of  $\text{Na}^+$  and 18,000 mEq of  $\text{Cl}^-$  each day (assuming GFR = 180 L/day), and 99% is reabsorbed by the nephrons, with less than 1% appearing in the urine. Although  $\text{Na}^+$  and  $\text{Cl}^-$  uptake into cells across the apical membrane and NaCl reabsorption across the paracellular pathway are passive processes (i.e., they do not require the direct input of adenosine triphosphate [ATP]), they ultimately depend on the operation of the  $\text{Na}^+\text{-K}^+\text{-ATPase}$ . Accordingly, reabsorption of NaCl requires a considerable quantity of ATP, the synthesis of which by kidney cells requires large amounts of oxygen and, hence, high blood flow.
2. “Normal” or “average” urine composition does not actually exist because of the variability in the volume of urine excreted, as well as variations in the intake of solutes in the diet (Table D-1). Urine was

- collected on three different days from a subject who ate a consistent diet but ingested different amounts of water each day. Although the amount of each solute excreted was similar each day (Table D-2), the concentration of each solute in the urine was different because the volume of urine varied each day. This question demonstrates that the amount (or rate) of a solute excreted, not the concentration of the solute in the urine, is important in the clinical evaluation of urine.
3. Passive transport always occurs down an electrochemical gradient. For coupled transporters

(antiport and symport), the movement of one molecule down its electrochemical gradient can drive uphill movement of the coupled molecule. When this occurs, the uphill movement is termed secondary active transport because the transporter is not coupled directly to the hydrolysis of ATP. Active transport occurs against an electrochemical gradient and requires the direct input of energy (i.e., ATP). Some authors refer to such transport as primary active to emphasize the direct coupling to ATP.

4. Because the  $\text{Na}^+\text{-K}^+\text{-ATPase}$  is ultimately responsible for the reabsorption and secretion of all solutes (except  $\text{H}^+$ ) and water by the nephron, complete inhibition of this transport protein would block all solute and water transport (both cellular and paracellular). Hence, in this hypothetical example, each day the kidneys would excrete 180 L of fluid (assuming  $\text{GFR} = 180 \text{ L/day}$ ) that would be similar in composition to the glomerular ultrafiltrate.
5. The reabsorption of  $\text{Na}^+$  in the first half of the proximal tubule is coupled to that of  $\text{HCO}_3^-$  and a number of organic molecules, and this generates a negative transepithelial voltage across the proximal tubule that provides the driving force for the paracellular reabsorption of  $\text{Cl}^-$ . The reabsorption of many organic molecules is so avid that they are almost completely removed from the tubular fluid in the first half of the proximal tubule. The reabsorption of  $\text{NaHCO}_3$  and  $\text{Na}^+$  organic solutes across the proximal tubule establishes a transtubular osmotic gradient that provides the driving force for the passive reabsorption of water by osmosis. Because more water than  $\text{Cl}^-$  is reabsorbed in the first half of the proximal tubule, the  $\text{Cl}^-$  concentration in tubular fluid rises along the length of the proximal tubule. In the second half of the proximal tubule,  $\text{Na}^+$  is mainly reabsorbed with  $\text{Cl}^-$  across the transcellular pathway.  $\text{Na}^+$  is primarily reabsorbed with  $\text{Cl}^-$  rather than organic solutes or  $\text{HCO}_3^-$  as the accompanying anion because the  $\text{Na}^+$  transport mechanisms in the second half of the proximal tubule differs from those in the first half. Furthermore, the tubular fluid that enters the second half contains very little glucose and amino acids, but the high concentration

of  $\text{Cl}^-$  (140 mEq/L) in tubule fluid exceeds that in the first half (105 mEq/L). The high  $\text{Cl}^-$  concentration is due to the preferential reabsorption of  $\text{Na}^+$  with  $\text{HCO}_3^-$  and organic solutes in the first half of the proximal tubule. In the second half of the proximal tubule  $\text{Na}^+$  enters the cell across the luminal membrane primarily through the parallel operation of a  $\text{Na}^+\text{-H}^+$  antiporter and one or more  $\text{Cl}^-$ -base antiporters. Because the secreted  $\text{H}^+$  and base combine in the tubular fluid and reenter the cell, the operation of the  $\text{Na}^+\text{-H}^+$  and  $\text{Cl}^-$ -anion antiporters is equivalent to  $\text{NaCl}$  uptake from tubular fluid into the cell.  $\text{Na}^+$  leaves the cell through  $\text{Na}^+\text{-K}^+\text{-ATPase}$ , and  $\text{Cl}^-$  leaves the cell and enters the blood through a  $\text{K}^+\text{-Cl}^-$  symporter and a  $\text{Cl}^-$  channel in the basolateral membrane. Some  $\text{NaCl}$  is also reabsorbed across the second half of the proximal tubule by a paracellular route. The transport of solutes ( $\text{NaCl}$ ) across the cellular and paracellular pathways lowers the osmolality of the tubular fluid and increases the osmolality of the interstitial fluid, which establishes a driving force for water reabsorption across the proximal tubule. Some solutes are reabsorbed with this water by the process of solvent drag. Starling forces across the wall of the peritubular capillary are important for the uptake of this interstitial fluid and can regulate the rate of solute and water back-flux across the tight junctions and thereby modulate net solute and water reabsorption.

6.  $\text{NaCl}$  is reabsorbed across the thick ascending limb by two mechanisms. First, transcellular transport involves  $\text{Na}^+$  and  $\text{Cl}^-$  entry into the cell across the apical membrane by the  $\text{Na}^+\text{-K}^+\text{-2Cl}^-$  symporter (some  $\text{Na}^+$  is also reabsorbed by the apical membrane  $\text{Na}^+\text{-H}^+$  antiporter) and exit across the basolateral membrane by the  $\text{Na}^+\text{-K}^+\text{-ATPase}$  (for  $\text{Na}^+$ ) and a  $\text{K}^+\text{-Cl}^-$  symporter and  $\text{Cl}^-$  channel (for  $\text{Cl}^-$ ). Second,  $\text{Na}^+$  is also reabsorbed across the paracellular pathway, owing to the lumen-positive transepithelial voltage. Furosemide would have no effect on water reabsorption in the thick ascending limb because this segment of the nephron is relatively impermeable to water and water is not reabsorbed even when  $\text{NaCl}$  reabsorptive rates are high. Furosemide increases water excretion by reducing the osmolality of the medullary interstitial fluid, which

in turn reduces water reabsorption from the descending thin limb of Henle's loop and medullary collecting duct.

7. Glomerulotubular balance describes the phenomenon whereby an increase in the filtered load of water and NaCl is accompanied by a parallel increase in water and NaCl reabsorption by the proximal tubule. If a constant amount of NaCl and water was reabsorbed by the proximal tubule, increases in GFR and the filtered load of NaCl and water would result in an increased delivery to more distal segments. If these segments were not able to reabsorb the excess NaCl and water, large amounts could be lost in the urine. If such an increase in excretion were not accompanied by a corresponding rise in dietary intake, the organism would develop negative NaCl and water balance. Hence, glomerulotubular balance helps maintain NaCl and water homeostasis despite changes in GFR and the filtered load of water and NaCl.

## CHAPTER 5

1. This problem illustrates the importance of effective versus ineffective osmoles in regulating AVP secretion. Although plasma osmolality is elevated, the increased osmolality is due to urea. Because urea is an ineffective osmole with regard to AVP secretion, it is necessary to estimate the osmolality of plasma that is due to effective osmoles ( $\text{Na}^+$  and its anions). The effective osmolality of the plasma is estimated by doubling the plasma  $[\text{Na}^+]$ , which yields a value of 270 mOsm/kg  $\text{H}_2\text{O}$  (see Chapter 1). Because the effective osmolality is reduced, AVP secretion is suppressed and plasma levels are reduced.

- Regardless of the presence or absence of AVP, tubular fluid osmolality is the same in all segments except the late portion of the distal tubule and collecting duct. When AVP is present, the tubular fluid within the lumen of these segments comes to osmotic equilibrium with the surrounding interstitial fluid (300 mOsm/kg  $\text{H}_2\text{O}$  in the cortex and 1200 mOsm/kg  $\text{H}_2\text{O}$  in the papilla). In the absence of AVP, solute reabsorption by these segments leads to further dilution of the tubular fluid.
3. a. Decreased renal perfusion: With a decrease in renal perfusion, as would occur with contraction of the extracellular fluid volume, delivery of solute and water to Henle's loop is reduced (GFR is decreased, and therefore filtered load is decreased and proximal tubule fractional reabsorption is enhanced [see Chapter 6]). As a result, there will be less separation of solute and water and a reduction in  $T^c_{\text{H}_2\text{O}}$ . Urine osmolality will be maximal, but the total volume of solute-free water reabsorbed by the nephron (i.e.,  $T^c_{\text{H}_2\text{O}}$ ) will be reduced.
    - b. Inhibition of thick ascending limb transport: Inhibition of thick ascending limb NaCl transport decreases the separation of solute and water that occurs at this site. Because transport by the thick ascending limb is necessary for the generation of the medullary interstitial osmotic gradient, the osmolality of the interstitium falls. This impairs the reabsorption of water from the medullary collecting duct. As a result,  $T^c_{\text{H}_2\text{O}}$  is reduced. The urine osmolality will approach 300 mOsm/kg  $\text{H}_2\text{O}$ , reflecting the fact that fluid entering Henle's loop from the proximal tubule has an osmolality of this value, and separation of solute and water is impaired.
    - c. Nephrogenic diabetes insipidus: In nephrogenic diabetes insipidus, the collecting duct does not respond to AVP. As a result, water cannot be absorbed. This impairs the ability of the kidneys to concentrate the urine and reabsorb solute-free water ( $T^c_{\text{H}_2\text{O}}$ ). Dilute urine will be excreted.
    - d. Defect in the urea transporter in the vasa recta: The urea transporter in the vasa recta (UT-B) helps to trap urea in the inner interstitium of the

medulla by the process of countercurrent exchange. In the absence of this transporter, trapping of urea is impaired. As a result, the osmolality of the inner medullary interstitium is reduced and the urine cannot be maximally concentrated.

4. If daily solute excretion is 800 mOsm and the individual can produce concentrated urine that has an osmolality of only 400 mOsm/kg H<sub>2</sub>O, the minimum volume of urine required for this solute excretion is:

$$\frac{800 \text{ mOsm}}{400 \text{ mOsm/kg H}_2\text{O}} = 2 \text{ L}$$

If insensible loss is 1 L, this individual must drink at least 3 L of water (or other dilute beverage) in that 24-hour period to prevent the development of hyperosmolality. This is slightly more than the average daily intake of most individuals. For the second individual, the daily water requirement is much less because of the ability to excrete a more concentrated urine. The minimum urine volume required in this individual:

$$\frac{800 \text{ mOsm}}{1200 \text{ mOsm/kg H}_2\text{O}} = 0.67 \text{ L}$$

With insensible loss of 1 L, daily water intake could be less than 2 L, and body fluid osmolality would be maintained. A corollary to these examples is that solute excretion also places constraints on the maximum volume of water that can be ingested. For example, if an individual who can dilute urine to 100 mOsm/kg H<sub>2</sub>O excretes 800 mOsm of solute, this person could drink as much as 8 L of water without reducing body fluid osmolality. If, however, the individual excretes more solute (e.g., 1200 mOsm), 12 L of water could be ingested. Indeed, a decline in body fluid osmolality can be seen in individuals who drink large quantities of water without sufficient solute intake.

5. Osmolar clearance and free water clearance are calculated as:

$$C_{\text{osm}} = \frac{200 \text{ mOsm/kg H}_2\text{O} \times 6 \text{ L/day}}{280 \text{ mOsm/kg H}_2\text{O}} = 4.3 \text{ L}$$

and

$$C_{\text{H}_2\text{O}} = 6 \text{ L/day} - 4.3 \text{ L/day} = 1.7 \text{ L/day}$$

## CHAPTER 6

1. It is assumed that the 3-kg weight loss reflects only the loss of ECF. Because the plasma [Na<sup>+</sup>] is unchanged, this represents a loss of isotonic fluid (3 L) from the ECF.

Plasma osmolality: Because the plasma [Na<sup>+</sup>] is unchanged, the plasma osmolality is unchanged.

ECF volume: The ECF volume has been decreased by 3 L.

Effective circulating volume (ECV): The loss of fluid from the ECF will be detected by the vascular volume sensors as a decrease in the ECV.

Plasma AVP levels: The vascular volume sensors will detect the decreased ECV and cause increased AVP secretion (see Chapter 5).

Urine osmolality: The increased levels of AVP lead to water conservation by the kidneys and excretion of a concentrated urine (see Chapter 5).

Sensation of thirst: Again, the detection of a decrease in ECV by the vascular volume sensors leads to an enhanced sensation of thirst. The elevated levels of angiotensin II, which would also exist in this situation, will also stimulate the thirst center in the hypothalamus (see Chapter 5).

2. The individual is euvoletic. To maintain Na<sup>+</sup> balance, the amount of Na<sup>+</sup> ingested in the diet must equal the amount excreted from the body. Because the kidneys are the primary route for Na<sup>+</sup> excretion, the amount of Na<sup>+</sup> excreted daily is very nearly equal to the amount ingested in the diet (small amounts of Na<sup>+</sup> are lost in perspiration and feces). Therefore, the Na<sup>+</sup> excretion rate in this individual is approximately 100 mEq/day.

4. Volume of accumulated edema fluid = 4 L  
 Amount of  $\text{Na}^+$  retained by the kidneys = 580 mEq

The man has gained 4 kg. This represents an increase in the volume of his ECF of 4 L of fluid (1 kg = 1 L). A portion of this will accumulate in the interstitial fluid compartment as edema because of the altered Starling forces across his capillary walls. The composition of this fluid is the same as that of serum and therefore has a  $[\text{Na}^+]$  of 145 mEq/L. Because the accumulation of the fluid requires NaCl and water retention by the kidneys, the amount of  $\text{Na}^+$  retained by the kidneys must be equal to the amount contained in 4 L of fluid having an  $[\text{Na}^+]$  of 145 mEq/L or 580 mEq of  $\text{Na}^+$ .

5. Aldosterone stimulates  $\text{Na}^+$  reabsorption primarily in the late distal tubule and collecting duct, which explains the reduction in  $\text{Na}^+$  excretion seen during the beginning of aldosterone treatment. As a result of the positive  $\text{Na}^+$  balance, the ECF volume is increased. This in turn increases the GFR (i.e., increases the filtered load of  $\text{Na}^+$ ), reduces proximal tubule reabsorption, and thereby enhances delivery of  $\text{Na}^+$  to the distal tubule and collecting duct. In addition, natriuretic peptides (ANP and BNP) and urodilatin levels are increased, and their action on the collecting duct to inhibit  $\text{Na}^+$  reabsorption, together with increased  $\text{Na}^+$  delivery to this site, results in the return of  $\text{Na}^+$  excretion to its previous level. A new steady state is reached ( $\text{Na}^+$  intake =  $\text{Na}^+$  excretion) but at an expanded ECF volume. Body weight is increased, reflecting the increased ECF volume. With cessation of aldosterone treatment, the  $\text{Na}^+$  reabsorptive rate of the late distal tubule and collecting duct decreases. Because of the increased ECF volume and, therefore, enhanced  $\text{Na}^+$  delivery to the distal tubule, the reabsorptive capacity of the distal tubule and collecting duct is overwhelmed, and  $\text{Na}^+$  excretion increases. After a period of negative  $\text{Na}^+$  balance, the ECF volume decreases back to normal. A new steady state is reached ( $\text{Na}^+$  intake =  $\text{Na}^+$  excretion), and the body weight returns to its original value as the ECF volume decreases.
6. ECF volume: With decreased cardiac performance there is NaCl and water retention (see Figure 6-6). This will increase ECF volume, blood volume, and interstitial fluid volume. The increased interstitial fluid volume is manifested as edema.
- ECV: Because of the poor cardiac performance (decreased blood pressure and cardiac output), the vascular volume receptors, especially those in the high-pressure side of the circulation, will detect a decreased ECV.
- Plasma osmolality: Because the plasma  $[\text{Na}^+]$  is unchanged, the plasma osmolality is unchanged.
- Fractional  $\text{Na}^+$  excretion: Because the ECV is decreased, renal sympathetic nerve activity is increased, and the renin-angiotensin-aldosterone system is activated. This results in a decrease in the filtered load of  $\text{Na}^+$  and also an increase in the reabsorption of  $\text{Na}^+$  by the nephron. This increase in  $\text{Na}^+$  reabsorption eliminates almost all the  $\text{Na}^+$  from the urine. Therefore, the fractional  $\text{Na}^+$  excretion decreases.
- Renal sympathetic nerve activity: The vascular volume sensors will detect the decreased ECV and increase the activity of the sympathetic fibers innervating the kidney.
- ANP and BNP levels: Because of the increased blood and venous volumes, the heart will be dilated. This will stimulate ANP and BNP secretion, and their levels in the blood will be increased.
- Angiotensin II levels: The vascular volume sensors will detect the decreased ECV and activate the renin-angiotensin-aldosterone system.
- Aldosterone levels: The vascular volume sensors will detect the decreased ECV and activate the renin-angiotensin-aldosterone system.
- Plasma AVP levels: The vascular volume sensors will detect the decreased ECV and cause increased AVP secretion (see Chapter 5).

## CHAPTER 7

1. Intravenous infusion of  $\text{K}^+$  into a subject with a combination of sympathetic blockade (i.e., no catecholamine release) and insulin deficiency

would result in significant hyperkalemia compared with a similar infusion of  $K^+$  in a normal subject. Although aldosterone secretion would be stimulated by the hyperkalemia, this hormone stimulates cell  $K^+$  uptake after a 1-hour lag period. In the first hour following  $K^+$  infusion, less than 50% of the infused  $K^+$  is excreted by the kidneys, and because sympathetic activity and insulin release are suppressed, most of the  $K^+$  remaining in the body is retained in the ECF.

2. Aldosterone deficiency would initially reduce urinary potassium excretion, and  $K^+$  would be retained in the body (i.e., dietary intake would exceed excretion). This would lead to hyperkalemia, which is a potent stimulus of  $K^+$  excretion. Because the individual is initially in positive  $K^+$  balance, plasma  $K^+$  rises until urinary  $K^+$  excretion becomes equal to dietary  $K^+$  intake. In the new steady state,  $K^+$  intake would equal  $K^+$  excretion; however, the subject has hyperkalemia. Thus, it is possible to match dietary  $K^+$  intake with excretion in the absence of aldosterone, although this occurs at an elevated plasma  $[K^+]$ .
3. In the first hour after a meal, the rise in plasma  $[K^+]$  is blunted by the rapid (minutes) uptake of  $K^+$  into skeletal muscle, liver, bone, and red blood cells. Some  $K^+$  is excreted by the kidneys, but in the first hour after the meal, most  $K^+$  is sequestered in the intracellular fluid. In the ensuing hours,  $K^+$  slowly leaves the cells and is excreted by the kidneys, thereby maintaining  $K^+$  balance and plasma  $[K^+]$ .
4. Normally,  $K^+$  excretion is determined primarily by the rate of  $K^+$  secretion by the late distal tubule and collecting duct and is largely independent of the GFR and the filtered load of  $K^+$ . When 50% of the nephrons are lost, the late distal tubules and collecting ducts in the remaining functioning nephrons secrete more  $K^+$  so that  $K^+$  excretion and plasma  $[K^+]$  are maintained at normal levels. However, if 80% to 85% of the nephrons are lost and GFR falls below 15% to 20% of normal,  $K^+$  secretion by the distal tubule and collecting duct cannot increase enough to maintain constant urinary  $K^+$  excretion, and hyperkalemia ensues.

## CHAPTER 8

If urinary buffers were not available, the 70 mEq of acid needed to be excreted by the kidneys to maintain acid-base balance (net acid excretion = non-volatile acid production) would have to be excreted as free  $H^+$ . If the minimum urine pH equals 4.0, this represents only 0.1 mEq/L of  $H^+$ . Thus, for 70 mEq of  $H^+$  to be excreted, the daily urine output would need to be:

$$\frac{70 \text{ mEq/day}}{0.1 \text{ mEq/L}} = 700 \text{ L/day}$$

This exceeds the daily GFR (180 L/day). Thus, the urinary buffers are essential for the kidneys' ability to excrete sufficient quantities of  $H^+$  and maintain acid-base balance.

3. The initial set of laboratory data indicates the presence of a metabolic alkalosis with appropriate respiratory compensation. Given the individual's history, the most likely cause of this simple acid-base disorder is the loss of gastric acid by vomiting. The second set of laboratory data continues to show the presence of metabolic alkalosis with respiratory compensation. In addition, there is evidence of fluid loss (decrease in body weight by 2 kg) and a resultant decrease in ECF volume (decrease in blood pressure). Given the worsening of this individual's metabolic alkalosis, it is somewhat surprising that the urine pH is so acidic. The appropriate renal response

should be an increase in  $\text{HCO}_3^-$  excretion (i.e., decreased net acid excretion) to correct the alkalosis. However, the kidneys' response to the ECF volume contraction prevents this from occurring (see Chapter 6). Thus, the filtered load of  $\text{HCO}_3^-$  is decreased because of a reduction in GFR, and proximal tubule  $\text{HCO}_3^-$  reabsorption is enhanced because of the need to conserve  $\text{Na}^+$  (i.e.,  $\text{H}^+$  secretion is stimulated because of the increased activity of the  $\text{Na}^+-\text{H}^+$  antiporter). In addition, the ECF volume contraction stimulates aldosterone secretion, which increases  $\text{H}^+$  secretion by  $\alpha$ -intercalated cells of the late distal tubule and collecting duct. Therefore, the urine is more acidic than expected for the degree of alkalosis. The ECF volume must be restored to its normal value to correct this situation. Infusion of isotonic  $\text{NaCl}$  would accomplish this and also allow the kidneys to excrete the excess  $\text{HCO}_3^-$ , thereby restoring acid-base balance.

- Carbonic anhydrase plays an important role in the secretion of  $\text{H}^+$  (reabsorption of  $\text{HCO}_3^-$ ) by the cells of the proximal tubule, thick ascending limb of Henle's loop, and  $\alpha$ -intercalated cells of the late distal tubule and collecting duct. Inhibition of this enzyme would therefore inhibit the secretion of  $\text{H}^+$  by these nephron segments. Because the proximal tubule reabsorbs the largest fraction of the filtered load of  $\text{HCO}_3^-$  (80%), the effect of carbonic anhydrase inhibitors at this site is quantitatively the most important. With decreased reabsorption, more  $\text{HCO}_3^-$  would be excreted in the urine, and urine pH would become alkaline. This loss of  $\text{HCO}_3^-$  from the body would result in the development of metabolic acidosis.
- This man has a metabolic acidosis with respiratory compensation. The plasma anion gap is calculated from the serum concentrations of  $\text{Na}^+$ ,  $\text{Cl}^-$ , and  $\text{HCO}_3^-$ , and is:

$$\text{Anion gap} = [\text{Na}^+] - ([\text{Cl}^-] + [\text{HCO}_3^-])$$

$$13 \text{ mEq/L} = 137 \text{ mEq/L} - (111 \text{ mEq/L} + 13 \text{ mEq/L})$$

Thus, this is a normal anion gap metabolic acidosis, which may be seen either in patients who lose

alkali in the feces secondary to diarrhea or in patients with renal tubular acidosis. Because his urine is more alkaline than expected for someone with his degree of acidosis (a urine pH of at least 5.5 would be expected), it is most probable that he has renal tubular acidosis. This would predispose him to the formation of kidney stones. Because of his acidosis, he will lose  $\text{Ca}^{++}$  from his bones (bones serve as a buffer source with chronic acidosis). This  $\text{Ca}^{++}$  will be excreted by the kidneys. However, the alkaline urine pH leads to  $\text{Ca}^{++}$  precipitation and thus stone formation.

## CHAPTER 9

- Approximately two thirds of  $\text{Ca}^{++}$  reabsorption across the proximal tubule occurs by solvent drag, a process that depends on  $\text{Na}^+$  reabsorption. Mannitol would inhibit  $\text{Ca}^{++}$  reabsorption by blocking solvent drag in the proximal tubule and thereby increase urinary  $\text{Ca}^{++}$  excretion.
- Furosemide would inhibit the  $\text{Na}^+-\text{K}^+-2\text{Cl}^-$  symporter and reduce the lumen-positive transepithelial voltage to 0. This, in turn, would inhibit passive  $\text{Ca}^{++}$  reabsorption by the paracellular pathway.
- A rise in plasma  $[\text{P}_i]$  increases the amount of  $\text{P}_i$  filtered by the glomeruli. Because the amount of  $\text{P}_i$  normally filtered is equal to the reabsorptive capacity of the kidneys, an increase in the amount of  $\text{P}_i$  filtered will increase urinary  $\text{P}_i$  excretion and reduce plasma  $[\text{P}_i]$ .

## CHAPTER 10

- Nephrogenic diabetes insipidus is a condition in which the late portion of the distal tubule and collecting duct does not respond to AVP. As a result, water reabsorption is impaired and a large volume of dilute urine is excreted. Long-term administration of thiazide diuretics provides symptomatic relief by reducing the volume of urine excreted. This occurs by two mechanisms. First, the diuretic-induced natriuresis reduces the volume of the ECF. This in turn reduces the

GFR and enhances proximal tubule reabsorption (see Chapter 6 for details). As a result, less fluid is delivered to Henle's loop and ultimately to the distal tubule and collecting duct, where water reabsorption is impaired. The net effect is that urine volume is decreased. Second, thiazide diuretics increase the abundance of aquaporin-2 in the principal cells of the late portion of the distal tubule and collecting duct (at least in the form of nephrogenic diabetes insipidus associated with  $\text{Li}^+$  ingestion). The increased expression of aquaporin-2 would thus allow increased water reabsorption and thereby reduce urine output.

2.
  - a. The long-term effect of diuretic therapy is a reduction in the volume of the ECF. With such a decrease, the blood volume and thus cardiac output are reduced. Because blood pressure is equal to cardiac output multiplied by the total peripheral vascular resistance, a decrease in cardiac output therefore reduces blood pressure (cardiovascular reflexes activate sympathetic outflow so as to increase peripheral vascular resistance and thereby try to maintain blood pressure). In addition, diuretics may cause some degree of vascular smooth muscle vasodilation, although the mechanism by which this occurs is not fully understood. This vasodilation reduces total peripheral vascular resistance, thereby decreasing blood pressure.
  - b. Hypokalemia is a side effect of all diuretics acting proximal to the  $\text{K}^+$  secretory site (late portion of the distal tubule and the cortical collecting duct). The most common diuretics given for the treatment of hypertension are thiazides. However, the loop diuretics, osmotic diuretics, and carbonic anhydrase inhibitors can also lead to hypokalemia. By their action, tubular fluid flow rate to the  $\text{K}^+$  secretory site is enhanced, which stimulates  $\text{K}^+$  secretion. In addition, the diuretic-induced decrease in ECF volume leads to stimulation of aldosterone and AVP, both of which stimulate  $\text{K}^+$  secretion by the late portion of the distal tubule and cortical collecting duct.
3.
  - c. Treatment of the hypokalemia could involve supplementation of the diet with foods containing high levels of  $\text{K}^+$  or with  $\text{KCl}$  tablets. Alternatively, a  $\text{K}^+$ -sparing diuretic could be given in combination with the thiazide diuretic.
3. Thiazide diuretics are secreted into the lumen of the proximal tubule by the same organic anion transport system that secretes penicillin. Competitive inhibition of secretion of the thiazide could decrease the effective concentration of the diuretic in the tubular field. Because thiazides act from the lumen, a reduction in their concentration at this site could reduce their effectiveness.
4.
  - a. To maintain  $\text{Na}^+$  balance, both individuals will excrete approximately 100 mEq/day of  $\text{Na}^+$ . Normally the kidneys excrete 99%+ of the daily ingested  $\text{Na}^+$  load. The remainder is lost in the feces and in sweat. When individuals are treated chronically with a diuretic, they do not exhibit a sustained natriuresis. This is the diuretic braking phenomenon. After a relatively short period of negative  $\text{Na}^+$  balance (i.e., intake < excretion), they again come into steady-state balance (i.e., intake = excretion). The ability to reestablish steady-state balance results from the diuretic-induced decrease in ECF volume and increased expression and function of  $\text{Na}^+$  transporters. The decrease in ECF volume results in a decrease in the GFR and increased proximal tubule reabsorption. This in turn delivers less  $\text{Na}^+$  to the portions of the nephron where the diuretic is acting. In addition, increased expression of  $\text{Na}^+$  transporters in the segments where the diuretics act, as well as in other nephron segments, contributes to this response. Together, these modifications in renal  $\text{Na}^+$  handling allow a new steady state to be reached where once again  $\text{Na}^+$  excretion equals  $\text{Na}^+$  ingestion.
  - b. Individual A was treated with a loop diuretic. With inhibition of  $\text{NaCl}$  reabsorption by the thick ascending limb, less  $\text{NaCl}$  is deposited in the medullary interstitium. As a result, the osmolality of the interstitium declines, and water reabsorption from the collecting duct in the presence of AVP is reduced. Thus the loop

diuretic inhibits the reabsorption of solute-free water. Individual B was treated with a thiazide diuretic, which, in contrast, inhibits NaCl reabsorption in the early distal tubule. Because this segment is located in the cortex of the kidney, medullary interstitial osmolality is not affected. Thus, when AVP is present, the urine can be concentrated. Thus thiazide diuretics do not impair solute-free water reabsorption.

- c. Individual A is treated with a loop diuretic. Because the thick ascending limb has the highest rate of solute reabsorption of all the water-impermeable segments of the nephron

(i.e., thin ascending limb, thick ascending limb, and early distal tubule), inhibition of solute transport at this site will greatly impair the kidneys' ability to dilute the urine. As a result, the urine osmolality will approach that of plasma (300 mOsm/kg H<sub>2</sub>O), which is the osmolality of the glomerular filtrate as well as that of the tubular fluid exiting the proximal tubule. Individual B is treated with a thiazide diuretic, which acts only on cortical nephron segments (early distal tubule). This will impair urine dilution, but not as significantly because the thick ascending limb is still intact.

# APPENDIX E

## ANSWERS TO INTEGRATIVE CASE STUDIES

### CASE 1

- 1a.** The ECF volume of this man is increased above normal. The presence of edema, distention of the neck veins, and rales (sounds related to fluid in the lungs) is evidence of this increased volume. Additional evidence could be obtained by measuring weight gain because accumulation of each liter of extracellular fluid would increase body weight by 1 kg.
- 1b.** The ECV in this man would be decreased from normal. With damage to the myocardium, cardiac output and therefore tissue perfusion would be reduced. This decreased cardiac performance will be sensed by the vascular baroreceptors as a decrease in the ECV.
- 1c.** As noted previously, the reduced cardiac performance would be sensed by the vascular baroreceptors in the body as a decreased ECV. This will activate the sympathetic nervous system and the renin-angiotensin-aldosterone system and stimulate AVP secretion. Because ANP and BNP are secreted from the cardiac myocytes in response to stretch and because the heart is dilated (expanded ECF and vascular volume), ANP and BNP secretion will be stimulated.
- 1d.** The kidneys would be avidly retaining  $\text{Na}^+$ . With a decrease in ECV, vascular volume sensors, especially in the high-pressure (juxtaglomerular apparatus, aortic arch, and carotid sinus) side of the circulation, would be activated and signals sent to the kidneys to retain  $\text{Na}^+$ .
- Sympathetic nerves innervating the afferent and efferent arterioles of the glomeruli would cause vasoconstriction. The net result would be to reduce the GFR. This in turn would reduce the filtered load of  $\text{Na}^+$ .
  - Sympathetic innervation of the proximal tubule, thick ascending limb of Henle's loop, and collecting duct will also increase  $\text{Na}^+$  reabsorption at these sites. This response is mediated by  $\alpha_1$ -adrenoceptors on the cells.
  - Increased sympathetic nerve activity, together with decreased perfusion pressure at the afferent arteriole, will result in the secretion of renin. This activation of the renin-angiotensin-aldosterone system will further stimulate  $\text{Na}^+$  reabsorption because angiotensin II increases both proximal and distal tubule  $\text{Na}^+$  reabsorption, and aldosterone increases  $\text{Na}^+$  reabsorption in the late distal tubule and collecting duct. Angiotensin II acts directly on the cells of the proximal tubule to stimulate  $\text{Na}^+$  reabsorption.
  - With the decreased ECV, the GFR decreases and the filtration fraction increases. This in turn decreases the hydrostatic pressure and increases the oncotic pressure in the peritubular capillaries and thereby enhances overall reabsorption of fluid by the proximal tubule.
  - With the increases in the ECF and vascular volumes, the heart dilates and ANP and BNP levels are elevated. However, the effect of these natriuretic peptides (inhibition of renin secretion and natriuresis) appears to be blunted by

the effect of the other factors, all of which act to reduce  $\text{Na}^+$  excretion. The net effect of these responses is retention of  $\text{Na}^+$  by the kidneys. As a result of this  $\text{Na}^+$  retention (positive  $\text{Na}^+$  balance), the ECF volume will increase, leading to the formation of edema as seen in the physical examination of this man.

- 1e.** The development of hyponatremia indicates that this man is in positive water balance. In this case the ingestion of water has exceeded the capacity of the kidneys to excrete solute-free water. There are several reasons why solute-free water excretion is impaired in this man.
- AVP secretion is stimulated because of the decreased ECV. As a consequence, the collecting duct reabsorbs more solute-free water.
  - The decreased ECV results in a reduction in the filtered load of solute ( $\text{NaCl}$ ) and water and an increase in fractional reabsorption by the proximal tubule (see earlier). As a result, there is decreased delivery of solute and water to the thick ascending limb, the primary site where solute-free water is generated.
- 1f.** Hypokalemia in this man is the result of increased renal  $\text{K}^+$  excretion. The major reason for increased  $\text{K}^+$  excretion is related to the elevated levels of aldosterone in this man (secondary to decreased ECV). Aldosterone then acts on the late distal tubule and collecting duct to stimulate  $\text{K}^+$  secretion. The enhanced secretion of  $\text{K}^+$  by the late distal tubule and cortical collecting duct will result in increased  $\text{K}^+$  excretion and the development of hypokalemia. Because delivery of  $\text{Na}^+$  to the collecting duct is reduced in this man (see earlier), the hypokalemia will be mild. It is likely that extrarenal factors will also contribute to the development of hypokalemia because aldosterone causes  $\text{K}^+$  to move into cells.
- 1g.** In order to get an appropriate response to a loop diuretic, there needs to be adequate delivery of  $\text{NaCl}$  to the loop of Henle. As outlined before, GFR is reduced in congestive heart failure, which reduces the filtered load of  $\text{NaCl}$ . In addition, proximal tubule reabsorption is enhanced. The net result is a significant reduction in the delivery of  $\text{NaCl}$  to the thick ascending limb and thus a blunted response to the diuretic.

**1h.** As noted, the diuretic is given to prevent  $\text{NaCl}$  retention by the kidneys and thus reduce his edema. The additional  $\text{NaCl}$  lost from the ECF by the action of the diuretic will further reduce his ECV. As a result, the sympathetic nervous system will be further activated, as will the renin-angiotensin-aldosterone system. AVP secretion will also be stimulated.

- 1i.** Loop diuretics increase the excretion of  $\text{K}^+$  and thus can lead to the development of hypokalemia. Two important effects contribute to this response. First, the thick ascending limb of Henle's loop reabsorbs approximately 20% of the filtered load of  $\text{K}^+$ . Loop diuretics inhibit this process.  $\text{K}^+$  is reabsorbed by the  $\text{Na}^+-\text{K}^+-2\text{Cl}^-$  symporter in the apical membrane and by the paracellular pathway driven by the lumen-positive transepithelial voltage (inhibition of the symporter results in a reduction in the lumen-positive voltage). Second, the loop diuretic will cause increased delivery of  $\text{Na}^+$  and fluid to the distal tubule and cortical collecting duct and thereby stimulate  $\text{K}^+$  secretion. Because aldosterone levels are also elevated (secondary to decreased ECV),  $\text{K}^+$  secretion is further stimulated. Together, these effects will enhance  $\text{K}^+$  secretion and thus renal  $\text{K}^+$  excretion, leading to a worsening of the hypokalemia.
- 1j.** Creatinine is excreted from the body primarily by glomerular filtration. Therefore, the amount of creatinine excreted is determined primarily by its filtered load. With a reduction in the ECV, the glomerular filtration rate is reduced. The reduced filtration rate will decrease the filtered load of creatinine and thus its excretion. As a result, the serum [creatinine] will increase. With the added decrement in the ECV caused by the loop diuretic, the glomerular filtration rate will fall further and thereby cause the serum [creatinine] to increase even more.

## CASE 2

- 2a.** This woman's symptoms and the electrolyte disturbances are most characteristic of decreased levels of adrenal cortical steroids and especially

the mineralocorticoid hormone aldosterone. This is a patient with Addison's disease. The presence of hyperpigmentation suggests that the primary problem is at the level of the adrenal gland (i.e., nonresponsive to ACTH). ACTH levels are elevated in response to the decreased circulating levels of adrenal cortical steroids. (ACTH is synthesized as proopiomelanocortin (POMC), and when this molecule is processed to ACTH several of the cleavage products have melanocyte-stimulating properties). These cleavage products act on the epidermal melanocytes leading to the hyperpigmentation of the gums and skin.

- 2b.** Normally, the kidneys would respond to the decreased ECF volume present in this woman by dramatically reducing the excretion of  $\text{Na}^+$ . The urine  $[\text{Na}^+]$  is unexpectedly high in this woman because of the reduced ability of her kidneys to reabsorb  $\text{Na}^+$  in the thick ascending limb, distal tubule, and collecting duct (the distal tubule and collecting duct are especially important). This " $\text{Na}^+$  wasting" is a result of the low levels of aldosterone. Although the angiotensin II levels would be elevated in this woman, her adrenal glands are not secreting aldosterone in response to the angiotensin II. The hypotension is a result of the negative  $\text{Na}^+$  balance present in this woman, which in turn reflects the decreased circulating levels of aldosterone. Because of the negative  $\text{Na}^+$  balance, ECF volume will be decreased. Because plasma is a component of the ECF, vascular volume and hence blood pressure will be decreased.
- 2c.** Hyponatremia indicates a problem in water balance. Thus, the ability of this woman's kidneys to excrete solute-free water is impaired, and she is in positive water balance (solute-free water ingestion > solute-free water excretion). There are several reasons for the decreased ability of this woman's kidneys to excrete solute-free water. Because of her decreased ECF and vascular volumes, her vascular baroreceptors are activated. As a result, the sympathetic nervous system and the renin-angiotensin-aldosterone system are activated. Nonosmotic release of AVP also occurs because of a fall in the ECF volume. As a

consequence of the elevated AVP levels, solute-free water is reabsorbed by the late portion of the distal tubule and collecting duct. In addition, the decreased ECF volume results in a decrease in the filtered load of solute ( $\text{NaCl}$ ) and water and an increase in fractional reabsorption by the proximal tubule. As a result, there is decreased delivery of solute and water to the thick ascending limb, the primary site where solute-free water is generated.

- 2d.** Urinary  $\text{K}^+$  excretion is determined in large part by the amount of  $\text{K}^+$  secreted into tubular fluid by the late distal tubule and cortical collecting duct.  $\text{K}^+$  secretion at these nephron sites is reduced by the low levels of plasma aldosterone in this woman. In addition, aldosterone causes the uptake of  $\text{K}^+$  into cells (e.g., skeletal muscle). In the absence of aldosterone, there will be less cellular uptake of  $\text{K}^+$ . This will also contribute to the development of hyperkalemia.
- 2e.** This woman has a metabolic acidosis as evidenced by her low serum  $[\text{HCO}_3^-]$ . This is a result of the inability of her kidneys to excrete sufficient net acid to balance the nonvolatile acids produced each day through metabolism. The defect in her kidneys is reduced  $\text{H}^+$  secretion by the  $\alpha$ -intercalated cells of the late portion of the distal tubule and the collecting duct.  $\text{H}^+$  secretion by these cells is dependent on aldosterone. This is both a direct and indirect effect. Aldosterone directly stimulates the  $\alpha$ -intercalated cells to secrete  $\text{H}^+$ . It is also responsible for stimulating  $\text{Na}^+$  reabsorption by the principal cells in these segments. This reabsorption of  $\text{Na}^+$  generates a lumen-negative transepithelial voltage that facilitates  $\text{H}^+$  secretion by the intercalated cell. Therefore, in the absence of aldosterone,  $\text{H}^+$  secretion is impaired. This will reduce  $\text{HCO}_3^-$  reabsorption, the excretion of  $\text{H}^+$  with urinary buffers, and the excretion of  $\text{NH}_4^+$ . Thus, net acid excretion is reduced.

### CASE 3

- 3a.**  $\text{Na}^+$  excretion is determined by diet and ECF volume status. In a euvolemic individual, the amount of  $\text{Na}^+$  excreted in the urine each day is

approximately equal to the amount ingested in the diet. Because the man appears to be euvolemic, his daily  $\text{Na}^+$  intake would be approximately 80 mEq/day. The hyponatremia in this man reflects a disorder of water balance. Specifically, the unregulated secretion of AVP prevents his kidneys from excreting solute-free water. As a result, his water intake exceeds the ability of his kidneys to excrete solute-free water and he is in positive water balance.

- 3b.** Infusion of 1 L of isotonic saline will add 300 mOsm of NaCl (150 mmoles of NaCl = 300 mOsm) to his ECF together with 1 L of water. This will transiently increase the ECF volume and raise the plasma osmolality and  $[\text{Na}^+]$ . However, over time the entire amount of NaCl will be excreted because he is in steady-state  $\text{Na}^+$  balance (excretion = intake). However, because of the inappropriate secretion of AVP, he will not be able to excrete the water. With a  $U_{\text{osm}}$  of 600 mOsm/kg  $\text{H}_2\text{O}$ , he will excrete the infused NaCl (300 mOsm) in 0.5 L of urine. Thus 0.5 L of solute-free water will remain in the body, and the plasma  $[\text{Na}^+]$  will decrease. For this man, the addition of 0.5 L of solute-free water to his body fluid will reduce the plasma  $[\text{Na}^+]$  to 119 mEq/L:

$$\begin{aligned} \text{Total body osmoles} &= 240 \text{ mOsm/L} \times 42 \text{ L} \\ & \quad (\text{unchanged}) &= 10,080 \text{ mOsm} \\ \text{New total body water} &= 42 \text{ L} + 0.5 \text{ L} = 42.5 \text{ L} \\ \text{New plasma osmolality} &= 10,080 \text{ mOsm}/42.5 \text{ L} \\ &= 237 \text{ mOsm/kg } \text{H}_2\text{O} \\ \text{New plasma } [\text{Na}^+] &= 237 \text{ mOsm/kg } \text{H}_2\text{O}/2 \\ &= 119 \text{ mEq/L} \end{aligned}$$

- 3c.** A 3% saline solution contains 513 mmol/L of NaCl (MW = 58.5 g/mole), which is 1026 mOsm/L. Thus 1 L of fluid and 1026 mOsm of solute are added to the body fluids. With the establishment of a new steady state, the infused NaCl will be excreted with 1.7 L of urine:

$$\frac{1026 \text{ mOsm}}{600 \text{ mOsm/kg } \text{H}_2\text{O}} = 1.7 \text{ L}$$

$U_{\text{osm}} = 600 \text{ mOsm/kg } \text{H}_2\text{O}$  because of the unregulated secretion of AVP. Therefore 1 L of infused

water is excreted together with an additional 0.7 L of solute-free water. This will result in a new plasma  $[\text{Na}^+]$  of 122 mEq/L:

$$\begin{aligned} \text{Total body osmoles} &= 240 \text{ mOsm/L} \times 42 \text{ L} \\ & \quad (\text{unchanged}) &= 10,080 \text{ mOsm} \\ \text{New total body water} &= 42 \text{ L} - 0.7 \text{ L} = 41.3 \text{ L} \\ \text{New plasma osmolality} &= 10,080 \text{ mOsm}/41.3 \text{ L} \\ &= 244 \text{ mOsm/kg } \text{H}_2\text{O} \\ \text{New plasma } [\text{Na}^+] &= 244 \text{ mOsm/kg } \text{H}_2\text{O}/2 \\ &= 122 \text{ mEq/L} \end{aligned}$$

- 3d.** The simplest treatment option would be to restrict his intake of fluids so that intake does not exceed the ability of his kidneys to excrete solute-free water (i.e., he should drink only in response to thirst). Another treatment option would be to block the effect of AVP on the collecting duct. Currently, AVP receptor antagonists (aquaretics) are available for this purpose.

## CASE 4

- 4a.** The acid-base disorder of this man is a metabolic acidosis. In the absence of insulin, the metabolism of fats and carbohydrates is altered such that nonvolatile acids (keto acids) are produced. The nonvolatile acids are rapidly buffered by cellular and extracellular buffers. Buffering in the extracellular fluid results in a decrease in the plasma  $[\text{HCO}_3^-]$ , which lowers the pH. The deep rapid breathing reflects the respiratory compensation ( $\text{Pco}_2$  is lowered). The plasma anion gap is calculated using the following formula (normal value is 8 to 16 mEq/L):

$$\begin{aligned} \text{Anion gap} &= [\text{Na}^+] - ([\text{Cl}^-] + [\text{HCO}_3^-]) \\ & \text{or } 130 - (95 + 7) = 28 \text{ mEq/L} \end{aligned}$$

The plasma anion gap is elevated because of the presence of unmeasured anions; in this case the anions would be the keto acids such as acetoacetate and  $\beta$ -hydroxybutyrate.

- 4b.** Despite the hyperkalemia in this man, he is probably  $\text{K}^+$  depleted. The  $\text{K}^+$  depletion is a result of  $\text{K}^+$  shift out of the cells (see later) and enhanced  $\text{K}^+$  excretion by the kidneys because of the glucose-induced osmotic diuresis (i.e., the increased urinary flow rate increases  $\text{K}^+$  secretion in the

late distal tubule and collecting duct). Hyperkalemia is a result of a shift of  $K^+$  out of cells (e.g., skeletal muscle) into the extracellular fluid. This shift occurs because of the lack of insulin and the hypertonicity of the ECF secondary to the elevated [glucose]. The acidosis is probably not a major contributing factor to the development of hyperkalemia in this situation. When acidosis is induced by mineral acids (e.g., HCl), movement of  $H^+$  into cells during the process of intracellular buffering results in a shift of  $K^+$  out of the cells into the ECF. However, with organic acidosis, as occurs in this situation, the cellular buffering of the organic acids does not result in a significant shift of  $K^+$  out of the cell. The polyuria is a result of an osmotic diuresis induced by glucose (also the keto acids). Normally, all of the filtered load of glucose is reabsorbed by the proximal tubule. However, in this man the filtered load of glucose exceeds the reabsorptive capacity of the proximal tubule. Consequently, the nonreabsorbed glucose will remain in the lumen of the proximal tubule, where it will act as an osmotically active particle. This will establish an osmotic gradient opposite to that generated by the NaCl reabsorptive processes. This glucose-induced osmotic diuresis will increase the delivery of NaCl and water to the distal tubule and cortical collecting duct, which stimulates  $K^+$  secretion at these sites. As a result,  $K^+$  excretion from the body will be increased. In addition, keto acids (anions) are excreted with a cation ( $Na^+$  and  $K^+$ ). Thus, some additional  $K^+$  will be excreted because of the high excretion rate of the keto acids. Increased  $K^+$  excretion together with the shift of  $K^+$  from the ICF to the ECF noted previously (secondary to the insulin deficiency and hyperosmolality) will lead to progressive whole-body  $K^+$  depletion. Accordingly, an increase in serum  $[K^+]$  is not always indicative of positive  $K^+$  balance. This man is in negative  $K^+$  balance and is at risk for the development of hypokalemia when insulin is administered and the metabolic abnormalities are corrected.

**4c.** The serum  $[K^+]$  fell for several reasons. Insulin causes  $K^+$  to move into cells. The mechanism

responsible for this effect of insulin is related to stimulation of the  $Na^+-K^+-ATPase$ . With increased activity of the  $Na^+-K^+-ATPase$ ,  $K^+$  uptake into the cell is enhanced. In addition, insulin's effect on glucose metabolism will lower the serum [glucose]. As a consequence, the osmolality of the ECF will decrease and cause additional  $K^+$  to move into cells. Finally, administration of fluids will reexpand the ECF and dilute the  $K^+$  in this compartment. For all of these reasons,  $K^+$  is usually administered during the course of treatment so as not to induce hypokalemia.

## CASE 5

**5a.** This is a metabolic acidosis with a normal anion gap (anion gap = 13 mEq/L). The two most frequent causes of nonanion gap acidosis are defects in renal acid excretion (renal tubular acidosis) and loss of  $HCO_3^-$  from the body (e.g., diarrhea). In this case, the relatively alkaline urine pH in the presence of systemic acidosis suggests a defect in renal acid excretion. Normally, the urine should be maximally acidic with this degree of systemic acidosis. The most likely diagnosis is distal renal tubular acidosis (i.e., a defect in  $H^+$  secretion or  $H^+$  permeability of the late distal tubule and collecting duct). The renal stone that brought this man to the physician is probably a calcium-containing stone because the solubility of calcium is reduced in alkaline urine. His filtered load of  $Ca^{++}$  is also elevated, reflecting the loss of  $Ca^{++}$  from his bones because of buffering of the acidosis.

**5b.** Normally, the kidneys respond to a metabolic acidosis by increasing net acid excretion. This typically occurs with a urine pH of less than 5.5. Thus, the urine pH of 6.4 indicates some defect in renal acid excretion. As noted, this is a case of distal renal tubular acidosis, where the defect is an inability of the distal nephron to acidify the urine maximally. Because of this defect, there is impaired  $HCO_3^-$  reabsorption, decreased excretion of titratable acid, and decreased excretion of  $NH_4^+$ . Therefore renal net acid excretion is less than net endogenous acid production, and metabolic acidosis (nonanion gap) develops.

5c. Urinary net charge should be negative under normal conditions, reflecting the excretion of  $\text{NH}_4^+$  in the urine. The positive value confirms the fact that the kidney is the cause of the acidosis because insufficient amounts of  $\text{NH}_4^+$  are being excreted.

## CASE 6

6a. This is a mixed acid-base disorder because the  $\text{Pco}_2$  is elevated and the serum  $[\text{HCO}_3^-]$  is decreased. There is a component related to respiratory acidosis caused by poor gas exchange in the lungs. In addition, her hypoxia (low  $\text{Po}_2$ ) has resulted in anaerobic metabolism by her tissues with the generation of lactic acid. Buffering of the lactic acid has resulted in a decrease in her serum  $[\text{HCO}_3^-]$ .

6b. This girl was given an injection of epinephrine by the paramedics to dilate her airways. Epinephrine is a  $\beta$ -selective agonist that not only acts to relax her constricted airways but also stimulates the  $\text{Na}^+$ - $\text{K}^+$ -ATPase, causing enhanced  $\text{K}^+$  uptake into cells (e.g., skeletal muscle).

Points to consider:

1. It is assumed that the 2-kg weight loss reflects only the loss of body fluids (i.e., 2 L) and not tissue mass. Given the short time period involved, this is a reasonable assumption.
2. Because the plasma  $[\text{Na}^+]$  has not changed this is isotonic loss of fluid. Consequently, all of the fluid loss will occur from the ECF (there is no

osmotic gradient to cause fluid to leave the ICF). This is a simplification, but again reasonable.

3. All of the osmole loss will occur from the ECF, essentially as NaCl.

4. Calculations:

*Initial Conditions*

$$\text{Total body water} = 30 \text{ kg} \times 0.6 = 18 \text{ L}$$

$$\text{ECF volume} = 18 \text{ L} \times 1/3 = 6 \text{ L}$$

$$\text{ICF volume} = 18 \text{ L} - 6 \text{ L} = 12 \text{ L}$$

$$\text{Total body osmoles} = 140 \times 2 \times 18 \text{ L} = 5040 \text{ mOsm}$$

$$\text{ECF osmoles} = 6 \text{ L} \times 2 \times 140 = 1680 \text{ mOsm}$$

$$\text{ICF osmoles} = 5040 - 1680 = 3360 \text{ mOsm}$$

*Day 2*

Points to consider:

1. Compared with the child in Case 7, this child is in much more serious condition. This child has lost 2 L of fluid with excess NaCl from the ECF. As a result he has become hyponatremic.
2. Because of the hyponatremia there is now a driving force to cause water to move from the ECF to the ICF. This movement will further reduce the volume of the ECF (of which the vascular volume is a component). This child is very near vascular collapse.

**3. Calculations:***Initial Conditions*

$$\text{Total body water} = 30 \text{ kg} \times 0.6 = 18 \text{ L}$$

$$\text{ECF volume} = 18 \text{ L} \times 1/3 = 6 \text{ L}$$

$$\text{ICF volume} = 18 \text{ L} - 6 \text{ L} = 12 \text{ L}$$

$$\text{Total body osmoles} = 140 \times 2 \times 18 \text{ L} = 5040 \text{ mOsm}$$

$$\text{ECF osmoles} = 6 \text{ L} \times 2 \times 140 = 1680 \text{ mOsm}$$

Isotonic dehydration (Case 7) is most common in pediatric patients, but hyponatremic dehydration (Case 8) is more common than hypernatremic dehydration (Case 9) in young pediatric patients (i.e., ~10 kg)—as more often than not their parents are trying to keep them hydrated with hypotonic solutions (e.g., juice, electrolyte replacement drinks). This results in “partial” rehydration with free water, which results in their sodium/solute losses exceeding water losses relatively speaking.

The children in Cases 7 and 8 need 2 L of water and some NaCl. For Case 7 this can be accomplished by infusing 2 L of isotonic saline (0.9% NaCl). However, the child in Case 8 needs additional NaCl. For this child infusion of an appropriate combination of isotonic and hypertonic saline would be required. In practice only isotonic saline is administered, and the kidneys reabsorb sufficient quantities of Na<sup>+</sup> to correct the deficit.

1. This child has lost 2 L of fluid but has a net loss of water. As a result he has become hypernatremic and the plasma osmolality is 320 mOsm/kg H<sub>2</sub>O.
2. Because of the hypernatremia there is now a driving force to cause water to move from the ICF to the ECF.
3. Calculations:

*Initial Conditions*

$$\text{Total body water} = 30 \text{ kg} \times 0.6 = 18 \text{ L}$$

$$\text{ECF volume} = 18 \text{ L} \times 1/3 = 6 \text{ L}$$

$$\text{ICF volume} = 18 \text{ L} - 6 \text{ L} = 12 \text{ L}$$

$$\text{Total body osmoles} = 140 \times 2 \times 18 \text{ L} = 5040 \text{ mOsm}$$

$$\text{ECF osmoles} = 6 \text{ L} \times 2 \times 140 = 1680 \text{ mOsm}$$

4. This child needs 2 L of water and some NaCl. Infusion of hypotonic saline would be appropriate. However, fluid replacement should be accomplished slowly (i.e., over 48-72 hours), and the serum [Na<sup>+</sup>] should decrease by no more than 10 mEq/L in 24 hours.

**CASE 10**

1. The initial acid-base disorder is a respiratory alkalosis. This results from tachypnea secondary to hypoxia. The increased respiratory rate in response to hypoxia results in a decrease in the Pco<sub>2</sub>, and therefore the development of a respiratory alkalosis.
2. After therapy the acid-base disorder is a respiratory acidosis, which reflects inadequate ventilation.
3. The girl remains hypoxic five hours after the initial presentation despite therapy (note that the

$PO_2$  remains 60 mm Hg despite therapy with 40% oxygen). After a period of tachypnea and labored breathing that lead to respiratory alkalosis she became fatigued due to hypoxia. Consequently, her respiratory effort decreased and breathing became slow and shallow. The hypoventilation caused respiratory acidosis. The decreased breath sounds and decreased wheezing on auscultation

reflect decreased air movement from hypoventilation. It is an ominous sign in a patient with hypoxia and requires immediate intervention. Note that decreased wheezing in an asthmatic patient would be a sign of improvement only in the presence of normal breath sounds and improving arterial  $PO_2$ .
